Speaking during the launch of Eldas South Sub-County at Elnur, in Wa-jir County, Prof. Kindiki stressed the critical importance of enhancing security measures in areas affected by the threat of terror.

Kindiki underscored the commitment of the Kenya Kwanza administration to safeguard every corner of the country and combat various criminal activities.

'We must ensure that Wajir, Mandera, Garissa, and the entire northern Kenya are safe and secure, just like the rest of the

✓ enya's mining sector has achieved a significant boost after a strategic investor embarked on the process of spearheading the revival of fluorspar mining at Kimwarer in El-

Negotiations over the project have already been completed, with terms agreed upon, paving the way for the long-overdue

5-year security equipment modernization plan, costing an estimated Sh. 37 billion.

Detailing the acquisition process, the CS disclosed an expenditure of approximately Sh. 7 billion over the past year for the procurement of security equipment.

The upcoming consignments include drones and other modern surveillance equipment, with the second consignment expected within two months, and gunship helicopters and other aerial mobility equipment slated to arrive within a year.

Kindiki at the same time installed Samuel Mokua as the first Deputy County Commissioner of the Sub-County Headquarters.

The move is part of a broader government initiative to decentralize administrative functions and bring governance closer to the citizens.

as a timely move, the PS noted that the resumption of fluorspar mining would not only generate revenues for national and county governments but also catalyze the creation of hundreds of direct jobs for residents.

He added that the investor would also engage in community-benefiting programs and activities through the terms agreed upon under the Community Development Agreement Committee (CDAC) as per the Mining Act 2016.

"We are delighted by this progress. Our aim is to ensure that mining is a profitable undertaking not only for the investors but also for the communities where the mineral resource is located. In the end, everyone should be a winner," the PS said.

The revival of the fluorspar mine has been received with excitement by residents and leaders of Elgeyo Marakwet County, who have been agitating for the revival and activation of what they deemed a dormant economic resource with vast economic potential.





PS addresses concerns over healthcare professional exodus to foreign capitals

he Principal Secretary of the State Department for Public Health, Ms. Mary Muthoni Muriuki, has defended the government's plan to export qualified health professionals to other countries, which she said will ease unemployment in the country.

Muthoni said the plan seeks to accommodate and offer a lifeline to thousands of graduating health professionals, especially nurses, from local colleges and universities.

The PS stated that each year, over 20,000 well-trained nurses graduate from the Kenya Medical Training Colleges and other local institutions in the country, with only a handful of

them employed locally.

Additionally, the PS mentioned that current data has necessitated the move to enter a Memorandum of Understanding with foreign countries to export qualified personnel.

So far, Kenya has signed an MOU on health partnership with the United Kingdom [UK], which will see a total of 20,000 nurses sent to UK hospitals by 2025, highlighting local nurses' competitive edge.

Consequently, the government last year signed a bilateral labor agreement with the Kingdom of Saudi Arabia, which seeks to regulate the export of skilled workforce to the Gulf nation, through which 2,500 nurses will benefit.

Ms. Muthoni dismissed the Council of Governors' concerns over the high number of health professionals leaving the country, noting that Kenya has more qualified nurses than those absorbed, and the move will not jeopardize local healthcare services.

"The government strives to

ensure that the range of trained healthcare professionals are compatible and adhere to both local and international health standards while discharging their duties," the PS said.

Speaking in Naivasha during a stakeholder meeting to develop the Quality of Care Bill [2024], Muthoni said the government is committed to overhauling the healthcare system to address the existing gaps in affording and accessing quality healthcare services.

The PS said the bill, which touches on the core mandate of the Social Health Insurance Act [SHIA], will address the underlying quality of healthcare services, products offered, and personnel.In addition, the bill, which will come into force in the next three months, will see the fixing of flagged dilapidated health and diagnostic equipment and the deployment of qualified personnel, which will help lower the mortality rate in local facilities.

Muthoni said Ministry of Health officials are currently

holding public participation forums on the Social Health Insurance General regulations across the country before it's rolled out in the coming months.

Under the Social Health Insurance Act, of 2023, the government seeks an overhaul of the current National Health Insurance Fund that has previously been plagued by corruption claims worth billions of shillings. The SHI Act establishes three new funds which include Primary Healthcare Fund, Chronic and Critical Illness Fund as well as Social Health Insurance Emergency Fund all geared towards easing access and financing of healthcare to every citizen.

The government has proposed a cap of 2.75 per cent cut of an employee's gross salary and a minimum contribution of Sh300 for low-income earners to fund and accelerate the rollout of the noble initiative.

To ensure every citizen boards the Universal Health Coverage train, the government will cater for medical bills for the most vulnerable members of society including the elderly.

NACADA sounds alarm as bhang consumption skyrocket in Kenya

The National Authority for the Campaign against Alcohol and Drug Abuse (NACADA) has raised the alarm over the rise in the use of bhang in the country.

During a night raid on bhang dens in Mtwapa, Kilifi County, NACADA Chief Executive Officer (CEO) Dr. Anthony Omerikwa regretted that consumption of the narcotic has risen by 90 percent in the last five years, becoming a major concern.

"Consumption of bhang in the last five years has gone up by 90 percent, and this is based on 2022 research. Nearly a million Kenyans are using cannabis sativa, that is, one in every 53 people is using this drug in the country,' Dr. Omerikwa said.

Two people were arrested during the raid at a private residence in the Kwa Gowa area, Mtwapa, which authorities believe is used as a bhang depot. "We have apprehended

two suspects with 435 rolls and assorted brooms of Cannabis sativa. One we suspect is the distributor and the other one is the consumer. We have also confiscated his motorbike, which was his mode of conveying the substance," Dr. Omerikwa confirmed.

Police attached to NAC-ADA, acting on a tip-off from the public, raided the three-bedroom house, where the huge consignment was hidden and undergoing packaging ready for distribution within the coastal region.

This is the second raid after a similar one was conducted last month. where several shisha dens, which were operating illegally, were shut down, and owners charged in court.

"We have been able to get information that indeed these drugs are transported from Migori. We have leads on who transports it, and we are soon going to get them. We have begun the investigations, and we will soon nab the suppliers," the NACADA CEO stated.

The agency has intensified crackdown on all forms of drugs in the coastal region with the target of bringing to book the big drug barons, with consumption of heroin and other drugs having taken a toll on coastal youth for decades.

"The government's stand on drugs is that the use of illegal drugs is not allowed, we will pursue these individuals to ensure this menace is addressed," Omerikwa said, adding that parents and politicians should work together to eradicate the scourge.

He further said NAC-ADA will not relent in its war on drugs and substance abuse.

Data from a NAC-ADA survey reveals that 518,807 Kenyans aged 15-65 years are currently using cannabis, translating to a national prevalence rate of 1.9 percent.

The report dubbed, 'Status of Drugs and Substance Use (DSU) in Kenya, 2022,' says of this figure 475,770 are male while 43,037 are female.

It showed that a total of 193,430 youth aged 15 -24 years (one in every 37) were currently using cannabis, translating to a 2.7 percent prevalence.

The figure for those aged 25 - 35 years stands at 174,142 (one in every 48) translating to a 2.1 percent prevalence rate.

Speaking during the national celebrations of World Radio Day 2024 at a hotel in Kisii, MCK Chief Executive Officer (CEO) David Omwoyo said radio remains a trusted source of information

for many Kenyans, and the sanctity of the radio space must be retained. Mr. Omwoyo noted that the introduction of technology had given rise to many radio channels due to reduced costs associated with on-air production, leading to low production standards and poor pay for journalists. Omwoyo consequently challenged media owners to employ and provide decent wages for trained journalists who spend more than three years learning the art of becoming well-rounded radio journalists. Further, the CEO urged journalists in the radio space to take advantage of mentorship programs offered by veteran journalists to hone their skills.

The Communication Authority of Kenya Director-General, Mr. David Mugonyi, who was represented by Fred Ambani, expressed the Authority's commitment to delivering on its statutory responsibility of licensing and regulating communication services in Kenya.

In a speech read on her behalf by Oscar Otieno, Data Commissioner Ms. Immaculate Kassait acknowledged the role radio has played in providing lifesaving information.



Delegates from the seven EAC partner states stated that the delicate lake ecosystem, a mainstay for millions of people in the region, faces myriad challenges, with pollution identified as a major threat.

Lake Victoria Basin Commission (LVBC) Executive Secretary, Dr. Masinde Bwire, stated that pollution in the lake has increased by 50 per cent over the last four decades, posing a danger to human and aquatic life.

He mentioned that raw sewage, industrial efflu-

State initiative targets training reforms for maritime sector

The Government has unveiled a multifaceted strategy encompassing vessel inspections, leadership appointments, and reforms in seafarer training in a landmark move aimed at enhancing safety and efficiency in Kenya's maritime sector.

The initiative, spearheaded by Cabinet Secretary Salim Mvurya and Principal Secretary Geoffrey Kaituko, is a proactive approach to foster sustainable growth and bolster regulatory frameworks within the maritime sector.

The announcement was made following a highlevel meeting convened in Mombasa, where top officials from key maritime entities including the Kenya Maritime Authority (KMA), Bandari Maritime Academy (BMA), and Kenya National Shipping Line (KNSL) deliberated on strategic measures to propel the industry forward. Central to the agenda was the imminent commencement of marine vessel inspections, slated to begin on April 1st.

CS Mvurya underscored the significance of the exercise, emphasizing its pivotal role in ensuring the seaworthiness of vessels operating within Kenyan waters.

With a focus on vessels measuring 24 meters and below, the inspection campaign aims to enforce compliance with regulatory standards and enhance safety protocols. "We want to ensure

that these vessels meet

the prescribed criteria and operate within a safe environment," Mvurya stated.

"Through comprehensive inspections and registration processes, we seek to bolster our capacity for managing rescue operations and maintaining an accurate database of maritime assets," he said.

He highlighted the government's commitment to facilitating the inspection process by offering a waiver for vessel owners, thereby removing financial barriers to compliance.

The Kenya Maritime Authority will spearhead the implementation of the inspection campaign, working in collaboration with relevant stakeholders to ensure its effectiveness.

Mwea rice farmers enjoy surge in production after Thiba Dam completion

BY MUTAI KIPNGETICH AND DAVID WANDETO(KNA)

Mwea Rice Farmers have recorded increased yields since the completion of Thiba Dam over a year ago, following reports that the scheme is currently producing an annual estimate of 114,000 metric tonnes for the last three years.

Mwea Irrigation Settlement Scheme (MIS) is in Kirinyaga County and falls within two sub-counties: Mwea East and Mwea West Sub-Counties.

The development of the scheme started in 1954 in the Tebere section with about 65 acres in irrigation farming and has since grown to the current gazetted area of 30,050 acres.

The scheme manager, Mr. Innocent Ariemba, said the expansion of the scheme is due to support from the national government and development partners.

The Japanese International Corporation Agency (JICA) is a major partner that has constructed the Nyamidi Water intake, Mwea Irrigation Agricultural Development (MIAD) research center, and the Thiba Dam.

The completion of Thiba Dam, which has ensured a steady supply of water,

has almost doubled production to about 220,000 metric tonnes.

The dam, which is 40 meters deep and one kilometer long, helps stabilize water supplies in Mwea Irrigation Scheme, allowing farmers to double rice crop production.

However, in the first year of completion, the country experienced severe drought, and the dam did not collect enough water to reach full capacity. After the long rains, the dam was filled to the brim, releasing water to the Thiba River via a spillway.

This year, all farmers will do double cropping, relying on water storage in the dam in case of low rains.

Dairy farmers to benefit from state intervention as milk prices increase


Dairy farmers will start earning more following interventions by the government to deal with a milk glut in the country.

Deputy President Rigathi Gachagua said the government has allocated Sh900 million to the Kenya Cooperative Creameries (KCC) to buy the milk to prevent prices from dropping due to excess production.

The milk prices will rise to Sh50 per litre from Sh45 beginning March 1, 2024, and the government aims to further increase the prices to over Sh60 per litre in the coming months.

"As a government, we have released Sh900 million to stabilize the prices in the milk sector after a glut resulting from heavy rains. Prices at Kenya Cooperative Creameries will be raised from Sh45 per litre to Sh50 starting March 1st and up to Sh60 in the coming months," Mr. Gachagua said.

The DP urged dairy farmers to supply milk to the New KCC to earn more. Mr. Gachagua spoke





Mass at St. Andrew Kaggwa Catholic Church in Kwanza Constituency, Trans Nzoia County, where he presided over a fundraiser for building the new premises for the church.

The Deputy President also urged farmers in Trans Nzoia to increase acreage under maize, stating that the government had released adequate subsidized fertilizer, which is being sold at Sh2,500 per 50kg bag.

"Trans Nzoia County is important in our country's

50



food security. The subsidized fertilizer is readily available here. We thank Governor George Natembeya for ensuring the lastmile distribution of the fertilizer," said the Deputy President who discouraged the farmers against selling all their harvests asking

them to keep some for domestic consumption. At the same time, the DP warned teachers against sending home Junior Secondary School learners for lack of school uniform or desks saying stern action will be taken against them. He urged the teachers to allow parents enough time to buy the uniform for their children. "Let them not send our children home over levies and unnecessary fees introduced at the school. Any teacher defying the government's orders will face stern action," he warned.

Mr Gachagua also called on leaders in Trans Nzoia to keep the existing unity in the cosmopolitan county for enhanced development. "This is a cosmopolitan county with members of different communities living here. We thank the leaders led by the governor for maintaining peace. As people of Trans Nzoia, continue to love one another and peacefully coexist," said the Deputy President.

Further, has asked leaders in the Western region to unite for the benefit of the people in the region.

"We congratulate the western leaders for the effort to unite the people. I call on the leaders to continue uniting the people and behind the President for the good of our country," said Mr Gachagua.

The DP welcomed the move by Governor Natembeya to work with the government despite being elected on an opposition party.

Kenya, Germany to adopt bilateral Labour mobility for their people

enya and Germany have kicked off negotiations which will culminate in the adoption of a Bilateral Labour Agreement to facilitate labour mobility between the two countries.

A technical committee comprising representatives from both governments has been constituted and directed to immediately initiate the development of a labour mobility framework for the two countries.

This decision was reached following a meeting between Kenya's Cabinet Secretary for Labour and Social Protection, Ms Florence Bore and Mr. Hubertus Heil, Minister for Labour and Social Affairs of the Federal Republic of Germany, held in Berlin Germany.

CS Bore, who led a strong Kenyan delegation of Labour and Foreign Affairs officials during the mission said the task force is expected to draft a labour Mobility framework in which migration will be fast-tracked through min-

imising bureaucracy. "I can now officially announce that we have started the process that is meant to address the issue of shortage of skills in the Germany labour market as well as the surplus of skilled and non skilled labour in Kenya", said the CS who was flanked by the Principal Secretary State Department for Diaspora Affairs, Ms. Roseline Njogu.

Both CS Bore and her Gernany counterpart acknowledged that the agreement arrived at will be a result of an initiative that was conceptualized during exchange

of high level visits between President William Ruto and Olaf Scholz, Chancellor of the Federal Republic of Germany in March and May 2023 respectively.

"Following the discussions, it was agreed that a task force drawing membership from both countries be constituted to develop a labour mobility framework which will allow migration of Kenyan Skilled workers to Germany in a safe, orderly and regular manner'

CS Bore gave assurances that the Kenyan Government has put in place measures to streamline labour migration through restructuring its policy, legal and institutional framework to support a seamless migration of Kenyan workers to key foreign destination markets.

"Indeed, we are grateful to the Government of the Federal Republic of Germany for considering kenya as the first country in sub-Saharan Africa and the second country in the entire African continent with whom to sign a labour mobility Agreement with" said the CS who also held separate meeting with the country's Commissioner for Migration Dr. Joakim Stamp.

Child protection units set up to safeguard vulnerable youth

The Ministry of Gender, Culture, the Arts, and Heritage, in partnership with the National Government Affirmative Action Fund (NGAAF), has established two Child Protection Units (CPUs) at Ahero Police Station in Nyando and Kasagam Police Station in Kisumu East.

The objectives of these units include providing safe spaces for children in conflict with the law or those who are victims of crime. Additionally, they seek to address the rising cases of physical and sexual abuse among young people in the lakeside county.

Speaking at the launch, Gender Cabinet Secretarv Ms. Aisha Jumwa affirmed that the move is part of a commitment by the government and development partners to establish CPUs and rescue centers in the fight against Gender-Based Violence (GBV), especially among vulnerable children.

"The Units will provide temporary shelter

and psychosocial support services to the GBV survivors, the majority of whom are children and women, as they navigate the justice system," CS Jumwa stated.

She said the CPU will protect children from direct contact with perpetrators who might seek to compromise them or interfere with evidence that can be used in pros-

ecution.

"In most cases, children suffer violence, exploitation, negligence, abuse, and even defilement from their relatives. GBV victims need to report such

cases at the police station, where they are assured of their privacy as they seek justice," CS Jumwa explained. Notably, the CS confirmed that the government has put in place plans to construct and operationalize 20 new safe houses by 2027 in its renewed commitment to ending Sexual Gender-Based Violence (SGBV) in the country.

According to CS Jumwa, while there are more than 54 safe houses nationally, only three are stateowned.

"As a government, we are committed to ensuring that SGBV victims get a safe and conducive environment as they recover and wait to get justice," Jumwa said. The safe homes, she said, would be constructed through a partnership with the Offices of Woman Representative through the NGAAF kitty to address the protection and rehabilitation of SGBV survivors.

According to the 2022 Kenya Demographic and Health Survey (2022 KDHS), the prevalence of SGBV has declined to 15 percent owing to the heightened campaigns and interventions by various actors to end these violations.

She called on other development partners to collaborate with the state agencies to reduce the 15 percent to zero by 2030.

Kakamega launches new multi-million project to upgrade slum infrastructure

The Kakamega County Government has launched a project to upgrade infrastructure in the Amalemba and Kambi Somali slums within Kakamega town.

The Sh116-million World Bank-funded Kenya Informal Settlement Improvement Project (KISIP) will go towards upgrading roads, fixing sewer lines, erecting security lights, and providing access to water.

Governor Fernandes Barasa, who launched the project, thanked the World Bank and the French Development Agency (AFD), and asked KISIP to also work on modalities to ensure that those who live in the project area receive title deeds.

"KISIP has assured us that those who own land in Kambi Somali and Amalemba will receive title deeds, so they can be proud owners of the land," he added. He welcomed the project, noting that it had been delayed in starting during two previous attempts at proposals in 2013 and 2017.

"I urge the contractor to involve residents in the construction works during the project phase," he added. Governor Barasa said the project comes at a time when the County is implementing a 10-kilometer per ward road construction project that will cost the county government over Sh600 million.

The program also aligns with the county's shelter improvement program, which aims to construct 360 low-cost decent houses every financial year. "I thank all political leaders with whom we work closely. We can achieve more in empowering our people if we stick together," he added.

The Governor implored the national government to understand that counties need funds to continue functioning and offering services to residents.

"As counties, we request the national government to release the equitable share of Sh450 billion to support counties to implement development projects.

We rejected the proposal from the National Treasury of Sh391 billion because it does not represent the increase in revenue collection, increase in the inflation and does not also represent the cost of living," he explained.

The Governor challenged senators to stand up and defend devolution to ensure that enough funds are disbursed to counties to finance development projects.

Speaking at the same event, the County Executive Committee Member-In-Charge of Land, Housing, Urban areas, and Physical Planning, Dr. Mariam Barasa, urged residents in the project area to support contractors and the county government for the project to be completed on time.

KISIP Regional Representative, Engineer Joash Wende, said Kakamega is one of the 28 counties benefiting from the Kenya Informal Settlement Improvement Project, which seeks to improve the living standards of people who live in slums.

He said the Kakamega County Government proposed Amalemba and Kambi Somali slums, to benefit from the World Bank funding project.

"The arrangement is always that the county identifies the projects to be done, and they propose to the funding agency, through the national government since the fund is meant for the county government, but through the national government," he explained.

"These improvements are meant for Mwananchi who lack the |necessary

facilities and infrastructure, so it is a good opportunity for all of us to benefit," he added.

Engineer Wende asked community members to co-operate with the contractors, consultants, and the county government to ensure the successful implementation of the project.

"The project has timelines to complete, it has got standards for quality and has got standards for safety. We don't want to hear issues of the project, causing damages or injuries or some harm, to people or in the environment," he said.

He also noted that the County Project Implementation Coordination team and the Settlement Executive Committee (SEC), will be on standby to supervise and monitor the progress of the project.

The process is being undertaken through the **Work-ing Group on Amendments to the International Health Regulations (2005) (the WGIHR)**. The amendment of the IHR aims to strengthen the international legal framework of pandemic prevention, preparedness and response.

Under the WGIHR, the 196 States Parties to the IHR (including the 194 WHO Member States) are considering more than 300 proposed amendments to 33 of the 66 articles of the IHR and 5 of its 9 annexes, plus 6 new articles and 2 new annexes.

Kenya is being represented in the WGIHR by an Inter-ministerial Negotiating Committee that is coordinated by the Ministry of Health. It comprises officers drawn from the Ministry of Health, Ministry of Foreign and Diaspora Affairs, Ministry of Interior and National Administration, Ministry of Agriculture and Livestock Development, Ministry of Tourism, Wildlife and Heritage, the National Treasury and Economic Planning, the State Law Office and the Office of the Data Protection Commission.

Pursuant to decision WHA75(9), the WGIHR will propose a package of amendments for consideration by the Seventy-seventh World Health Assembly in May 2024.

The Ministry therefore invites relevant stakeholders, members of the public, and all interested parties, to provide inputs and comments on the proposed amendments to the IHR, which will inform the country's position for future negotiations. It comprises officers drawn from the Ministry of Health, Ministry of Foreign and Diaspora Affairs, Ministry of Interior and National Administration, Ministry of Agriculture and Livestock Development, Ministry of Tourism, Wildlife and Heritage, the National Treasury and Economic Planning, the State Law Office and the Office of the Data Protection Commission.


The INB will submit its final outcome (the Pandemic Treaty) to the Seventy-seventh World Health Assembly in May 2024. Currently, the INB is reviewing the proposal for the negotiating text of the WHO Pandemic Agreement, and is receiving inputs from Member States and stakeholders through meetings, drafting groups, as well as informal discussions and briefings.

ens of small businesses are set to benefit from a government-backed programme that seeks to enhance sustainable management of waste.

"The dual role of the programme in addressing environmental concerns and unlocking economic opportunities through innovation is critical. I have a vision of a future where waste becomes a valuable resource," said Joseph Murabula, the CEO of KCIC.

The project promises to create job opportunities, economic growth and a clean environment

Projections show it will generate over 6,000 direct and indirect jobs and improve the livelihoods of thousands of households boosting socio-economic advancement.

It is expected that the project would generate some Sh1.5 billion from waste management activities that accelerate the transition to a circular economy and drive inclusive green economic growth.

These activities will be aligned to the country's climate goals as outlined in the Kenya Nationally Determined Contributions as well as the Paris Agreement and the Sustainable Development Goals.

In the first year of the initiative, 55 MSMEs, particularly those led by young people and women, will be supported.

The other 55 small businesses will be on boarded onto the programme in the last two years.

Patrick Obonyo, the programme manager at the IKEA Foundation, said collective action will help in addressing waste management challenges and advancing environmental sustainability.

His added that there is need to accelerate Kenya's transition towards a circular economy.

"It is imperative that we adopt a collaborative approach that brings together government, private sector, civil society, and other stakeholders. Only through concerted action can we overcome the complex challenges facing our waste management sector and create a future that is clean, healthy, and sustainable for all," said Ngeno.

Insights from SWIFT will be used to scale-up the initiative and improve the approach to supporting MSMEs in waste management.

Applications for the SWIFT programme remain open to eligible enterprises, said Murabula, as he asked waste management entrepreneurs to take up the opportunity and contribute to the country's goal of attaining sustainable waste management.

According to the National Environmental Management Authority, improper management of waste leads to degradation of the environment and fans climate change.

This is because waste is one of the contributors of greenhouse gases, which lead to global warming and thus climate change.

'It is for this reason that as a country, we should develop sustainable waste management technologies and initiatives to curb this growing global challenge," the agency notes its solid waste management strategy. The various wastes generated in Kenya

can be categorised as domestic, municipal, industrial, hazardous and e-waste.

With Sh20,000, one is good to go but it's good to have some knowl-edge about the business and have passion for it.

Tell us about dog breeding...

In breeding dogs, you work with what is known as "working line". These are dogs with stronger qual-ities such as powerful muscles and are purposely selected for breeding. This means the breeder should know their animals well.

Some people say it's hard knowing when a female dog (bitch) is on heat...

It can be if one does not know how It can be if one does not know now to detect the heat signs. The obvious sign is bleeding from the vulva and others licking the back end more than usual or being over friendly to other dogs. I mate the dogs once I detect blood. Three to six mating sessions are enough to make the sessions are enough to make the female pregnant.

How does a quality

working line look like? In the case of German shepherds, a good quality working line will have medium-sized animals, with good quality fur, temperament and body structure. These are the ones I use for breeding purposes. To avoid inbreed-ing, I change males every two years.

Community health promoters receive Sh3 billion incentive

The health services providers will now begin to get monthly stipends in efforts to motivate them

ome 107,000 community health promoters will start receiving their monthly stipends after the government started the process to pay them, furthering the primary health care agenda.

Deputy President Rigathi Gachugua said the Sh3 billion stipend reimbursement programme will help promote service delivery.

"Today we make a key milestone in our health sector as we launch payment of Sh3 billion stipend to the 107.000 Community Health Promoters (CHPs)," he said.

The initiative, a joint effort between the National Government and its partners, marks

According to the Government Spokesperson Isaac Mwaura, the benefiting Counties include Turkana, Marsabit, Isiolo, Laikipia, Mandera, Wajir, Garissa, Tana River, Taita Taveta, Kilifi, Kwale, Lamu, Meru (Meru North Sub-County), Tharaka Nithi, Samburu, Baringo, West Pokot, Narok, Kajiado, Makueni, and Kitui.

through to 2027, also seeks to facilitate livestock trade across the Horn of Africa (HOA) countries and to upgrade livestock value chains by mobilizing private investments.

"It has financial support from the World Bank with Kenya being supported by a credit of Sh16.082 billion," he declared.

He noted that the project component entails pasture and fodder production and conservation, livestock breeding covering Dorper, Sahiwal, Boran, and Galla goats among others.

Other components include livestock finishing through the institution of feedlots and fattening, establishment of abattoirs or slaughterhouses for facilitation of meat production and processing for both local and international markets.

Leather tannery and processing and value addition on the livestock and its products including livestock feed processing are other components.

So far, the project has

attained numerous milestones in the target counties for instance, the number of pastoralists and their dependents covered by the financial services stands at 696,642, and a total of Sh1,620,293,803 has been paid out as insurance claims payouts to the beneficiaries, Dr. Mwaura said.

Mwaura added that the project has also seen 107,492 individual pastoralists and 411,123 of their tropical livestock insured, noting that an amount of Sh6,000 per beneficiary has been paid as an enrolment saving bonus bringing the total bonus payout to Sh492,090,000.

"The project has also sought to empower the female gender as the percentage of women supported and who own bank accounts increased from baseline of 33 per cent to 108 per cent," he remarked.

The Government Spokesperson observed that the project has also created several jobs as proven by the 163,578 digital accounts in use under the project.

KVDA sinks 2 boreholes in Samburu West Sub County

Over 18,000 residents of Samburu West Sub-County and their 35.000 livestock will now have access to clean water after the Kerio Valley Development Au-thority (KVDA) sunk two boreholes as part of the national government's Drought Mitigation Pro-

gram. Speaking during the com-missioning of the two boreholes, KVDA Managing **Director Sammy Naporos** said that the initiative was part of long-term measures to alleviate acute water

shortage in the area. Naporos noted that the boreholes at Nontoto Arus village, which will pump water via solar power, have a capacity of 30,000 liters per hour, while the other one at Garma village will pump 9,000 liters per hour, providing water to nearby schools and residents. "Samburu is one of the

counties with the lowest access to water in Kenya, and these water projects will boost food security through the creation of kitchen gardens, improve


reduce conflict with neighboring communities," he said.

Naporos added that through KVDA, the national government has pumped Sh130 million towards 12 water projects in Samburu West and Samburu North Sub-Counties. "Two pro-jects are complete, while another two are ongoing, and we are in the process of tendering the remaining eight to be completed by June 2024," he said.

At the same time, the MD encouraged the residents to sustain the projects through the already formed borehole committees and ensure water flows for vears to come.

Pamela Lekuku, a resident of Nontoto Arus village, welcomed the projects saying that life has been made easy for the women who used to travel for miles to fetch one jerry can of water. "We used to travel for over 20 kilometers under the scorching sun but not anymore," an elated Lekuku said.

Social Health Authority (SHA) Chairman Dr Timothy Olweny. He has disclosed that Kenyans will start contributing to the Social Health Insurance Fund (SHIF) next month following a court ruling that gave a green light on its implementation

green light on its impleon the draft Social Health mentation.

He explained that he sides addressing basic health services, SHIF encompasses a wide range of healthcare services, ensuring that Kenyans have access to quality healthcare across various medical needs.

NHIF has a total of 15.4 million members. Out of this, only 6.7 million are active members. In the 2021/2022 financial year, NHIF collected a total of Sh61.53 billion from its members.

The 57-year-old NHIF is set to be disbanded and replaced by the Social Health Authority thanks to the Social Health Insurance Bill of 2023. Under the new SHIF, health benefits will be accessed in all facilities accredited by SHA and licensed by the Medical Council.

"SHA will offer services in public facilities, faith-based, and private facilities. SHA will pay standardized tariffs to all hospitals, including private and public ones. People will be free to choose which facilities to access, but those

looking for high-end facilities might have to top up for additional services," Dr Olweny said.

For example, those pay-ing Sh300 and those paying more than Sh1 million will be able to access equal services under SHA. SHA will not have a mix

of schemes that are going to be run. It is one package for everyone regardless of contribution. This is the principle of SHA," said Dr Olweny.

He observed that the inclusion of services such as screening, drug rehabilitation, mental health support demonstrate the government's commitment to providing holistic healthcare coverage

"The Constitution guarantees good health to every Kenyan, but most citizens have been financially drained by these ailments, he noted.
