The Government intends to reduce dependence on basic food imports by 30 percent through the revamping of moribund sectors and the expansion of emerging sectors to enhance food security in the country.

The Principal Secretary for the State Department for Agriculture, Dr. Kiprono Rono, spoke during a meeting on the Financing Agriculture Sustainably Conference (FINAS 2024), scheduled for March 2024.

He stated that the government plans to increase domestic oil crops production from 5 percent to 25 percent, rice from 18 percent to 40 percent, and revamp underperforming and collapsed export crops while also expanding emerging ones.



Rono emphasized that the conversation on agriculture investment and funding is overdue and needs to take place. This discussion is essential to better position the country to transform the agricultural sector and determine the most effective way to involve all relevant actors.

“Government is committed

to the provision of adequate, affordable working capital to farmers, through well-managed farmer organizations, deployment of modern agricultural risk management instruments, that ensure farming is profitable and income is predictable,” he said.

Kirinyaga County achieves medical milestone with first minimally invasive surgery

The County Government of Kirinyaga has achieved yet another milestone in the medical field as doctors performed the first minimally invasive surgery in the county at Kimbimbi Sub-County Hospital.

This achievement comes barely a month after the first spinal surgery in the county was successfully performed at Kerugoya County and Referral Hospital.

The laparoscopic cholecystectomy was conducted on a 39-year-old woman

from Gathigiriri Ward. The patient, suffering from cholecystitis, is stable and is now recuperating in the ward after a successful surgery. Laparoscopic cholecystectomy is a term for a type of surgery to remove the gallbladder when one has gallstones.

This groundbreaking medical procedure is a step forward for the county's elaborate Comprehensive Healthcare Coverage strategy aimed at ensuring that

The PS noted that the Conference could not come at a better time as Kenya, like many other countries in the region, is facing unprecedented times of disruption in agri-food systems, resulting in loss of livelihoods and increased food insecurity.

“As we embark on implementing the Food Security Agenda, we have also been grappling with climate change impacts such as the ongoing El-Nino rains and the resultant floods, the recent drought and the global ramifications of the Ukraine and Russian conflict. Many enterprises are still yet to recover fully from the Covid shock, while some wound up for good,” the PS said.

He noted that the government has prioritized funding agriculture in the Bottom-Up Economic Transformation Agenda (BETA), and that it is in the process of developing a 10-year agriculture master plan aimed at enhancing investment to boost food

production in the country.

The master plan 2024-2034 will help in implementing the Agricultural Sector Transformation and Growth Strategy (ASTGS 2019 -2029), which envisions a vibrant private sector that contributes up to 80 per cent of the National Agricultural Investment Plan.

“All programmes and initiatives developed to implement the ASTGS are ending in June this year, prompting the Ministry in conjunction with other stakeholders to

develop new ones and more that are aligned to BETA,” the PS said.

Through engagements with relevant stakeholders, the government expects to chart tangible investment and funding action plans that are alive to the current realities of the country and the 47 counties,” he said.

Council of Governors (COG) Chief Executive Officer, Mary Mwiti, said counties should be at the forefront in addressing challenges that impede

farmers from accessing development funds.

“Counties are pivotal in coming-up with solutions, facilitating access to credit and establishing farmer-centric policies,” she said.

Mwiti hoped that the upcoming conference on financing agriculture, sustainably will centre discussions to financing county-led agricultural development programmes, in the mind that agriculture is devolved.

She noted that success stories emerging across various counties where innovative financing have flourished, is because of collaboration between the national and local governments, as well as financial institutions and farming communities.

Mwiti opined that focus on financing agriculture should be in reducing risks through crop insurance, price stabilization, increasing credit accessibility by streamlining loan processes and promoting sustainable practices via investment in research and development.

county residents have access to quality and affordable healthcare services within the county.

After successfully completing the laparoscopy, Dr. Madaraka Ogoye, the lead surgeon, stated that the surgery was a breakthrough in the county’s medical care provision. He emphasized that the minimally invasive procedure is effective and more cost-effective compared to conventional open surgery.

“Minimal invasive surgery does not make big cuts on patients since we use specialized equipment to make small incisions, through which we carry out the surgery. Smaller incisions mean less pain, faster recovery, quicker return home, back to work quickly, and all this means that overall, minimally invasive surgery is cost-effective, as the shorter the stay at a hospital, the cheaper it is,” he said.

Dr. Ogoye emphasized the global trend towards minimally invasive surgeries due to their benefits, including reduced morbidity associated with open surgeries, faster recovery times, and cost-effectiveness. He termed the surgery as the first of its kind that has been introduced in the county as the world transitions from open surgery.

He thanked the Kirinyaga County Government for allowing him to undertake postgraduate studies where he acquired skills in general surgery as well as minimally invasive surgery and for providing a conducive environment and equipment to carry out such an operation.

The doctor said that there were plans to collaborate with other counties on building the capacity of doctors and other medical cadres to build teams that can safely and effectively provide minimally invasive surgeries in various counties.

Kenya's new push for a secure work environment overseas

The government is urging Kenyans to apply for various job opportunities sourced abroad, as part of its efforts to tackle unemployment, and assures them of their safety as they go to work abroad.

Principal Secretary of the State Department for Labour and Skills Development, Shadrack Mwadime (pictured), mentioned that the Labour migration desk at Jomo Kenyatta International Airport (JKIA) will assist in enhancing the safety of Kenyans working in the diaspora.

During an interview with the press in Mombasa, PS Mwadime emphasized that this initiative aims to curb irregular migration, creating a safe, fair, regular, and productive working environment in the diaspora.

Mwadime explained that the operationalization of the Labour Migration Desk is part of a government initiative to curb illegal migration in the country.

He highlighted that labor



migration significantly contributes to the growth and development of the country's economy, serving as a source of employment and livelihood for many Kenyans.

"When these Kenyans work in foreign countries, they invest back home where their families are, and that is how the government earns revenue that is channeled into development programs," he said.

He noted that the number

of Kenyans working abroad has significantly increased, which is estimated to be four million for skilled and non-skilled workers.

Mwadime said the Government has signed a Memorandum of Understanding (MoU) with key labour destination countries which include Germany, Austria, Bahrain, Oman, Poland, Jordan, Kuwait, Canada, and Ireland among others.

"In ensuring the promotion of employment opportunities for migrant workers, we had a job order of 200 nurses last year which was secured in March 2023 to go and work in the Ministry of Health in the Kingdom of Saudi Arabia, and this was a government to government initiative," he added.

The PS noted that the Cabinet Secretary for Labour and Social Protection has also secured 2,500 posts for healthcare professionals to be recruited to work in Saudi Arabia.

He urged qualified health workers to apply for the jobs through the National Employment Agency (NEA) where qualified nurses will be picked for the jobs.

"We want to assure you

that the government is concerned about your safety and welfare from your employer thus nothing should stop you from applying for these jobs," he said.

The PS insisted that the government will keep an eye on its citizens working abroad and provide immediate interventions when an issue arises.

Mwadime said the Ministry has already established help desks and helpline numbers for any inquiries in case of anything.

He added that they will also recruit staff to monitor the activities, welfare and working relations of Kenyans working abroad.

"We have our desks and numbers in these countries thus we will be following up on their welfare with their employers so that we make sure they are all working in a safe environment," he said.

He added a Bill on labour migration will be introduced in Parliament to support the migrant workers' program and ensure their safety in foreign countries.

The PS said through the Migrant Labour Bill, they will also introduce a savings program where migrant workers can make their retirement benefits.

"We want to introduce


a program where migrant workers can save for retirement which will help them in future when they have retired and have come back home," he said.

On her part, Deputy Government Spokesperson Ms Mwanisha Chidzuga said that the President has made good relations with foreign countries to secure employment opportunities for Kenyans. Chidzuga said the government will not only secure opportunities for its people to work abroad but will also ensure that their safety is guaranteed.

"We know there has been fear by Kenyans when it comes to working abroad but we assure them. Opportunities are there and we advise them to apply for these posts since Kenyans are well known for hard work and commitment when given tasks," she said.

She noted that the President is working hard with the relevant Ministry to ensure that the youth who are skilled and cannot secure employment in the country can go and work abroad and improve their quality of life.

Chidzuga advised Kenyans not to be selective and instead apply for opportunities in a bid to eradicate poverty.

Kenya rakes in extra Sh650 million as tourist numbers continue to soar

International arrivals into Kenya have grown by 18.42 percent in the last 16 months, with the country receiving 273,412 more visitors compared to the previous year.

The Government Spokesperson, Isaac Mwaura, stated that the country was able to generate an additional Sh650 million from the tourism sector alone, with visitors accommodated in hotels increasing by three percent in bed occupancy.

Mwaura noted that this means more money has been injected into the economy, as hotels realize increased profits due to the number of days tourists spend in Kenya, which has risen from 10 to 11 days.

Addressing the press at

the Kenyatta International Convention Centre (KICC) on the insights of the ongoing Service Delivery Review

Roadshow, Mwaura mentioned that tourism is the fourth-largest foreign exchange earner in the coun-

try.

“We pride ourselves as a very hospitable country, with our slogan ‘Hakuna Matata’ being a global catchphrase for international travel. Our country is now visa-free, meaning that we shall have more visitors coming going forward,” Mwaura said.

He explained that tourists come to Kenya primarily to see animals and the government is putting in place measures to ensure that the endangered species such as the Northern Rhino- whose current population is only two in the country do not become extinct.

“Kenya has also increased training opportunities for 1,044 youth in the tourism sector. These graduates will help support this grow-

ing sector of the economy, whose full potential is yet to be realized,” Mwaura said.

He highlighted that the Ronald Ngala Utalii Training College, which will be opened in June this year will have a capacity to train 5,000 youth at a go.

“The focus is to make the college a centre of excellence on export labour to countries such as Saudi Arabia that is building a new city, requiring 350,000 workers,” said Mwaura.

He said the country has become a popular destination for international

meetings, incentives, conferences, and exhibition (MICE) travel.

According to Mwaura, last year alone, local and international conferences hit the 10,000 mark, with an increase of 2,151 conferences, and over 14,000 delegates from around the world.


He added that a total of 869 youth were recruited last year alone to work in foreign ships thus earning an income for their families in foreign currency.

“An additional 621 common interest groups comprising fishermen and other forms of trade within the blue economy were given grants amounting to Sh1.5 billion in the last one year to boost their businesses,” Mwaura said.

He said in addition, 26 boats have been donated by the government to eight Beach Management Units (BMUs) while 875 fishermen have been trained on how to fish in the deep sea.

Revitalized 4K Clubs cultivate a new generation of agricultural innovators

BY ANNE KANGERO (KNA)

The resurgence of 4K clubs in the country has ushered in a new generation of young students in schools, dedicated to boosting the nation's food production and devising strategies to combat climate change in their counties.

The 4K Club, representing "kuungana, kufanya, kusaidia" (unite, act, assist) for Kenya, lapsed into dormancy in the 90s, adversely affecting food security.

However, in 2021, it was revitalized as part of the government's initiative to enhance agricultural production.

In Machakos County, Ms. Eveline Mutei, a teacher at General Mulinge Primary School in Kaani and Chairperson of the 4K club, oversees 52 pupils who voluntarily participate in the club.

Carbon beds

These students have grasped the fundamentals of agriculture, including the creation of carbon beds that effectively retain water in plants for extended periods, making them well-suited for arid areas.

Carbon beds play a crucial role in augmenting organic matter in the soil, thereby enhancing its capacity to retain water. Ms. Mutei highlighted that the adoption of carbon beds has enabled the school to produce an ample supply of food and vegetables for the pupils, particularly during periods of drought.

She added that most students were interested in the 4k Club and its benefits such as learning different ways of growing healthy and nutritious food, so they introduced their parents to the use of carbon beds in increasing healthy food production at home.

The 4k Club Chairperson said to prepare the carbon beds, one has to dig four meters flat surface, fill it with dry matter such as dried grass, then put some soil on top, after that, green grass is added to the soil, and then finally at the very top place some soil that is mixed with manure to cover it, then some water is poured into it, making it ready for planting any crop.

Ms Mutei pointed out that during the drought period, the school had enough food because of the carbon beds, and some students who come from vulnerable families, went to school to get some food to eat.

"Despite the harsh climate experienced last year, we did not lack food. We had plenty of vegetables that we cooked for the learners, which they had planted themselves," she said.

She said that the 4k Club has also encouraged the older students who have cleared primary school, to continue with farming and have started earning from it and are also teaching others about the benefits of carbon

beds in managing the effects of climate change in Machakos.

Mutei said they were introduced to the carbon beds by the Haki Nawiri organization which focuses on food, climate, and youth.

Ms Leonida Odongo, the founder of Haki Nawiri Africa, who spoke to KNA at General Mulinge Primary School, where they had gone to help prepare the carbon beds, said that they chose the school because climate change and food justice, are one of their pillars.

Ms Odongo said the idea of carbon beds is part of agro-ecology, which is a food production process, where you produce food and take care of the environment, as they also focus on sustainable production and consumption.

She said climate change affects children most and the focus should be to remove children from the hunger map in the future.

The Haki Nawiri founder added that before they chose to work with the school, they did an analysis and research and found

out that the main response from the pupils was hunger and Ukambani being a dry zone, they came up with the carbon bed which has been a success so far.

Hunger

"Our work in this school is informed by research because we did an analysis, where we asked the children what is ailing them and they said hunger and that's when we decided to work with the school in promoting human rights," Leonida said.

She noted that there is a major connection between education and food and in some areas, children are unable to go to school due to lack of food at home and in school and they end up becoming criminals or committing immoral vices for food.

Ms Odongo noted that when children learn different ways of producing food on the farms, then it encourages intergenerational learning since there are kids as young as four years learning the trade and so in a few years the children will solve the climate change effects in Machakos.

Artificial Intelligent 'man' finally meets artisanal and small scale gold miners

Artificial Intelligence which is becoming a game changer in the world of technology across the globe has finally met the small scale gold diggers in Lolgorian ward, Transmara South Sub County, Narok County and is poised to revolutionise mining in the area.

The Artificial Intelligent 'man', dubbed Dr. Mining Manhattan AI has tripped excitement among the artisans and small scale gold miners as it is expected to help solve a myriad of challenges which have bedeviled the sector for a long time.

Dr. Mining Manhattan Pilot Program which marks a pioneering initiative is a brainchild of an experienced miner and visionary Matt Hales who has been working with the community for six years since 2017.

According to Hales, who is a Co-chair of the Global Community Miners Forum, the new concept is a conversation robot which is bound to bring expert guidance to the fingertips of miners through question and answer model in social media networks including WhatsApp, Instagram, and Facebook messages among others.

Hales describes Dr. Manhattan as very intelligent, able to speak over 105 languages and responds to voice conversation when giving solutions adding that Dr. Manhattan which took five months to create is not just a tool but a catalyst for change where every miner will join in and gather information on better and safer

mining processes.

He notes that frequent communication with the tool will help shape its future by enabling the AI to grow smarter and more attuned with Miners needs with each query answered and each piece of advice given from the area that is not fully exploited which will be rendering the tool, a mentorship type of technology.

Hales says that running the program is quite expensive and to sustain it they were looking for sponsorship from well wishers organisations.

"We're creating a living, learning hub of mining wisdom that will echo in the tunnels and pits of mines worldwide, fostering a safer, more prosperous future for the ASM community," says Hales.

If successful, Dr. Mining Manhattan's Project has the potential to transform livelihoods of 45 million artisanal and small scales miners in over 80 countries across the globe once it is rolled out.

Hales notes that the local Farmers of Gold Association affiliates are partnering with the Global Community Miners Forum which was started last year, and Artisanal Small scale Miners Association of Kenya (ASMAK) among others to ensure success of this pilot program before it is extended to Indonesia in the next phase.

Urging all to test Dr. Manhattan by messaging on WhatsApp to +254-703179958 and allowing it up to 1 minute to reply, Hales notes that Dr. Manhattan was still undergoing creation and therefore may have occasional hitches.

CS Wahome vows to streamline ministry, cleanse land offices across Kenya

The Cabinet Secretary for Lands, Public Works, Housing, and Urban Development, Ms. Alice Muthoni Wahome, has declared a war against cartels and fraudsters that have infiltrated land offices nationwide, defrauding Kenyans of their hard-earned money and property.

During a meeting in Nivasha with her departmental heads and other senior ministry officials, Wahome emphatically pledged to address the issue of fraudsters,

some of whom collude with ministry officials to illegitimately alter documents and deceive Kenyans.

"We will confront the fraudsters, revoke and nullify all fraudulent titles they have obtained, and expose them, irrespective of their status," declared the CS, sternly warning them to stay away from land offices.

Wahome disclosed that the Ministry faces a pending bill of approximately Sh.8 billion due to ongoing court litigations. She assured a thorough examination of documents before any pay-

ment is authorized for concluded lawsuits.

Furthermore, she acknowledged about 2,000 pending cases in the Land and Environment Courts (ELC) and urged the courts to expedite these land-related matters.

"The more these cases are delayed in court, the more they attract extra cost and delay justice and the fraudsters take advantage of the delay to continue with their illegal activities," Wahome said. To this end, the CS said the ongoing digitization of the land registries will be a

game changer as it will put an end to the disappearance of land documents and other fraudulent activities, protect all the data, and bring efficiency to the entire process of land transactions.

Wahome observed that digitization of the Central Land Registry in Nairobi is complete, and the process will soon be rolled out in the entire country.

She also stated that her Ministry, through the Department of Planning, is working with county governments to secure land set aside for the Special

Economic Zones to ensure a seamless process for all who want to invest in those zones. Wahome announced that adjudication of land is going on and her Ministry will hold clinics around the Country to educate Kenyans and help resolve various land issues.

She noted with regret that some Kenyans have some land issues that have been pending for decades.

The CS defended the ongoing Affordable Housing Project which has stirred controversy saying it is going to create jobs for over

two million youths and maintained that it was legal and was only being done on government land whose custodian is the Treasury.

There has been a war of words between the Judiciary and the Executive after the courts in November last year ruled the Housing Levy Fund, to be used in constructing affordable housing in the Country, unconstitutional.

The meeting was called to discuss how to improve service delivery and coordination of functions in various offices of the Ministry.

Kenya Forest Service launches ambitious tree cover expansion campaign

The Kenya Forest Service (KFS) will embark on a campaign this year to increase tree cover by raising seedlings and growing trees throughout the country.

Led by the Chief Conservator of Forests, Mr. Alex Lemarkoko, the organization has initiated the campaign by planting over 5,000 blue-gum species trees at the Upland Forest Escarpment Block.

“We have decided to step out of the offices to engage in tree planting exercises and collaborate with other stakeholders, particularly the Community Forest Association (CFA), who are crucial shareholders in KFS,” he stated during the exercise.

Lemarkoko expressed gratitude to the government for employing 321 personnel, noting that they will significantly contribute to raising seedlings, protecting forests, and ensuring the efficient management of plantations.

“The most critical challenge that KFS has had in the last three decades was lack of personnel and support in terms of finances and also the issue of training and competency of development but since last year the government has given us personnel, resources and also training,” he said.

He noted that in the short period, KFS has managed to reduce deforestation in most of their forests because of the efforts of high-level discipline by forest rangers in curbing theft.

The CCF noted that technology is key in the monitoring of activities and in the surveillance of forest areas against threats such as fires and that KFS is currently being supported through a

project by the French Government to build capacity of the personnel of monitoring, response, and mitigation of fires to ensure that the forests are healthy and free of common thefts.

“We are bringing in matters of technology to enhance production in terms of efficiency and cutting costs on production. We cannot achieve much without engaging the community forest services and also the KFS component in our strategy of 30 per cent recovery which requires us to plant 300 million seedlings which need planning, labor, and production materials,” Lemarkoko said.

He explained that they are currently enhancing the skills and competence of officers through training that is ongoing among the personnel, from rangers to inspectors, but notably also training of forest officers in the KFS Londiani College to ensure there is an adequate number of personnel to address government’s

agenda of planting the 15 billion trees.

Dr. Solomon Kipkoech of EarthLungs Reforestation Foundation said they have been working with KFS and communities in protecting the degradation of forests in the country.

“We have adopted a forest where we work together with communities surrounding the forest and in turn, we support these families in raising seedlings and

to benefit from health covers and supporting school-going children,” he said.

Kipkoech added that as an organization they have

a slogan: Plant and grow a tree for five years for Sh50 “Kafinje tu” to support the government’s tree-planting initiative. He called upon Kenyans to support the noble cause. “EarthLungs is asking Kenyans to join us in planting trees. We will plant 10 per cent of the 15 billion target that is 1.5 million trees, by 2032. Through the collaboration we are getting from KFS and communities

we are determined we will make it”, he noted.

Frasia Wanjiku Mbugua, the treasurer of Uplands Forest CFA said they voluntarily support KFS in tree planting and benefit by utilizing the land through livelihood support programs where they grow food.

“We support the exercises and as CFA we assist in the restoration of forests. We have a target to plant over

300,000 tree seedlings at our three blocks at the Uplands Forest supported by many partners,” she said.

Two months ago, statistics showed Kiambu County had managed to plant at least seven million trees since President Ruto in 2022 December commissioned the Programme dubbed “jaza miti” to increase the country’s forest cover by 15 billion trees by 2032.

Murang'a communities prepare for 10,000 new affordable housing units

The Government, through the Affordable Housing Programme, is targeting to build 10,000 units in Murang'a County within a period of five years.

Currently, the construction of 220 house units at the Makenji site in Kandara constituency is underway, with the project expected to be completed by December of this year.

Albert Muchiri, the Central Regional Director of Affordable Housing and Markets, mentioned that by next month, construction of affordable houses will commence in Kiharu, Kangema, and Maragua constituencies.

He noted that in every constituency, they are aiming to build more than 200 affordable house units, stating that the areas have already designated land for the projects.

"The construction of affordable houses in the Makenji area is progressing smoothly, and we hope

that by December, the project will be completed, and people will start occupying the houses. The project sits on 2.5 acres of land, which was donated by the county government."

"In Kiharu, the project targeting to have 106 units in the first phase will be done on 1.6 acres of land which belongs to the ministry of housing. In the Mitumbiri area of Maragua constituency, 450 units will be constructed on a 4-acre piece of land," explained Muchiri.

The Director was speaking during inauguration of Murang'a county affordable housing committee, added that in Kangema con-

In other constituencies we are planning to buy two acres of land and phase one of the affordable houses

stituency in the first phase, 120 units will be constructed in already identified two acres of land.

"In each of the other constituencies we are planning to buy two acres of land and start the first phase of the affordable houses," he noted.

Muchiri said through the Boma Yangu portal, residents can register so as to get the houses once they are completed.

"Residents can register with the boma yangu portal so as to be considered once the houses are completed. In Makenji there will be 100 two-bedroom units, 60 three-bedroom units and another 60 one-bedrooms. The price of the houses will range between Sh. 1 million and 3 million," he stated.

The Director hailed the programme saying it has been a big source of employment to young people.

"For instance, at the Makenji site, more than 500 workers are engaged on a daily basis. There are also

those benefiting indirectly like suppliers of building materials, those selling food at the site among others," he averred.

Murang'a County Commissioner Patrick Mukuria on his part asked the locals to support the programme which also involves construction of modern markets within the county.

"The Government is also developing modern markets at Kangari, Muthithi, Kanyenyaini among other trading centres. These facilities

are meant to improve the livelihoods of the local residents," the Commissioner added.

Mukuria encouraged local residents to apply to own the houses on the e-citizen online platform under Boma Yangu or short code message *832 # so that they can benefit from affordable housing.

On her part, Murang'a director of housing Ms Lauren Wasungu called upon local jua kali artisans to take advantage of the housing

programme and supply materials like doors, grills and windows.

The artisans, Wasungu said they have to register with the department of small and micro enterprises so that they can tender to supply the materials.

"Doors, windows and other fabricated house fitting items will be sourced locally and we appeal to local jua kali artisans to apply so as to be considered in supplying the materials," she added.

Turkana County launches Sh534m scholarship scheme for vulnerable students

Turkana Governor Jeremiah Lomorukai has launched the Turkana County Education Fund amounting to Sh534 million for the 2023/2024 financial year.

The Governor stated that 80 per cent of the Fund, amounting to Sh427 million, has been earmarked for bursaries. Furthermore, 12 pc of the Fund, equivalent to Sh64 million, has been allocated to the Turkana County Scholarship Scheme.

Established under the Turkana County Education Fund Act (2023), the Fund aims to provide financial support to needy students across the county.

He also announced that five per cent, totaling Sh26 million, has been allocated to the Turkana County Loan Scheme.

This scheme will provide financial support to students in colleges and universities through loans.

The Governor distributed cheques amounting to Sh191

million in the first phase of the bursary allocation, benefiting 23,246 students across the county.

The beneficiaries include students in secondary schools, universities, colleges, vocational training centers, polytechnics, and other educational institutions.

Speaking at the launch, Governor Lomorukai asked ward bursary committees to observe transparency and avoid politics in the alloca-

tion process.

“I want to appeal to the committees to ensure that the bursary allocation is free of politics and fair to all applicants. If we politicize such key issues like bursary allocation, then we risk causing divisions among our people,” he said.

He revealed that the scholarship program will benefit 100 secondary school students, along with several students pursuing rare skills in Technical and

Vocational Education and Training (TVET) and universities. The Governor also announced that the second phase of fund disbursement is set for April.

The County boss assured residents that the county would digitize bursary allocation to streamline the process and thanked the Onesimus Kipchumba Murkomen Foundation, Cooperative Bank and KCB Bank for providing a total of 17 scholarship opportunities to students from Turkana County.

Deputy Governor Dr John Erus urged the youth to take up opportunities in TVETs to acquire skills which will help change their lives. He rallied residents to join the county’s efforts to combat drug and alcohol abuse.

County Commissioner Jacob Ouma cautioned school heads about misappropriating food in the school feeding programme. He also directed the County Police Commander to investigate claims of financial malpractice by the management of Eldoret Technical Training

Institute (ETTI).

County Executive for Education Leah Audan announced that application for the scholarship scheme was open and directed interested applicants to apply.

Deputy Speaker Philip Ekuwam led a team of MCAs in the launch including Chairperson of the County Assembly Committee on Education Michael Aemun (Kaputir).

Senior County Government officials present included Deputy County Secretary Dr Albert Gamoo.

Female inmates at Shimo la Tewa Prison are poised to benefit from opportunities to establish and manage businesses, supporting their families and laying the foundation for startup ventures upon their release.

Correctional Services Principal Secretary, Ms. Salome Beacco, who launched

the pioneering Shimo la Tewa Women Prison Chandaria Workshop, said the workshop will encompass a bakery, tailoring, and an ICT hub. Additionally, the 'Karakana Project,' an initiative by First Lady Rachel Ruto, will involve training female inmates in cross-crocheting. Ms. Beacco stated that the initiative aims to empower women

Nyeri drafts regulations for disaster management and the Disabled

The County Government of Nyeri is working on regulations that will help operationalize the Disaster Management Act and the Persons with Disabilities (PWDs) Management Act.

The Disaster Management Bill became an act in 2021, while the PWDs Management Bill was passed by Governor Mutahi Kahiga a year later.

The Department of Gen-

der, Youth, Sports, and Social Services, under whose docket the two acts fall, is currently undertaking a four-day workshop to formulate the regulations before they are subjected to public participation.

Ms. Esther Ndung'u, the Gender, Youth, Sports, and Social Services CECM, says she hopes the new regulations will, among other things, provide a legal framework to ensure that the public, especially PWDs,

always enjoy government services and are free from any form of discrimination.

She observed that despite the two acts having been assented to since 2022, they had remained in limbo due to the lack of a necessary guiding legal framework.

"We already have an Act for Persons Living with Disabilities which was accented to by our governor during his first term in office. But for us to be able to actualize or implement there must

be a regulation to guide the process. So, the regulations we are coming up with for the Disaster Management Act and for the Persons with Disabilities Act are provided for in the Act but now we must come up with the regulations. So that is what we are coming up with," the CECM stated.

Apart from providing the necessary guiding principles for the implementation of the acts, Ndun'gu said the drafters of the regulations

will also entrench a working board that will ensure the law is adhered to.

The board, which will incorporate stakeholders from all relevant agencies will further make sure PWDs are not discriminated against in terms of employment and mandate all public buildings to have facilities that are friendly to such persons.

"There was a proposal to establish a board and a proposal to ensure the rights of PWDs are looked into, such

as not being discriminated against in the workplace and buildings coming up in Nyeri are accessible to PWDs.

"We also want to make sure that all employers come up with regulations, where PWDs are not discriminated against and that if you become a PWD while you are employed that you don't lose your job. Those are some of the regulations that we are coming up with," Ndung'u added.

Council advances efforts to fortify Kenya's investment climate

The National Investment Council (NIC) is implementing strategic measures aimed at fortifying Kenya's investment climate and catalyzing the influx of Foreign Direct Investment (FDI) alongside fostering Domestic Direct Investment (DDI) growth.

Recognizing the paramount importance of real-time feedback on policy impact and identifying

barriers to investment, the council adopted a resolution to conduct quarterly private sector roundtables during a meeting chaired by President William Ruto.

President Ruto said that this initiative seeks to provide a platform for private sector stakeholders to candidly address challenges within Kenya's investment climate and agree upon solutions, both policy and non-policy, within defined

timelines.

Understanding the significance of transparent communication to investors and the nation's global positioning, the Council resolved that the Cabinet Secretary responsible for The National Treasury and Economic Planning, as well as the Cabinet Secretary for Investment Trade and Industry shall schedule periodic media briefings targeted at investors and the interna-

tional media, with the aim of conveying the accurate stance of the country on fiscal, monetary, and investment matters.

President Ruto, also the Chair of the NIC, acknowledged the economic resurgence resulting from interventions in various sectors. Council members were reminded of their crucial role as the focal point for private sector concerns related to the investment environment.

He said that this commitment is poised to elevate Kenya's regional and international standing as the preferred investment destination.

Similarly, the government is implementing robust measures to foster industrial growth and ensure it is commensurate with the country's Gross Domestic Product (GDP) by equipping Special Economic Zones with the necessary facilities to attract investors.

He noted that this will attract foreign direct investment, drive industrial growth and increase exports.

"Exports are a very important agenda because we are importing too many things that can be manufactured locally," he added.

He pointed out that this will position the country to benefit from the African Continental Free Trade Area, African Growth and Opportunity Act and other markets.

Additionally, the Cabinet Secretary emphasized that her ministry is actively promoting safe, orderly, and regular labor migrations, ensuring the protection of migrant workers and their families.

Speaking during the same function, the Kenya Central Organization of Trade Unions (COTU) Secretary General Francis Lipwoni Atwoli defended the Judiciary over corruption allegations raised by the executive.

Atwoli instead called for a truce between the two arms of government saying the current war of words between the two arms is detrimental to service delivery.

Agency implements multi-million Horn of Africa water project

The Water Resources Authority (WRA) is actively implementing transboundary water management initiatives to enhance the sustainable use and management of groundwater in the region.

This effort is part of the Horn of Africa Groundwater for Resilience Programme (HoAGW4RP), a regional initiative involving Kenya, Somalia, Ethiopia, South Sudan, Djibouti, Eritrea, and IGAD. The World Bank is financing this program at a cost of 45 million dollars.

The collaborative implementation of the programme is designed to promote regional integration among communities residing in the borderlands within the Horn of Africa. The project is expected to benefit approximately 1.5 million people in rural communities, particularly in the five counties of Turkana, Wajir, Garissa, Marsabit, and Mandera.

Scheduled to run for six years, the project aims to ensure the proper recharge and protection of underground water reservoirs. This will be achieved by enhancing the capacities of communities in target areas regarding conservation measures.

Speaking in Garissa after a county stakeholders' consultation workshop, Ms. Agatha Njuguna, the Project Implementation Unit Coordinator for the Water Resources Authority (WRA), emphasized that the introduction of managed aquifers will enable the tapping of rain and floodwater into a sand dam.

Subsequently, this water will gradually infiltrate the ground over time. She said that managed aquifers are artificial aquifers that will be created to feed the natural underground water aquifers in the form of dams which will be well conserved and protected.

"We are trying to stop the water from flowing and intercept it and create a reservoir allowing it to percolate into the ground. The aquifer is a very big resource in terms of storage and when you create the infrastructure, you sort of

put in conducive conditions for the water to sink instead of creating floods and causing havoc," Agatha said.

"If you do some ditches, furrows, spreading basins or sand dams, the water will be intercepted and stored even for later use after the rains stop, while recharging the underground reservoir, which could be exploited to serve the communities," she added.

Ms Njuguna further said that all stakeholders will be brought on board, from the national and county governments, non-governmental organizations and community leaders, whose input will be key in completing the project implementation.

The stakeholders will also be able to receive adequate data on the water reservoirs, the salinity of water, possible water output, and the most accurate place to drill a borehole.

Speaking to MyGov, John Kinyanjui, Water Resources Assessment and Monitoring Manager at WRA disclosed that surface water is scarce in ASALs due to high temperatures and evapotranspiration rates.

Stable water supply

"Therefore, groundwater is often the most reliable source of a stable water supply for domestic, agriculture and livestock use.

Thus, sustainable groundwater development constitutes a key adaptation measure to climate change," Kinyanjui said.

He pointed out that borderlands often face low agricultural productivity, environmental and land

degradation, unemployment and under-employment, conflict and violence and forced displacement.

Kinyanjui said that climate shocks in the borderlands contribute to food insecurity, increased tensions over scarce natural resources, particularly over water and land and heightened risks to public health.

Drought resilience

"In the ASALs, groundwater plays a critical role in building drought resilience. In times of drought, when surface water dries or silts up, communities, particularly women and children, walk long distances searching for the few available productive boreholes," he said.

The Manager noted that drought does not only threaten the livelihoods and food security of these communities but also creates tensions over scarce water resources and exacerbates conflict and fragility within and across Kenya, particularly in the borderlands.

The project will rehabilitate approximately 400 rural water schemes and drill new drought-strategic boreholes where feasible, conserve groundwater resources and build resilience against drought.

Recognizing the centrality of public participation, Kinyanjui said that local readiness and community inclusion are key to ensuring that vulnerable communities are effectively engaged and prepared to play an active role in the sustainable management and use of groundwater resources.

Kenya's fish production soars, surpasses 30,000 metric tonnes annually

Kenya produced over 30,000 metric tonnes of fish last year, an improvement from previous years when the country produced as low as 4,000 metric tonnes annually.

The Principal Secretary for Blue Economy and Fisheries, Ms. Betsy Njagi, stated that the government is looking forward to increasing this production by encouraging aquaculture, providing seeds (fingerlings) to farmers, and establishing centers of excellence where farmers can access quality seeds.

"The capture of fisheries is decreasing due to dwindling fish stocks in water bodies. Revamping aquaculture will ensure food and nutritional security through a steady supply of fish stock to the local market and beyond," the PS said.

She added that the government is also collaborating with the private sector to ensure the provision of quality feeds, which has been a major challenge for fish farmers.

Njagi further mentioned that the Government, through the Ministry of Fisheries, Aquaculture, and Blue Economy, is partnering with the African Union-Inter-African Bureau for Animal Resources (AU-IBAR) to revamp the aquaculture value chain in the country and Africa at large.

The remarks were contained in a speech read on her behalf by Director of Fisheries Ms. Lucy Obungu, during the official opening of the Second General Congress of Aquaculture Network for Africa (ANAF) in Naivasha.

Aquaculture currently accounts for only 2.7 per cent of fish catch in the country and the annual supply gap of 50,000 metric tonnes of fish is projected to increase to 75,000 by 2030 if annual per capita fish consumption remains constant at 4.3 kilograms.

As the ANAF member states convene in Kenya for this three day conference, the PS explained that some of the challenges facing the fisheries sector include poor quality seed (fingerlings) and high cost of fish feed, which have hindered the progression of aquaculture in the country, and called for urgent measures by stakeholders to resolve the

challenges.

The PS noted that the centres of excellence that have been established will help address the issue of the high cost of fish feed and lead to production of high-quality fish fingerlings in the country.

As part of the government's commitment in enhancing the aquaculture value chain in the country, the PS pointed out that the establishment of Sh1-billion Kabonyo Fisheries Aquaculture Service and Training Centre of Excellence in Kisumu County will come in handy in ensuring the availability of quality fish seed.

Vital food component

This comes at the backdrop of concerns raised by stakeholders in the sector over declining fish catches from capture fishing because of over-exploitation of marine ecosystems. Aquaculture is now being seen as the solution that will help bridge the gap in supply of this vital food component.

The PS called upon member states to enhance activities around the promotion and growth of the aquaculture sector in their respective countries to ensure food security and alleviate poverty.

"In this vein, given the importance of fish in our food baskets and in social safety nets for the ma-

jority of our citizens, I wish to implore all member states to similarly embark on promoting industry or market led-aquaculture development for food security, income and wealth creation," she added.

Ms. Obungu observed that they were working with various security apparatus to stem the rampant illegal fishing in the country's water bodies, which she says denies the country revenue and contributes to dwindling fish stocks through capture of immature fish.

The African Union-Inter-African Bureau for Animal Resources (AU-IBAR) Director, Dr. Huyam Salim, emphasized that aquaculture has the potential to provide food security and economic empowerment to the masses on the African continent.

He called for collaborative efforts between individual governments of member states and the private sector in enhancing aquaculture production.

"Governments' participation in their own continental organization and developing a work program based on their common problems bestows assurance that appropriate strategies are engaged, to resolve priority issues, create wider impact and efficiently perform more effectively in its institutional roles," she said.

Dr. David Balikowa, from the East African Community (EAC) Secretariat, called for urgent need to address the emerging challenges in the aquaculture sub-sector, adding that it is an important player, not only in the food and nutritional security, but also economic empowerment as well.

Governor Achani's initiative to empower local farmers ahead of anticipated long rainy season

Kwale County Governor Fatuma Achani says efforts are underway to distribute agricultural assets and farm inputs to local farmers ahead of the anticipated long rainy season in the area.

Governor Achani states that preparations are in top gear to provide farming inputs to farmers in the 20 administrative wards across the coastal county before the March-April rains.

The County has already distributed certified seeds, fertilizers, knapsacks, power sprayers, pipes, insecticides, fungicides, and agricultural adjuvants for spraying to local farmers. Governor Achani urges farmers to seize the opportunity presented by the upcoming long rains and prepare for planting.

The coastal county boss explains that this initiative is part of the devolved government's plan to enhance food security by supporting

agriculture and enabling local small-scale farmers to thrive.

She emphasizes that the devolved unit is committed to revitalizing the agricultural sector by providing adequate support to local small-scale farmers.

"The programme is meant to assist local smallholder farmers enhance their productive capacity and reduce the high poverty levels in the rural areas," she said.

Achani said the move to empower small-scale farmers with inputs would open investment opportunities in the agricultural sector, create jobs and facilitate increased production as well as food and nutritional security.

The Governor was speaking at the County Headquarters during the flagging-off of the agricultural inputs to local farmers, ahead of the anticipated long rains.

"The distribution of high-quality seeds, fertilizers and other agricultural equipment to farmers, is meant

to improve yields," she said, and warned farmers against selling the inputs provided.

Achani urged the beneficiaries to make the best use of the input received towards the overall development of agriculture in the county.

She, therefore, urged the farmers to ensure full utilization of the inputs in their various farms, to increase their farm output.

The Governor says that the agricultural sector would continue to be a priority for her administration in a bid to stimulate local production of food aimed at achieving self-sufficiency, enhancing the livelihood of local farmers and general livelihoods of the residents.

She commended the smallholder farmers who produce the bulk of food consumed at the local level, for their perseverance and commitment to agriculture, despite climate change disrupting food availability.

In the recent past, the County Government of Kwale distributed tonnes

of improved and certified seeds, fertilizers, bulls, dairy cattle and Galla goats to farmers to improve local stock.

Tractors have also been ploughing fields for free in a bid to improve the acreage under crops as well as agricultural education to farmers, to improve stock and crops. At the same time Governor Achani said the devolved government is determined to establish ir-

rigation schemes and revive stalled ones to boost agricultural productivity and enhance food security.

She said irrigated farming will ensure more food production and crop diversification and urged local communities to make lands available for agricultural purposes, in support of the irrigation projects.

Achani said the devolved unit's ambitious rural irrigation schemes seek to link

villages through nearest possible sources of water.

"The small-scale irrigation schemes are designed as a ladder out of poverty, for the rural communities and small holder farmers," she said.

The Governor said to make agricultural production more sustainable in the region, the county government is empowering farmers who venture into irrigated crop production.

Government launches groundbreaking programme to preserve indigenous knowledge across 47 counties

The Government, through the Natural Products Industry (NPI) Initiative anchored at the National Museums of Kenya, has initiated a program aimed at documenting and digitizing indigenous knowledge (IK) intellectual assets within the 47 counties.

The programme, popularly known as the DoDi Programme, is a collaborative effort involving state agencies, county governments, and local communities. Under the DoDi Programme, an Indigenous Knowledge Innovation Bank (InKiBank) has been established, housing IK assets collected from various counties.

The initiative seeks to facilitate the development and commercialization of products by adding value to the IK assets for the marketplace. The ultimate goal is to generate income for local communities and counties.

Prof Mary Gikungu, the Director General of the National Museums of Kenya who was speaking at a Machakos hotel during the

workshop said after digitization of all the intellectual assets, NMK plans to find out what products can be developed from the said assets.

The IK intellectual assets which include traditional medicinal remedies, traditional foods, heritage sites, music and dance and indigenous technologies will have value addition and packaged in such a manner that will benefit the common mwananchi and drive the government's Bottom-Up Economic Transformation Agenda (BETA), she said.

The Director General affirmed that the intellectual assets do not belong to the National Museums of Kenya but are owned by the local communities as stipulated in the Protection of

Traditional Knowledge and Cultural Expressions Act 2016 (TK and CE Act 2016).

"At the end of the day, we want our communities to benefit from the indigenous knowledge assets and drive cottage industries within the counties where all institutions are represented," Prof Gikungu said.

She noted that they have chosen 13 counties to start with for Phase I and have

so far rolled out the DoDi Programme in nine counties including Murang'a, Narok, Kisii, Kilifi, Makueni, Tharaka Nithi, Kericho, Kakamega and Vihiga.

She pointed out that in the due course, NMK will go to Phase II where they will take another set of 20 counties before proceeding to Phase III involving 14 counties to clear all the 47 counties.

Dr Evans Taracha, the NPI

National Coordinator and a researcher at the National Museums of Kenya, said that the DoDi Programme is incorporated into the Kenya Vision 2030 as a flagship project.

Dr. Taracha said the documentation and digitization of intellectual assets was influenced by the 2010 Constitution Art.69 (1) (c) which mandates the State to protect and enhance intel-

lectual property, indigenous knowledge of biodiversity and the genetic resources of the communities for their benefit.

He further added that according to the TK and CE Act 2016, in addition to protecting the IK assets, the DoDi Programme will ensure that there is value addition and commercialization of the assets to boost the country's economy.

The project coordinator said the project was well-received in some counties, despite being received with doubt and suspicion by the communities in the initial stages.

"Some complained and suspected that we were there to pick their knowledge to make a profit out of it without compensating them," Dr. Taracha added.

He said they decided to involve the National Government Administration officers (NGAO) who held public barazas to create awareness in the communities concerning the main purpose of the DoDi Programme and how they stood to benefit from it.

East African Insurance Supervisors Association (EAISA) develop cross-border insurance products and services

The East African insurance supervisors have resolved to jointly promote the development of cross-border insurance products and services to address the challenges of low insurance uptake and penetration in the region.

The members also agreed to coordinate joint innovation initiatives relating to insurance development in member states under the auspices of the East African Insurance Supervisors Association (EAISA).

The supervisors who were speaking during their 7th Special Meeting of the Executive Committee (ExCo) meeting held in Eldoret, Kenya also agreed to employ a joint approach in supervising systemically important insurance groups, monitor cross-border industry stability, and coordinate the establishment of insurance supervisory colleges.

Speaking on behalf of all the EAISA members, the Exco Chairman Alhaj Kaddunabbi Ibrahim Lubega, Uganda's Insurance Regulatory Authority (IRA) Chief Executive Officer underscored the importance of coordinated regional initiatives relating to research and development (R&D) for effective policy development and implementation.

"EAISA is committed towards building capacity across the member countries as they seek to implement industry integration initiatives," he added.

The 1st EAISA 2024/2025 - 2028/2029 Strategic Plan was approved and adopted by the supervisors during the meeting, with its approval, the regional insurance landscape is headed for major changes as the member countries have now to harmonize their legal and regulatory frameworks to provide a unified foundation that supports cross border insurance operations by September 2025.

The members also have up to June 2025 to develop and adopt risk management and solvency standards to ensure that insurers

across the region maintain adequate financial reserves to cover potential risks and solvency requirements.

The Plan is drawn along five thematic areas, that include insurance industry stability, insurance market development and innovation, consumer protection, institutional sustainability and cooperation, collaboration, and industry integration.

The strategic plans have identified 11 key result areas, including claims handling and settlement, fair pricing practices, innovation hub establishment, product diversification, insurance inclusion, market expansion, crisis management, stress testing, and market surveillance.

It envisages the development and adoption of regional frameworks for information exchange sharing and data standardization, group-wide risk assessment, and cross-border supervision framework, as well as putting in motion plans to develop and adopt regional frameworks for financial literacy/ insurance education, risk-based supervision, certification for insurance professionals and actuaries and market conduct and insurance claims guidelines among other things.

The Meeting was hosted by the Insurance Regulatory Authority, Kenya, and attended by representatives from member states including, the

Commissioner of Insurance and CEO, Insurance Regulatory Authority (IRA) of Kenya Godfrey Kiptum, Madam Doreen Shelagh Kahonda, Executive Director, National Bank of Rwanda (BNR), and Madam Issa Said Khadija, Deputy Commissioner of Insurance, Tanzania Insurance Regulatory Authority.

Others were Emmanuel Mutatsh, Representative to the Director General - Autorité de Régulation et de Contrôle des Assurances (ARCA) - Democratic Republic of Congo (DRC), Désiré Nimubona, Representative to the Secretary-General - Agence de Régulation et de Contrôle des Assurances (ARCA) - Burundi.

The meeting comes at a time when the EAC insurance markets are addressing issues related to market volatility, climate change risks, cyber risks, and geopolitical developments. Further, frontier risks continue to disrupt supply chains and pose new challenges to existing policy, regulatory, and supervisory frameworks.

The East African insurance Supervisors Association (EAISA) is an umbrella body comprised of insurance supervisors from the East African Community Region.

Membership is drawn from EAC partner states of Kenya, Uganda, Tanzania, Rwanda, Burundi, South-Sudan and the Democratic Republic of Congo (DRC).

Tomato grower Fredrick Gitau's childhood farming dreams shattered by invasive pest

Fredrick Gitau has fond memories of small-scale farming from his childhood, as he and his seven siblings were educated through the proceeds from the sale of tomatoes.

Gitau's family used to earn money every three months, and he recalls how his father was a well-known tomato farmer in Subukia, Nakuru County.

Having witnessed firsthand how lucrative tomato cultivation was in the 1980s, it was easy for Gitau to be enticed to delve into that wing of horticulture, with his dream being to be as successful as his father was.

"Tomatoes were among my first crops when I began farming," he says.

But his high hopes were dashed, and he abandoned the crop.

"Tuta Absoluta (tomato leafminer) emerged, and I didn't possess knowledge regarding the pest," he says.

His wife, Gladys Wangui, says, "If Tuta attacks your

tomatoes, you will be finished. There's nothing you harvest," she says.

The couple incurred significant losses in 2019 due to the pest. It was a complete crop failure for them. They never imagined at the time that there could be potential solutions to the menace other than chemical spraying.

Gitau laments that the farm inputs he had invested went down the drain, "The following year I didn't grow tomatoes, I switched to cabbages," he said.

But what he anticipated didn't come to be, "The prices were low, earnings were poor," he said.

The following season, having been enlightened on how to combat Tuta Absoluta he sowed tomatoes again, he says.

However, another adversity hit him—drought, "Tomatoes require a lot of water, if they lack water for a week, they wither and reviving them is a daunting task," he says.

More expensive

He dropped tomatoes and returned to cultivation of cabbages. The difference in farm inputs for the two crops caught his eye when he noted that tomatoes were more expensive in terms of seeds, pesticides, and labour but well-paying.



The only cabbage variety that the Gitaus grow is the Gloria. From these seedbeds the vegetables would be transplanted in another portion of the farm.

"I know how to grow them in a greenhouse. But I lack the resources to do so. If you have a greenhouse, whether there's El Nino or not you'll go on," he said.

As such, Gitau's family has partly sought solace in mixed farming. Their one-and-a-half-acre farm hardly rests. A variety of sweet potatoes—yellow, white, and pink-fleshed for human consumption, and another kind for animal feed—dot their farm. Other crops are Irish potatoes, French beans, maize, beans, pyrethrum and cabbages.

While the Gitaus were reeling from the effects of Tuta absoluta, a solution was being sought. Agricultural authorities, research and non-governmental institutions have urgently been directing attention towards efforts to mitigate the impact of the pest.

The Ukulima True is a

campaign implemented by the County Government of Nakuru in Partnership with the Centre for Agriculture and Bioscience International (CABI) and the Centre for Behaviour Change and Communication Centre (CBCC). The campaign, seeking to reduce the risk of pesticides to stakeholders in the food value chain was being implemented in Subukia Sub-County from May to December 2023.

This is in addition to the fact that Integrated Pest Management (IPM), which entail combination of cultural, biological, and chemical control methods to curb infestation, have been deployed on the farms of many farmers in Subukia.

One of the most effective strategies farmers in Subukia have employed is the use of pheromone traps. These traps emit synthetic chemicals that mimic the

sex pheromones of the tomato leaf miner, attracting and trapping the male insects. The number of male insects is reduced disrupting the breeding cycle of the pest. While the battle against pests in the tomato fields of Subukia had beaten some farmers into a retreat, with more than 1,000 farmers having been trained on the IPM strategy, it is hoped that the tide will swing in the farmers' favour which will ensure sustainable tomato farming in the region.

Pests

When the Gitaus' tomato cultivation resulted in total crop failure, they didn't know how to biologically control the proliferation of the pest. "Now we do," says

Gitau.

His wife adds, "If we were to resume tomato farming, we'd manage to combat the challenge."

The CBCC Technical Director, Dr Catherine Lengewa, says, "We came up with a social and behaviour change strategy on addressing the unsafe use of pesticides."

She says that the Ukulima True campaign aims at, "Inciting others to be a true farmer—one who's conscious about the safety to themselves, the consumers, the soils and the environment of the products and the chemicals they use."

If the biological traps were 80-90 per cent effective, then the chemical spray required would be minimal.

The fully-equipped NCLEX-RN Test Center which was launched by the Prime Cabinet Secretary who is also in charge of Foreign and Diaspora Affairs Musalia Mudavadi is touted as a game-changer for Kenyan nurses which is poised to significantly reduce examination costs by 50 per cent besides eliminating the need for nurses to travel abroad to seek job opportunities.

"This development opens doors for Kenyan nurses to

access opportunities in the U.S, Canada, and Australia and contributes to both individual career growth and national economic development", said the Health Cabinet Secretary Susan Nakhumicha during the event.

"The Ministry of Health, collaborating actively with various partners, aims to create additional job opportunities for nurses in alignment with the Bottom-Up Transformation Agenda," Ms Nakhumicha said.

According to Ms Mary Muthoni Muriuki, the Principal Secretary for Public Health and Professional Standards in the Ministry of Health, the launch of Pearson VUE Test Centre in Nairobi addresses the long-standing need for a local National Council Licensure Examination for Registered Nurses (NCLEX-RN) which will reduce the dependency

on foreign countries for the examination process.

Ms Muriuki noted that the centre which is administered globally by Pearson VUE, the NCLEX-RN is crucial for nurses aspiring to work in the U.S, Canada, Australia, and New Zealand and its inauguration not only brings the examination closer to home

but also aligns with KMTC's efforts to enhance accessibility for Kenyan candidates," Ms Muriuki said.

The new center, according to the Ministry of Health is expected to slash examination costs by over 50 per cent with KMTC pro-actively addressing this initiative by developing a comprehensive

NCLEX Preparatory course curriculum, aiming to equip nurses with the skills needed to excel in the examination on their first attempt.

Citing the centre launching as a positive stride in the healthcare sector, Mudavadi said the launch underscores the commitment to nurturing quality health professionals in the country.

"For nearly a century, the Kenya Medical Training College (KMTC) has been a cornerstone in producing highly competent health professionals, contributing significantly to the middle-level health workforce in Kenya," Mudavadi said.

Pearson Virtual Universal Enterprises (VUE) has expressed its intent to establish the second International Professional Test Centre in Africa—a decision supported by the Kenyan Diaspora in collaboration with the Kenya Medical Training Colleges, the House of Representatives

Government decries low uptake of empowerment loans by residents of Busia

The Principal Secretary for Micro Small and Medium Enterprises Development, Ms. Susan Mang'eni is challenging the Busia County leadership especially the County Government, the national government administration, elected officials, religious leaders, and other stakeholders to take the lead in rallying the masses around the Bottom-Up Economic Transformation Agenda (BETA) following reports of low uptake of existing economic empowerment opportunities offered by the National Government by the people of Busia county.

Ms Mang'eni noted that Busia County has only benefited from a paltry Sh166 million out of the Sh 9 billion disbursed through several government empowerment programmes adding that since the inception of the Uwezo Fund, only a mere Sh 98million has been disbursed to Busia and out of the Sh15billion by held by the Youth Enterprise Development Fund only a handful of borrowers have benefitted.

She further lamented that Busia county is yet to significantly benefit from financing in the manufacturing sector through the Kenya Industrial Estates.

Ms Mang'eni attributed the low uptake to a lack of proper sensitization and information dissemination, calling on the national government administration to leverage its structures to mobilize and organize the masses into groups to maximize existing economic opportunities.

The PS further noted that Busia County ranks among

the least beneficiaries of financial empowerment programs, utilizing slightly over Sh 100 million from the in Uwezo Fund and a similar estimate in youth empowerment funds disbursed against national allocations of Sh15 billion and 9 billion respectively.

The PS was speaking during the kick-off of the Mashinani Pesa Mfukononi sensitization program in Busia County which is aimed at rallying the grassroots population around the government's Priority Value Chains in the Bottom-Up Economic Transformation Agenda (BETA).

The multi-agency initiative, led by the State Department for MSMEs Development in collaboration with Uwezo Fd, MSEA, KIE, WEF, YEDF, and NGAAF, aims to raise awareness at the grassroots level on the government's priority value chains to enable people to align their business ideas and lives with BETA and benefit from the opportunities created by these unique value chains.

PS Mang'eni disbursed Uwezo Fund cheques worth Sh 4.4 million from and Sh 4 million from the Youth Enterprise Development Fund which targets to benefit 100 women and youth groups in the county and also urged the county to provide 10,000 acres of land to kick-start sunflower production in the area.

She was accompanied by Busia County Commissioner Mr. Kipchumba Ruto and representatives from the Busia County government, a Board Director Mrs Florah Jerop and CEOs from Agencies under the State Department namely; CEO Uwezo Fund Mr. Peter Lengapiani, Youth Fund representative Mr. Benson Muthendi and the Acting CEO of the Kenya Industrial Estates Charles Mativo.

Kisumu County set for renewal with infrastructural overhaul in slums

The Second Kenya Informal Settlements Improvement Project (KISIP 2) has achieved a significant milestone in the lakeside city of Kisumu by initiating key infrastructural projects in the city's informal settlements.

The new KISIP 2 projects in Kisumu aim to transform the county's informal settlements into modern residential areas, benefiting thousands of slum dwellers.

According to Mr. George Arwa, the National Coordinator for KISIP 2, the Sh1.4 billion projects are anticipated to modernize slums into residential areas following the county's qualification for the second phase of the Kenya Informal Settlements Improvements Project (KISIP 2) slum upgrading initiatives.

Kisumu County had previously successfully implemented KISIP 1, which concluded in 2020.

Mr. Arwa made these remarks during a ceremony presided over by Kisumu County Governor Prof. An-

yang' Nyong'o. KISIP 2 has officially commenced major works in selected informal settlements in the lakeside city.

"Under the KISIP 2 project in Kisumu, infrastructure projects including construction of bitumen roads, pedestrian walkways, street and security lighting will be undertaken in Bandani, Manyatta A, Manyatta B, Nyawita, Kibuye and Muhoroni" Arwa said.

Other works envisaged in the KISIP 2 projects in Kisumu, the Co-ordinator

said will include construction of storm water drainage as well as water and sanitation systems in Migosi, Nyawita, Bandani, Kibuye, Manyatta A, Manyatta B, and Muhoroni informal settlements.

"Apart from improved quality of housing and dignity for residents, KISIP's interventions in Kisumu county are poised to increase security provision through high mast lighting which will see increased business activities during late hours, increased accessibil-

ity for fire engines in case of fire outbreaks, reduction of threats caused by flooding because of improved drainage", Arwa said.

While thanking KISIP 2, the project financiers including the World Bank and Agence Française de Développement (AFD), Prof Nyon'go termed the initiative as a game-changer and a great milestone for the residents.

"Our intention is to make these informalities formal. We cannot let the continued mushrooming of informal settlements in our city. I want to thank KISIP and the financiers," said the county boss.

During the ground breaking ceremony, the Governor was accompanied by his Executive Committee Member for Lands and Physical Planning, Dr. Kennedy Hongo, Salmon Orimba, the Chief Officer Mr. Victor Kanyaura, KISIP County Project Coordination Team led by the Coordinator Tom Ogolla, Kisumu Central MP, Joshua Oron, MCAs of the respective project implementation areas, project consultants, contractors among others.

Nakuru County to train 3,000 Community Health Promoters

At least 3,000 Community Health Promoters (CHPS) will be trained by the County Government of Nakuru to enhance their capacity in service delivery.

The County Executive Committee Member (CECM) In-Charge of Health Services, Ms. Roseline Mungai, stated that the County will ensure that community health promoters are well-equipped with adequate skills to perform their duties effectively.

This initiative aims to reduce the burden on the healthcare system by preventing diseases, promoting healthier lifestyles, and providing vital health support to families.

Ms. Mungai announced that the first training cohort of over 500 CHPS from Njoro, Subukia, Kuresoi South, Bahati, and Gilgil Sub-counties is in progress, focusing on Integrated Community Case Management (ICCM) and Non-Communicable Diseases. The CECM affirmed that the county government is committed to ensuring the success of the Community Health Promoters (CHPS) program by al-

locating adequate resources. Ms Mungai emphasized that strengthening of Primary Health Care (PHC) was at the heart of Universal Health Coverage (UHC) and, therefore, as the CHP programme kicks off there is a need for adequate support from all stakeholders.

She said the county government valued the health workforce because it is central to the delivery of quality health services and that they were exploring local and international development partnerships, to prioritize support for the community health program, as a key contributor to UHC. The Community Health Promoters, she said, will handle patients at the households, and refer them to Level II hospitals, where they are likely to be referred to Level III, IV and V, as per the need of care.

The CECM said that the county would also educate community members on safe drinking water, availability of toilets and handwashing facilities, made of locally available materials.

Narok County expands bursary fund to Sh400m

The Narok County Government has distributed a bursary of Sh400 million to benefit over 47,000 needy students in the county.

Governor Patrick Ntutu said that among the beneficiaries are 1,600 students who are receiving full scholarships for their secondary and tertiary level education.

The number represents an increase from last year when the bursary issued was Sh370 million, benefiting about 44,000 students, with 500 students receiving full scholarships.

The beneficiaries, he said, will receive a direct message sent to their phones, indicating the school, the amount received, reference number, and admission number.

"This is unlike before when a manual system was used to identify the beneficiaries. This year, the beneficiaries will only have to walk to the school and simply present the message to confirm the bursary allocation with the school management," he said.

Since the onset of devolution in 2013, that was the highest amount of bursary distributed by the county government. Ntutu said he is committed to continuing championing initiatives that will improve educational infrastructure, accessibility, and quality.

On Early Childhood Development and Education (ECDE), Governor Ntutu said he constructed over 298 classrooms last year.

ment and Education (ECDE), Governor Ntutu said he constructed over 298 classrooms last year.

"The foundational structure of a child's education is critical, if that foundation is not well laid out, the future of that child is at stake," he added.

The function was attended by the Anglican Church of Kenya (ACK) Archbishop Jackson Ole Saitit who called on parents to take care of their children, as they are the future professionals of the county.

He lauded Governor Ntutu for the good work he is doing, saying many children from vulnerable backgrounds have benefited from the bursary.

"Among these children are prominent business people, professors, and medics, who will be known in the entire world. I request parents to take care of these children, so that they can attain their dreams," he reiterated.

Ole Saitit called on learners to take their studies seriously and to avoid engaging in unproductive business such as Female Genital Mutilation (FGM) and early marriages.

New NSSF Act brings tenfold surge in employee pension contributions

The increased employees' contribution to the National Social Security Fund (NSSF) will benefit workers when they retire.

Charles Machira, the CEO of the Retirement Benefits Authority (RBA), stated that the contributions will be increased from Sh2,160 to Sh4,320 this February, in accordance with the new NSSF Act.

Speaking in Nyahururu town during the 8th annual Minet-Kenya pension conference, the RBA CEO emphasized that contributing to NSSF is advantageous for the worker, as it ensures a substantial pension payout.

He defended the increment in NSSF contributions, asserting that the tenfold increase will provide employees with a more substantial retirement package.

Despite lamenting the sub-

optimal number of people saving for their retirement in the country, Machira noted that the retirement benefits sector remains stable.

Macharia added that the industry has an asset management of gross value of over Sh1.7 trillion and these

resources have been saved by 1,050 pension funds in Kenya. "The pensions sector continues to face challenges, some of which the regulator is working on such as unremitted contributions by employers currently estimated to be at Sh40 billion"

said the the CEO, adding that pension funds ought to embrace environmental, social, and governance principles as a measure of sustainable business practices and continuity. Moreover, Machira said the RBA policy will address some challenges which include delayed payment of benefits among others.

Mr. Daniel Mainga, the General Manager of Minet, Financial Services and Pensions, said that this year's pension's theme is sustainability and resilience, and the sustainability of the pensions industry is a must-have conversation. He said they are aligning with the changes in the industry to ensure employees in Kenya go home with a decent pension.

He regretted that many people retire with minimal pensions that cannot sustain them after working for many years.
