# Boarding schools to cut energy bills with new solar bulbs

The institutions will receive donations of LED tubes and solar outdoor lighting appliances from Signify Foundation through the State Department for Energy on a pilot programme to replace the high energy consumption fluorescent tube lights and bulbs

t least 100 secondary boarding schools across the country will Lebenefit from efficient lighting equipment, which will help reduce costs associated with electricity bills.

The schools are located in Busia, Embu, Homabay, Kakamega, Kisumu, Kitui, Laikipia, Machakos, Nairobi, Na-kuru, Nyeri, and Uasin Gishu Counties.

These institutions will receive donations of LED tubes and solar outdoor lighting appliances

from the Signify Foundation through the State Department for Energy. This pilot program aims to replace high-energy consumption fluorescent tube lights and bulbs.

A team of inspectors from the Ministry of Energy and Petroleum, the Energy and Petroleum Regulatory Authority (EPRA), and Sustainable Energy for All (SE4ALL) visited various schools to assess their readiness for the pilot project.

The Ministry will then develop a learning pack and avail it to schools for students and

## Government races to roll out health insurance policy for chronic illnesses

he Government has scaled The Government masses up plans to roll out a statefunded health insurance scheme for Kenyans suffering from chronic diseases such as

Deputy President Rigathi Gachagua stated that the government is also investing in medical equipment to aid in the early diagnosis and management of cancer.

"Cancer is devastating to any family, both emotionally and financially. We, as a government, have made interventions to establish an insurance scheme to cover chronic illnesses because the cost of treating cancer abroad

is beyond the means of many families," Mr. Gachagua said.

The Deputy President explained that the new insurance policy will transform the healthcare sector, save lives, and empower communities and families by reducing the financial burden.

"Many families are conicting harambees trying to raise millions of shillings to support their loved ones suffering from cancer. But I am encouraged that now we have equipment.

"Public health facilities like Kenyatta University Teaching, Referral and Research Hospital (KUTRRH) have in-

stalled a PET scan, which was only available outside the country several years ago.

We have equipment that can help with early diagnosis because cancer ailments if detected early can be managed,' he stated.

The PET scan machine at KUTRRH was installed in 2022. The machine, the Deputy President said, brought relief to Kenyans as most patients were accessing the services outside the country.

The health insurance policy for chronic illnesses is part of strategic interventions deployed by the government towards ensuring that Kenyans have access to quality healthcare and holistic coverage.

Mr Gachagua added that the government intends to ensure families with cancer patients do not have to ponder how they will cover medical expenses of their kind.

Meanwhile,

**CONTINUED FROM PAGE 1** Gachagua said the fight against illicit brews and drug abuse will continue uninterrupted.

"The challenge of illicit alcohol and drugs is real, and many people want to run away from reality.

When we came to office with President Ruto, we found a big challenge on illicit brews and drugs in the entire country and more specifically in the Central Kenya region.

We took it head on and we have made serious strides. The fight must continue uninterrupted to save our country," he said.

He added: "I have put leaders on notice, anyone trying to interfere will be called out by names so that they can be shamed. We cannot allow the re-introduction of poison disguised as alcohol to kill our children."

He called on the Church and religious organisations to join the government in saving the youth affected by the vices and rehabilitating those addicted.

# Boarding schools to receive energy-efficient lighting under pilot program

teachers to understand the benefits of energy efficient lighting solutions.

The Prioncipal Lwanda Dudi Secondary School Dr. Elizabeth Aseka welcomed the project with hopes that it will help in cutting down the cost of electricity bills which currently stands at over Sh30,000 per month for a school with a population of 565 students where 150 are boarders.

"Our electricity bills are very high, and they have really shot up in the recent past. This is a very big challenge for us because funding is a problem because we depend on the government for funding. So, there are times when you need to pay these bills which are very high, yet the government has not released funds," Dr. Aseka noted.

She said that Kenya Power and Lighting Company (KPLC) sometimes issues warnings of disconnecting power for failure to clear electricity

"So sometimes we are

threatened that the electricity will be cut off so we are forced to go out of our way which inconveniences other vote heads so that we can pay the electricity bills to minimize interruption of learning," she added.

"We also encounter power outages and when there are outages, we experience a very big problem for us since we have a boarding section in the school," Dr. Aseka noted.

The Principal of Mwihila Boys High School in Khwisero, Maurice Ajulu, says the school spends more than Sh75,000 on electricity bills monthly.

He says, to reduce the cost of electricity, the school has installed solar panels for security lighting, but they are still facing challenges since the school is vast, covering 33 acres of land.

"Lighting the entire area will need quite a lot of those high mast flood lights yet we are not able to do that at the same time due to financial constraints, but at least we have started. That is another area where we may need some assistance to improve our security," he noted.

Mr. Ajulu said replacing the type of bulbs the school uses with more efficient energy-saving bulbs will help the school in cutting down expenses on electricity.

To try and reduce electricity costs, the management of Lwanda Dudi Secondary School has tried to replace high voltage bulbs with energy efficient ones.

A teacher at the school, Nicholus Opati, said they ensure they switch off security lights early during the day to minimize usage.

Opati asked for an automated system that can automatically switch off and on the lights.

## 1,500 poor households in Murang'a to receive financial support from state

ome 1,500 vulnerable families from Murang'a County will receive financial support through a program funded jointly by the government and the World Bank.

The families, drawn from Murang'a East and Murang'a South sub-counties, are expected to begin receiving financial support for consumption and for establishing income-generating projects by the end of this month.

In the initiative dubbed the Economic Inclusion Programme (EIP), each family is set to receive Sh. 2,000 per month for one year and an additional Sh. 30,000 as asset transfer seed capital. Murang'a County Coordinator for Social Services, Ms. Lucy Gakera, stated that the Sh. 2,000 is intended to help families purchase food and other basic commodities. Gakera told KNA that the program is being piloted

in two sub-counties in each of five counties, including Kisumu, Taita Taveta, Makueni, Marsabit, and Murang'a. "This is cohort two. The first group benefited in 2021, and participants were selected from the two sub-counties where 750 households in each subcounty were chosen," said Gakera.

The government, she noted, has deployed mentors to train and guide the families on

sustainable projects they can invest in with the seed capital. "The mentors are already on the ground, training and guiding the families to ensure they use the funds prudently, particularly for establishing sustainable projects."

"The seed capital will be disbursed in two tranches: initially, families will receive Sh. 20,000, followed by an additional Sh. 10,000 later," she added. Ga-

kera explained that the families were selected from an enhanced single register completed in 2022, which ranked households on their vulnerability. "Currently, we are opening bank accounts for the beneficiaries, and this process is expected to be completed within a week. The families should start receiving their financial support by the end of July," she stated. According to Gakera, the beneficiaries are also expected to form village savings and livelihood groups to help them make savings. "The savings are intended to support the families after the program ends. They will receive guidance on how to save effectively to ensure they become self-reliant after the support period con-cludes," added the Coordinator. Gakera urged the families to use the funds wisely and establish sustainable projects that will provide a lasting solution to their vulner-

## Five students to represent Kenya in global maths contest in UK

Five Kenyan students have represented the country at one of the world's most prestigious mathematics tournaments in the United Kingdom.

The students are Cvnthia Kathomi Mworia from Kenya High, Master Gilbert Ongoro from Alliance High School, and Tony Rotich Odhiambo from Light Academy, Nairobi. Other participants include Alfred . Githui Muriu from Nairobi School and Lenny Muriungi Mutuma from Oloolaiser High School in Kajiado County. The five will participate in the 65th edition of the International Mathematical Olympiad (IMO), a world championship mathematics competition for high school students held annually on a rotational basis in different countries.

This year's event was held from July 11, 2024, to July 22, 2024, at the University of Bath in the United Kingdom, with participants from over 100 countries across North America, Europe, and Asia. Countries such as Canada, the USA, China, India, and South Korea were represented.

Centre for Mathematics, Science and Technology Education in Africa's (CE-MASTEA's) Deputy Science Technology Engineering and Mathematics (STEM) Coordinator Martin Mungai indicated that the participants were selected from a pool of 8,000 students who successfully participated in the 2023 and 2024 Kenya Mathematics Olympiad (KMO) contests.

Besides, he said, Master Tony Rotich will also proceed to the prestigious MIT for undergraduate studies on full scholarship.

Mungai explained that the five students were best overall in this year's Kenya Mathematics Olympiad organised annually from 2022 by CEMASTEA in partnership with the Centre for Education in Mathematics and Computing from the University of Waterloo Canada and the University of Nairobi. He regretted that Nyang`ori High School s Elvis Obulemire Atsulu who also qualified for the contest was not able to participate for lack of a United Kingdom Visa.

# State sets aside 3,000 acres to settle evictees of Mau forest

The Government, through the State Department of Land Adjudication and Settlement in collaboration with Narok County Government has set aside 3,000 acres of land to settle squatters evicted from Maasai Mau Forest in Olokurto area, Narok North Sub-County.

This will be a big relief to over 3,000 people who were forcefully evicted from the forest land in October 2023 where they had occupied about 6,000 acres of forest land.

Narok Governor Patrick Ntutu and Narok County Commissioner Lotiatia Kipkech, who led the top government officials in a peace baraza in the area, said the government was committed to protecting the forest land against any form of destruction in a bid to conserve the mega water catchment land.

Ntutu revealed that though the area had been adjudicated over 40 years ago, the people remained without title deeds as there were no clear forest boundaries.

"When I realized that there is a problem here, I consulted President William Ruto and he agreed to give us 3,000 acres to settle those evicted from the forest land. It is better the little you will get with proper documentation than the huge parcels we occupied illegally in the forest land," Ntutu said.

The county boss reiterated that all government administrations have failed to issue title deeds to the people living in the area because it was clear

that they were living in forest land.

"I am the custodian of the Maasai Mau Forest title deed, and I can confirm to you today that the land you have been occupying is forest land. Please accept the little that the government is offering you free of charge instead of remaining landless," Ntutu said in Maa dialect.

Commissioner Kipkech asked the residents to keep off the forest land saying the government had provided an alternative land for them to settle.

He asked them to beware of ill-motivated people who would love to incite the community to return to forest land saying the land is protected from any human activities.

Deputy Director in the Directorate of Land Adjudication and Settlement Michael Kagwe said 60 surveyors had been deployed in the land for 21 days to demarcate the 3,000 acres of land and establish the clear forest boundaries.

# China donates 40,800 bags of rice to aid flood victims

The Government has received a donation of 40,800 bags of rice from China to help Kenyans affected by floods in various parts of the country.

The donation, packed in 88 containers, was presented to the Principal Secretary for Arid and Semi-Arid Lands and Regional Development, Kello, by the Chinese Ambassador to Kenya, Zhou Pingjian. This aid is intended to assist Kenyans impacted by severe flooding in different regions.

During the handover ceremony at the Inland Container Depot in Nairobi, Mr. Harsama emphasized that the relief effort is focused on areas most affected by the floods, including the Lake region counties of Kisumu, Homa Bay, and Busia.

The North Eastern region, particularly Garissa, Mandera, and Wajir, as well as Tana River, will

also benefit from this essential aid.

Ambassador Zhou Pingjian noted that the donation underscores the strong bilateral relationship and mutual cooperation between China and Kenya. He expressed optimism that the rice would significantly alleviate the challenges faced by families affected by both floods and droughts.

"This gesture highlights the enduring connection, friendship, and brotherhood between China and Kenya," said Ambassador Zhou. "We hope it will provide much-needed support to those in distress."

The donation reinforces the Kenyan government's commitment to effectively respond to disasters and emergencies, ensuring that relief reaches those in greatest need.

## Government rolls out mass vaccination to tackle viral disease affecting livestock

The Government has launched a national mass vaccination campaign targeting sheep and goats to combat Peste des Petits Ruminants (PPR), a highly contagious viral disease.

The launch ceremony was held in Syokithumbi, Kwa Mutonga, Kitui West Sub-County, bringing together key stakeholders in the livestock sector, including government officials, veterinary professionals, and representatives from international organizations.

Speaking during the ceremony, Livestock Development Principal Secretary Jonathan Mueke stated that the livestock sector is a crucial component of Kenya's economy, contributing up to 12 percent of the GDP and employing half of the agricultural labor force.

"Livestock, including 22 million cattle, 63 million sheep and goats, three million camels, and 1.8 million donkeys, forms the backbone of livelihoods for many rural communities, particularly in the arid and semi-arid lands (ASALs) where 10 million Kenyans depend

on livestock," Mueke said. The PS also added that sheep and goats, often referred to as small stock, play a vital role by providing livelihoods, income, employment, and export earnings.

However, the sector faces significant challenges such as diseases, pests, adverse climatic conditions, and market access issues, he noted.

He further lamented that transboundary diseases like foot and mouth disease, Rift Valley fever, anthrax, and PPR cause substantial economic losses due to high mortality rates, treatment costs

and poor animal health.

"PPR, also known locally as "sotoka ya mbuzi," is particularly devastating. The disease was first reported in Kenya in 2006 in Turkana and has since caused severe outbreaks, primarily affecting the ASAL regions. PPR not only threatens the health of small ruminants, but also poses a risk

to some wild animals, further complicating control efforts," the PS regretted.

Mueke observed that to combat the severe impact of PPR on food security, rural livelihoods, and the economy, a global strategy for its eradication has been developed and adopted in Kenya.

He noted that the strategy aims to control and eradicate PPR by 2027, emphasizing the reduction of other priority small ruminant diseases (SRDs). The economic impact of PPR is significant, with the annual losses in the ASAL counties estimated at Sh1.67 billion in 2016.

"The control of disease restricts access to lucrative markets for livestock and livestock products due to trade-sensitive restrictions imposed to prevent its spread.

These restrictions hinder the movement of small ruminants and their products, affecting the economic well-being of pastoralist communities reliant on livestock," Mueke said.

He said the government's BETA Agenda includes improving the meat value chain, recognizing the importance of sheep and goats in the rural economy and their contribution to the popular 'nyama choma' joints across the country.

## KenGen unveils solar energy project to complement hydroelectric power

he Kenya Electricity Generating Company (KenGen) will soon add 42.5 MW of solar energy to the Seven Forks area as part of its efforts to scale up Kenya's green energy deployment.

The project is expected to take twenty-eight months to complete and aims to install a 42.5 MW solar power plant in the Seven Forks dams area, where KenGen generates most of its hydroelectricity.According to KenGen Managing Director Eng. The solar plant will complement hydroelectric generation during the day and conserve water for nighttime electricity generation, especially during periods of drought.

Eng. Njenga revealed that the project is being implemented in partnership with the French Development Agency (AFD) and is the first of its kind

#### 1.0 Background

Bachuma Quarantine Station was initially conceptualized as a Disease-Free Zone (DFZ) and a flagship Project under the Kenya Vision 2030 blue print. The goal of the DFZ Program was to contribute towards poverty reduction and food security. The overall objective was to improve livelihoods and increase the Livestock Sub-Sector contribution to the national economy by promoting trade in animals and animal products through improved access to international markets

The expected outputs of Disease-Free Zones included increased supply of quality meat, by 48,000 MT, for sale locally and export; creation of over 100,000 employment opportunities; reduction in human deaths arising from diseases transmissible from animals to humans; increased milk production for sale or household consumption by 5 million litres; increased hides and skins value and rangeland and environment improvement of 2 million hectares per year.

The value of the benefits was estimated at Ksh. 16.2 billion annually. Direct beneficiaries would be livestock owners (pastoralists, agro-pastoralists, ranchers, mixed farmers and dairy farmers), livestock traders, associated operators and chambers of commerce, public and private sector animal health service providers and Community-Based Organizations engaged in the Livestock Sub-Sector. The Disease-Free Zone concept is not entirely feasible in Kenya due to existing land ownership models. Consequently, the concept of Disease-Free Zones was dropped in favour of quarantine stations and disease-free compartments.

The livestock value chain disease risk management concept based on quarantine stations was conceptualized in 2013 and approved for implementation after revision of the previous Kenya Disease Free Zoning program of Vision 2030. The purpose of the quarantine stations is to increase access to Kenya's animals and animal products to local and international markets and realize some of the objectives under the previous DFZ concept. The national livestock finishing system that feeds into the quarantine stations will be at the county level through government and private sector initiatives at the various holding grounds, feedlots, ranches, and large farms. Strategic holding grounds have been identified within the Counties of Marsabit, Isiolo, Laikipia, Tana River, Lamu, Narok, Baringo, Kajiado, Kwale, Taita Taveta, and West Pokot amongst others for use towards the realization of this concept.

The World Organization for Animal Health (WOAH) and the World Trade Organization (WTO) guidelines require animals destined for export to be quarantined in a standard veterinary-approved facility. For Kenya to fulfill this requirement, the development of a national livestock quarantine facility, Bachuma Livestock Quarantine Station (BLQS), was initiated in Bachuma livestock holding ground in Taita-Taveta County. This quarantine station was fully funded by the Government of Kenya though construction was discontinued at 80% completion due to funding challenges. The current livestock holding infrastructure at BLQS are nine (9) cattle pens each measuring 50m x 80m capable of holding 500-600 heads of cattle, six (6) sheep and goat pens each measuring 35m x 80m capable of holding 1400 heads, and three (3) camel pens each measuring 50m x 80m capable of holding 400 heads. Other installations at various levels of completion include fencing, electricity and water installation and reticulation, Laboratory building, staff houses, office block, emergency slaughterhouse and post mortem building, maintenance workshop, feed store, and wildlife protection trench.

The overall goal of BLQS is to provide a controlled environment for monitoring the health of animals destined either for export or local markets live or as products, and veterinary certification. The Quarantine Station is expected to process 50,000 cattle, 100,000 sheep and goats, and 10,000 camels annually. The facility is to be expanded based on livestock demand. The Director of Veterinary Services will provide the necessary regulatory and sanitary controls.

#### 1.1 Proposed Operational Framework

The proposed operational framework to manage the Bachuma Livestock Quarantine Stations is as follows;

- Providing a long-term lease to a private operator through the provision of the Land Act No. 6 of 2012. This act provides for the lease process and activities to be undertaken by the procuring entity while retaining ownership of the land in a Build, Operate, and Transfer (BOT) model.
- Under this lease, the private operator will manage the station, and develop all infrastructure, transport, and equipment necessary for handling the livestock during Transportation, housing, feeding, and disease screening under the oversight of the Director of Veterinary Services (DVS). The operator will deploy all manpower necessary to operate the facility.
- The partner will charge fees per unit animal processed as the revenue generation model within an approved framework in consultation with the State Department for Livestock.

#### 2.0 Objective of the assignment

The objective of this lease arrangement is to engage an appropriate partner for the lease to undertake the overall management of the Bachuma Livestock Quarantine Station and the associated facilities. The land available for lease in the BLQS project is 15,000 acres inclusive of the developed infrastructure.

- Operationalize Bachuma LQS and Support the livestock screening activities at the station in collaboration with the Director of Veterinary Services (DVS).

## Tourism professionals decry low numbers following protests

#### BY CHRIS MAHANDARA(KNA)

Tourism professionals have called for a speedy resolution of the issues fueling anti-government protests to save the tourism sector from losses.

Tourism Professionals Association (TPA) Chairman Ray Mutinda said that, although the sector is steadily recovering from the adverse effects of the COVID-19 pandemic, the protests gripping the country for the past month threaten to reverse these gains.

Mutinda mentioned that the industry is expected to fully recover this year by registering over two million tourists but expressed concerns that the protests might hinder this growth.

Although no cancellations have been made yet, Mutinda noted that the protests are slowly tarnishing the country's reputation.

"July to October is our

media in Kisumu. PHOTO: CHRIS MAHANDARA. peak period. This is when our hotels are usually fully booked, but this is unlikely to happen due to the ongoing protests," he said.

The chairman called for a middle ground between Generation Z (Gen-Z) and the government to ensure that the projected growth for the tourism sector is not disrupted.

Speaking during the TPA's Annual General Meeting in Kisumu, Mutinda added that the association is pushing for the enactment of the Tourism and Hospitality Practitioners Bill, 2023 to enhance professionalism in the sector. The bill, he said, will ensure that only qualified professionals are allowed to work in the sector

This, he said, follows concerns over infiltration of quacks in the sector which is giving it a bad name. "These measures require a proper legal framework, that is why we are pushing for the bill

which will ensure that all workers in the sector register with the association," he said. Kisumu County Executive Committee Member (CECM) in charge of Tourism Faridah Salim said the sector remains a key contributor to the country's Gross Domestic Product (GDP), calling on the national government and other stakeholders to address the security concerns posed by the nationwide protests to protect the sector.

# Mwatate women miners use blockchain technology to fight gemstone smuggling


At the heart of a well-lit booth at the Voi Gemstone Value Addition and Marketing Center in Taita-Taveta County, a row of expertly cut gemstones placed carefully on tiny white boxes along a beautifully decorated wall speaks of class and sophistication.

These are rhodolites and red garnets displayed for sale to both local and international buyers who visit the iconic facility.

Each semi-precious stone has a fascinating history detailing a long journey from the bowels of mines in the rural villages of Bura in Mwatate to the glass shelves of the marketing booth at the Gemology Center.

However, this unique narrative is embedded deep into the heart of every stone through a complex but secure non-fungible token (NFT) blockchain technology. This technology gives every cut piece a unique digital identifier whose data can neither be altered, erased, nor corrupted by any actor in the value-addition chain.

"Each stone on our display has a narrative stored in a blockchain network. It protects the unique identity of our artisanal miners' stones and supports traceability for that product anywhere in the

world," explains Irene Walowe of Taita Gems at the Voi Gemstone Center.

The deployment of blockchain NFT technology to enhance the security of the gem market and protect the unique identities of precious and semi-precious stones mined by women artisanal miners in the remote villages of Taita-Taveta County is a major milestone in the new frontier of utilizing digital assets in Kenya's mining sector.

This technology is being viewed as the most practical approach in promoting gemstone brand identities and domesticating the

traceability factor in the fight against gemstone smuggling.

Once a gemstone is digitally mapped and all relevant information is captured in the NFT blockchain network, the details can never be altered or changed by the final consumer, be it a buyer or a jeweler.

This technology, developed by GEMFUND—an organization that supports artisanal women miners—is being piloted in Mwatate, where several women mining groups are having their gemstones digitally secured.

The organization has

partnered with Taita Gems to promote the market for digitally secured gemstones mined and value-added by artisanal miners. James Biss, the founder, says the blockchain used for mapping the gemstones employs the Traceability and Transparency Technology (T3) model.

This system addresses the challenges of widespread smuggling of precious stones and has even introduced special platforms for giving micro-royalties through M-Pesa to individuals involved in the value-addition process.

He discloses that this technology, developed by a team in Nairobi, will be rolled out across the country within the next year, where youths and actors, especially women in the artisanal and small-scale mining sector, will be trained on value addition and the integration of the T3 factor in locally mined gemstones.

He also predicts that once refined, the T3 model will be a highly sought-after technology to address many challenges facing the gemstone sector.

"This is a Kenyan initiative and invention that was born here but will be raised everywhere. We will spread this technology to miners across Kenya and beyond. Gems on the T3 network are slowly appearing in Kenyan shops and will be worldwide very soon," he

transparency variables are addressed, several related issues like labor practices and fair payments will also be addressed.

He points out that by curbing smuggling and increasing transparency in reporting on gemstones, this technology can be a formidable asset in driving the country's goal of having mining contribute 10 percent to Kenya's Gross Domestic Product.

Over the years, gemstone trade has been adversely affected by the proliferation of smuggled precious stones in the global market. There have also been concerns over human rights violations in the mining sector, including child labor and the exploitation of miners.

This has spawned a class of conscientious buyers keen on the history of precious stones in the market. These 'buyers of conscience' are often driven by fears that their purchases are indirectly supporting illegal activities like smuggling, promoting the exploitation of artisanal miners, or encouraging labor malpractices such as the use of children in the mineral extraction process. This technology helps address such concerns.

In the international gem market, the technology is also seen as a solution to multiple challenges, including brand theft and the misappropriation of gemstone identities. Smuggled minerals have often ended up in prestigious global exhibitions without giving credit to the source countries.

"This technology is introducing honesty and transparency in the gemstone sector," he says.

This transparency is

This transparency is reflected in the comprehensive data captured for each cut gemstone, which includes the mineral type, size, weight, color, shape, and location.

Other details include the faceter, the faceter's photo, the gem checker, the faceting grade, authorized store, broker details, information on taxes, contact information, the weight before and after faceting, and even whether fair payment was made to the miner.

Margaret Zigodi, 71, the chairperson of Rise and Shine, a women miners' Community-Based Organization (CBO) in Bura, Mwatate, is among the miners who have acquired skills in cutting, faceting, and inputting data for the T3 network.

## Boost to transport sector as varsity launches solar-powered tuktuk

A local university has developed an electric-powered tuk-tuk, marking a significant step in efforts to reduce carbon emissions from the transport sector in the country.

During an interview, Zetech University lecturer Prof. Gitau Kamau explained that the engine-less tuk-tuk operates on electric motors and has rechargeable batteries capable of lasting for more than 100 kilometers.

It also features integrated solar panels across its roof to harness solar energy, which charges the batteries.

Prof. Kamau noted that while it is built similarly to other tuk-

tuks, it is faster, with a speed of over 60 kilometers per hour. However, it is priced slightly higher than traditional tuktuks, at Sh450,000.

"We have assembled the tuktuk, installed electric motors, and added solar panels to recharge its batteries once they are depleted. It is noiseless, cost-effective, and clean," said Prof. Kamau during the University's Innovation Week.

He stated that his motivation was to provide efficient, cost-effective, and eco-friendly transportation, reducing reliance on conventional fuels and minimizing environmental impact.

"The vehicle does not use fuel,

thus reducing carbon emissions as well as making it cost effective during this time when the cost of fuel is high," he said.

The innovation is however yet to be released onto the market with Prof. Kamau decrying the high cost of e-mobility equipment used to assemble the vehicle which he said is a major challenge in the mass production of the tuktuks.

To make it cheaper for their manufacture, Prof Kamau called on the government to come up with policies that support adoption of e-mobility and ensure elimination of excise duty on body parts including steel, batteries and other accessories.

# Sh77m water infrastructure to boost supply in Makueni wards

akueni Governor Mutula Kilonzo Jr. has unveiled three water projects worth over Sh77 million in Kikumbulyu North Ward, which are set to benefit approximately 111,000 people.

In the Kiaoni area, Mutula inspected the extension of the Makaani-Kiaoni water pipeline by 4.4 kilometers. This project included the rehabilitation of the Kiaoni Water kiosk, the elevation of the tank tower, and the installation of a 10-cubic-meter tank at a cost of Sh4.3 million.

The Governor also commissioned a concrete reservoir tank with a capacity of 225,000 cubic meters, built by KIBMASCO Water Company in Kathyaka at a cost of Sh4.5 million. This reservoir will serve 6,300 people in the Ngulu and Nyayo clusters.

"The commissioning of these water development projects aims to ensure a safe and adequate water supply across Makueni County for domestic, irrigation, and industrial use," said Mutula at the Kiaoni market during the unveiling of the Ma-

kaani-Kiaoni water project.

In Athi, the Governor commissioned the Athi-Kilema-Tunguni water project, which has cost Sh68 million. This project is expected to benefit over 100,000 people in Kikumbulyu North, Makindu, and Nguumo Wards.

Among the scope of work includes construction of 250,000 cubic meters water tank at Mukononi hill and composite filtration, electromechanical systems for water treatment plant, distribution networks for Makindu, Kikumbulyu North and Nguumo Wards and the construction of four water kiosks.

Other works include installation of three panels of 100 Watts of solar, streetlights, installation of chemical injector pump and painting of the elevated tank components and gauge repair.

During the tour, Mutula also commissioned two Early Childhood Development Education (ECDE) projects where classrooms, stores, three door toilets and offices were constructed at Sh7 million.

In Kyaani and Katilani ECDE centres, two classrooms, a store, an office and three door toilets for each were constructed.

"My government has embarked on ensuring the ECDE learners learn in a good and conducive environment," said Mutula while unveiling the projects.



# Embrace skill acquisition, NCPD tells youths

The National Council for Population Development (NCPD) Director General Dr. Mohamed Sheikh has urged youths to embrace the various skill acquisition programmes of the government in order to reduce restiveness and unemployment among them.

Dr. Sheikh says that relevant skill acquisition for the youth is a necessary pathway to peace, poverty eradication and the realization of socio-economic progress.

Sheikh noted that learning a skill to improve oneself is an invaluable asset during these tough and challenging economic times.

He has urged the youth to embrace skills acquisition in addition to academic performance in view of the grim reality of unavailability of white-collar jobs in the country.

Sheikh says the youth should not shy away from blue-collar jobs such as carpentry and joinery, refrigeration and air conditioning, welding, masonry, mechanics, scaffolding, electrical and plumbing among other trades in their quest for a decent and better life.

"The increasing youth population should not see these kinds of jobs as a waste of time but embrace it to earn an income from the skills they have learnt," he said

Sheikh was speaking in Kwale during the dissemination of Sessional Paper No.1 of 2023 on national population policy for sustainable development where he encouraged counties to promote integration of population issues in development planning.

DG Sheikh says the goal of the NCPD sessional paper No.1 of 2023 on national population policy for sustainable development is to attain high quality of life for all Kenyans and contribute to the realization of national aspirations

He says Vision 2030, the national development agenda, recognizes the importance of integrating population dynamics in development planning for socio-economic development and wellbeing of the people.

The sessional paper seeks to promote integrated approaches to address population, environment and disaster challenges to achieve sustainable development, enhance availability, accessibility and utilization of reliable and timely population data by use of technology and innovation and increasing citizen engagement.

The NCPD DG stressed on the need for youths to embrace vocational training and acquire skills to be independent and urged them to embrace blue-collar jobs as a sustainable alternative to the elusive white-collar jobs.

The NCPD top official noted that the government has set up Technical Vocational Education and Training (TVET) centres across the country in a bid to pull millions mostly youths out of poverty.

"75 percent of our population is below 35 years of age hence investing in their potential with marketable skills is critical," said Sheikh adding that TVETs are the most practical avenue for youth to acquire work skills.

He says the youth bulge will continue for the unforeseeable future presenting great economic and social opportunities for the country but also enormous challenges necessitating rethink in youth employment initiatives.

Sheikh says investing in training on workforce will not only assist the country in developing talent to meet local needs but developing labour requirements to be used across the world.

He says the importance of TVETs in skill acquisition among the youth for socio-economic and technological development cannot be overemphasized.

Sheikh blamed the recent youth

unrest under the banner of Gen Z on a disengaged, disenfranchised and frustrated set of young people.

"These are frustrated youth and they are not happy at how they are locked out of economic and life opportunities," he said and called on all stakeholders to join forces in empowering young people to build a brighter future for themselves and their communities.

Msambweni sub-county Deputy County Commissioner Josphat Mutisyo says the government is committed to empowering young people, promoting gender inclusivity, and fostering a supportive environment for all.

Mutisyo says the government would continue to initiate and implement youth employment programmes and activities that would take the youth off the streets and make them valuable to the society.

He encouraged young people to leverage technology alongside vocational skills to engender national development and unlock a world of opportuni-

The DCC says high levels of youth unemployment creates economic strain as a large segment of the population remains dependent on social services thus increasing the burden on the government.

He also urged the youths to make good use of the skills acquired at TVETs during the training in order to positively impact other unemployed youths in their locality.

# State to focus on sustainable human development for economic growth

The Government is focusing on sustainable human development as a new vehicle to drive equitable and resilient economic growth countrywide in line with its Bottom-Up Economic Transformation Agenda (BETA).

The new policy framework emphasizes maximizing human capital potential and focusing on harnessing the demographic dividend to achieve sustainable development goals. The Director of the National Council for Population and Development (NCPD) Mr. Parveen Sigey who was speaking during launching of Sessional Paper No. 1 of 2023 on the Kenya National Population Policy for Sustainable Development in Mwatate Sub-County, Taita-Taveta County, underlined the organization's role in research and demographic statistics.

Mr. Sigey noted that the newly released sessional paper addresses critical issues such as population size and age structure, fertility, mobility and mortality, migration and urbanization.

The paper also addresses key issues including population and human settlement, youth unemployment, environment and disasters, data, research and innovation, and resource mobilization.

The Director emphasized the significant migration concerns in Taita Taveta, where urban-rural and rural-urban migration are affecting local development.

He also cited the high rates of early marriages and child mortality in the county, stressing the need for urgent action.

## New labour pacts with **Europe, Middle East to unlock** job opportunities for Kenyans

The government is pursuing nineteen bilateral labor agreements with Western European and Middle Eastern countries to help unemployed skilled Kenyans secure jobs abroad.

The State Department for Labour and Skills Development Principal Secretary, Shadrack Mwadime, stated that negotiations with various countries in these two regions are at an advanced stage, even as the government works to address rising unemployment in the country.

Mwadime mentioned that the government has concluded negotiations

with Germany, and the two countries are set to sign the agreement in September this year. This will open up opportunities for skilled Kenyans to work in Germany.

"We have had two rounds of negotiationsone in Germany and another here in the country. Germany has an aging population, whereas Kenya has a youthful population. We are set to sign the bilateral labor relations agreement this September so that our young people can secure jobs in Germany," he said.

The PS noted that sending Kenvans abroad is intended not only to address unemployment but also to boost Kenva's economy through diaspora remit-

Kenyans living abroad remitted Sh663 billion last year. He added that the comprehensive program to create more opportunities abroad is expected to increase this amount to Sh1 trillion.

Speaking during the Kisumu Job Fair, the PS said the bilateral labour agreements being pursued by the government target to ensure that Kenyans moving to foreign countries are not mistreated.

He added that the ministry is working with legitimate recruitment agencies to ensure that all Kenyans seeking jobs outside the country are pro-

cate from the country. We want you to work there for three to five years and come back to invest in the country and help grow our economy," he said.

The State Department for Labour and Skills Development, he said, has rolled out a national skills mapping exercise to help

identify gaps in skills development to ensure that the country's workforce has the requisite skills that meet industry needs.

This, he said, was informed by feedback from local employers, adding that once the exercise is concluded, it will inform changes in the curriculum to ensure all learning institutions produce graduates ready for the labour market.

Since the exercise started in February this year, so far 40,000 Kenyans seeking job opportunities have uploaded their skills on the National Employment Authority (NEA) website.

Even though the survey has been hampered by lack of funds, the state department is seeking partnerships with the Kenya National Bureau of Statistics (KNBS) and the Ministry of Youths to conclude the exercise, the PS said.

The two days' Job Fair, which brought together youths, students, Federation of Kenya Employers (FKE), Kenya National Chamber of Commerce and Industry (KNCCI), Universities and other learning institutions was critical to ensure that both job seekers and employers understand one another to help address unemployment in the country.

# Kenya's Gemstone sector set for growth with new regulations and strategic investments

The national government and key players in the mining industry have pledged to work together to rejuvenate and expand the country's gemstone sector.

The announcement was made in Taita Taveta County during the Gemstone Summit at the Gemstone Centre in Voi.

This initiative promises to harness the collective strength of both governmental support and artisanal miners' expertise to transform Kenya into a leading global hub for gemstone mining and trade. This year's summit, dubbed "Tsavorite Week," focuses on promoting the Tsavorite stone, a unique green garnet mined in several parts of Kenya.

The government has declared Tsavorite a strategic mineral to protect it, boost production, support small-scale miners, and enhance marketing and branding efforts.

The summit also celebrated the inauguration

of the Voi Gemstone Value Addition and Marketing Centre by President William Ruto in Octo-

ber 2023. This centre aims to promote

More mining committees have been established to issue permits ethical trade, traceability, and responsible sourcing of gemstones.

The Gemstone Summit drew stakeholders from various counties, bringing together key players from the mining industry. It highlighted the importance of collaboration, sustainable development, and the growth of artisanal and small-scale mining (ASM) while em-

phasizing the collective efforts to enhance Kenya's mining sector.

Speaking during the event, Dr. Patrick Kanyoro, the chairperson of the Kenya Chamber of Mines, emphasized the need for cooperation and compliance with regulatory frameworks, urging stakeholders to unite for mutual benefit. Kanyoro encouraged miners to participate in multiple business organizations to facilitate their mining activities.

"We must engage the government rationally and ensure we contribute to tax revenues for our own growth as well as for national development," Kanyoro said. Edward Omito, the Acting CEO of the National Mining Corporation (NAMICO), lauded the government for its substantial investments in the gemstone sector, stating that the state has injected over Sh50 million into the Gemstone Value Addition and Marketing Centre.

He also highlighted Kenya's rich diversity of gemstones, including green garnet, tourmaline, ruby, and sapphire, found across numerous counties.

In a speech delivered on his behalf by Omito, the State Department for Mining Principal Secretary (PS) Elijah Mwangi highlighted recent regulatory advancements under the Mining Act 2016. These include the publication of new regulations and the lifting of the mining moratorium, which had been in place since 2018.

"The mining moratorium, which had been in place since 2018, has also been lifted. This is a significant milestone as people interested in mining can now apply for mining licenses and permits to make the industry more robust," read part of his speech.

Mwangi stated that these changes are designed to foster sustainable governance and revitalize the mining industry by allowing new licenses and permits.

He praised the Association of Women in Energy and Extractives in Kenya (AWEIK) and the Kenya Chamber of Mines for their invaluable support to the mining industry.

He reiterated that the government has initiated several measures to support small-scale miners, including forming mining and marketing cooperative societies to facilitate organized mining operations and make it easier for miners to receive assistance.

Additionally, he noted that more mining committees have been established to issue permits and delineate productive mining areas.

Mwangi emphasized that the summit's objective is to foster ideas to improve the gemstone industry, attract investors, and enhance the capacity of small-scale miners.

He highlighted the importance of market days, stating that they provide small-scale miners with access to buyers and ensure fair trade practices. PS Mwangi encouraged gemstone traders to import and trade gemstones from other countries in Kenya, aiming to make Kenya a global gemstone hub.

He reiterated the government's openness to stakeholder input and collaboration to grow the mining industry. "I encourage our gemstone traders to venture outside our borders to bring gemstones from other countries and trade them in Kenya to make Kenya a gemstone hub, just like we have other hubs like Hong Kong and Bangkok," the PS said.

## Governor urges residents to register for affordable healthcare scheme

Ilgeyo Marakwet County Governor Wisley Rotich has announced an ambitious goal for every household in the county to be registered with the Social Healthcare Authority (SHA) by December 2024.

Governor Rotich highlighted the financial hardships that arise from extreme healthcare bills, which often plunge families into poverty. "Many have to sell their land to cover huge bills, especially in cases where a family member is diagnosed with cancer," he noted.

He emphasized the scheme's affordability, saying, "You pay

Dr Patrick Amoth, the Acting Director General for Healthcare Services, echoed Governor Rotich's sentiments, emphasising the transformative impact of the SHA on Kenya's healthcare system.

"The services we are unveiling today will enhance the health-

care department and enhance the lives of Kenyans considering the law," Dr. Amoth stated, highlighting the legal framework supporting the initiative.

He urged critical partners, stakeholders, teachers, political leaders, religious leaders, and the youth to join hands in this initiative.

"We need to walk this journey together for us to be able to succeed as a country," he said.

"The greatest ingredient required for countries globally to be able to achieve universal health coverage is political enlightenment, as the President has exhibited. Therefore, failure is not an option as we progress on this journey," he concluded.

## Laikipia women receive 50 water tanks to tackle perennial drought

Pastoral women in Laikipia North Sub-County have benefited from water tanks for water harvesting during the ongoing rainfall, aimed at cushioning them from perennial drought.

The 50 water tanks, each with a capacity of 3,000 liters, were donated by Habitat for Humanity Kenya in partnership with the Laikipia County government and distributed to women's groups in both Naibor and Kiandutura areas, which are most affected by dry weather.

"The tank will significantly boost my water storage capacity, ensuring sufficient water for both domestic and livestock use. At the same time, it will help me concentrate on other activities without worrying about water," said Zipporah Lang'at, one of the beneficiaries, during the handover exercise in Naibor, Segera Ward.

She further revealed that she previously spent most

of her time fetching water, which deprived her of opportunities to engage in other livelihood development activities.

Habitat for Humanity Kenya Programs Director Nixon Otieno said they are keen on supporting pastoral women to generate income through farming and livelihood diversification. Additionally, he pointed out that the tank donation initiative aligns with the government's agenda to increase agricultural productivity through climate-smart farming technologies.

Laikipia County Secretary Koinange Wahome lauded the initiative, noting that it would improve water accessibility in the county, which remains a challenge, especially during dry periods

"I am delighted that through this partnership, we are making progress in addressing water challenges. This effort aligns with our vision to distribute 50,000 water tanks by 2027 to residents," said Wahome.

## Relief for Kirinyaga residents as bulk water project opened

bout 400,000 residents of Kirinyaga County will now enjoy a steady supply of clean water following the operationalization of the new Kerugoya-Kutus Bulk Water Project.

The project, which sources its water from the Kiringa and Thiba Rivers, has increased water production from 10,000 cubic meters to 30,000 cubic meters per day, thereby ending perennial water rationing and shortages in most parts of the county.

This project, realized through collaborative ef-

forts between the national and county governments, is a significant milestone towards providing universal access to clean and affordable water in the county.

Major towns that are benefiting from the project include Kagumo, Kagio, Kerugoya, Sagana, Makutano, Kandongu, Kangai, and Mutithi. There are also plans to extend parallel lines from the intake to serve residents in upper Gichugu, including Karumandi, Baragwi, Kabare, and Njukiini wards.

Managed by the county government through the Kirinyaga Water and Sanitation Company (KIRI-WASCO), the project has enabled continuous 24-hour service, up from the previous 18-hour service, thus reducing water shortages and rationing.

The County Executive Committee Member (CECM) for Environment, Water and Irrigation, James Kinyua has noted that with an excess of 20,000 cubic meters of water produced per day, water services will now be extended to underserved areas.

"The project's treatment plant at Muratiri has also enabled the reduction of water turbidity to zero

and we can assure our residents that the quality of water has greatly improved and can be consumed from tap to mouth.

We conduct monthly testing to ensure that the quality is maintained," he said, noting that clean water will significantly reduce the prevalence of water-borne diseases and have a positive impact on socio-economic standards of the county.

Apart from enhancing water production and supply, the project has significantly addressed water loss during distribution thus reducing non-revenue water which in turn increases the county's revenue.

Residents have hailed the project as "the longawaited solution to the water woes in the county" since they are now enjoying clean water which is critical to their health wellbeing.

## Nyeri coffee factories to benefit from new solar dryers to cut operational costs

horong'i Coffee Factory in Ruring'u Ward, Nyeri Central Sub-County, is among the factories set to benefit from new solar dryers purchased to help reduce operational costs. The initiative, spearheaded by the Department of Climate Change, is part of the Financing Locally Led Climate Action (FLLoCA) program.

The project also complies with the National Climate Action Change Act of 2016, which mandates counties to integrate climate change actions into their development programs and governance structures.

The dryers will enhance the processing capacity and quality of coffee beans produced by the targeted factories. Nyeri County Climate Change Director Yvonne Mathenge said the county government hopes to extend the program to at least four other factories in the coming days.

"We had a budget to install three or four solar dryers and have already completed two. We are preparing to install one or two more in other areas. It is one of the priority actions we are taking in climate action and the optimization of production in the agriculture and manufacturing sectors," she told KNA.

One advantage of solar dryers over conventional ones, which rely on natural sunlight or electricity, is that the former are not affected by changes in weather or unintended

blackouts.

In addition, the temperature of the driers could always be regulated to avoid overheating which can affect the quality of the produce.

Ms Mathenge said the project not only promotes sustainable practices through harnessing solar energy but also supports the farmers in reducing processing costs and increasing their income.

The solar dryers will similarly help improve the drying process, leading to better preservation of coffee quality and a

higher market value for the product.

"We are encouraging the solar dryers because by the end of day it means they are saving on operation costs and it's an advantage for them (farmers). So, it is a good thing and it is making work easier because they are able to process more, use less time and incur less costs," she added.

Last year, the County Department of Water, Environment and Climate Change came up with a proposal that would see the county dedicate a percentage of its annual development budget to climate change mitigation.

The proposals were contained in the Climate Change Act and the Climate Change Fund Regulations.

The move was one of the first steps towards ensuring the county was able to fund climate change mitigation strategies.

"The Climate Change Act and the Climate Change Fund Regulations are proposing that at least one per cent of the county's development budget be set aside for climate change strategies.

"The model will be similar to the county integrated development plan where the county government dedicates funds in the budget to go towards the programmes," said Ms Mathenge regarding the new regulation.

"Our hope is that moving forward, climate change mitigation will not just be about dependency on foreign support. We want to ensure that as a county, we have a strategy that we can start implementing some of these measures even as we are looking out for external assistance," she added.

## IGAD gives Red Cross Sh20 million for flood-hit communities

The Intergovernmental Authority on Development (IGAD) has provided Sh20 million in financial support to the Kenya Red Cross Society (KRCS) to strengthen health services for communities affected by floods.

In April, the country experienced devastating floods that caused significant damage, resulting in over 200 deaths, numerous injuries, and extensive property loss and infrastructure destruction.

In a speech delivered on his behalf by the Director of Administration and Finance, Josephat Onyari, at a Mombasa hotel, IGAD Executive Director Dr. Workneh Gebeyehu noted that the recent floods had displaced over 300,000 people, destroyed 10,000 homes, and disrupted essential services, including healthcare.

"This immense disaster demands urgent and decisive action. IGAD, in collaboration with our esteemed partners, recognizes the pressing need to address the healthcare challenges faced by the affected communities," Dr. Gebeyehu said.

The assistance was made possible through contributions of IGAD member states which are Djibouti, Ethiopia, Kenya, Somalia, Sudan and Uganda and development partners to rebuild and strengthen healthcare systems in flood-affected counties.

Dr Geneyehu extolled the Red Cross for its dedication and effectiveness in responding to humanitarian crises across the country.

"Over the past year, they have provided emergency assistance to over one million people, showcasing their capability to mobilize resources swiftly and efficiently," Dr Gebeyehu said.

"Their compassionate actions have delivered life-saving medical care, shelter, clean water, and food to those in dire need, embodying the spirit of solidarity and humanitarian service," he added.

The Executive Secretary further commended the Red Cross for the setting up of over 50 temporary health clinics, distributing more than 100,000 hygiene kits, and ensuring clean water and sanitation for 200,000 individuals.

"The contribution is more than a financial transaction; it is a testament to our shared commitment to humanity. It reflects our belief that no community should be left behind, especially in times of crisis," Dr Geneyehu said.

He added that the support also underscores IGAD's dedication to strengthening health systems and building resilient communities capable of withstanding future challenges.

On his part, Red Cross Secretary General Dr Ahmed Idriss said the IGAD region has experienced a cyclic pattern of emergencies in recent times.

He noted that there are 83 per cent of climate change-induced disasters globally because of climate change.

# Youth State Department pleads with parliamentary committee for additional funding

The State Department for Youth Affairs and Creative Economy has requested Parliament to accede to its request for an additional provision of Sh1.94 billion under the recurrent vote and a further Sh126 million being the Government Fund for National Youth Opportunities Towards Advancement - Nyota under the Development vote to support youth projects.

Appearing before the Ms Alice Ng'ang'a-led Departmental Committee on Social Protection of the National Assembly at the Bunge Towers in Nairobi, the Principal Secretary for the State Department Ishmael Maalim Madey(pictured)said the request falls under 2024/25 supplementary estimates.

Madey requested the Parliament to consider the reinstatement of the State Department's allocation in respect of its capital projects as per the approved estimates for the Financial Year 2024/2025.

The PS disclosed that in the proposed supplementary estimates, the Youth Empowerment Centres (YEC) - BETA has zero allocation for the current 2024/2025 Financial Year, adding that others adversely affected are the Vijana Vuka na Afya and Youth Fund

Kenya among others.

Madey added that the Kenya National Innovation Agency (KeNIA) is also affected. He said funds towards hosting the Kenya Innovation Week (KIW) 2024 were slashed, significantly hampering efforts of successfully host the event which supports identification, nurturing and awarding innovators, mostly the youth and creatives.

Speaking during this meeting, KeNIA Chief Executive Officer Dr. Tonny Omwansa decried the shortfall of Sh50 million for the Kenya Innovation Week which is a flagship forum championed by President William Ruto in support of innovation in the country.

Dr. Omwansa noted that the proposed allocation of Sh104 million for the Agency's core mandate in the Financial Year 2024/2025 will negatively impact the financing of activities precedent to the establishment of technology transfer offices and supporting innovators across the country, among others.

He revealed that due to the austerity measures brought about by the supplementary budget estimates, establishment of technology transfer offices and running the popular Presidential Innovation Challenge and Award (PIA) will not be fully achieved because of the short fall.

Further, Dr. Omwansa pointed out that innovation is a catalyst for wealth creation.

"It is so vital that we invest in the value chain as a country if we are to solve the challenges of tomorrow, particularly enterprise creation, jobs and wealth generation," he said, adding that new ideas that address challenges need to be supported to develop into meaningful enterprises.

He said KeNIA has developed a ten-year innovation masterplan to guide Kenya's investment in the sub-sector which was launched by the President to serve as a great inspiration, educational and aspirational framework on what the country must do to create new jobs of the future, particularly for the youth.

For KeNIA to oversee the implementation of the mas-

terplan, there is need for appropriate funding, the PS said.

In the current strategic efforts of KeNIA, commercialization of research outputs as well as growth of the startup economy have been prioritized.

Responding to the issues raised, the Committee Chairperson, Ms Ng'ang'a, said the committee will do what it takes to restore the full allocation for the Agency given the critical role it continues to play in regards to incubation and innovation of ideas for the youth and creatives for economic sustainability.

"It is sad that during this critical time when the youth, more so, Gen-Zs are restless and are seeking for government's support and implementation of projects and fulfilment of key pledges for their improved livelihoods that such huge austerity measures are being experienced in this critical Youth Ministry," the Chairperson said.

Ms Ng ang a assured the State Department's team that the government, through Ministry of Youth Affairs, Creative Economy and Sports will continue to be supported to work towards ensuring that projects aimed towards the wellbeing of Kenya's Youth, are impactful and are felt by them, through enhanced budgetary allocations for their sustainability.



# KALRO's innovative project to produce 5.8 tonnes of early generation rice seeds

The Kenya Agricultural Livestock Research Organization (KALRO) has launched the development of a sustainable certified rice seed production system that is expected to transform farmers' livelihoods by providing affordable certified rice seed for improved productivity.

Through a five-year collaborative project with the Korea Partnership for Innovative Agriculture (KOPIA), KALRO will support the production of early generation seeds, the multiplication of certified seeds of elite varieties, and the distribution of certified rice seed to rice farmers.

Speaking in Mwea during the launch of the project, KALRO Director General Dr. Eliud Kireger said Kenya's domestic rice sector has not satisfied the increasing demand for rice. This issue has been exacerbated by the growth of the middle-class population and urbanization, with

more people relying on rice for food.

"Consumption of rice in the country is going up especially because of the young people who are abandoning 'ugali' and going for rice. Kenya's urban population is also projected to reach 50 per cent of the total population by 2050, which means their demand for food will lead to a significant deficit in milled rice," he said.

The DG explained that currently, the demand for rice per individual per year

is 28 kilograms but, looking at the current trends, Kenyans are expected to consume approximately 30 kilograms of rice per capita by 2027 translating to a total of 1.8 million metric tons of milled rice.

"Currently, we are consuming about 950,000 to a million metric tons of rice whereas we are only producing 200,000 metric tons, a deficit of 80 per cent and for us to be able to close that gap, we need to have a seed system which ensures affordable quality seed, so

that farmers are able to increase production," he observed.

He explained that to meet this demand, the government, through the Bottom-Up Economic Transformation Agenda under the 'reduce imports pillar', targets to have a compounded annual growth rate of 25 per cent in rice production.

"Hopefully in the next four to five years, we will have bridged that gap of up to 50 per cent to 60 per cent of what we are producing, and this will be done through improving access and availability of certified rice seeds of high yielding market preferred varieties to farmers," he added.

Dr. Kireger said that in any crop-based production system, the significance of seed quality and effective seed systems cannot be underestimated, saying that in Kenya, 90 per cent of the released and adopted rice varieties are open-pollinated varieties (OPV) and farmers often recycle grains as seeds

## Board warns public about false diabetes treatments

The Pharmacy and Poisons Board (PPB) has cautioned the public about false diabetes treatments, urging vigilance and reporting of anyone selling suspicious medicines.

PPB Chief Executive Officer Dr. Fred Siyoi said the Board received an alert from Interpol concerning the falsification of Ozempic pens (semaglutide). Apidra Solostar pens (glulisine), used to treat both type 1 and type 2 diabetes, have been falsely relabeled as Ozempic (semaglutide) nens

"Consequently, the Board would like to inform the public that Ozempic pens are currently not registered or authorized by the Board to be placed in the Kenyan market.

Therefore, any product being marketed as Ozempic pens is illegal in the market, and the Board cannot ascertain their safety, quality, and effectiveness," Dr. Siyoi explained.

To safeguard public safety, he said the Board has initiated a rapid response and heightened surveillance to verify whether the falsified Ozempic pens are presently circulating in the Kenyan market.

"The Board cautions the public and healthcare professionals against trading, distribution, wholesaling, retailing, issuing, dispensing, use or administration to patients of the falsified Ozempic pens, as such actions are illegal and jeopardise public health and safety," the CEO said.

He called on members of the public and healthcare professionals to immediately share any information regarding Ozempic pens with the Pharmacy and Poisons Board.

## Mount Kenya region to benefit from Sh63b water and sanitation development scheme

The Tana Water Works Development Agency (TWWDA) is seeking KSh 63 billion to enhance water supply and improve sanitation services in five counties in the Mount Kenya Region over the next five years.

These proposals are outlined in the 2023-2027 Strategic Plan, which aims to increase access to quality water services from 57.8 per cent to 90per cent by 2027. Additionally, the agency targets increasing sanitation services from 8.1per cent to 30 per cent by the end of the implementation period.

To achieve these goals, TWWDA will rely on the government to contribute KSh 8.5 billion in support of the projects. These projects will be implemented in Embu, Kirinyaga, Nyeri, Tharaka-Nithi, and Meru counties.

Public Private Partnerships will contribute Sh 30 billion to the plan while Sh 21.7 billion will be sourced from development partners. and the remaining Sh 3.5 billion will be sourced from income generating activities within the Agency. Speaking at a Nyeri hotel during the launch of the strategic plan, TWWDA Chief Executive Officer, Eng. Philip Gichuki said

that the Agency intends to implement 32 water projects in its bid to increase water coverage throughout the five counties. Additionally, the Agency has lined up 14 sanitation projects which will cost it Sh 8 billion to implement.

"We aim to achieve 90 per cent water coverage by 2027. The strategic plan has set out very specific targets covering specific counties.

We have big water supply projects that we really want to reach the population within these counties with adequate water supply. When we do the water projects, we also need to ensure that waste that is generated is handled. Therefore, we will also be having a component for waste management," noted Eng Gichuki.

The projects include the construction of a Sh 1.6 billion water supply project in Embu county which will benefit at least 250,000 residents and a Sh 1.1 billion bulk water supply project for Kirinyaga targeting 100,000 residents of Kirinyaga South East.

The Water Agency is also planning to construct a dam in Timau, Meru County at the cost of Sh 9.3 billion while in Nyeri the Agency has listed the construction of Muhoya Dam at the cost of Sh 10.44 billion as a key project.

#### High hopes for Team Kenya as Paris 2024 Olympics beckons

Sports Principal Secretary Eng. Peter Tum is optimistic that Team Kenya will bring home at least eight gold medals from the Paris 2024 Olympic Games.

Eng. Tum was speaking at the Ministry's office at Talanta Plaza as the National Olympic Committee of Kenya (NOCK) made public the final list of the Kenyan contingent to the games.

contingent to the games. Kenya's best performance in the history of the Olympic Games was in 2008 during the Beijing Olympics, where the country bagged a total of 16 medals: six gold medals, four silver medals, and six bronze medals.

"I am not an athlete, but I am confident this team is going to bring home at least eight gold medals. The preparations have been top-notch both locally and internationally through their federations, and the team that we are sending to Paris is the best," said Tum, who will be the head of the delegation for the team and the highest-ranked government official. He added, "I want to thank President William Ruto for flagging off the team on July 5th and ensuring that the allowances this

time are at an all-time high. This kind of motivation assures us of many medals." "Apart from participating

'Apart from participating in the Olympics, Kenya will also be showcasing several aspects of itself. We will be showcasing our tourism prowess as the best destination in Africa, we will also be looking into trade, and that is why we have curated a Kenya House in Paris."

The team comprises 81 athletes, 33 team officials, 26 members of the management team, and five members of the Olympic family. It is a leaner team compared to the contingent that travelled to the Tokyo 2020 Olympic Games.

Nock president Paul Tergat said the over 80 athletes had come across different sports, namely: athletics, rugby, fencing, volleyball, judo, and swimming.
