Government begins appraisal of new funding model for higher education

Presidential Working Party on Education Reforms (PWPER) findings, the differentiated unit cost, a previous criteria used by the government to disburse funds to tertiary institutions, had plunged universities and technical training institutes into huge debts

The Ministry of Education commenced the appraisal of the New Funding Model (NFM), currently used to disburse funds to students in universities and technical training institutes, two years after its inau-

guration. The model was unveiled in May last year following recommendations from the Presidential Working Party on Edu-cation Reforms (PWPER) report.

According to the PWPER findings, the differentiated unit cost, a previous criterion used by the government to disburse funds

to tertiary institutions, had plunged universities and technical training institutes into huge debts. While officiating the launch of the NFM evaluation exercise at a Naivasha hotel, Higher Education and Research Principal Secretary Dr. Beatrice Īn-

Mr. Stanley Loter, the County Director of Mineral Resources, says the region's initial outlook is a camouflage that conceals the vast economic opportunities the land harbors.

"This land's appearance is deceptive. This is a virgin treasure trove that contains the key to our economic transformation and takeoff," says Mr. Loter.

huge deposits of Kenya's rarest and most precious minerals. There are pre-

cious, construction, and strategic minerals, creating a resource-laden tapestry in a marginal-ized region that sits on hundreds of millions in potential revenue.

The Cabinet Secretary for Mining, Blue Economy and Maritime Affairs Salim Mvurya says the minerals in Turkana County can trigger unprecedented growth in the region supported by an enabling environment to promote sustainable exploitation.

yangala (pictured) said the adoption of the model was meant to help universities resolve the financial woes facing them.

The Principal Secretary said the move to review the model is informed by the desire to identify and address obstacles arising from its implementation.

"We are committed to overcoming these obstacles and ensuring that every student has the opportunity to pursue higher education without financial barriers," she said.

She said the model is designed to align funding with the needs of individual students rather than institutions.

"This approach aims to better address the diverse economic backgrounds of our students and ensure that financial support is available to those who need it most", added the Principal Secretary. Dr. Inyangala also described the model as a transformative step towards a more equitable and effective education funding system in the country.

She said NFM introduced

several key changes including delinking placement and funding.

"Placement by the Kenya Universities and Colleges Central Placement Service will now be based on merit and choice. Students will apply separately for financial assistance, including government scholarships and loans "explained the PS.

She said the model further enables the government to disburse funds in form of scholarships and loans to deserving students as guided by a means testing instrument.

"The model additionally provides for actual funding criteria based on the cost of University programs", added the Principal Secretary. Similarly, Dr. Inyangala said the new formulae facilitates universities to benefit from diversified funding streams, including student financing, research grants, capital infrastructure grants as well as consultancy services.

On categorization of applicants, the PS noted that NFM classifies student into five bands based on household income levels.

ernments collaborate to create efficiencies in licensing and enforcement to rid the region of illegal operations.

The CS was accompanied by Principal Secretaries Elijah Mwangi, Mining; ms Besty Njagi, Blue Economy and Geoffrey Kaituko for Maritime Affairs.

"We working with the county to exploit mining potential. With the Artisanal Mining Committee in place, we can issue licenses and monitor operations to have investors pay royalties for distribution to residents," he explains.

Occupying a land size of 68,000 square kilometers, Turkana County is the second largest devolved unit after Marsabit. While the local vibrant culture characterized by spectacular dances, the breathtaking colorful traditional regalia and the iconic desert lake have become symbols of Turkana's people enduring pride and

identity, the real miracle with a promise for economic transformation lies under the arid surface.

The region has confirmed presence of over 21 high-value minerals. They are construction; asbestos, silica, gypsum to precious stones; rubies, sapphires and garnets and strategic like chromite and coltan. There are also radioactive elements including samarskite and pitchblende that fall under uranium class.

Mr. Joseph Ekiru, chair of Turkana County Artisanal Miners, says mineral occurrences have been reported across the county. He adds that benefits from full exploitation will eclipse other sectors, making mining the main factor driving Turkana's economy.

"This mineral giant is awakening. The minerals will become the ultimate gamechanger for growth and progress for this county," he said.

Mineral data shows

extensive distribution that cuts across Turkana. Areas like Nadapal and Lokitang have gold deposits with reports showing a major gold belt runs through Kainuk to the South in Nakwamoru, Maruputh and Loima. Blue sapphires are in Kaeris and Malpus while red and green garnets are in Kaputirr.

This area also has graphite; a high-value mineral used in refractory and manufacturing of batteries.

State Department re-distributes vaccines across the country to address shortage

The National Vaccines and Immunization Programme (NVIP) is redistributing current stocks of available routine vaccines across the country to ensure eligible children do not miss vaccinations during this critical period.

The State Department for Medical Service Principal Secretary, Harry Kimtai, stated that they are undertaking this as an urgent stop-gap measure.

He added that they are closely engaging with UNICEF to expedite the delivery of vaccines ordered after the last payment. Kimtai explained that the Ministry is tracking vaccine consumption at all levels nationally and facilitating redistribution between counties to alleviate the stock-out situation.

"A total of Sh1.25 bil- steadfast-PS

lion has been set aside to urgently procure routine antigens and replenish the life-saving vaccines in our health facilities," explained Kimtai.

The PS further elaborated that despite logistical challenges from the current heavy rains, the Ministry and partners are fast-tracking the shipment of vaccines, expected to arrive by the first week of June 2024.

"Our commitment to the health and well-being of all Kenyans remains steadfast, and we are working diligently to address any challenges

in our immunization program," assured

Our commitment to the health and well-being of all Kenyans remains steadfast-PS Kimtai.

He continued: "We are aware of reports of vaccine shortages of routine antigens across health facilities in the country.

"Currently, there are stockouts of key vaccines, with less than two months of stock available nationally for traditional vaccines such as the BCG Vaccine, Oral Polio Vaccine, and Measles Rubella Vaccine."

Kimtai added that stock levels for most other routine childhood vaccines, including those supported by Gavi (Pneumococcal, Rotavirus, HPV, and Malaria vaccines), are low, with only three to six months of stock available.

These stockouts, Kimtai said, put children and vulnerable populations at risk of vaccine-preventable diseases and potential outbreaks.

"Recognizing that immunization is one of the

most effective public health interventions, we are committed to ensuring a consistent and uninterrupted supply of vaccines," said the PS.

He highlighted that Kenya has benefited from a robust immunization system for over 44 years, and as a Ministry they are dedicated to ensuring future generations enjoy full and healthy lives.

"Mechanisms for "accelerated transition planning" from Gavi support are being set up, including exploring innovative options for sustainable financing of vaccine procurement and program operations," he said.

The PS added that they are engaging the National Treasury to ensure increased and dedicated resources are allocated to the immunization program.

"Ring-fencing domestic resources will ensure sustainable financing for immunization, especially as donor support for vaccines continues to decrease," said Kimtai. He said that during this period, the Ministry is coordinating closely with healthcare workers and keeping them informed on measures to alleviate the current situation. "We urge all caregivers to liaise closely with their healthcare providers and bring their children back to the facilities once stock levels have normalized," said the PS.

Kimtai highlighted that they understand the importance of maintaining an uninterrupted supply of vaccines and are taking every necessary step to address the current stock challenges.

"Our goal is to ensure that all Kenyans have access to life-saving vaccines and to maintain high immunization coverage across the country," said Kimtai

Ministry, KNBS team up for comprehensive basic education institutions census

The Government, through the Ministry of Education and the Kenya National Bureau of Statistics (KNBS), has launched the 2024 census for basic education institutions in Kenya.

The State Department for Basic Education Principal Secretary, Dr. Belio Kipsang, maintained that the purpose of the school census is to gather accurate and comprehensive data about students, teachers, infrastructure, and resources.

This data, according to the PS, is the bedrock upon which the Ministry will build its plans, policies, and strategies to enhance the country's ed-

ucational landscape.

"Accurate data is indispensable. It helps us identify gaps and disparities within our system, enabling us to address them effectively. It also allows us to understand where resources are most needed and to ensure that every child, regardless of their background, has access to quality education," Dr. Kipsang stated.

He added that data-driven decisions lead to better educational

This means better facilities, more targeted teacher training-Kipsang outcomes, improved school environments, and equitable resource distribution.

Speaking during the event at Moi Girls' School in Nairobi, the PS said the benefits of the census are vast and with the information collected, the Ministry will be able to plan more effectively, allocate resources more efficiently, and monitor and evaluate the country's educational programmes with greater precision.

"This means better facilities, more targeted teacher training, and improved curriculum development, all aimed at fostering a conducive learning environment for our students," he added.

Calling upon school

administrators, teachers, parents, and students to cooperate fully in ensuring the success of this process, Dr. Kipsang noted that the census is not just a government initiative, but a collective effort that requires the active participation of all stakeholders.

"Your involvement is crucial to ensuring the accuracy and completeness of the data we collect," he reiterated.

Further, the PS revealed

that the Ministry will use advanced technology and innovative methodologies to streamline data collection and processing, terming the approach to conducting the census as transparent and methodical.

This, he said, will help the Ministry overcome challenges such as logistical issues and ensure the integrity of the data even as the Government remains steadfast in its commitment to improving the quality of basic education.

Additionally, Dr. Kipsang disclosed that the Ministry is continuously working on initiatives to enhance educational standards and infrastructure and that the insights gained from this census will inform its policies that will help drive longterm improvements and reforms.

"We recognize the potential challenges in conducting the census, from logistical hurdles to ensuring data accuracy. However, we have put in place robust strategies to address these issues, including comprehensive training for data collectors and rigorous data verification methods," he said.

The PS noted that the data from the census will provide the foundation that will guide the government in creating an education system that serves all children in Kenya.

These roads have enhanced the potential of Bungoma and Western region as part of the Bottom-up approach that supports job creation and urbanization.

Speaking during the inspection of the roads in Bungoma town, Eng. Silas Kinoti, KURA Director General lauded the efforts by leaders and local investors in supporting private investment within the town.

Eng Kinoti noted that roads play a vital role in building investor confidence and connecting people.

Ūrbanisation is very critical in fulfilling the Sustainable Development Goals through uplifting people's living standards and providing human dignity while opening up access to services and

improved securit,." he said. Eng Kinoti disclosed that Kenya Urban Roads Authority has upgraded new roads and improved existing ones as part of enhancing connectivity and contribute to the socio-economic development of the region.

'Under the Annuity Road Programme, KURA has overseen the construction a road network totalling to 14.7 kilometres.

The network includes Bungoma-Mateka-Samoia-Muslim Primary C33, spanning 6.3 KM, which was constructed at a cost of Kshs. 638,460,000.00 and Mateka-Mwanda-Siritanyi A104, measuring 8.4 kilometres, constructed at a cost of Kshs. 851.2 million," said the Director General.

Additionally, Eng Kinoti pointed out that KURA has also undertaken the improvement of several roads totalling 6.5 km at a cost of Kshs. 385 million within Bungoma town

in preparation of the Madaraka day celebrations slated for 1st June, 2024.

These include Stadium Roads, Wamalwa-Kijana High School Road, Elegant Road, Kanduyi DEB - Lusaka, West FM Loop Road, and Khetias Back Street Road.

'These roads have greatly benefitted residents of Bungoma through increased agricultural production, reduction in transport cost, job creation, increase in land value and improved service delivery.

Other towns within Western region have also benefitted in road infrastructure. The towns include Kakamega-(9.4 km Kakamega-Ilesi-Rosterman-Emaondo Road), Vihiga-(6.0 km Vihiga-Chavakali-Munoywa-Kiritu) and Busia-(5.0 Musia Jn B1-Alupe Jnc C43 Bypass) respectively," said Eng Kinoti.

The Director General said that these infrastructural developments are a testament to Government of Kenya's commitment to transforming urban mobility in western region and county at large.

The Bill is to provide for the establishment of the Kenya Veterinary Council; to provide for the training, registration, licensing, practice and employment of veterinary surgeons, veterinary para-professionals and veterinary specialists; to provide for the regulation of animal health training institutions; for the regulation of animal health and welfare; to provide for the establishment of the Veterinary Medicines and Vaccines Authority, for the regulation of veterinary pharmacy; to provide for the regulation of veterinary medicines, vaccines and other biologicals, nutrients and for connected purposes. Thus, a highly skilled human resource is required to provide services at all levels of the Animal Resource Industry development as provided in the Sessional Paper No. 2 and 3 of 2021 on the Veterinary Policy and the National Livestock Policy respectively.

Proposed PWD bill promises tax relief for parents of disabled children

arents of children living with disabilities will benefit from the proposed Persons with Disabilities (PWD) Bill, 2023 once it is enacted.

Nominated Senator Ms. Crystal Asige assured parents and caregivers of children with disabilities of tax relief once the Bill she has sponsored is passed by the Senate and assented to law.

Speaking at Makupa Primary School in Mvita Sub-County during the handing over of cooking items worth Sh120,000 to parents with disabled children, Senator Asige said enacting the bill will be a big relief to suffering parents.

The Senator, through her empowerment program dubbed the 'Ability Programme', aims to empower parents of children with disabilities. Every month, the Senator will be visiting all the six wards in Mombasa, she said.

"This is just the first one, it won't be the last. We want to inform parents

that they are not forsaken, and they can do small businesses through the cooking items to support their children," Senator Asige said.

As a disabled Senator, Asige added that she recognised the efforts that parents and caregivers of children with disabilities put into feeding and educating their children, hence it is important to support them. She thanked her parents for supporting her to reach the high echelons of leadership.

"I have written in the PWD Bill that parents and caregivers should be allowed to get income tax relief of up to Sh150,000," she said, adding that caregivers of children are usually forgotten.

"As PWDs, we have tax exemption, but we have never looked at parents

who take care of children with special needs," she said.

She lamented PLWDs still face accessibility challenges in accessing buildings. The Senator, in partnership with the Mombasa County Disability Leaders Forum has petitioned the National Gender and Equality Commission (NGEC) to assess buildings in Mombasa.

"The CEO of NGEC came with his team to Mombasa. He realised that there is a big problem with accessibility, especially of government buildings. They

will work closely with us in ensuring the buildings are renovated for PLWDs to access them," Senator Arige said.

The nominated Senator has also drafted the Kenya Sign Language Bill, which once is passed in the Senate and the President assents to it, she said, will ensure sign language is incorporated in the country's education curriculum. The Senator is also pushing the Ministry of Health to augment her efforts in sensitizing families on how to take care of children born with disabilities.

Christine Mungai, a mother with a child with Severe Cerebral Palsy thanked the Senator for the project that will enable her to earn a living.

"I appeal to parents with disabled children not to hide them. They are not a curse. They will get assistance once we bring them out, let's not discriminate against them," Mungai said. Abdalla Shaaban, a father with a mentally challenged son, urged the government to sensitize parents with disabled children not to hide them.



Itare Dam revival promises 3,000 jobs for locals as construction begin

onstruction of the stalled Itare dam in South Rift will resume this September after the government allocated funds for the project in the current budget.

Government Spokesman Isaac Mwaura said the resumption of work is part of the government's efforts to build over 100 water dams over the next five years countrywide, as it actualizes its plan to enhance access to clean and safe drinking water.

Speaking in Nakuru when he led a delegation of state officials on a tour to establish the status of government-funded projects in the devolved unit, the Spokesperson indicated that the project would create over 3,000 jobs for locals, 70 percent of which would go to them.

In March, the Cabinet gave the Treasury the nod to enter Alternative Dispute Resolutions (ADR) with contractors of three dams, including Itare, Arror, and Kimwarer.

Once completed, the Itare Dam will have the

Mwaura said the construction of Itare dam stalled at 11 per cent in terms of civil works and was 27 per cent complete overall

engaged the Italian Government on this project that they were funding, and we are glad that the project is set to resume. We have been talking to the people on issues of wayleaves and land compensation that the govern-ment will take care of," the Spokesman noted.

While appreciating the importance of the project to residents of Nakuru and its environs, Dr Mwaura indicated that once the project commences, no hitches would be ex-

We are looking into ways of supporting the contractor through the supplementary budget to seek out the compensation and wayleaves as the contractor works on the dam and main trunk." he noted, adding that the community would be supported to back up the conservation efforts to sustain the water flow.

The contractor, the spokesman said, will work on the main trunk as the government works on reticulation through the last mile connectivity to homes and businesses around the county to satisfy the demand of 80,000 cubic metres of water, with the surplus expected to reach Naivasha.

The national government, he added, is committed to fast-tracking infrastructure projects in Nakuru.

This would be achieved through the National Government Development-County Implementation, Coordination and Management Committees (NGD-CICMC).

CS announces special programs for floodaffected arid counties

The government has set up special programs to address the needs of all arid and semi-arid counties during the current ravages of floods and beyond. East African Community, ASALs, and Regional Development Cabinet Secretary Ms. Peninah Malonza said each of the 23 counties often ravaged by drought will receive Sh250 million to restock flocks killed by drought last year.

The Cabinet Secretary, who spoke in Kajiado County when she visited flood victims and witnessed the distribution of food aid, added that the Government will acquire 50,000 acres of land in the 23 counties plus ten others to start ranches for cattle fattening and resale to Middle East countries.

"President William Ruto has his government focused, like never

before, on the welfare of pastoralist communities and set up special programs to promote their economic empowerment," she said. Malonza noted that the Government will also fund pasture development, provide veterinary services and ensure skins and other livestock products like skins fetched money instead of being thrown away as is the current practice.

She said the Government had mooted various initiatives meant to boost community resilience and infrastructure development in areas prone to natural disasters like droughts, floods among others.

CS Malonza who was accompanied during the tour by Kajiado West MP George Sunkuyia, Principal Secretary Kello Harsama and local leaders visited Esonorua, Eroret Primary School, Magadi, Kamukuru, Shombole, Olerai, and Ngurumani in Kajiado West Constituency.

Government unveils 'DRIVE Project' to cushion pastoralists against natural disasters

The State Department for Livestock Development, in collaboration with the Kenya Development Corporation and insurance companies, has initiated a project aimed at bolstering resilience in the livestock sector among Kenyan pastoralists.

This project seeks to strengthen their ability to withstand disasters and enhance their financial capacity for necessary investments.

According to Jonathan Mueke, the Principal Secretary for Livestock Development, the project, dubbed "DRIVE" (De-Risking, Inclusion, and Value Enhancement of Pastoral Economies), will enhance productivity and market penetration for pastoralists in Kenya.

In a press release to media outlets, Mueke emphasized that the

"DRIVE" project aims to improve pastoralists' access to financial services for drought risk mitigation, integrate them into value chains, and facilitate livestock trade in the Horn of Africa.

Mueke revealed that during the last drought cycle, which concluded in 2022, Kenya lost over 2.5 million livestock, resulting in significant economic losses for households and the country.

To fortify the sector against such losses, Mueke stressed the necessity of multi-sectoral approaches to mitigate losses and de-risk critical investments for access to fodder, value addition, and markets.

"The DRIVE project is in line with the Government blueprint which is committed to provide adequate capital through well managed farmer organizations and deployment of modern risk management instruments such as crop and livestock insurance

schemes for profitable and predictable incomes by sector players" Mueke said.

The initiative, according to the PS also aims at improving the saving culture in Arid and Semi-Arid (ASAL) regions as a way of building resilience to mild shocks and accumulation of long-term capital.

Mueke said, in part-nership with the World Bank, the Government of Kenya through State Department for Livestock Development in collaboration with twenty one county governments is executing this project through implementing agents like Zep-Re for de-risking pastoralists through an insurance product and saving incentives and the Kenya Development Corporation (KDC) for access to capital for livestock value chain actors and jointly access to markets and livestock traceability systems.

"DRIVE's incentives, which have so far reached over 138,000 pastoralists in twelve counties with insurance and saving incentives has had over Sh2.7 billion in benefits transferred to pastoralists through government insurance premium subsides, savings bonuses,

and insurance sector claims payouts.

"The Cabinet Secretary, Simon Chelugui, for Cooperatives and MSMES has been instructed to prepare a memo to be presented to the Cabinet so that we can start afresh," he stated.

The Deputy President added that the Ministry

of Cooperatives would soon disburse to farmers the second batch of the Cherry Fund at a rate of Sh40 per kilo.

He emphasized that the government is keen to support farmers to increase production and sales of the cherry.

The Deputy President has been leading reforms in the Coffee, Tea, and Dairy sub-sectors for the small-scale farmer to



earn more. Mr Gachagua said reforms in the tea sub-sector are bearing fruits and farmers' income has increased.

He spoke during the funeral service of his former teacher at Kianyaga High School, Mwalimu Julius Kano Ndumbi, 73.

Mr Ndumbi was the Principal of Kianyaga High School when the Deputy President was a student there. The Deputy President eulogised Mr Ndumbi as an educationist and disciplinarian, who loved and shaped the lives of many young people.

Cruise liner defies tropical storm 'IALY' to dock at Mombasa Port

ore than 300 tourists aboard the cruise liner Ms Insignia braved strong winds and storms occasioned by Tropical Storm 'IALY,' which hit the Kenvan coast, to sail to the Port of Mombasa. According to the Kenya Meteorological Department (KMD), IALY intensified to a tropical cyclone. It will remain offshore despite passing within 150 kilometers of the Kenyan coast.

Vessels calling at the Port of Mombasa were not affected by the storm. The manager of the vessel, Laurence Badasse, with 357 passengers and 396 crew members, stated that the vessel was not full, as some passengers had disembarked in Dubai.

The 26-year-old Marshall Islands-flagged vessel was supposed to go through the Suez Canal but was rerouted to Africa because of the security crisis on the Red Sea. Vessels were forced to go through the Cape of Good Hope in South Africa to reach Europe.

"The itinerary changed back in February dictating that we go through Africa to reach Europe as the Suez Canal is not safe therefore some of our guests were given the op-

tion to go home if they did not want the new itinerary. Normally, we will be sailing with 608 guests,"

said Badasse.

"We so much wanted to come to Kenya that we braved the storm that trav-

elled between Madagascar and the Kenyan coast. We had two rough sea days before we reached. We are glad we made it on time

and safely," she added.

The next stop for the vessel is Zanzibar, before heading to Mozambique and the final call in Cape Town before heading back to Europe.

Kenya Tourism Board Chief Executive Officer (CEO) June Chepkemei said they are pleased to see the rebound of cruise tourism after the Covid-19 pandemic that disrupted the sector.

tatistics from the Tea Board of Kenya indicate that the tea industry contributes about 23 percent of total foreign exchange earnings and two percent of the agricultural GDP, with over 450 million kilograms of tea produced annually, earning the country over Sh120 billion in export earnings and Sh22 billion in local sales.

Speaking during the inaugural Tea Belt Conference and Innovation Exhibition held in Kericho to celebrate the strides made in the tea industry, which brought together key stakeholders in the tea industry, participants noted that the tea sector supports about five million people directly and indirectly, while an estimated 650,000 tea growers depend on it, making the industry one of the leading sources of livelihood in the

The Kericho County Director for TVET, Dr. Peter

Cheruiyot, who was the chief guest at the event, underlined the critical role of TVETs as the bedrock of capacity building, enhancing skills and knowledge for the players in the agricultural sector.

Dr. Cheruiyot said participants in the conference would benefit from various topics that were discussed in depth, including innovations in teaproduction, sustainable farming practices, and the integration of modern technology into traditional agricultural methods.

"Tea has been more than just a crop; it has been a cornerstone of our economic development and cultural identity, and TVETs enhance the industry by imparting agricultural knowledge and skills, especially to the young people," Dr. Cheruiyot said.

At the same time, the Kericho County Chief Officer in charge of Trade, Industrialization and Cooperative Management Mr. Willy Rop, pointed out the critical role of TVET in

fostering economic development, highlighting the need for continuous innovation and skill development to maintain Kenya's competitive edge in the global tea market.

"Kericho's tea industry stands at the forefront of our economic achievements, by investing in vocational education, we equip our workforce with the skills needed to drive sustainability and innovation in tea production," Rop aaded.

Ministry of Health identifies hypertension as growing health concern in Kenya

BY ROSELYNE KAVOO(KNA)

The Ministry of Health has flagged hypertension as an emerging healthcare problem in the country, with at least 24 percent of Kenyans suffering from the condition.

Dr. Issak Bashir, the Director of Family Health, states that out of the 24 percent of those suffering from hypertension, only 22 percent of the patients have initiated treatment.

Bashir mentioned that a paltry three percent of those undergoing treatment have achieved control of the non-communicable disease (NCD), terming the prevalence of the disease as alarming and underscoring the need to create awareness for early detection and management.

"The statistics are alarming. Hypertension was labeled a disease of the affluent, but it is now affecting many people from low socioeconomic backgrounds," Dr. Issak said.

The director called for the prioritization of screening for prevention and early detection, saying hypertension progresses unnoticed until complications arise.

"Screening is the cornerstone of high blood pressure management; it is the first step to taking proactive measures to mitigate potential risks. Regular monitoring also enables people to track their progress and make informed decisions," he added.

Dr Issak called for collaborative approach from stakeholders to enable access to quality health care for management and treatment of hyperten-

The director disclosed that the Ministry of Health has put in place a raft of measures to strengthen primary health care services and promote preventive strategies for the

"We have mobilized community health volunteers (CHVs) and equipped them with blood pressure monitors to screen people

at the community

Hypertension was labeled a disease of the affluent, but it is now affecting everyone-Kimeto

level. The CHVs also play a pivotal role of conducting patients' follow up and facilitating referrals, if need be," he noted.

Issak further added 96 per cent of primary health care facilities are equipped with blood pressure machines, enhancing the ability to detect hypertension early.

"The government has also availed medication in all levels two and three health facilities for management of the NCD," the director said.

Speaking Machakos during celebrations to mark the World Hypertension Day, Dr Issak also launched the guidelines for NCDs which will ensure services for the diseases remain uninterrupted in case of emergencies like the COVID-19 and the floods and called on county governments to adhere to the guidelines.

The Acting Chief Executive Officer (CEO) for Kenya Diabetes Management and Information Centre Joan Kimeto said the prevalence hypertension continues to rise both locally and globally and reiterated the need for screening.

Kimeto said most of the hypertension cases go un-diagnosed due to the asymptomatic nature of the disease, leading to poor health outcomes.

"Hypertension, iust like the majority of other NCDs, only show symptoms once the disease has progressed hence the need for screening for early detection and man-

agement," she said. The acting CEO also called on patients to adhere to instructions given to them by health care workers for easy management of the disease.

"We are also encouraging people to eat healthy foods, exercise and avoid consumption of alcohol and smoking of cigarettes which can predispose them to the disease and other NCDs," Kimeto noted.

Present was Machakos County Executive Committee Member for Health Dr. Daniel Yumbya who disclosed that the county government has availed medication for hypertension in all levels two and three health care facilities.

The proposed dam will submerge the existing two rivers dam and therefore the current production (12000M³/day) of the existing two rivers dam will be lost. The selected dam type is Roller Compacted Concrete Dam(RCC) of structural height 39.3m high with an Overflow Ogee Spillway(126m) stepped spillway chute and a stilling basin. Other key features of the proposed dam include: Riverbed Elevation(2150masl), Storage Level(2173.55masl), Full Supply Level(NWL);2180.3Masl), maximum water level at floods (2182.80masl), Dam Crest Level (2184.3masl), Dead Storage 6.62Mm³, Live Storage 9.06Mm³,Total Dam Volume 15.686Mm³, Area Inundated at Full Supply Level 1.74Km². The raw water from the one river will be transmitted to the Amanga Water Works for treatment before distribution to consumers. The project will be located in Namanga town in Kajiado County.

The following are the anticipated impacts and proposed mitigation measures:



KRA, public health officials join forces to strengthen tobacco regulations compliance

The Kenya Revenue Authority (KRA) and the State Department of Public Health and Professional Standards (SDPHPS) have joined hands to boost adherence to Tobacco Regulations in the country.

The strategic partnership between the tax collector and the State Department focuses on

streamlining processes, enhancing control, and strengthening regulatory compliance in the tobacco industry. The Principal Secretary for the State Department for Public Health and Professional Standards, Ms. Mary Muthoni Muruiki, said several key initiatives have been introduced under this partnership, which include the efficient collection of solatium compensatory funds from importers and manufacturers of tobacco products intended to support public health programs aimed at reducing tobacco consumption and mitigating its health impacts. The PS, who was speaking at the KRA Times Tower headquarters in Nairobi after paying a courtesy call on the Taxman's Commissioner-General Humphrey Wasanga, said the agree-

ment will streamline the collection process.

Kenya aims to surpass pre-Covid tourism numbers with German partnerships

The Ministry of Tourism and Wildlife is seeking collaboration with German investors to enhance the country's appeal as a destination of choice among German tourists.

According to Tourism Cabinet Secretary Dr. Alfred Mutua, the ministry hopes to leverage previously untapped opportunities in the sector to surpass the pre-Covid-19 numbers of 200,000 by the end of this year.

While delivering the speech on behalf of CS Mutua during the German Business Delegation Conference held at a Nairobi hotel, the Principal Secretary for the State Department for Tourism, Mr. John Ololtuaa, said the ministry is relying on partnerships with countries like Ger-

many to diversify its products as well as support the development of its facilities to achieve the projected targets. "There are a wealth of possibilities awaiting exploration by both Kenyan and German companies. Investments in parks and conservancies present an exciting frontier for collaboration, particularly in the establishment and furnishing of numerous

lodges and hotels, state-

of-the-art facilities, and a high level of services," said Dr. Mutua.

The conference which is themed "Exploring Business Opportunities in the tourism sector for Kenya and German companies" has brought together six German companies that are seeking to venture into the Kenyan market or extend their services by setting up shop in the country.

It comes barely two

months after the ministry through the Kenya Tourism Board participated in the International Tourism Bourne, in Berlin with a view of linking Kenya to the German market. During the expo, KTB also sought to strengthen Kenya's appeal to both existing and emerging markets.

Dr. Mutua said that through the collaborations with German companies, which are renowned for their conservation efforts and sustainable practices, the country was on its way to creating unique and memorable experiences for its visitors while at the same time prioritizing sustainability and responsible tourism practices.

"Whether it is investing in infrastructure, developing new attractions, promoting cross-cultural exchanges, or contributing to wildlife conservation efforts, together, we can chart a path towards a more vibrant tourism industry," said the CS.

Last year, there was a notable surge in German visitors, rising from 53,498 in 2022 to 77,907, translating to a 146 per cent growth

Multi-billion Mwache multi-purpose dam takes shape as Dongo Kundu Bypass nears completion

oast Regional Commissioner (RC) Rhoda Onyancha has urged constructors to strictly adhere to project completion timelines for the coastal communities to derive economic benefits from mega infrastructural projects undertaken by the government.

Onyancha was speaking during a National Government Development-Regional Implementation Coordination and Management Committee (NGD-RICMC) project monitoring visit to the Mwache multi-purpose dam, Dongo Kundu bypass, and the Shimoni Fishing Port project in Kwale County.

The construction of the multi-billion Mwache multi-purpose dam in Kwale County is rapidly gathering pace as the constructor works around the clock to realize the project objective of upscaling water production.

The Coast Region Water Security and Climate Resilience Project (CR-WSCRP), being implemented by the Ministry of Water, Sanitation, and Irrigation, aims to increase bulk water supply to Mombasa and Kwale counties sustainably and

to increase access to water and sanitation in Kwale County.

The dammed water will also be used for irrigation purposes, with more than 6,000 acres of land expected to be under irrigation for food production in Kwale. The project is designed to have a main dam, lower check dam and upper check dam.

The main dam with a height of 84 meters (m) and a crest length of 526m will have a capacity of 127 million m3 of water. It will harness water flow

from the Mwache River basin for domestic water supply.

The dam will supply 186000 m³ of water in a day to the Port City of Mombasa and the expansive Kwale County.

Concrete works are ongoing at the diver-

The project will promote trade facilitation between Kenya and her neighbours

sion channel of the main dam and the stilling basin of the lower check dam, and an aggregate crushing plan has been set up for aggregate stockpiles.

The land acquisition had slowed the kicking off and the handing over of the Kenya Government and World Bank (WB) funded project.

The WB is supposed to disburse United States dollars (USD) 255 million (equivalent to Sh33.7 billion, at current exchange rates) for the construction while the Kenya Govern-

ment will cater for land compensation at USD 45 million (Sh5.9 billion).

RC Onyancha assured the constructor of security that they work 24 hours to ensure the timely completion of the project that commenced last year.

The project is at ten per cent and is scheduled to be completed in June 2027

The RC further directed Kwale County Commissioner Stephen Orinde to be firm for the project and not be derailed by local politics.

"Don't allow that. We have timelines," said RC Onyancha, urging the Kwale administrator to work with other security agencies to facilitate seamless construction.

The NGD-RICMC team later crisscrossed the long dual carriageway Dongo Kundu bypass that nears completion.

The Sh22 billion bypass involves the construction of an interchange at the Likoni-Lunga Lunga highway and two bridges at Mwache – covering 660 metres, and another at Mteza straddling 1,440 metres. The Mwache Bridge is 100 per cent complete, the Tsunza Viaduct 99.2 per cent, Mtenza Bridge 97.6 per cent.

At the tail end its con-

struction, the bypass is poised to be a game changer as it will not only connect three main transport corridors: The Mombasa-Nairobi highway, Mombasa-Malindi highway, and the Mombasa-Lunga Lunga highway but also reduce congestion at the Likoni ferry crossing channel.

The project aims to provide road connectivity to the South Coast including the 3000-acre Dongo Kundu Special Economic Zone (SEZ) for socio-economic development, and connection to/from the Moi International Airport and SGR Miritini terminus thus improving tourism in Diani.

The project will also promote trade facilitation between Kenya and the neighbouring countries.

The Sh2.6 billion Shimoni Fish Project is 61 per cent complete. It involves the construction of a Modern Jetty of 75m x 30m with a causeway of 135m long x 7m wide, a warehouse accommodating a Fish Processing Plant, Cold Storage, and Ice-Making Plant.

The project will also entail the construction of a port access road, port gates and support facilities such as offices and washrooms, a Power Sub-station including a generator (500KVA), a water storage tank (250CM), and a goods warehouse at the existing Jetty side to serve the general public.

NGOs warned against embezzling funds meant for flood relief

¬ast African Com**d** munity, ASALs, and **⊿**Regional Development Cabinet Secretary Ms. Peninah Malonza has urged non-governmental organizations involved in humanitarian assistance for flood victims to genuinely channel the funds they raise towards alleviating the suffering of the affected communities.

Malonza stated that many organizations are raising money and other forms of assistance for flood victims, but the resources are not reaching the victims.

"Let nobody take advantage of the suffering of flood victims by raising funds but then pocketing the money instead of channeling it to help them," she said. She, however, thanked bilateral bodies, friendly nations, and other partners who have come out to help flood victims across the country.

Speaking at Tara area during her tour of Tana River County to assess the ravages of floods in the county, Malonza said the government was committed to tackling persistent floods in the area.She

said the Government will resettle people living on riparian land along River Tana and set up ranches in the area to support pastoralist communities living on the Tana Delta.

She also witof food and nonfood aid to flood victims which included rice, beans, fortified Unga, mattresses and other household items.

During the tour, she visited Garsen, Tara, Marafa, Hola among other areas where the floods have damaged infrastructure, farms marooned and schools, homes and other public and private facilities.

Tana River Senator Danson Mungatana urged the Government to hasten the construction of the High Grand Falls Dam along River Tana to curb flooding in the county.

He said the area had not rained at all but the floods were ocassioned by waters that flowed from Mt Kenya and spillage from up-

nessed distribution

stream dams.

Garsen MP Ali Wario said 80% of Garsen Constituency was flooded leaving more than 15 primary schools either marooned or heavily devastated by the floods.

He said many children were yet to return to school and appealed to the Government to assist in reconstruction of the schools.

Tana River County Commissioner David Koskei said more than half of the county was affected by floods.

He said that the County and National Governments, local leaders and development partners were working together to develop a strategic plan to bring a lasting solution to persistent floods and turn the waters to gainful use.

EU awards Sh113.6 million grant for global plant breeding project

The European Union has announced a Sh113.6 million grant towards a plant breeding and biotechnology project aimed at mitigating the impacts of climate change.

This project will be conducted by a consortium of eleven institutions of higher learning spread across the globe. Kenya's Egerton University has been named the lead institution, which will coordinate the three-year project titled 'Building Capacity in Plant Breeding and Biotechnology Education and Research through Partnership Program in Africa, the Middle East, and Europe for Agricultural Transformation' (BREEDTECH).

This project also brings together institutions from Ethiopia, Palestine, Italy, Serbia, Sweden, and Austria. Egerton University's Vice Chancellor, Prof. Isaac Kibwage, stated that the initiative will focus on developing and implementing a harmonized curriculum in Plant Breeding and Biotechnology across the consortium countries.

Additionally, it aims

to improve the skills and competence levels of 12 students and 24 academic staff in teaching and research activities from African and Palestinian universities.

The VC noted that the project, spanning from 2024 to 2027, is expected to enhance agricultural technologies for better productivity, sustainability, and environmental safety by developing, equipping, and modernizing research facilities and infrastructure on Plant Breeding and Biotechnology in the 11 institutions.

Prof. Kibwage observed that biotechnology development remains a top priority in enhancing food security, evolving more efficient and cleaner industrial manufacturing processes, and reducing negative effects on the environment in the country.

"Evidence shows biotechnology has aided so far in increasing

Evidence shows biotechnology has aided so far in increasing food production

food production as scientists aim at making it beneficial too to the environment", elaborated the

Dr Miriam Charimbu, a crop production and protection specialist and Professor Paul Kimurto, a Crop Physiologist, both from Egerton University have been listed as Principal Investigator and Co-Principal Investigator respectively in the project.

Egerton University has been allocated Sh13, 638,528 to undertake the coordination work of the project.

The partner institutions include Laikipia University (Kenya), Haramaya University (Ethiopia) Oda Bultum University (Ethiopia), Al-Quds Open University (Palestine) and An-Najah National University (Palestine).

Others are Pixel - Associazione Culturale (Italy), Institute of field and vegetable crops (Serbia), Sant'Anna School of Advanced Studies (Italy), Swedish University of Agricultural Sciences (Sweden) and BOKU -University of Natural Resources and Life Sciences (Austria).

Prof. Kibwage added

that through the venture a total of 150 students from partner universities will participate in knowledge transfer, with 8 centers and laboratories being upgraded alongside development and reviewing of 20 curriculums.

The packages also entail development of six research projects in plant breeding and biotechnology, establishment of three BREEDTECH incubators and development of the BREEDTECH Massive open online course (MOOC) in African and Palestinian universities with support from Institutions of higher learning in selected European countries.

According to Prof. Kibwage, to ensure that the project has a broad impact across the target regions, plant breeding and biotechnology incubators will promote innovation and product development to support startups and entrepreneurship skills which turn their ideas into successful businesses.

Crop production and protection specialist Dr. Charimbu, indicated that while the project will encompass training of graduate and post graduate students and staff in Plant Breeding and Biotechnology, it will also mentor young institutions of higher learning to develop and review their programs in Plant Breeding and Biotechnology across the consortium countries.

Kakamega County Government launches free cattle vaccination campaign to safeguard livestock health

The County Government of Kakamega has embarked on a comprehensive free cattle vaccination campaign to prevent a possible spread of diseases into the county from the neighboring counties of Bungoma and Trans Nzoia.

The targeted diseases are Foot and Mouth, Lumpy Skin, Black Water, and Anthrax in cattle, while dogs and cats will be vaccinated against rabies.

Speaking during the launch of the campaign at Koromait area of Chekalini location in Lugari Sub County, Livestock Production, Veterinary Services, and Fisheries Development Chief Officer, Jessica Wesonga, said they target 100 percent coverage across the

Wesonga, who urged residents to avail their animals for vaccination, said the campaign is geared towards enhancing cattle health and improving livestock productivity in tandem with Governor Fernandes Barasa's agenda of improved food security

and wealth creation. She said: "We are ready, and the vaccines are available. I am appealing to all farmers to avail their animals for vaccination, which is free of charge.

"We are pitching camp

here in Lugari and Likuyani for four days before moving to other sub-counties.

"We have had an outbreak of Foot and Mouth disease in the neighboring sub-counties within

Bungoma and Trans Nzoia Counties. "We do not want to take chances and that is

why we are launching the vaccination campaign in these border sub counties so that our farmers do not incur losses.

She said the vaccines are adequate and her department's target is to achieve 100 percent coverage within the shortest time possible.

"For the vaccines that will remain we shall place them at the sub county headquarters so that farmers whose animals will not have been vaccinated within the stipulated time frame will take them there."She said.

Wesonga disclosed that her department recently undertook another successful livestock vaccination exercise in Ikolomani and Shinyalu sub counties following an outbreak of Anthrax disease.

The County Director for Veterinary Services Christopher Kadenge said the vaccination exercise against the listed diseases is essential to farmers and will ensure they earn better profits from their cattle and the milk will be of high quality.

The diseases are already affecting cattle in the neighbouring counties. We are taking precaution by vaccinating our animals to protect them from contracting the diseases and leading to farm losses."he explained.

Kadenge said dogs and

cats will also be vaccinated against rabies and owners issued with certificates.

He however said that for the cattle, there will be no issuance of certificates although they are contemplating doing so in future to ensure farmers avail all their animals for vaccina-

"It will also be an indicator that you value the county's fight against animal diseases once you take your cattle to the market for sale."he explained.

Koromait Assistant Chief Wilkister Barasa lauded residents for heeding to the animal vaccination call and turning up in large numbers.

"The number of cattle and dogs is high. However, that of cats is discouraging although we had asked those with cats at home to bring them." She said noting that cats just like dogs are dangerous once they scratch a person with their claws or bite them.

Koromait residents Emmanuel Nyongesa and Agneta Akonya lauded the county government for the free vaccination exercise saying it will save most farmers from the high vaccination cost.

They asked the county government to always avail free vaccines to farmers so that they can continue reaping benefits from animal rearing.

Poisons Board and partners forge alliance against illicit health product trafficking

The Pharmacy and Poisons Board (PPB) is holding stakeholder engagement forums to focus on tackling illicit trade in health products and technologies (HPTs) which are transmitted via courier and postal services in order to safeguard public health.

Under the stewardship of the Regulator's Executive Officer, Dr. Fred Siyoi, the Board underscored the need for collaboration among stakeholders to thwart the circulation of unauthorized medical products, including narcotics and psychotropic substances.

Dr. Siyoi re-affirmed the Government commitment to combating drugs and substance abuse, and underscored PPB's vigilance in the monitoring

"By strengthening enforcement mechanisms and enhancing coordination among agencies, the PPB and its partners are poised to make significant strides in preserving the integrity of the health supply chain and safeguarding public well-being" Siyoi declared.

DP Gachagua urges international support for climate initiatives

The Deputy Pres-Rigathi ident, Gachagua, is appealing to international partners to enhance support for climate change programs in the country.

Gachagua stated that the government has scaled up responses to climate change to mitigate occurrences such as severe droughts, enhanced rainfall, and floods, as witnessed in the country recently, called for more global support.

Speaking as he hosted the Common Board of Trustees of the Center for International Forestry Research (CIFOR) and the International Centre for Research in Agroforestry (ICRAF) at his official residence in Karen, Nairobi, the DP said the ongoing program targeting the planting of 15 billion trees by 2032 would greatly benefit from partners' support.

"Climate change is real. We have an ambitious program of planting trees as one of the mechanisms we have identified to combat the negative effects of climate change. I appeal to you for your expertise and technical advice for this program to come to fruition," he said.

The DP said Kenya has suffered the brunt of climate change which has manifested in the form of five failed rainy seasons that led to severe drought that hit the country, and enhanced rainfall that has led to destructive floods.

Kenya is the host country of ICRAF (also known as World Agroforestry Centre) which has been merged with the Center for International Forestry Research

During the event attended by Board Chair Doris Capistrano, Vice-Chair Alexander Müller and ICRAF Director General Éliane Ubalijoro, Irrigation Principal Secretary Ephantus Kimotho among others, Mr Gachagua praised the organisation for lasting collaboration in environmental conservation and promoting agroforestry.

"The Cabinet Secretary for Information, Communication, and the Digital Economy, Eliud, has lauded the critical role played by technology in transforming the agricultural sector in Kenya through the use of new digital tools and devices.

Speaking in Nandi, Owalo said that the way farmers grow crops and how they end up at the final consumer is now shaped by dramatic digital evolution.

The CS noted that with the use of information and communication technology, farming is changing for the better, hence improving food security and foreign exchange in our economy.

"Mechanical harvesting has led to improved efficiency in tea harvesting, leading to improved productivity and saving on cost of production," he noted.

He however expressed concern over cost constraints to maintain the tea harvesting equipment among the small-scale farmers.

He said the government is keen on growing value-added tea exports, expanding the market base and product diversification in green tea, purple and tea extracts with the aim of bettering farmer's returns.

The CS pointed out that the tea sub-sector is one of Kenya's leading foreign exchange earners, accounting for 25 per cent of the country's total foreign exchange earnings.

Agriculture and Livetock Development Cabinet Secretary Mithika Linturi, who also graced the occasion hailed the establishment of the China-Kenya Tea Trade Centre saying it will widen Kenya's tea market in China and improve the welfare of tea farmers especially the smallholder farmers.

Stakeholders resolve to have informal sector workers register for pension schemes

enyans in the informal sector have been urged to join pension schemes and commence saving for retirement to secure a good future once they exit from their jobs.

According to statistics by the Retirement Benefits Authority (RBA), despite the total assets under management amounting to over Sh1.7 trillion as of December 2023, only 26 per cent of the labour force is actively saving for retirement.

Speaking during the official opening of a fiveday Huduma clinic in Mombasa meant to educate residents on the critical importance of saving for retirement, RBA Chief Executive Officer (CEO) Charles Machira said the public needs to be informed that formal employment is not a prerequisite for pension scheme enrolment, and it is important to save and plan for retirement.

Machira also urged

stakeholders in the pension industry, including the media, to reverse the trend of poor saving for retirement by enlightening Kenyans on the importance of retirement savings and the various options available.

He noted that sensitization through the Huduma clinic plays a profound significance particularly when considering the alarming statistics indicating that approximately seven out of 10 Kenyans face the risk of falling into poverty upon retirement due to inadequate savings.

"The initiative targets informal sector workers, with the goal of enlightening them on the various avenues available for retirement savings.

"Additionally, for those already engaged in the sector, we continue to provide free retirement preparation training for scheme members nationwide," he said.

He added that RBA is closely collaborating with other stakeholders, such as the individual pension plans represented, to raise awareness among all Kenyans regarding the importance of retirement savings.

He said instances of retirees encountering challenges in accessing their pension benefits have been noted over the years and promised to do a follow up and ensure every retiree gets their benefits 30 days after the day of retirement, as prescribed by the law.

Huduma Centre Chief Executive Officer Mugambi Njeru said Huduma Centres are ready to partner with RBA and bring services closer to the people, ensuring accessibility and inclusivity for all.

Mombasa Deputy County Commissioner Ronald Mwiwawi said the initiative will offer a prime opportunity for residents to learn how to start saving and secure their future.

Mwiwawi said the government is steadfast towards ensuring citizens do not retire into poverty and is promoting a culture of saving for retirement as a crucial step in achieving the goal.



Kenya emerges as a key US ally in sub-Saharan Africa as two countries deepen 60-year ties

The visit highlights the country as an important investment destination, its crucial role in regional security and stability and fast-rising status as a digital hub



resident William Ruto's historic State Visit to the US last week has elevated Kenya's international standing, marking a significant moment for the country's diplomatic relations.

The visit highlighted Kenya as an important investment destination, its crucial role in regional security and stability and fast-rising status as a digital hub in the continent.

Kenya without doubt won big during the visit after bagging various multibillion shillings deals that span across various sectors, including healthcare, education, road and transport, digital technology, security, agriculture and climate mitigation.

The impact of the deals would certainly transcend beyond the borders, spreading the country's influence.

"We are stronger - and the world is safer - when Kenya and the United States work together," US President Joe Biden said.

Kenya, said President Biden, would be designated as a key non-NATO ally, making it the first country in sub-Saharan Africa to have the symbolic title.

The designation reflects Kenya's role in regional security, especially in counterterrorism operations and raises its standing from a regional player to a global partner.

As a non-NATO ally, Kenya joins other

countries with the title namely Argentina, Australia, Bahrain, Brazil, Colombia, Egypt, Israel, Japan, Jordan, Kuwait, Morocco, New Zealand, Pakistan, Philippines, Qatar, South Korea, Thailand and Tunisia.

Kenya will further receive multiple security equipment including helicopters and Armored Security Vehicles from the US to strengthen the country's security operations, including the fight against terrorism especially in Somalia where the nation has 5.000 troops.

President Ruto's State Visit further kickstarts a new era of technology cooperation with the US, including in areas such as AI, semi-conductor making, cybersecurity, data and internet access.

During the tour, Kenya signed with Microsoft and its partner G42 a deal worth Sh132 billion (\$1 billion) to implement various tech infrastructure projects revolving around AI and data in a project dubbed the Comprehensive Digital Ecosystem Initiative.

Ruto and his host US President Joe Biden at

the White House.

This is the largest single private-sector digital investment in Kenya and would accelerate digital investments in the country.

One of the deliverables under the project is the building of a state-of-the-art green data centre in Olkaria, Naivasha, which will run entirely on renewable geothermal energy, supporting Kenya's green energy agenda.

Through the centre, Kenya is expected to benefit from cloud data opportunities and business since Microsoft and G42 will work with the ICT Ministry to design and operate the new East Africa Cloud Region as part of a "trusted data zone" based on global standards to protect digital safety, privacy and security. from G42 and Microsoft, Kenya will establish the new data centre as part of a "trusted data zone" under which data from other countries may be governed by their local laws, even while stored and resident in Kenya," Microsoft said in a statement.

Kenya, which has been pushing for a more connected Africa, received a boost through its partnership with Google, which announced the first ever fibre optic cable to directly connect Africa with Australia.

The cable dubbed Umoja is anchored in Kenya, and will pass through Uganda, Rwanda, Democratic Republic of the Congo, Zambia, Zimbabwe, and South Africa, "before crossing the Indian Ocean to Australia. Umoja's terrestrial path was built in collaboration with Liquid Technologies to form a highly scalable route through Africa, including access points that will allow other countries to take advantage of the network," said Google.

The US has also committed to designate Kenya as a semi-conductor partner, with the country becoming the first in Africa to benefit from funding in the Chips and Science Act of 2022, which provides Sh6.9 trillion to boost the production of computer chips in and out of the US.

"This designation will cement Kenya-US tech industry relationships. Kenya will be among less than IO countries with that status, unlocking new market and opportunities for investments," ICT PS, Eng. John Tanui said.

These investments are a huge benefit to Kenya's digital transformation agenda, where the government is providing free public Wi-Fi, has pushed over 16,000 services online, trained over 390,000 youths in digital skills and is working to build 100,000km of fibre optic cable.

Trade across East Africa will also benefit once the construction of a 440km Mombasa-Nairobi expressway is completed. Kenya National Highways Authority (KENHA) signed Sh471 billion (\$3.6 billion) deal with US infrastructure investment manager Everstrong Capital that will see the building of the highway enhancing movement of goods from port of Mombasa to neighbouring countries.

The road makes the Northern Corridor, which links landlocked countries of the Great Lakes Region, including Uganda and Rwanda to the sea-port of Mombasa.

Fergus Kell, the Projects Manager and Research Analyst, Africa Programme at Catham House, observed that in President Ruto, the US has found an assertive international leader, "with a track record of promoting African solidarity and a keen awareness of the new partnerships possible in a multipolar world."

He added that visit offered policymakers in US and Kenya an opportunity to strengthen "foundations for long-term partnership".

President Ruto said the agreements arising from the State Visit represent a strategic investment in Kenya's future, promising significant economic growth, job creation, and improved quality of life for its citizens.

For the United States, these deals not only strengthen ties with a key African country, but also open up new opportunities for trade and geopolitical influence in the region.

How ministry will curb vaccine stockouts

Medical Services PS Kimtai says the institution is engaging Treasury to increase allocations to the immunisation programme to curb reliance on donors

he government will transition from the reliance on Gavi, the Vaccine Alliance, in acquisition of the life-saving medicines as it seeks to ensure there is no

Mr Harry Kimtai, the Principal Secretary for Medical Services, said the transition is one of the options the government is exploring as part of sustainable financing of vaccine procurement and programme operations.

"We are engaging the National Treasury to ensure increased and dedicated resources are allocated to the immunisation programme," said the PS.

He noted that ring-fencing domestic resources for the vaccine programme will ensure sustainable financing for immunisation, especially as donor support continues to

He added that stock levels of routine childhood vaccines like rotavirus, pneumococcal, HPV and malaria were low.

To alleviate the problem, he said the government had allocated Sh1.25 billion for urgent procurement of life-saving vaccines and it is closely engaging Unicef to expedite

"The Ministry is tracking vaccine consumption at all levels nationally and facilitating redistribution between counties to mitigate the stock outs," said the PS.

According to the Ministry of Health, when

a stock out of a particular vaccine occurs, patients should be immediately referred to the nearest facility known to have the acquired the vaccine to reduce unacceptable intervals between doses.

Vaccines are most successful and cost-effective way to prevent diseases like poliomyelitis, and reduce morbidity and mortality from several other illnesses.

The government, through its National Vaccines and Immunisation Programme, provides 14 primary vaccines and five others namely Hepatitis B, anti-snake venom, anti-rabies, yellow fever and typhoid.

The vaccines are provided to more than 1.5 million infants and a similar number of pregnant women and 700,000 young girls ear through a network of health facilities - public, private, faith based and NGOS, free of charge, according to the Ministry of Health.

The Kenya National Immunisation Policy Guidelines 2023 provides that every child born in the country must be immunised to reduce mortality and morbidity from vaccine-preventable diseases.

"Kenya has benefitted from a robust immunisation system for over 44 years and the government is dedicated to ensuring future generations enjoy full and health lives," said Mr Kimtai.■

- All immunisation services shall be at all immunising health facilities provided on all working days and on demand.
- **♦** All efforts shall be made to screen children for vaccination status on joining school.
- All immunising health facilities shall report through the Ministry of Health systems as prescribed on all vaccines administered whether they are procured by government or private entities.
- All vaccines for human use in Kenya must meet quality requirements as determined by the Pharmacy and Poisons Board and must be duly approved for use within the country by the Pharmacy and Poisons Board.
- All vaccines for human use must be certified as safe under normal circumstances of use.
- Where the safety profile of a particular vaccine or immunological component cannot be guaranteed but the risk of the disease is serious, then the vaccine/immunological component must receive Emergency Use **Authorisation from the Pharmacy** and Poisons Board and should be administered after obtaining informed consent from the client.
- All vaccines intended for simultaneous use with other antigens must have proven immunological efficacy in the presence of the other vaccine and must not significantly interfere with the immune response to the other vaccine.

New cybersecurity requirements aim to safeguard public sector organizations

The Public Sector Accounting Standards Board (PSASB) has announced the release of an exposure draft on the Cybersecurity Topical Requirement by the Global Institute of Internal Auditors.

Topical Requirements are one of the three key elements of the International Professional Practices Framework® (IPPF), alongside the Global Internal Audit Standards™ and Global Guidance adopted by the Public Sector Accounting Standards Board (PSASB).

According to the PSASB Acting CEO, Georgina Muchai, the Cybersecurity Topical Requirement provides a comprehensive approach to assessing the design and implementation of cybersecurity governance, risk management, and control processes and is applicable to those who are specifically auditing this

The Cybersecurity Topical Requirement, Ms. Muchai said, further seeks to assist public sector entities in establishing policies and procedures related to cyber-

security governance, risk management, and control processes, in a bid to enhance cybersecurity practices and risk management processes, strengthen the control environment, internal audit functions, and effectively manage cybersecurity risks across their operations.

'The implementation of the Cybersecurity topical requirement will enhance the protection of public sector entities' information assets from unauthorized access, disruption, alteration, or destruction and strengthen the overall control environment to reduce risk," the CEO stated.

She said cyberattacks can lead to direct and indirect impacts that are often significant, as computers, networks, programs, data, and sensitive information are critical components of public sector entities.

"Since entities heavily rely on information technology resources, having clearly defined a cybersecurity plan, objectives, inherent risks, and effective controls should be a priority for management," PSASB Acting CEO, Georgina Muchai

The CEO said the cybersecurity topical requirement consists of three sections, namely Cybersecurity Governance, Cybersecurity Risk Management, and Cybersecurity Control Processes. Each section contains a set of requirements that public sector entities are expected to adhere to.

She said Kenya is facing a significant surge in cybersecurity attacks, with frequent strikes occurring daily on websites and ICT systems of public sector entities.

Most of these attacks exploited system vulnerabilities, which may be attributed to the proliferation of Internet of Things (IoT) devices, which are inherently insecure, the latest Cybersecurity Report from the Communication Authority of Kenya indicates. Ms. Muchai said this alarming trend, heightened by the advent of artificial intelligence (AI), not only jeopardizes the online presence of public sector entities but also undermines the trust and integrity of Kenya's digital economy.

Bandari Academy to train Turkana youth as coxswains

One thousand youths in Lodwar, Turkana County, will benefit from coxswain training to be conducted by Bandari Maritime Academy and Kenya Maritime Authority, which will enable them to gain employment at sea. Additionally, fifty more youths will benefit from scholarship training in life jacket making.

Speaking during a community meeting in Kalokol, Turkana County, the Cab-inet Secretary for Mining, Blue Economy, and Maritime Affairs, Salim Mvurya, underlined the importance of training youths in the coxswain course for the purpose of job creation and utilization of the lake's water resources.

Mvurya who led a delegation of senior government officials from the Ministry including three Principal Secretaries (PS for min-ing Elijah Mwangi, PS for Blue Economy and Fisheries Betsy Njagi and PS for Shipping and Maritime Affairs Geoffrey Kaituko) underscored the importance of maintaining safety standards when conducting activities around Lake

The CS also urged the local community to move away from riparian land and give way in order to avoid calamities due to rising waters in the lake.

The Principal Secretary for Shipping and Maritime Affairs Mr. Geoffrey Kaituko stated that the Ministry was looking to expand services of shipping and maritime not only at the coastal areas but to other counties that have water bodies in form of lakes and rivers.

The PS also urged the community to utilize opportunities available in the Lake. The PS who is part of the committee of five-year Lake Turkana Management Plan emphasized that plans are underway to enhance and improve services in the Lake region.

Turkana County Governor Jeremiah Lomorukai noted that Turkana has a potential to connect communities through a shipping line.

Uasin Gishu County to distribute 383,000 coffee seedlings for crop diversification

The County government of Uasin Gishu will distribute 383,333 coffee seedlings to farmers across the county to promote crop diversification in a program designed to promote highvalue crops as an alternative to traditional maize, wheat, and others, aiming to boost farmers' income through foreign exchange.

Uasin Gishu Deputy Governor Eng. John Barorot indicated that the county government has elaborate plans to involve youth in the future in coming up with certified nurseries to achieve the target acreage of 3.000 in a period of five years and will be launched across all six sub-counties by the governor.

Additionally, the county will also distribute 17,500 avocado seedlings to farm-

tude wards like Tarakwa for multiplication. The program will also include other activities to enhance livestock production.

"As a way of empowering the youth economically and

ers across the county and enhancing sustainability, 50,000 clones in high-alti- we will be supporting them and other local players to produce the required seedlings through cooperative societies," Eng. Barorot said.

The national government's target to produce coffee within three years is

150,000 metric tonnes while the County Government of Uasin Gishu targets to produce 31,500 metric tonnes of coffee. "This financial year, we have an elaborate program to promote cash crop farming, and our lead crop for this year is going to be coffee," he added.
County Executive for Ag-

riculture Edward Sawe said the county aims to increase the acreage under coffee cultivation by over 600 acres, building upon the existing 1,452 acres already established.

In his remarks, Chief Officer for Agriculture Elphas Kesio emphasized the importance of the integration of modern technology through the Agricultural Management Information System (AIMS), which promises to empower farmers with crucial data and innovative techniques.

Kiambu County opens bank accounts for elderly citizens

Older persons in Kiambu County will benefit from Inua Jamii funds starting in June 2024, as the Government begins to open bank accounts for those registered last year.

The exercises, which started in Kiambu Sub-County, will take place in all the sub-counties for five days. The funding targets eligible senior citizens aged 70 and above who will receive Sh2,000 every month from the national government through the Department of Social Pro-

The Social Development Officer in charge of Kiambu Sub-County, Ms. Rose Kanyutu, said they had invited the six contracted banks to set up tents in selected locations in the sub-counties to ensure a smooth operation of the exercise. "Today is the first day of the account opening exercise for the older persons, happening here at Ndumberi stadium. pating in this exercise, including Kenya Commercial Bank (KCB), Co-operative Bank of Kenya, Equity Bank, Post Bank, National Bank of Kenya, and the Kenya

Women Finance Trust (KWFT)," Kanyutu said. She added that about 1,200 eligible older persons will be opening new bank accounts in Kiambu

Sub-County alone. "Account opening is a continuous process which will be going on in our offices, even after the five days planned for the exercise have passed," Kanyutu said. The social development officer further encouraged the beneficiaries to take note of the place and dates when the exercise will be taking place in their locations to avoid long queues in the banks. Kanyutu said the account opening exercise will only be restricted to the older persons as the government is yet to conduct validation tests for people living with disabilities, orphans and vulnerable children.

"Plans are underway to ensure that validation tests are conducted to the registered persons with nerable children to ascertain their legibility for the funds before they can also open their bank accounts. Kanyutu stated.
