The State Department for Lands and Physical Planning has launched a nationwide initiative to implement the Cashless Revenue Collection Policy across the country.

This initiative is regarded as a crucial step in eliminating cash transactions within Land offices, ultimately leading to a reduction in embezzlement cases.

During the program's inauguration, Mr. Zachariah Njeru, the outgoing Cabinet Secretary for Lands, Public Works, Housing, and Urban Development, (pictured) expressed that the Ardhipay system will enhance service

efficiently," said Njeru.

The Principal Secretary for

Lands and Physical Planning Nixon Korir said the program will ensure that no cash is involved in land transactions.

We want to go cashless in all our registries nationwide in 14 days starting today. For the last three weeks we have rolled out cashless payment at Ardhi House and it is working well," Korir said.

The PS added that the State Department has developed an Ardhipay system that is linked to the E-citizen, which will help in the implementation of the policy.

He noted that the policy mandates the use of digital payment methods (MPESA or banks) for all services,

Mombasa adopts tenant-purchase model to tackle squatter problem

The Mombasa County Government has embraced the tenantpurchase model as a solution to the longstanding issue of squatters in the coastal county. To implement this approach, the county government, in collaboration with the Ministry of Lands, distributed 1,000 title deeds to squatters in Mikindani Ward on World Habitat Day.

The theme of this year is "Resilient urban economies,

cities as drivers of growth and recovery".

Governor Abdulswamad Nassir reiterated his commitment to end the squatter problem in Mombasa during his tenure, with land still being a thorny issue in the Coastal

He said his administration has secured necessary financing on behalf of the residents to negotiate with landowners whose land is occupied by squatters.

fostering accountability, precision, and timely reporting in revenue collection.

Implementation in the 18 offices has demonstrated remarkable improvements in revenue collection.

These include Wundanyi, Kiambu, Murang'a, Ruiru, Thika, Ngong, Kajiado, Eldoret, Mombasa, Kisumu, Trans Nzoia, Machakos, Gatundu, Naivasha, Survey of Kenya, Ardhi House, Yatta, and Kisamis.

To expedite the nationwide transition, Korir noted that the State Department will embark on an extensive 14-day exercise to implement the policy in the remaining 76 Land offices.

This initiative includes the provision of computers and essential ICT equipment and ensuring that all Land offices are well-prepared to implement the policy and embrace the future digitization of Lands services.

Dedicated field office staff, he added, will receive specialized training in cashless revenue collection, ensuring a smooth transition.

Elsewhere, the Kenya Revenue Authority (KRA) has launched an online auction platform to streamline its tax administration procedures for enhanced service delivery and improvement of revenue collection.

The auction, which was previously a physical pro-

cess is part of KRA's technological strategies after the authority collected Sh37.5 million while piloting the new platform.

Speaking at the launch in Mombasa Custom House, the Cabinet Secretary for The National Treasury and Economic Planning Prof. Njuguna Ndung'u said the platform would boost government efforts to decongest ports and ensure cargo is cleared in a timely and efficient manner.

ters to assume ownership of titles progressively in a tenancy purchase structure guaranteed by the County Government of Mombasa," said Nassir.

"Through the partnership we have with the national government, we will issue 700 titles to Chaani settlement through the Kenya Informal Settlement Improvement Programme (KI-SIP)," he added.

Nassir urged landowners who received title deeds to utilize them for their own benefits of developing the lands.

The governor said the county government is planning to issue at least 3,000 title deeds in the area.

The Principal Secretary for the State Department for Housing and Urban Development Charles Hinga in a speech read by Mr. Hiram Kahiro hailed Mombasa as a pacesetter in embracing climate change as a key component in addressing

urban resilience in the cities for sustainable human settlement and urban development.

"Our cities, municipalities, and towns play pivotal roles as drivers of growth and recovery to the path of a sustainable future by integrating climate change mitigation and adaptation strategies into urban planning and development," PS Hinga said.

Cities, he added, can promote resilient urban economies including supporting sustainable industries, fostering the creation of green jobs, and investing in renewable energy infrastructure.

PS Hinga noted that Mombasa due to its geographical and strategic position as a port of entry to Kenya is prime to implement climate change mitigation actions.

Government to install bulk coolers to support dairy sector

¬he Government is investing in bulk cooling and storage infrastructure for the dairy sector to support marketing cooperatives and the farmers in the sector.

Agriculture, Livestock and Fisheries Cabinet Secretary Mithika Linturi has noted that milk is a highly perishable product which needs efficient and orderly measures of collection and cooling, adding that marketing systems are also crucial to the overall viability and profitability of the commercial dairy sector.

Linturi said a cooler will soon be installed in every ward in high milk producing counties which will cushion farmers against losses and spoilage, thus raising their financial capabilities and safeguard milk quality.

Linturi's remarks were contained in a speech read on his behalf by the Deputy Secretary for Administration in the State Department of Livestock Mr. Boniface Simba during the 67th Graduation Ceremony of the Dairy Training Institute (DTI) in Naivasha.

During the graduation, three groups totaling to 198 students who qualified were awarded certificates in Dairy Production and Management, Dairy Technology and Management, and Diploma in Dairy Production and Processing.

The CS observed that Dairy is a very crucial subsector as it accounts for about 15 per cent total agricultural sector Gross Domestic Product (GDP) and contributes substantially to the national economy and still aims to play a significant role in achieving the 10 per cent economic growth as stipulated in the Kenya Vision 2030 blue print and is a major source of livelihood for the families of about 1.8 million small-scale farmers for whom dairy farming is a primary activity.

"Consequently, Dairy sub-sector also offers employment to over two million people either directly or indirectly along the milk marketing chain and it accounts for the largest share of livestock contribution to the country's GDP at 3.5 per cent total GDP share as smallholder dairy production accounts for over 70 per cent of total milk produced," Linturi stated.

He said due to the high

contribution of the dairy value chain to the economy, the government has chosen to promote dairy as one of the priority areas under the Bottom-up Economic Transformation Agenda (BETA).

Linturi noted that in line with the BETA plan, the Government intends to carry out several interventions in the dairy value chain including doubling milk production per animal and maximizing lactation rates, set-up feed centres for livestock within each cooperative and establish dairy hubs with a variety of Business Development Services (BDS) to farmers that includes animal health, extension services and access to agro vet services among others.

Other interventions include ensuring access to Artificial Insemination (AI) services within the dairy farmer cooperative societies, operationalization of milk processing plants for bulking to improve quality and market access as well as value addition and continual strengthening of the capacity of dairy hub management and farmers through various training, exposure

"To this end, DTI will play a critical role of capacity building among the dairy producers and processors,"

He noted that the Dairy sub-sector is facing various challenges namely climate change and recurrent

drought, high cost of inputs, low productivity and declining land sizes and seasonality in production among other challenges.

Gov't to improve educational facilities in ASAL areas to reduce dropout rates

The Government is keen on improving educational infrastructure in public secondary schools in Arid and Semi - Arid Lands (ASALS) to cater for the increased enrolment and reduce dropouts.

Marsabit County Commissioner, Mr. Norman Komora said while majority

of schools have benefited from infrastructural developments initiated by the national government, a lot more needs to be done to further make learning conducive in the area and ease facility congestion.

Komora, who spoke during an entry meeting of the joint support mission for the implementation of Secondary Education Quality Improvement Project (SEQIP), called on the contractors to expedite the completion of the project. "The State must get value for money from the World Bank-funded programme," he said.

On his part, the Ministry of Education Director for Primary Education Mr. Steven Barongo reiterated the

state's commitment to upgrade the existing schools' infrastructure to enable more learners to transit to secondary level.

He, however, stated that there will be no work on site during the national examinations, and asked contractors to increase their human resource to ensure the work is completed on time.

DRAFT PUBLIC FINANCE MANAGEMENT (WILDLIFE CONSERVATION TRUST FUND) REGULATIONS, 2023

Section 4(a) of the Statutory Instruments Act, 2013 provides that "the object of this Act is to provide a comprehensive regime for the making, scrutiny, publication and operation of Statutory Instruments by requiring regulation-making authorities to undertake consultation before making Statutory Instruments". In addition, Section 5 (3) of the Statutory Instruments Act, 2013 states that "without limiting by implication the form that consultation referred to in sub-section (1) might take, the consultation shall –

- involve notification, either directly or by advertisement; of bodies that, or of organizations representative of persons who are likely to be affected by the proposed instrument; or
- invite submissions to be made by a specified date or might invite participation in public hearings to be held concerning the proposed instrument.

Pursuant to Section 23 (1) of the Wildlife Conservation and Management Act, 2013, the Wildlife Conservation Trust Fund was established with the objective of funding wildlife conservation initiatives, manage and restore protected areas and conservancies, protect endangered species, habitats and ecosystems, support wildlife security operations, facilitate community based wildlife initiatives, award wildlife grants among other related activities.

Accordingly, a Multi-Agency Taskforce composed of officers drawn from the Ministry of Tourism, Wildlife &Heritage, the Office of the Attorney General & Department of Justice and the National Treasury has now finalized preparing the draft Public Finance Management (Wildlife Conservation Trust Fund) Regulations, 2023.

The Public Finance Management (Wildlife Conservation Trust Fund) Regulations, 2023 have been posted to the National Treasury website http://www.treasury.go.ke.

The State Department for Correctional Services is urging Kenyans to accommodate convicts who have served their terms and after their release from penal institutions.

The correctional facilities stakeholders noted that some of the ex-convicts end up going back to prison after they have been released owing to discrimination and stigmatization by society.

The Principal Secretary for Correctional Services Ms Salome Beacco, who was speaking at the Nanyuki GK Prison in Laikipia County during a familiarization tour, said the Prison Department is implementing programmes aimed at making offenders productive members of the society once they are freed from jail.

"Let us help prisoners so that after they are released, they don't get re-arrested, and this is what the correctional department is trying to do. Accept them back in society," the PS said.

She noted that the correc-

tional facilities equipped the prisoners with artisan and entrepreneurial skills and called on Kenyans to support them by purchas-

"We encourage you to come and buy the merchandise made by those behind bars. Part of that income is channeled to train them to ensure after they have been released from jails, they can earn a living," Ms Biacco said. She further called on more partners to join hands and support the correctional facilities in the country through counseling and rehabilitation

"If you're a counseling expert, talk to us, come and help inmates change their behaviour for a better country. Let us partner and support our people," the PS appealed.

During her visit, Ms Biacco commissioned the construction of a resource centre donated by Faraja Foundation, a non-governmental organization that aims to empower inmates through counseling and entrepreneurial skills.

Brigadier (Rtd.) John Kibaso Warioba lauded Faraja Foundation for its continued support over the years to Kenyan prisons.

He noted that the resource center would host a barber shop, a computer centre, library, carpentry, and counseling chamber all fully equipped by the Faraja Foundation.

"I am informed that the resource centre has been conceptualized for a salon, barbershop, computer, library, and carpentry section prior to handing over to Kenya Prison service," he said

Kephis trains farmers to access international markets

Rarmers in Elgeyo Marakwet County will be trained on the requirements needed to access international markets.

The Kenya Plant Health Inspectorate Service (Kephis) Managing Director Prof. Theophilus Mutui said his organisation will support farmers to export their mangoes and avocados among other products, by ensuring that they are free from diseases.

"We will also issue them with the necessary certification so that their goods can access various markets across the world," he said.

Speaking in Iten after meeting with county officials led by Governor Wisley Rotich, the MD said the organisation in partnership with other agencies has in the past three weeks managed to open an avocado market for India where they are targeting a population of 500 million people.

He continued to say that these are people living in Indian cities who are potential buyers of Kenyan avocados where three avocados are being sold at an equivalent of Sh2,000.

Prof. Mutui further said the country has also been given access to the avocado market in China, which is the second most populous nation in the world, as well as Mauritius adding that new markets could be opened in the USA, South Korea and South Africa among others.

Noting that fruit flies were a major challenge in the county, Kephis Chairman Joseph M'Uthari said the experts will work with farmers to eradicate the flies so that their products can be certified fit for export.

Ministry partners with universities to conduct research on value of minerals

Plans are underway to work with universities and mining stakeholders to conduct research to establish economic value of minerals available in the country.

The Mining, Blue Economy and Maritime Affairs Cabinet Secretary Salim Mvurya said the ministry is working with universities to help in capacity building, research and training of engineers and geologists.

He said they have also grouped the minerals into industrial and strategic, which need a lot of research, thus requesting universities to work with the ministry to establish the value of value addition in the country.

Speaking during a Kenyan-German Centre of Excellence for Mining, Environmental, Engineering and Resource Management (CEMEREM) conference in Mombasa, Mvurya said the mining sector is very important in Kenya as the government strives to move the revenues from one per cent

of Gross Domestic Product (GDP) to 10 per cent in the next three years.

He said they will be

working with stakeholders and investors, adding that they have set up a meeting in two weeks for all the mining stakeholders in a bid to enable the sector to be a lucrative business free from cartels.

The CS noted that the mining sector, for the last five years has had a moratorium to protect the national interests and to also do geosurveys across the country.

Mvurya said the Cabinet has consequently decided to lift the moratorium, therefore inviting stakeholders and investors who want to apply for prospective mining licenses to do so.

He said the ministry is also working on mineral value addition and processing policy which is very instrumental in growing the mining sector.

"We want to modernize the laboratory so that we can solve the issue of sampling and testing which has been a challenge," Mvurya said. He said they will make sure the lab in Madini House in Nairobi can be accredited internationally and then move in to decentralize lab services across the country.

"It is critical to work with universities in this so that they can have their input in the process," he added.

He noted that the government has also decriminalized artisanal mining and is looking forward to working with Taita Taveta University on trading, with the artisanal miners and universities playing a key role in updating their skills.

New biotechnology engineering and research center to set up base in Kenya

enya's profile as a research and technology hub will soon receive a major boost as the International Centre for Genetic Engineering and Biotechnology (ICGEB) gets poised to operationalize its first Regional Research Centre (RRC) in Africa.

The ICGEB Regional Research Centre which will be domiciled at Egerton University's main campus in Njoro Sub-County which will be the second such outfit in the world after the one in China, will specialize in food safety and molecular plant breeding.

Speaking after inspection of facilities that will host the RRC by a team of officials from ICGEB led by its Director Prof. Ramesh Venkata Sonti, Egerton University Chancellor Prof. Isaac Kibwage disclosed that the center is set to also foster on-going

and future cutting-edge, research in genetic biofortification, development of molecular diagnostic tools and their applications and bioprospecting for biopesticides and bioactive compounds.

The ICGEB board which runs 46 state-of-the-art laboratories in Trieste, Italy, New Delhi, India and Cape Town in South Africa has also approved the appointment of National Commission for Science, Technology and Innovation (NACOSTI) Director General Professor Walter Oyawa as ICGEB Governor for Kenya.

During the 22nd session of the ICGEB Board of Governors held in Cape Town in 2016, it was decided to explore possibilities of setting up ICGEB- RRC in Africa. Subsequently, during the Annual General Meeting in December 2020, ICGEB Board resolved that Kenya was to host the RRC within its territory.

Gov't procures 100 dryers to support maize farmers in reducing losses

¬he Government, through the Ministry of Agriculture has instituted various measures to reduce crop post-harvest losses in the wake of the bumper harvest expected following the long rains and the application of the subsidized fertilizers that it provided to farmers.

Speaking in Uasin Gishu County during a tour of National Cereals and Produce Board (NCPB) depots, the out-going Principal Secretary for Crop Development Kello Harsama, noted that the government has procured 100 dryers to help farmers dry their maize and reduce post-harvest losses.

The PS, who has since been moved to ASAL and the Regional Development State Department in the same capacity said farmers in North Rift are expected to harvest over 23 million bags of maize, noting that NCPB has the

capacity to store the produce during the harvesting period.

He asked cereal farmers not to fall prey to brokers who want to purchase their produce at a throwaway price in the wake of a bumper harvest in maizegrowing regions.

Harsama noted that there was no cause for alarm over the delay by the government to announce the maize price per 90 kilogrammes as the government would make public the minimum buying price for the maize produced.

He regretted that some farmers had fallen prey to brokers from neighboring countries who were offering them Sh3,500 per 90kg bag of maize.

"Don't be deceived that the market price of maize will drop due to the delay by the government to announce the minimum buying price for your maize produce, "he assured.

Artistes urged to unite to benefit more from the creative economy

A rtistes in the creative industry have been urged to establish structures to reap maximum benefits from the sector.

The State Department for Youth Affairs and the Arts Principal Secretary (PS) Ismail Madey said the creative economy is largely disorganized compared to other sectors like sports which have well-established

structures

"We are fond of saying this economy generates a certain percentage of the Gross Domestic Product (GDP) of our nation which if we ask the sector leaders how that is arrived at nobody can explain. It is something that is hypothetical – a theory that has not been measured," the PS said.

The government has a standardised compensation for artistes and those who perform in various state events are now paid using approved rates by the Salaries and Remuneration

"I call on all artistes to unite and join associations where they can speak with one voice on this crucial matter of compensation. I also dare you not to accept anything less than what has been approved by SRC," the PS said.

Speaking at the Pwani Innovation Week at Swahilipot Hub, the PS urged youths to challenge the status quo and bring forth innovations that will stimulate the economy.

"While innovation is important, alone, it is not enough," he said.

IGAD validates five year regional plan to enhance peace and security

¬he Inter-governmental Authority on Development (IGAD) has validated the Regional Plan of Action and Common Position that will provide a roadmap towards unlocking the full potential and address myriad of challenges facing the region.

The regional body identified four key thematic areas of interest that the five-year plan seeks to address including regional cohesion and cooperation, socio-economic development, maritime and terrestrial matters, research, technology, and innovation as well as capacity building.

IGAD termed the implementation of the Regional Plan of Action (RPA) as key to the achievement of IGAD peace and security regional strategy especially in safeguarding the interests of member states and strengthening their cooperation on safety issues in the Red Sea and Gulf of Aden area.

According to Ambassador Moi Lemoshira, the Director General at the Kenya State Department of Foreign Affairs, there is need for a common action that safeguard the political, economic and security interests and stability of the region population.

The ambassador decried the rising costs of conflicts in the region that has seen diversion of developmental resources towards addressing conflicts and insecurity.

Speaking to ambassadors from IGAD member Lemoshira afstates, firmed Kenya's commitment towards enhancing trade, shipping and navigation operations in the Red Sea and Gulf of Aden and Somalia(RESGAS) to unlock the full potential of the maritime resources.

State to provide title deeds to empower communities and reduce land disputes

¬he Government is committed to transitioning all group ranches to community land in an effort to empower communities to register and develop their pieces of

The Principal Secretary for the State Department of Lands and Physical Planning, Mr. Nixon Korir said the Government will provide communities with title deeds through the titling program to enable them to benefit from development projects in their areas.

Korir said communities have been losing benefits and at times compensation from development projects due to lack of title deeds.

Korir said the Department of Lands and Physical Planning, in collaboration with the National Lands Commission (NLC), has prioritized the issuance of titles and the transitioning of group ranches to community land to enable communities to register

their parcels and geo-reference them for development purposes.

The PS further said the Community Land Act, of 2016 was passed to give effect to the provisions of Article 63(5) of the 2010 Constitution that all undissolved group ranches be transitioned to communities adding that to date a and issued with total of 309 inventory and undissolved group ranches have been submitted to the

Chief Land Registrar by land adjudication and settlement offices.

"To date, 46 such

To date, 46 ranches have transited to communities fresh title deeds -Ng'eno

ranches have transited to communities and have been issued with fresh title deeds under the Land Registration Act, 2012," he said, and added that the transited land includes 21 in Samburu, 13 in Laikipia, five in West Pokot, five in Taita Taveta and two in Kajiado respectively.

A case study conducted by NLC in collaboration with NAMATI Kenya has revealed that the progress on transitioning group ranches across the country to community land is slow, indicating that by May 2023, only 46 out of 315 group ranches nationally had fully transitioned in a survey that began in 2017.

The PS, who was speaking during the launch of the report on the 'monitoring the transition of group ranches to community land in Kenya' at a Nairobi hotel said the number of transitions from group ranches to community land is low, a need that calls for all stakeholders to work closely to alleviate the challenges hindering the transition.

Health Ministry steps up polio vaccination to address outbreak in North Eastern region

The Government has enhanced efforts to curb the spread of polio in the country after some cases were reported in the North Eastern region.

Public Health and Professional Standards Principal Secretary Ms Mary Muriuki said that the Ministry has put in place all the necessary measures to ensure a smooth polio vaccination campaign hass been on going for afew weeks.

Speaking in Nairobi during a media and stake-holders meeting on the up-coming polio vaccination campaign, Ms Muriuki said this is the second of the three planned vaccination rounds following polio outbreak confirmation in Garissa County in June this year.

"Recently, I reported that we had confirmed six cases, and we were going to conduct an emergency polio vaccination campaign in four counties. Sadly, there are clear indications that transmission of the virus is still active in Garissa

County especially within the refugee camps," Ms. Muriuki said.

surveillance system has detected an additional two polio cases, bringing the total number to eight.

"The ministry, in collaboration with county governments and partners successfully undertook round one of polio campaigns from 24th to 28th August 2023 in four counties namely Kiambu, Kajiado, Garissa and Nairobi where a total of 1,960,748

of children under five years were vaccinated, out of a target of 1,879,402 children," Ms. Muriuki said.

She said that this translates to 104.2 per cent coverage as she lauded all parents, guardians, religious leaders, media, partners and all members of the public for supporting the noble course.

"The upcoming round will target 10 high risk counties namely Mandera, Wajir, Tana River, Lamu, Kitui, Machakos, Kiambu, Kajiado, Nairobi and Garissa," she said.

According to the PS, the campaign is targeting 3,119,158 children under five years of age in all the targeted sub-counties.

"For a long time, it has been assumed that polio largely affects children under five years of age. However, the confirmation of the virus in a seven-year-old child re-affirms that polio is a threat to all persons irrespective of age in areas where population immunity is compromised," the PS said.

Kenya inches closer to achieving Universal Health Coverage

The Ministry of Health is inching closer to achieving the Universal Health Coverage (UHC) following the operationalization of Primary Health Care Networks (PCNs) in counties to provide Kenyans with accessible and integrated health care services.

According to the Principal Secretary for Public Health and Professional Standards, Ms Mary Muriuki, the PCNs are heralding a new era of comprehensive and integrated healthcare delivery besides shaping the country's healthcare landscape.

Ms Muriuki, who was speaking in Nairobi, revealed that through these special PCNs, the ministry intends to deploy at least one network in each of Kenya's 47 counties by October 20th.

Through the PCNs concept, the PS said, health

indicators particularly in reproductive, maternal, child, and adolescent health (RMCAH) are expected to improve.

"PCNs promote appropriate use of healthcare resources and facilitate efficient referrals, reducing congestion in tertiary healthcare facilities," Ms Muriuki said.

"We are resolutely committed to ensuring that every Kenyan has access to high-quality healthcare services and to achieve this, we are working tirelessly to establish PCNs in every county," PS Muriuki declared.

Currently, the PS said, 34 counties have already forged partnerships with various stakeholders to support the establishment of the PCNs in their areas of jurisdiction.

She added that significant efforts are underway to mobilize resources for extending the PCNs initiative to all the counties.

The standalone complex constructed at a cost of Sh600 million is part of the Sh1 billion facelift that the county government has been carrying out at the referral hospital in response to the increased number of patients seeking services at the facility.

County Executive Committee Member (CECM) for Health Services Ms Jacqueline Osoro said the US-AID-funded project will be

undertaken by Stand-med, a private healthcare technology company.

The outpatient complex, Ms Osoro explained is equipped with a pharmacy, X-ray machines and modern laboratories which will cater for more patients, adding that they were experiencing an increased influx of referrals from other hospitals and health centres within the larger Rift Valley.

"Our strategy is not only

to cope with the numbers but mainly to offer quality and affordable disease diagnostic, management and treatment services," the CECM said.

She said the referral hospital serves more than eight counties in the South Rift region including Bomet, Kericho, Samburu, Baringo, Nyandarua, and Laikipia where 2,000 patients are said to be treated daily, 750 of them being inpatients.

Ms Osoro was speaking

when she led a team from Stand-med healthcare technology company led by its Chief Executive Officer Mr Ian Okello, on a tour of the referral and teaching

She noted that the out-patient facility was part of the county government's efforts to revamp the county's health sector to ensure improved efficiency in emergency re-

The CECM indicated that huge investments in outpatient health facilities are still needed to improve health services across the devolved unit, pledging that the county administration would continue looking for avenues to increase budgetary allocation to improve the provision of health care services.

Osoro noted that malaria, diseases of the respiratory system, skin diseases, diarrhoea, and intestinal parasites were major challenges at outpatient facilities around the county.

Government to spend the money every month as it seeks to cushion the vulnerable, who include the elderly, orphans and persons with disabilities

he government's spending on social protection that targets the elderly, orphans and persons with disabilities is set to rise to about Sh3.5 billion every month following the conclusion of registration of new beneficiaries.

The government, through the Department of Social Protection, disburses every month some Sh2.1 billion to slightly over a million beneficiaries across the country.

In September, the government released Sh2.09 billion to 1.04 million beneficiaries enrolled in the cash transfer programme known as Inua Jamii, according to the department.

Each beneficiary gets Sh2,000 which is sent to them mainly via a registered mobile phone number.

And in August, the department released Sh2.08 billion to the 1.04 million beneficiaries, with the payment being made promptly at the end of every month.

In the just-concluded registration, the government had targeted to enroll some 700,000 people.

With each beneficiary getting Sh2,000 every month, the monthly spending on the welfare programme is set to rise by Sh1.4 billion to hit Sh3.49 billion as the government moves to cushion the vulnerable in the society.

The cash transfer initiative, according to President William Ruto, is meant to enable the vulnerable have decent lives.

In July, the President assured that the government will disburse the funds on time - at the end of every month, even before the CONTINUED ON PAGE 2

salaries of public workers have been paid.

The government has kept its word on this, with the social protection department every 29th day of each month disbursing the cash to the over a million beneficiaries.

"Older citizens, orphans and vulnerable children, as well as people living with extreme disability, have a right to receive support now, and it is grossly unjust to wait even one moment, for any reason," the President said at the social protection conference in April.

He added that the bottom-up economic transformation agenda stands on the foundation of creating sustainable capacities and viable opportunities for the empowerment of people at the base of our socioeconomic pyramid.

He explained that the government was simultaneously pursuing rapid economic transformation and social protection.

"Social protection cannot wait until 2030, when we will have achieved our economic vision. If it does, the development achieved at the expense of, or in exclusion of social protection, will be hollow and fragile," he said.

The government in September kicked off the registration of new persons in the social welfare programme, targeting some 700,000 older persons, orphans and persons with disabilities.

Registration closed on September 30 after being extended on September 15 to allow more potential beneficiaries to enroll.

As at mid-September, registration stood at 600,000, according to the Labour and Social

In an update, Bore noted that older persons led in new registrations at 371,725, followed by orphans at 167,575 and the rest were persons with disabilities

One of the counties that led in registration is Makueni, where over 37,000 potential beneficiaries were registered.

He added that there is a relationship between disability, old age and poverty. "If we give money to older people, poverty decreases and, therefore, many of them will live more years because they will be able to buy food and medicine for themselves so that they can live with dignity in their old age", he said.

Mr Motari said to save the beneficiaries the struggle to access their money, the government will disburse it through mobile phone services.

Most elderly persons had been forced to travel to towns to access their stipends from registered financial institutions including banks and micro-finance. The movement was a big challenge, especially to those with disabilities.

"Once this exercise ends, in six months time, the beneficiaries will be getting their stipends through their mobile phones. This will be a great relief, especially to our sick and physically challenged elderly people," stated the PS. \blacksquare

Revenue collection has progressively increased in the last five years from Sh1.58 trillion in FY2018/2019 to Sh2.17 trillion in 2022/23, representing a growth of 37 per cent in five years.■

State targets 3.1m children in new polio campaign

THE GOVERNMENT IS targeting to vaccinate 3.1 million under-five children in 10 counties in the second round polio vaccination campaign that runs until October 11. The targeted counties are Nairobi,



Kiambu, Kajiado, Machakos, Kitui, Tana River, Garissa, Lamu, Wajir, and Mandera, according to State Department of Public Health and **Professional Standards PS Mary**

The PS said the Ministry of Health is conducting the campaign dubbed nOPV2 Supplemental Immunisation Activity (SIA) with support from the Global Polio Eradication Initiative (GPEI) and various other partners.

Dr Emmanuel Okungu, the Head of Disease Surveillance and Response Unit in the ministry, said in the first campaign conducted in August, the government targeted 1.8 million children but reached 1.9 million.

"There are still more children we have missed, and we must reach them in this nOPV2 campaign," he said. Dr John Burton, a Senior Public Health Officer at the United Nations (UNHCR), said there is a correlation between spread of polio and climate change.

"The best way is to maintain high surveillance at the border points to prevent its transmission to other places. We will continue to support Kenya to achieve their target to eradicate polio," he said. Kenya, with other countries in the region, remain at risk of imported poliovirus from Somalia, which has health system challenges. ■

Regional judges call for increased cooperation to end transborder crimes



They say there is need for more collaboration in evidence gathering to enable countries deal with crimes like human trafficking and money laundering

udges from across the region have called for increased cooperation and partnerships among justice institutions to end transnational crimes.

The judges who held a three-day meeting in Mombasa noted that lack of cooperation has made courts find it harder to deal with crimes like terrorism, money laundering and human trafficking, which transcend borders.

 $\hbox{``When it comes to transboundary organised'}\\$ crimes, it doesn't matter how countries are well-organised. We can never succeed until we work together," said Chief Justice Martha Koome at the Africa Regional Dialogue on Adjudicating Transnational Organised Crime and Illicit Financial Flows in Mombasa.

Koome noted that no nation could singlehandedly fight crimes like drug trafficking, arms dealing, poaching and trafficking, whose frequency has risen in the region thanks to freer movement of people.

"For sure, Justice has no boundaries, so

we should care the kind of system that is applicable in any country. In fighting crime, we are joined together because we are all seeking justice for our people," she said.

Justice Susan Okalany of the International Crimes Division High Court, in Uganda, said many of the current transnational crimes are not only complex but also involve dozens of countries. In the case of the 2010 Kampala bombing, she said the case involved Tanzania,

Among the challenges her country faced was difficulties in extraditing suspects from neighbouring nations to face death penalty in Uganda. "The suspect was held in Tanzania and lived in Kenya where he raised finances

We can never succeed until we work together," - Chief Justice Martha to fund terror activities through the hawala system. Tanzania was not keen to release a terror suspect to face death penalty in Uganda. The suspect was from Kenva and had been receiving money through the mobile cash transfer system," she explained.

She added that cases of human trafficking from the region to the Middle East have been on the rise, but they are tougher to fight due to lack of mutual legal assistance with countries like Saudi Arabi. In most cases, this leads to acquittal of suspects.

Tewodros Kebede, the Chief Justice of the Federal Supreme Court of Ethiopia, said countries must cooperate in terms of evidence collection to end transnational crimes

Further, he said there is need for specialisation, training and sensitisation of judges on the extent and seriousness of the problem

"Most countries have excellent laws, enforcement is the problem. We also need political commitment for funding and training of prosecutors," he said.

The forum offered an opportunity to increase collaboration between justice actors in Africa and galvanise their response to transnational crimes. The crimes are one of the most significant challenges confronting not only the regional judicial systems but also the economic and political stability of

Apart from these government farms, quality breeds can also be sourced from some trusted farmers who work some trusted farmers who work with the NRB&TC.

Can I make my own rabbit pellets?

radbit peliets:
Yes, if you know how do it because
that saves costs. Don't compromise
on quality though. The main ingredients are usually grass, vegetables,
bran, hay, alfalfa, maize and other
necessary matters like limestone,
vitamin C and mineral premix, mixed
in specific ratios.

Tell me about the feeding schedule and recommended quantities

Rabbits are normally fed twice a day with water offered ad libitum or made available throughout. A kit needs 45 grammes of pellets per day, and a mature animal 150 grammes. Extensive feeding can be done using green fodder and edible weeds, which can sometimes be weeds, which can sometimes be supplemented by concentrates. Fresh succulent greens should not be fed directly to the rabbits, as too much water in the greens leads to bloating. Wilt the fodder for a few hours first before consumption.

At what age do they start breeding?

For both males and females, puberty or sexual maturity is attained at between five and six months. This variation depends on the breed, feeding level and management. That is, the larger the breed, the longer the maturity and vice versa. longer the maturity and vice versa. Similarly, rabbits fed wholly on pellets mature early while those fed on greens only take longer.

Some tips for successful rabbit breeding....

Keep up-to-date breeding records and replace the buck every year. Proper housing is essential and breeding does and bucks should always be housed in separate compartments. During mating, the doe should be taken to the buck. If done the other way, the female is likely to fight the buck. The farmer should not worry as to when the likely to fight the buck. The farmer should not worry as to when the doe will show heat signs. The heat in rabbits is as a result of external stimulus such as the presence of the buck. During mating, the farmer should wait to witness the service. If the serving is successful, the male falls back.

After mating, then what?

The gestation period is between 28 and 32 days. In-kit (pregnancy) can be confirmed three weeks after mating by palpating the abdomen to feel the lining of the young embryo. Another method of checking on the in-kit is by taking the doe back to the same male after two back to the same male after two weeks of mating. If it is in-kit, the doe will make noise and refuse to be mated, if not it will accept the male to serve again.

Kenya's textile industry revival gains momentum with Indian partnership

The Government quest to revive the textile industry in the country has received a boost through the establishment of business collaborations with Indianbased textile machinery and technological companies.

The collaboration is being fostered through the ITME Africa and Middle East 2023 exhibition which shall showcase a complete range of innovative textiles technology and engineering in multiple chapters of the textile technology.

The exhibition shall take place from 30th November 2nd December 2023 at the Kenyatta International Con-

vention Centre (KICC).
A total of 23 participating countries other than India will be participating and they include Austria, Benin, China, Egypt, Ethiopia, Germany, Ghana, Italy, Jordan, Kenya, Nigeria, Rwanda, South Africa, Spain, Sri Lanka, Taiwan, Togo, Turkey, Tunisia, Uganda, United States of America and Zam-

tary (PS) Juma Mukhwana said the revival of the textile industry is well on course adding that this year, the government has supported farmers to grow 40,000 acres of cotton and the next season the plan is to increase the acreage to 100,000.

Speaking during the preexhibition press conference, Mukhwana said ' I don't want you to be just exhibiting here. I want you to open a warehouse of Indian machinery in Kenya. We want an outlet for Indian textile technology here.'

The PS explained that the machinery used in manufacturing does not attract taxes from the government and thus urged the investors to establish their textile factories in Kenya.

The biggest manufacturers in Kenya are those of Indian origin and our manufacturing story is not complete without the Indian dimension," said the PS.

Mukhwana opined that the last wave of industrialization is coming to Africa and that the continent is ripe for investments since it has young and skilled labour and raw materials. He explained that it would not be affordable to take the raw materials from Africa to India for manufacturing then bring them back as finished goods.

"If you manufacture in Kenya, you will have access to a duty and quota free East African Community (EAC) market of over 400 million people comprising Uganda, Tanzania, Rwanda, Burundi, DRC, South Sudan and Somalia is soon joining," said Mukhwana. The PS added that Kenya, through the African Growth and Opportunity Act (AGOA), has been given access to the US market duty and quota free and that it has not even reached one per cent of that market saying that if the manufacturers set up shop in the country, they will also have access to the US market.

Through AGOA, we have 31 textile companies based in Kenya that are making top brands like Gucci. Kenya is the leading exporter of textile into the US although our market is so small," the PS

The CS consequently called on investors to establish firms

"Leaders should unite for the sake of development. Politics should only be allowed when campaign season is near," Mr Kuria said.

Governor Wanga said the launch of the industrial park comes at a time when her administration is finalising the registration of farmers.

She said Homa Bay has reg istered more than 220,000 farmers which was so far the highest in the country.

Ms Wanga said they will be supported to make them more productive.
