through value addition in the face of the current global glut," the PS noted.

He said, "I am impressed that as the government advances the National Edible Oil Crops Project, Kakuzi Plc, as part of its branding programme, is set to introduce competitively priced macadamia cooking oil in the local market."

Harsama disclosed that this is a significant milestone that complements the National Edible Oil Crops Project and provides an avenue to diversify the pool of edible oils-producing crops beyond sunflower, canola and soybeans to macadamia.

"The government plans to provide 720 metric tonnes of certified sunflower seeds by the use of the e-voucher input subsidy services, 200 metric tonnes of assorted canola seeds, sunflower, soya and 10,000 coconut seedlings.

"It will disburse Sh42 million to 840 farmers as loans in Kwale, Mombasa, Taita Taveta Tana River and Kilifi Counties under the National

Kakuzi Plc Chairman Mr Nick Ng'ang'a described the new identity as a growth driver for the firm that currently holds Sh7.1 billion net current assets.

Kakuzi, he explained, will focus on sharing its expertise and quality standards with local and international consumers.

"Over the last 95 years, Kakuzi has grown from a sisal grower, citrus, passion and pineapple fruits grower to a superfood's producer and exporter of repute. "We have over that period gained immense experience in all our stakeholder engagements and can now aim to unlock value with a distinct corporate identity," said Mr Ng'ang'a.

Attesting to the firm's growth trajectory, Kakuzi, Mr Ng'ang'a said it had significantly expanded its avocado and macadamia orchards to meet growing demand.

The firm, he disclosed, is on course to convert all its former pineapple-growing fields to avocado orchards by 2026.

"We recognise that private security guards can be cogent partners for maintenance of law and order. That is why we have come out strongly to prescribe this move to better track, evaluate and elevate the quality of their services within our communities," he said.

Speaking in Kisumu on Friday where he presided over the opening of the Private Security Regulatory Authority (PSRA) regional office, the PS said the government is keen on the training of private security guards to ensure they receive the necessary skills, knowledge and ethical understanding required to navigate complex situations.

The PS, who also opened a private security guards' training institution in Kisumu City said the training programme would inject professionalism, competence and integrity in the sector.

He challenged the private sector to open up more institutions to ensure that as

many guards as possible receive the training.

in order to generate skilled labour not just for the Kenyan market but also for the global market," he said.

The industry, which has employed around one million Kenyans, he said, has a lot of potential with annual revenues from the sector reaching Sh100 billion.

Private Security Regulatory Authority Director General Fazul Mahamed said over 450 security guards in the Nyanza region have been trained.

Communication Authority steps up cybersecurity amid soaring attacks

The Communications Authority of Kenya (CA) has scaled up measures to safeguard the country against cyber-at-

This follows a sharp rise in the number of attacks from 7.7 million in 2018 to 444 million in 2023, ranking Kenya among the top three targeted countries in Africa.

CA Internal Audit Director, Ms Rosalid Muriithi, said, the efforts target to build capacity for institutions to disrupt cyber threats, fix newly discovered vulnerabilities and counter emerging threats.

The National Computer Incident Response Team (KE-CIRT), domiciled at the Authority headquarters, she said, was working round the clock to ensure Kenvans are protected.

'Cyber threats are unpredictable. You cannot plan how it will happen and when it will happen. Our team at CA works 24 hours to monitor and give feedback to institutions that are being hacked, so that they

can be able to enhance their systems," she said.

Focus, she said, was on safeguarding the digital economy from data breaches, hacking attempts, identity theft and malware attacks.

Speaking in Kisumu during the awards ceremony of the Kisumu edition of the Communications Authority Cybersecurity bootcamp and hackathon series 2023, Muriithi said the initiative targets to instill skills in ICT students to boost the country's capacity to address emerging threats in

the sector.

"It is envisaged that through these capacitybuilding sessions, the Authority will contribute towards building a pool of cybersecurity professionals who can meaningfully participate in addressing emerging threats in the evolving ICT sector," she

Through partnership with Huawei and Kenya Cybersecurity Forensics Association (KCSFA), the bootcamp and hackathon series 2023 has attracted 6, 000 students.

Inua Jamii cash transfer program shifts to monthly payouts for beneficiaries

eneficiaries of the Inua Jamii Cash Transfer Programme will now be accessing their money on a monthly basis to help address perennial backlogs in disbursing the stipends.

The decision comes at a time beneficiaries of the social safety net that covers orphans and vulnerable children (OVC), older persons (OPC) and persons with severe disabilities (PSD) have in the past been forced to wait for months before receiving the dues.

Nyeri County Children Officer Mwaniki Kung'u said already, the State Department for Social Protection and Senior Citizens has disbursed Sh2.8 billion as payment for Inua Jamii Cash transfer for the month of July. The State also released an extra Sh4.3 million for the Nutrition Improvement through Cash and Health Education (NICHE) program, which complements the Inua Jamii initiative.

A total of 1,042,864 per-

sons are expected to benefit from this disbursement.

Kung'u said they expect to disburse Sh2,000 per household to a total of 4,800 households through the Cash Transfer to Orphans and Vulnerable Children CT-OVC and a similar amount to each of 17,000 elderly persons under the Older Persons Cash Transfer (OPCT) programme for the month of

The officer lauded the move by the Government, terming it a big relief for hundreds of beneficiaries who initially had to wait for months before accessing the money.

He also lauded the President for announcing the start of a new enrolment for new beneficiaries for the programme beginning next month.

"We are happy to announce that all the pending arrears for the Inua Jamii payment since 2021 to date have been paid out. What we are currently doing is clearing payments for the month of July," Kung'u said. "Towards the end of this month, we expect to pay out money for August and embark on enlisting new beneficiaries for this program as directed by the Head of State," said Kung'u.

Farmers urged to register for unified agricultural subsidies through KIAMS

The State Department for Crop Development is urging farmers across the country to register and reap benefits from the centralized Kenya Integrated Agriculture Management Information System (KIAMIS), an online platform domiciled under the Ministry of Agriculture

and Livestock Development to facilitate the distribution of subsidies to farmers.

The Principal Secretary in the State Department for Crop Development Harsama Kello said during a meeting in Nairobi which brought together agricultural value chain actors under the umbrella of National Value Chain Development Project (NAVCDP) that, having all the farmers on a centralized platform would make it possible to effectively distribute agricultural subsidies, while at the same time identifying each county's potential and pumping resources into viable projects.

"Having all farmers' data in one place will make it easy to plan for food production in the country. It

will be easy to identify each region's potential and put resources into productive projects," Kello said.

The centralised system will also ensure support in a range of other areas that reinforce a seamless agricultural production landscape including extension services, cooperatives planning, marketing, investors' collaboration among others, he said.

The national government has been firm on ensuring food security, focusing on four major value chains namely, staple foods, livestock, dairy, and horticulture.

According to Kello, the country aims to bring 200,000 acres under sunflower farming and the plans to procure seeds are already underway.

In yet another move to make good its food security agenda, the national government through the Ministry of Agriculture has embarked on an ambitious plan to turn 500,000 of idle public land into food production zones.




States launches internet connectivity pilot project impact report to schools

"The report has clearly found that the internet enhances access to, and quality of education for learners in rural areas, particularly girls and those with disabilities. I want to thank Huawei through their TECH4ALL initiative and UNESCO for their collaboration with the government to provide sustainable internet connectivity to the government's fibre-optic network, and for supporting this im-

Use of data driven interventions for TB yield fruits in Kenya

enya's adoption of evidence-based and data-driven interventions in policy decisions and Tuberculosis (TB) programme implementation has yielded promising results, enabling Kenya to surpass key impact indicators for TB over the past few

According to recent reports, between 2015 and 2020, Kenya achieved a substantial 32 per cent reduction in new TB infections, far exceeding the global target of 20 per cent.

Additionally, the country

recorded a remarkable 44 per cent reduction in TB-related deaths, surpassing the global target of 35 per cent within the same period.

A major driver for this success is the concerted efforts between the Government and development partners to accelerate uptake of innovative diagnostic and treatment solutions and improving access to TB services.

In a recent initiative, the Ministry of Health partnered with USAID and Stop TB Partnership to roll out newer TB diagnostic equipment, digital adherence solutions and shorter TB preventive treatment valued at Sh429 million (3 m USD).

The equipment including 78 Truenant and eight digital chest X-ray were distributed across the 47 counties after need assessment.

Over the years, Kenya has taken proactive measures to enhance TB diagnosis by widely adopting and scaling up the use of World Health Organization (WHO) approved molecular tests for TB diagnosis across all counties, a crucial step in ensuring accurate and efficient detection of the disease.

Once TB patients are diagnosed, the country has ensured quality treatment options are available.

Kenya rolled out childfriendly TB medicines going on record as the first country to nationally adopt their use.

Additionally, the country took up the use of injectionfree regimens for the treatment of drug-resistant TB

Given the commendable progress Kenya has made in TB control and the strong political commitment towards this success, Kenya was se-

lected to host the Fourth Africa TB Summit, 2023 in Nairobi.

Speaking during the inauguration of the Summit, Principal Secretary, State Department for Public Health and Professional Standards Mary Muthoni Muriuki reiterated the Ministry's commitment to eradicate TB as outlined in the National Strategic Plan.

"We will deploy the Primary Health Care (PHC) model to enhance TB screening and care across all health service delivery points," she

Power transmission line to bring reliable supply to North Rift

BY RICHARD MUHAMBE AND ANTONY MELLY (KNA)

West Pokot and Trans Nzoia residents will benefit from a reliable power supply with the operationalization of a new electricity transmission line from the Turkwel hydropower generation plant.

Energy and Petroleum Cabinet Secretary (CS) Davis Chirchir said the future of the country is pegged on power generation that is environmentally sustainable.

Chirchir said the new Turkwel-Ortum-Kitale power transmission line will minimize power loss, noting that the North Rift region has for a long time been exposed to high power losses since power generated from the Turkwel plant goes to waste because of the



long distance.

"It has been a pity since a lot of power being generated from the plant has to be evacuated to Lessos in Uasin Gishu County hundreds of miles away before being reverted back to the source for use.

"This line will enhance reliability of power and connectivity within the region and reduce power losses," the CS stated, while delivering of a transformer with a power supply capacity of 220 megawatts at Ortum Sub Station.

The North Rift Region has been plagued by unstable power supply, the reason being the long distance in power transmission lines.

Chirchir argued that geothermal and hydroelectric power is environmentally friendly, hence good for the future generation.

The CS stated that the country could be experiencing a loss of about 22 per cent of power both transmission, commercial and technical losses, reiterating that with introduction of short and high-capacity routes, these kind of losses shall be a thing of the past.

He noted that the losses are generally met by the taxpayers.

for both mother and child, the government will advocate for reasonable nursing breaks for working mothers. The measure aims at giving mothers the time they need to prioritize their children's well-being without compromising their career aspirations," the PS said.

By introducing the strategy, the PS said, the MoH wants to help working mothers to balance their professional and parenting responsibilities, besides encouraging employers to adopt flexible working hours which will allow mothers to adjust their schedules to better meet the needs of their infants.

Ms Muriuki revealed that the government will launch a nationwide awareness campaign to educate employers and employees about the benefits of breast-

feeding.

The campaign aims to foster a supportive and breastfeeding-friendly culture in workplaces by dispelling common misconceptions and promoting understanding,

Health experts say breast milk is nutritious for infants as it provides all essential nutrients infants need for the first six months of their life

It acts as powerful immunisation against life-threatening diseases, preventing 45 per cent of diarrhea and 32 per cent of respiratory infection episodes.

It can also reduce infection-related mortality by 88 per cent among infants less than three months old.

As such, the government will collaborate with non-governmental organizations and healthcare providers to offer training and support to employers.

PSC issues new guidelines on HR management in state corporations and public universities

The Public Service Commission has issued new guidelines on human resource management in state corporations and public universities.

In a circular signed by the Chief Executive Officer Dr Simon Rotich and addressed to all authorised officers, vice chancellors of public universities and CEOs of state corporations, the Commission cautioned that any HR instruments released for implementation without prior approval by the Commission will be considered null and void in line with the court decisions

"Any newly developed or reviewed human resource management instruments or proposals for establishment of new offices or abolition of offices should comply with the guidelines and be submitted to the Commission for consideration and approval," the circular reads.

The new guidelines come against the backdrop of court decisions that affirmed the role of the Commission in the management of the human resource in state corporations and public universities.

They are also in accordance with Article 234 of the Constitution that outlines the mandate and powers of the Commission on human resource management in the public service.

The guidelines were developed through a participatory process that incorporated views from various stakeholders and are available on the Commission' website: www.publicservice.go.ke.

Battle for survival as striga weed ravages maize farms in Busia

BY ABSALOM AMWALO (KNA)

Parmers in Busia County have called upon the government to intervene urgently and find a solution for them following the invasion of their maize and sorghum farms by the deadly striga weed threatening food security in the area.

An exclusive visit by KNA to the affected farms mainly in Teso North and parts of Teso South, Amagoro es-

tablished that the weed has spread in maize and sorghum farms.

The weed has left most farmers appealing to both the county and national governments to incorporate research institutions and scientists to find a lasting solution to the problem.

By dwarfing the crops, the weed has caused most farms to look flowery at the expense of maize and sorghum making it difficult for the crops to mature and vield.

With the short rains already going on, Christopher Emukule, a maize and sorghum farmer at Moding area is a sad farmer as he narrates how the weed has forced maize in his farm to dwarf with others drying up.

Commonly known as "Luyongo" in Kikhayo, a subtribe in Luhya, the deadly weed spreads fast and if its multiplication is not checked, it could spread across a farm in less than

three planting seasons.

"It's saddening that most farms around here are badly hit by this weed. Crops look small with many shiny flowers from the weed seen from far, clear evidence of no hope to farmers," Emukule said.

Striga weed, which survives by siphoning water and nutrients from crops for its own growth, causes stunted growth of the maize by attaching its roots to the host crop and extracting es-

sential nutrients and moisture for its growth.

It spreads by shedding seeds which germinate in subsequent planting seasons, making it hard to control. Animals' movement in the farm also helps its spread.

With the cost of spraying being expensive to most farmers, they resort to the traditional method of uprooting the striga weed, though the method does not seem to be working.

Online State university opens its doors

Application for programmes at the online university, which has four schools, is now open as the institution readies to have its first batch of students next month

o you want to study from the comfort of your home or phone at your own convinience? Well, the chance is here, and it is open to all and sundry.

This follows the award of charter and the launch of the Open University of Kenya (OUK) by President William Ruto.

Application for programmes at the university, which has four schools, is now open, and one enrolls online.

The schools are: Science and Technology, where one can study Data Science, Cyber Security or Digital Forensics; Education - Technology Education and Learning Design and Technology; Economics and Business - Business and Entrepreneurship Economics and Statistics, and Leadership

and Accountability; and Agriculture - AgriTechnology and Food Systems.

"Through our state-of-the-art online learning platforms, we bring the classroom to you, breaking down geographical barriers and providing you with the opportunity to learn at your own pace, from anywhere in the world," said OUK vice-chancellor, Prof Eliiah Omwenga.

He noted that the university actively "promotes a research culture, provides avenues for students and faculty to explore new frontiers of knowledge, addressing the pressing challenges, and contributes to the development of the nation".

President Ruto, while awarding the university a charter, said courses at the in-

stitution will cost a quarter of the Sh200,000 traditional universities charge.

This means that students will pay about Sh50,000 a year for their studies at the university that will offer courses online, reaching thousands of people.

"This is a bottom-up institution because it gives ordinary Kenyans a chance to get university education from remote places," the President said.

He expects farmers, *boda boda* riders and *mama mbogas* to be among the biggest beneficiaries of the institution since they will be able to learn at more convenient terms.

According to the President, for decades, Kenya's higher education has failed to give equal chance to those seeking to advance their education and skills.

"Millions of Kenyans have been left behind due to restrictive admission processes and

OUK set up

Like other universities, OUK has a vice-chancellor who is in charge of the day-to-day running of the institution.

The institution also has two deputy vice-chancellors, a Senate, Chancellor

Funding of the University will come from the exchequer as well as fees from students.

The government's free WiFi project is expected to complement the provision of education. OUK was one of the recommendations that was made by the Presidential Working Party on Education Reforms by Prof Raphael Munavu.

limited learning opportunities. Universities every year admit about 200,000 students leaving thousands. OUK will now correct this challenge," he said, adding the institution will help the country achieve 100 per cent transition to universities.

He noted that the university would implement a framework for recognition of prior learning to enhance enrolment and cater for those who have skills earned outside the classroom.

OUK, he added, will be incorporated into Kenya Universities and Colleges Central Placement Service (KUCCPS) system to admit students who would be able to get government funding.

Prof Chaacha Nyaigotti-Chacha, the chairman for Commission for University Education, which awarded OUK a charter, said the university provides flexibility and accessibility to the learners unable to attend traditional universities.

"This university will enable learners to pursue education as they fulfil other needs of their jobs and families. The establishment is timely as it provides learners with an alternative to university education and will come in handy during disruptions like the one that happened during the Covid-19 pandemic," he said.

OUK is expected to attract academic staff from across the world, delivering lecturers from anywhere online, according to Prof Chaacha.

Prof Ezra Maritim, the chairman of the OUK Council, noted that the plan to operationalise the university was mooted 14 years ago.

"Setting up of this university is a response to the country's quest to achieve SDG 4-10 by making learning affordable and accessible," he added.

He observed that OUK will repair injustices in the university sector, which made higher education an exclusive club by locking out many students and failing to recognise prior learning. "OUK is a framework of hope, shared prosperity, and an enabling enterprise for continuous learning and opportunities for all. The openness implies that the university embraces inclusivity without limitation, and strategic framework for actualisation of African Union Agenda 2063," he said.

President Ruto appointed Equity Group CEO James Mwangi, the first chancellor of the OUK. Mr Mwangi said new challenges, including disruption like Covid-19, as well as advancement in information technology that provides efficient way of learning, justify the setting up of OUK.

With the open university, Kenya joins nations that are embracing new modes of offering education.

"OUK is a public university that would be regulated like any other. We will optimise the university and ensure it attains global standards," he said

Education CS Ezekiel Machogu said the university, a first of its kind in Kenya, will promote higher education conveniently and at affordable cost. "This is an important milestone to build our human capital," said Machogu.

Kenya, Somalia sign agreement on air services

KENYA AND SOMALIA have signed a bilateral air services agreement that will see their airlines increase frequency of travel in both countries.

The Cabinet Secretary, Ministry of Roads, Transport, and Public Works, Mr Kipchumba Murkomen, said that designated airlines of the two countries will now operate seven weekly frequencies for passenger flights, while cargo flights will have unlimited frequencies.

"The airlines may also enter code-sharing arrangement with any airline, including third country airlines provided that it has an underlying traffic act," Murkomen said. Civil aviation authorities of the two countries will also increase collaboration

for the development of their industries, added Murkomen.

The talks leading to the agreement started in Nairobi in March between officials of the Federal Republic of Somalia and Kenya.

Fardowsa Osman Egal, Somalia's Minister for Transport and Civil Aviation, and Murkomen signed the agreement in Nairobi. Somalia, alongside DR Congo and South Sudan, is one of the fast-growing export markets for Kenya, with country exporting goods worth Sh9.2 billion in the first five months of the year.

Mobile money use plummets in H1

MOBILE MONEY USE registered a decline in the first half of the year on reduced transactions, according to the Central Bank. The half-year usage fell 3 per cent, from Sh3.84 trillion in a similar period in 2022 to Sh3.74 trillion at the end of June. This is the first time mobile money

This is the first time mobile money transactions have declined since the Central Bank started to capture the data in 2009.

The decline can be blamed on higher

charges as the Central Bank reintroduced fees for transactions between mobile money wallets and bank accounts starting January 202 The charges were waived on March 16, 2020, as part of the emergency measures to facilitate use of mobile money in the context of the COVID-19 pandemic boosting usage. During the period, the largest transaction was made in May at Sh670 billion and the lowest, Sh578 billion in January, The number of registered mobile money users stood at 77 million at the end of June while agents, who are employed by the service, 328543. ■

Treasury releases 90pc of funds to various sectors



Top on the list of the monies disbursed is the equitable share to county governments amounting to Sh400 billion

he National Treasury has assured that the country's economy is on a positive trajectory, enabling the disbursements to various sectors to perform at 90 per cent in the just-ended 2022/2023 financial year for the first time in many years.

PS Chris Kiptoo said the government collected and disbursed Sh3.24 trillion during the year out of the revised estimate of Sh3.62 trillion.

"Being one year since the last election and the Cabinet Secretary being in office for about 10 months, the National Treasury and the economy in general has performed well considering that we have had an environment of many shocks that include the lagging effects of Covid-19, the Russia-Ukraine war and drought," Dr Kiptoo said.

The PS said Treasury has disbursed 100 per cent of equitable share to county governments amounting to Sh400 billion, which also included arrears of Sh30 billion.

They have also disbursed the entire amount of allocation to the National Government Constituency Development Fund (NG-CDF), Sh47.2 billion.

"We also funded all arrears to Orphans and Vulnerable Children totaling Sh16 billion and we have a directive from the President that these funds will have to be paid together with salaries of public servants or even earlier than salaries and we implemented that in July," the PS said.

According to him, the country has also done well in serving its domestic and foreign debt service.

"In July, we made several external payments including Sh63 billion to the Exim Bank of China," said the PS.

He noted that Treasury had an underfunding of Sh77 billion for pending bills, and added that CS Njuguna Ndung'u had ordered all accounting officers to pay the bills faster to stimulate economic growth.

"Next week, the CS will be gazetting a Pending Bills Committee to look into the issues," said the PS.

He observed that the government's efforts to make timely payments have received accolades from several stakeholders, including the National Assembly.

External financing

Kenya borrowed Sh492 billion from external lenders in the financial year 2022/2023.

The money came from the International Monetary Fund (IMF), syndicated loans and the World Bank, according to the Treasury.

The total cumulative external disbursements from project loans stood at Sh156 billion.

Kenya also received Sh84.5 billion from the International Monetary

Kenya further got Sh115 billion from syndicated facilities and Sh144 billion from the World Bank for budgetary support. "I received an SMS from the Clerk of the National Assembly saying that they closed the year 2022/2023 having settled most bills including members' constituency items and mileage claims, which is unprecedented. The National Assembly also closed the year with the least amount of pending bills in the last nine years," said Dr Kiptoo.

For pension payments, the PS explained that in the 2022/2023 financial year, they remitted to the Public Service Superannuation Scheme (PSSS) the employer's portion of contributions reinforcing sustainability of the crucial pension system launched in January 2021.

"While members of the scheme contributed Sh11 billion, the government contributed Sh2.6 billion. The government has also disbursed an additional Sh51.6 billion under the old defined pension scheme towards lump sum payment of pensions," said Dr Kiptoo.

According to Dr Kiptoo, as of July 31, all monthly pension payments had been distributed promptly, with the government remitting Sh65.51 billion during the fiscal year 2022/2023.

What is the authority's relationship with other stakeholders in the education sector?

The authority continues to provide advisory, enhance capacity building and sensitisation of stakeholders to ensure that they all understand their role in implementation of the national qualification's framework. In the international space, the authority is aligning the Kenyan qualifications awarding process with those of other regions, including Southern Africa Development Cooperation (SADC), Inter Governmental Authority on Development (IGAD), The East Africa Community (EAC) and entire continent. KNQA is an active member of the African Quality Assurance Network and AQVN. KNQA is currently involved in development and implementation of the Africa Continental Qualifications Framework (ACQF) and IGAD Qualifications Framework (IGADQF), which will allow for transparency of qualifications and mutual trust between qualifications frameworks for lifelong learning in Africa.

Any legislative and policy gaps?

Yes, there are some gaps. The authority is currently implementing the framework, however, with the introduction of Competency Based Curriculum (CBC) in our education and training, this has occasioned various legislative and policy gaps in the laws. For instance, the Kenya National Qualifications Framework (KNQF) does not have a clear pathway to accommodate junior secondary school learners necessitating the need to review our KNQF Act, No. 22 of 2014. There is also lack of a policy to enforce full operationalisation of Section 5 (2) of the KNQF Act No. 22 of 2014.

Does KNQA take part in the development of all curriculums for tertiary institutions in Kenya?

In consultation with stakeholders, relevant institutions and agencies, KNQA has developed level descriptors and KNQF levels to support trainers in designing and packaging curriculum. KNQA also participates in providing advisory during curriculum development, standards for curriculum development and registering of the curriculum on the KNQF register of national qualification.

Why is it important to align a foreign certificate?

That provides access to training and employment, promotes lifelong learning and facilitates mobility of skills and qualifications. Alignment of qualifications supports globalisation of education, training and mobility of skills and qualifications. It is also now a legal requirement in Kenya for holders of foreign qualifications to aligh their qualifications.

What is alignment of a foreign certificate?

This is the process of locating the level of foreign qualification on the local qualification framework.

How is this done or what is the process?

You can access KNQA portal using qa.knqa.go.ke and follow instructions therein to complete the process.

Are there charges?

Yes, there are depending on services one is seeking.

Are these processes targeted at individuals or institutions?

Both individuals or institutions can apply for the two services.

Must every certificate obtained in Kenya at tertiary level be recognised by your institution?

Yes, it is important for authentication purposes.





State in grand plan to boost coffee production for global market share

The Government has announced new plans of stimulating coffee production in the next five years in order to expand her share in the international coffee market

To achieve this, the Principal Secretary (pictured)in the Department of Cooperatives Patrick Kilemi revealed that the Government is committed to spurring the production of coffee from the current 51,000 to 81,000 metric tonnes by 2024 and progressively to 260,000 metric tonnes by 2027.

"We shall achieve this by lowering the cost of production through subsidizing farm inputs, streamlining the accessibility and disbursement of the Cherry Advance Revolving Fund at New Kenya Planters Cooperative Union (New KPCU) and revamping coffee research through re-introduction of the Coffee Research Institute," Kilemi said.

The PS made the remarks during a workshop on familiarization with the operations of the Direct Settlement System (DSS), a technology platform on which coffee trading will henceforth be conducted as provided for in the new coffee trading regime supervised by the





Capital Markets Authority (CMA).

He added that the government will fast track the reintroduction of the Coffee Board of Kenya to over-

see and coordinate the coffee policy, especially positioning the Kenya coffee globally and working with county governments to strengthen the extension services. "We would like to invite our coffee traders and buyers both local and international to support the farmers and the government by offering prices that are commensurate to the farmers' efforts in the farm and the quality of our coffee," he added.

Kilemi recalled that between 1984 and 1990, the coffee sub-sector generated an estimated 30 per cent of employment opportunities in the agriculture sector while the households involved in coffee production progressively increased from 11,000 in 1963 to an estimated 700,000 families between 2019 and 2020.

Land under coffee cul-

tivation in Ke ya in 1963 was 45,000 her tares with a production of 3,778 metric tonnes of clean coffee. The hectares under coffee cultivation, the PS added, increased to 170,000 ha by 1987/1988 with an alltime high production of 129,637 metric tonnes of clean coffee but decreased to about 116,000 ha with a total production of 36,867 metric tonnes in the year 2019/2020.

"These numbers clearly spell the work we have to do as a sector," he noted.

Nairobi Coffee Exchange (NCE) Acting Chief Executive Officer Lisper Ndungu announced the appointment of the Cooperative Bank of Kenya as the provider of DSS to ease payment of proceeds to coffee farmers in the country.

Coffee market users -coffee brokers, traders, warehousemen, coffee farmers and other service providers were inducted by NCE Secretariat and coffee directorate on the workings of DSS. The then National Treasury and Planning Cabinet Secretary Ukur Yatani on April 3, 2020 gazetted the Capital Markets (Coffee Exchange), Regulations 2020, which brought the NCE and its members under the regulatory oversight of CMA.

Homa Bay unveils ambitious five-year development blueprint

■ The County Government of Homa Bay has launched a blueprint for development which will be rolled out over

the next five years. Launching the development roadmap, Governor Gladys Wanga said the County Integrated Development Plan (CIDP) was aimed at spurring productivity across all sectors of the economy.

Speaking during the launch of the CIDP in Homa Bay town, the Ms Wanga said her government was determined to deliver on all the pledges made ahead of the last general elections

She said among the strategies to be employed include eliminating communicable diseases, tackling the high burden of non-communicable diseases, providing essential medical services and minimizing exposure to health risks.

The Governor said her administration also plans to facilitate housing and urban development to accord residents the right to affordable and conducive acommodation.

She said the county government also intends to promote trade and tourism by improving tourist attractions and creating a conducive business environment

"Our objective is to create wealth, reduce poverty and create employment for residents." She added.

The Governor said the county also envisages construction of good roads and ensuring Homa Bay town becomes a city by 2034.

Among those present during the launch held at the new Governors Park was Deputy Governor Oyugi Magwanga, Senator Moses Kajwang and Woman Rep Joyce Osogo.

Prisons decongesting programme underway, PS assures

The Government Plans to decongest prisons with a view of improving the living conditions of inmates, State Department for Correctional Services Principal Secretary (PS), Salome Wairimu, has said.

To achieve this, one of the approaches the administration has employed is to work hand in hand with the judiciary to upscale the issuance of Probation Orders and Community Service Orders, the PS said.

"It is our desire that inmates, especially petty offenders, instead of serving sentences in prison they go and do community service or serve probation terms,'

Ms Wairimu said cur-

rently there were over 62, 000 inmates in the country, out of which about 25,000 are petty criminals who could be placed under noncustodial sentences to reduce congestion.

Speaking at the Embu GK Prisons during a familiarisation tour in company of among others Commissioner General of Prisons Brigadier John Kibaso, the PS said they are working closely with the Office of Chief Justice through the National Commission on Administration of Justice to achieve this.

PS wairimu said the State Department is also scalingup the Alternative Dispute Resolution (ADR) mechanism, to see to it that disputes, especially family or land related, are arbitrated and resolved locally.

On the issue of ADR, we are working with the National Government Administration Officers and other stakeholders, to see to it that family disputes can be resolved outside the court system," she said.

She encouraged the community to accept back the offenders who they are trying to rehabilitate in the non-custodial programme, so that they can be able to be reintegrated in the society and become productive.

"We are moving away from imprisonment and punishment of inmates to the program of reformation and rehabilitation, and we ask members of the society to give them the benefit of the doubt and a second chance," the PS said.

She also urged those wishing to be set free under presidential pardon commonly known as Power of Mercy, to make relevant applications for consideration.

The PS also said the Department had received a request from some inmates who want to be enrolled on a virtual university programme, saying they were working with the Ministries of ICT and Education, to work out the modalities.

At the same time, the PS reported that inmates' visitation had resumed following suspension in 2020, as a result of the outbreak of Covid-19 pandemic.

"We have now reviewed that and have allowed them to have their loved ones visit them, but within the set limits," she said.

Gov't to set up Maritime **Rescue Centre in Kisumu**

■ The Government will set up a Maritime Rescue Co-ordination Centre (MRCC) in Kisumu to address safety and security of Lake Victoria users.

Making the announcement, the Principal Secretary for the State Department for Shipping and Maritime Affairs Mr. Shadrack Mwadime said, Sh 350M has been allocated for the construction of the centre during the current 2023/2024 financial year.

Mr. Mwadime made the disclosure when he chaired the Kenya Lake Victoria Maritime Communication and Transport Steering Committee meeting in his office which was also attended by his counterpart in the State Department for East African Affairs, Mr. Dubat Abdi.

Additionally, Mwadime said the Government will put up four Search and Rescue Centres (SARS) in each of the riparian Counties of Migori, Homabay, Siaya and Busia which will be equipped with fast rescue boats and trained crews to provide first aid in case of accidents in the lake. "The Co-ordination Centre

and the search and rescue Centres will address the maritime transport and navigation safety through provision of safe, efficient, cheap and environmentally friendly transport and communication systems within the East African countries sharing the lake", said the PS during the meeting during which the committee also approved the project.

Kenya Lake Victoria Maritime Communication and Transport Project is the successor of the former Multinational Lake Victoria Maritime Communication and Transport Project which was conceptualized in 2010 and was envisaged to be implemented jointly and regionally by the East African countries sharing Lake Victoria. However, the Multinational

project which was financed by the African Development Bank (AfDB) at a cost of Sh. 3.6 billion, was faced by what was described as both technical and structural challenges that inhibited it from taking
