# Kisumu port's capacity doubles with MV Uhuru II ship commissioning

enya is on the verge of becoming a significant shipping hub with the commissioning and launch of the MV Uhuru II wagon ferry, a project valued at Sh2.4 billion, at the Kenya Shipyards Limited (KSL) in Kisumu County.

During the inauguration ceremony, President William Ruto highlighted the necessity of constructing this 100-meter-long vessel, MV Uhuru II, to complement MV Uhuru I and meet the rising demand for transporting goods within the Lake Victoria region.

The President commended KSL

for achieving this milestone, stating that it positions Kenya as a destination for shipbuilding and repair in the East Africa region.

Further, he underscored Kenya Shipyards' ability to build, repair and maintain ships for the local and regional markets as a reflection of the nation's commitment to harnessing available resources and talents to meet the region's growing demand for quality maritime services.

"MV Uhuru II before us is not only a means of transportation, but also a catalyst for economic

grade of C plain were not eligible to secure admissions at various teacher colleges due to cluster requirements.

Machogu, however, hastened to say the elimination of the cluster requirement was not meant to compromise the quality of education

"What was done before was insensitive, irresponsible and really we cannot allow that kind of situation. And that is why I commit to implement and enforce the recommendations made by the Presidential Working Party and remove the cluster element that was there before which does not mean that we are compromising the quality of edu-cation", he stated.

Machogu made the remarks in Mandera County when he led other education officials to launch various infrastructural projects including the Mandera Teachers Training College, the Technical Training Institute as well as the County Education Taskforce Report.

He said the government will implement in totality the recommendations in the PWPER report.

At the same time, the Cabinet Secretary banned transfer of non-local teachers from the Northern Counties of Kenya.

"This tendency of some people saying that they want to move out of this area because of one reason or another, we are not going to allow nor agree with it", he added.

Mr. Machogu further said that, the government is committed to addressing the teacher shortage experienced in the northern regions of the country.

"We will take action by making sure that we post more teachers now that we have good enrollment in our teacher colleges", the Cabinet Secretary further said.

He said the government has put in place adequate measures to ensure that early exposure of exams does not take place anywhere across the country.

been constructed from scratch by KSL personnel in conjunction with Damen Gorinchem company from the Netherlands would double Kisumu port's haulage capacity to over 2,300 tonnes.

MV Uhuru I, built in 1965, was brought into operation after her successful rehabilitation by the Kenya Defence Forces in 2019 with a capacity to carry 1,260 tonnes of cargo.

Subsequently, MV Uhuru II is capable of transporting 1,063 tonnes of cargo and is optimised for transportation of petroleum oil products as well as cereals, fertilisers, sugar and seeds.

Construction of MV Uhuru II was completed within a period of 24 months, 12 months ahead of the usual 36 that it ordinarily takes to complete a project of such magnitude.

# Cabinet approves Sh117b bailout for struggling state owned sugar companies

## **BY CHRIS MAHANDARA** (KNA)

he Cabinet has approved a Sh117 billion bailout for six state owned sugar factories in the Western and Nyanza regions.

During a sitting held at the Kisumu State Lodge, the Cabinet directed the National Treasury to work on the necessary paperwork to facilitate the process.

President Dr. William Ruto, who chaired the meeting, said the executive will submit a supplementary budget to the National Assembly for approval for the funds to be made available as the government moves to revive the sugar industry.

"The cabinet has approved Sh. 117 billion to clear debts of the six state owned sugar millers. This will ensure that all these debts are put behind as we move to lease the sugar factories," he said.

Speaking at the Kenya Shipyards Limited (KSL) in

Kisumu, where he commissioned the newly build MV Uhuru II vessel, the president said the bailout targets South Nyanza Sugar (SONY), Nzoia Šugar, Muhoroni, Chemelil, Miwani and Mumias

Sugar companies which are earmarked for leasing.

The government, he said, was determined to revive the sector adding that the money shall be released to the factories by this week as preparations for leasing the firms continue.

Leasing, he added, was set to inject capital in the struggling firms and ensure they operate optimally to save farmers from agony.

The programme, he said, was set to benefit not only farmers but also members

of the community, adding that the land on which the factories sit will continue to be in the hands of the com-"Initially the nucleus and all the other facilities

did not directly benefit the community.

Members of the community will now use county governments or any other entity that shall be agreed upon to benefit from the nucleus owned by the factories," he said.

Apart from sugarcane, he said the government through the Bottom-Up Economic Transformation Agenda (BETA) was on course to revive agriculture in the Nyanza region.

"It is not only sugarcane that we are focusing on. This region has potential for many other crops including cotton, maize, vegetables and beans," he said.

Among the key interventions, he said is the expansion of the Lower Nzoia Irrigation Project at a cost of Sh5.9 billion.

A similar venture, he added, has been planned in Migori County with the Lower Kuja Irrigation Project set to be expanded by 14,000 acres.

The two projects, he said, target to scale up rice production in the country.

# **ADC Board commits to** ensuring food security through partnerships **BY SADIK HASSAN(KNA)**

he newly inaugurated Agricultural Development Corporation (ADC) Board has made a commitment to ensuring that the country achieves food self-sufficiency following the recent

prolonged drought. To achieve this goal, the Board is actively seeking partnerships with the private sector, focusing on maximizing the potential of ADC lands in Galana Kulalu, Tana River County, and the ADC Kisiwani Complex in Malindi, Kilifi County.

Mohammed Bulle, the Managing Director of ADC, mentioned the government's encouragement of Public-Private Sector Partnerships (PPP) through the PPP Act, and the ADC's intention to move in that direction.

Speaking during a visit to the ADC Kisiwani Complex in Malindi, where the new Board, led by Chairman Abdillahi Alawy, toured the Galana Kulalu project in Tana River, Bulle

expressed the Board's commitment to finding suitable private sector partners to enhance food production and nutrition security in the country.

Several private sector entities, including the Nyumba Foundation, Twiga Foods, and Sheldrick Wildlife Trust, have submitted applications expressing their interest in collaborating with the government.

These partnerships aim to boost local production of edible oil, increase maize production, and contribute to wildlife and vegetation conservation efforts in the Galana Farm region.

The Board has visited other parts of the country including Kitale, where there are satellite ADC facilities to assess them in their orientation tour.

According to the MD, partnership with the private sector, will happen in Galana and not at the ADC Kisiwani complex.

"It is going to happen in the near future," Bulle said

# KPA expands Mombasa Port and infrastructure to foster regional trade

The Kenya Ports Authority has been investing heavily in the implementation of various port projects in the country to align with the global trends and guarantee the competitiveness of its facilities within the African region.


According to the KPA Managing Director Captain

William Ruto, Mombasa being the biggest and busiest port in the East and Central Africa region, capacity expansion at the Port is on-going, as the Authority targets to benefit from the expanding economies of the region.

Ruto, who was speaking during the KPA Corporate Golf dinner at Vetlab Golf Club at Kabete in Nairobi, said with Phase Two of the second container terminal in the Port of Mombasa now operational, the port's capacity stands at 2.1 million TEUs annually.

To complement the newly developed infrastructure, Captain Ruto, whose speech was read on his behalf by the General Manager, Corporate Services at KPA Mr Edward Kamau added, KPA has procured new equipment to facilitate faster and efficient

cargo handling adding that the acquisition of the three new ship- to shore gantry cranes (STSs) have replaced the decommissioned ones at berth number 16.

"For yard operations, the Authority has acquired an additional nine empty container handlers, 12 reach stackers and terminal tractors to keep up with the demand occasioned by rising cargo volumes in the Kilindini Harbour," the KPA MD revealed.

He added that Harbour Mobile Cranes have also been delivered, with three cranes deployed to the Port of Lamu and with the first phase of Port of Lamu up and run-

ning, the port will receive three ships-to-shore gantry cranes by the end of year to make the facility a fully fledged container terminal.

KPA is liaising with partner government agencies like Lamu Port South Sudan Ethiopia (LAPSSET,) the Kenya National Highways Authority (KENHA), and National Lands Commission (NLC) to fastrack completion of other infrastructure like roads network, roadside stations along the corridor including truck marshalling yards, service centres and resting places.

# Stakeholders in Kajiado call for laws to control sand harvesting

Stakeholders and environmentalists in Kajiado County are urging the local government to enact laws regulating sand harvesting in the area to combat environmental degradation.

During a public participation forum held in Kajiado Town, the participants highlighted the severe environmental damage caused by uncontrolled sand harvesting over the years.

They emphasized the urgent need for legislation to manage this practice and reduce its harmful impacts.

According to Kajiado Youth Senate Representative Gideon Toimasi, sand harvesting in Kajiado was a ticking time bomb and there was need for swift enactment of legislation to regulate the sector.

Toimasi noted that the region had experienced the effects of environmental impacts including riverbank degradation, soil erosion, destruction of wildlife habitat, biodiversity loss, sedimentation of seasonal rivers, and drying up of tributaries.

"As much as we are earning from sand harvesting, there is a need to regulate the sector so as to protect the environment for

posterity and ensure ecologically sustainable development and use of natural resources," he said.

Toimasi added that apart from the negative effects on the environment, drugs and substance abuse and child labor were on the rise as many young boys were dropping out of school to work as sand loaders.

The Youth Senate representative revealed that they had petitioned the County Assembly to pass the Kajiado County Sand Harvesting and Quarry Bill 2020, which would ensure the regulation of sand harvesting in the county.

He said once the laws are enacted, the sector will benefit all stakeholders including the sand harvesters and loaders who are often exploited by middlemen.

"Once the bill is passed by the Assembly, all parties will benefit fully from it and there will be no more exploitation by rogue sand dealers. There will be regulation on how the community can harvest sand while protecting the environment," Toimasi remarked.

Rashid Muzee, an environmental activist, echoed Toimasi's remarks adding that many families relied on sand harvesting as a source of income but do not benefit fully from it due to exploitation by middlemen and sand dealers.

In light of the provisions of section 57 A of the Environmental Management and Coordination Act (EMCA) 1999, Regulation 42 and 43 of Environmental (Impact Assessment and Audit) Regulations, 2003, the National Environment Management Authority (NEMA) has received a Draft Strategic Environmental Assessment report for the Reviewed Integrated National Transport Policy (INTP). The SEA findings are expected to integrate the existing sectoral policies, plans and programs to establish sustainable development mechanisms.

The State Department for Transport is the Policy owner and recognizes that an appropriate INTP is the prerequisite for attaining an excellent transport system that is responsive to the needs of the people and the industry. The INTP intends to promote the Country's development in terms of integrating production, marketing and population centres hence facilitating mobility in rural and urban areas, national and regional integration, trade promotions, improving the welfare of the people and Kenya's competitiveness.

The policy is based on the recognition that the construction of transport infrastructure systems and their maintenance often affect the environment, leads to displacement of human settlements loss of livelihoods, habitat fragmentation among other negative changes in the environment. As such there is need to ensure that the environmental, social, health and safety considerations are incorporated in transport infrastructure development, management and operations to safeguard the environment and human health.

A summary of the proposed environmental management and monitoring plan for the Integrated National Transport policy is highlighted in the table below. The proposed mitigation strategies are aimed at minimizing the negative impacts while enhancing the positive ones.

The Music Copyright So-ciety of Kenya (MCSK) is upbeat that recent commitments by the government to monetise the music sector through the Talanta Hela Programme and the unveiling of various policy measures and enactment of legislation to fight piracy so that musicians get compensation commensurate to costs of production and standards of living will put billions of shillings in the pockets of the artists.

The MCSK says that the policy measures unveiled and the legislation to be passed by the Government will fight poverty, depression and drug abuse among them by putting money in their pockets.

MCSK Chief Executive Officer Dr. Ezekiel Mutua says under the Kenya Kwanza government, music is being recognized as a business and the copyright ecosystem is being streamlined to maximise profits and ensure that music becomes a profitable and respectable business for Kenvans.

Dr. Mutua acknowledges

that the Government has lined up new initiatives to spur growth of the music industry.

He said that the launch of the Talanta Hela Program which is a flagship project to monetise sports and creative arts under the Ministries of Sports and Youth Affairs as well ad Gender, Culture and the Arts in line with the Bottom UP Economic Transformation Agenda (BETA) as well as the rolling out of the Blank Tape Levy otherwise known as Private Copying are among some of the key initiatives which are likely to take the industry to a new level.

Dr. Mutua, who was speaking to MyGov in an exclusive interview, said the Blank Tape Levy will generate between Sh6 to 11billion for the MCSK members once it gets fully operationalised through levying a nominal fee for all gadgets with copyrighted materials and the Society was collaborating with the Kenya Revenue Authority (KRA), the Kenya Copyright Board (KECOBO) to identify those producing the gadgets to collect the levy.

"This new Levy is poised to immensely benefit all musicians, book publishers and audio visual performers as the sector transitions from the old and traditional methods of collecting royalties from those who play music in their hotels, public service vehicles, broadcasters, clubs and it will also target to collect money from new media like tiktok, youtube, instagram with renewed government support," Dr Mutua said

"The Government has begun to understand that music is business and that it can create jobs and wealth but also act as a tool to re-engineer Kenya's moral fabric and with government support, we are championing the interests of musicians given that music could be deployed as a vehicle of shaping national values.



# Institute pilots game-changing saline water purification for agriculture

#### **BY EMMANUEL MASHA** (KNA)

Kenya Marine he and Fisheries Institute (KMFRI) is currently piloting a saline water purification technology that could potentially revolutionize agriculture in Kenya's arid and semiarid areas (ASALs), turning them into food-producing regions.

This innovative technology also has the potential to produce lithium, a valuable natural element used in various industries, including the manufacturing of lithium metal, lithium-ion batteries, heat-resistant glass, ceramics, and lithium grease lubricants.

Known as the "Seawater Greenhouse Technology and Lithium Mining from Saltworks Project," this initiative is undergoing pilot testing in the Kadzuhoni area of Magarini Sub County, Kilifi County.

Notably, it is one of only

two such projects in Africa, with the other being piloted in Somalia.

Dr. Joseph Nyingi Kamau, a research scientist at KM-FRI, has explained that the technology is most feasible in regions with abundant saline water, strong winds, and high temperatures, making places like Turkana potential candidates.

Dr. Joseph Nyingi Kamau, a research scientist at KM-FRI, says the technology is feasible in areas that have huge amounts of saline water, strong winds and high temperatures, such as Turkana.

entist explains that the saline water from the sea or aquifers is sprinkled on an evaporator setup erected on a greenhouse that is constructed using paper local materials to form two radiator-like structures - the evaporator on the windward side and a condenser on the opposite side - while the roof and the other sides are covered by polythene materials.

Dr. Kamau says that the windy environment provides a gust of wind flow into the greenhouse, which evaporates the water from the evaporator into the greenhouse and flows to the other end where it passes through a heat exchanger to warm the humid air.

The research scientist adds that the humid air then passes through a condenser where it condenses and is collected in a reservoir, ready to be used to water crops and for domestic purposes.

# KenGen gets nod for Gogo Hydro power in Western Kenya

**h**e Cabinet has granted approval for the Kenya Electricity Generating Company PLC (KenGen) to initiate the Gogo Hydropower Redevelopment Project, marking a significant step towards harnessing clean energy in Western Kenya for the first time.

This decision, made during a Cabinet meeting chaired by President William Ruto at the Kisumu State Lodge, offers hope to the people of Western Kenya, who stand to benefit from this transformative and environmentally resilient project.

According to KenGen Managing Director, Eng. Peter Njenga, the Gogo Hydropower Redevelopment Project, located along the picturesque banks of the River Kuja in Migori County, aims to increase the dam's electricity generation capacity from 2MW to a robust 8.6MW.

Eng. Njenga noted that beyond its economic impact, this transformative endeavour aligns with Kenya's commitment to clean energy and bolsters its efforts to achieve the 100 per cent clean energy targets outlined in the Global Climate Action Agenda.

'The Cabinet's approval of the Gogo Hydropower Redevelopment Project is a momentous milestone for the people of Western



ment to the government's commitment to regional development," said Eng. Njenga.

He added, "This project not only signifies progress in the energy sector, but also holds the promise of economic growth, job creation and improved livelihoods for our communities while contributing to our clean energy goals.

"The existing power plant, with its origins dating back to 1958, has admirably served its purpose, but now suffers frequent breakdowns and the challenges of sourcing spare parts due to its aging infrastructure.

The MD said, the Gogo Project is set to rejuvenate the reliability of power supply, while stimulating socio-economic activities across the entire Nyanza and Western Kenya Regions.

Western Kenya hosts several significant power plants, including, Sondu Miriu Hydropower Plant, generating an impressive 60MW, Sang'oro Hydropower Plant with a capacity of 20MW and the substantial Turkwel Hydropower Plant, boasting a remarkable 105MW capacity.

These existing power facilities, Eng. Njenga said, have been essential in meeting the region's energy needs and fostering economic growth.

He said the people of Western Kenya in particular, are poised to benefit significantly from these combined efforts and the increased power generation capacity of the Gogo Hydropower Redevelopment Project, coupled with the contributions from existing power plants, will provide a reliable and steady supply of electricity.





# DRAFT INTERGOVERNMENTAL CONDITIONAL ALLOCATIONS TRANSFER AGREEMENT

Article 201 of the Constitution provides of principles of Public Finance and among them is that, "there shall be openness and accountability, including public participation in financial matters".

The County Governments Additional Allocations Act, 2022 amended the Public Finance Management Act, 2012 by introducing Section 191A – 191E. Section 191A requires that the National Treasury and the County Governments shall enter into Intergovernmental Agreements for the transfer of the Conditional Additional Allocations. Further, Section 191E provides that the requisition of funds from the county revenue fund for purposes of a conditional grant shall be supported by the intergovernmental agreement approved under Section 191A.

In this regard, and in order to ensure a consultative approach in developing the intergovernmental agreements, the National Treasury constituted an Inter-Agency Taskforce comprising of members from the National Treasury, ControllerofBudget (COB), Council of Governors (CoG), Commission on Revenue Allocation (CRA), Intergovernmental Budget and Economic Council (IBEC), State Department for Devolution, the Judiciary, Parliamentary Budget Office (PBO) and three representatives of the County Executive Committee Members responsible for finance.

The Interagency has finalized preparing the Draft Intergovernmental Conditional Allocations Transfer Agreement in line with the requirements of the law. The draft agreement once approved and signed will unlock the additional resources to county governments. The Draft Agreement and prescribed template for receipt of comments have been posted to the National Treasury website **www.treasury.go.ke**

# New road to rejuvenate more attractions for Tsavo tourism circuit

Ms Onunga adds that despite the delays that had faced the project in the past, the contractor was on site and had completed the first milestone of around 5.4 km.

Ms.Onunga pointed out that one of the sectors poised to benefit immensely from the completed project is tourism and Wundanyi will become the new addition to the Tsavo Tourism Circuit.

The administrator consequently urged the tour stakeholders and promoters to take advantage of the road and market their products to potential clients which she said will create jobs, increase grassroots revenue and market the region as a prime tourist destination.

"Once complete, it will allow the Tsavo tourism circuit to get an extra destination. We are hoping that stakeholders in the tour sector will exploit this chance and promote the hills and other areas as part of key tourist attractions," she says.

She also pointed out that the road will bolster farming activities through enhancing farmers' access to markets in Voi and Mombasa while promoting establishment of businesses along the winding route.

"The road is also intended to bolster the crop and dairy sector value chains for thousands of farmers in Wundanyi, Bura and Mwatate," she said.

# **KU medical** students to train at KUTRRH

The first cohort of 100 Kenyatta University School of Medicine students will now access the Kenyatta University Teaching, Referral and Research Hospital (KUTRRH) facilities, following the recent Kenya Medical Practitioners and Dentists Council (KMPDC) regulatory accreditation.

According to KUTRRH CEO, Ahmed Dagane, the level six facility is all set to onboard Kenyatta University School of Medicine students as per the regulatory procedures outlined by KMPDC to undertake patient bedside teaching (BST).

As part of the reception protocols, KUTRRH, he said, had already shared an Onboarding Letter with Kenyatta University, outlining a detailed orientation process and programme for the students and their supervisors. "Medical Training in

Kenya is undertaken through a strict regulatory regime involving KMPDC accreditation to ensure quality assurance.

'The onboarding protocols have been outlined and shared with Kenyatta University to facilitate entry of the first 100 School of Medicine and Surgery Undergraduate students,<sup>3</sup> said Dagane.

Upon entry and orientation, the students, he explained, will undergo clinical rotation in five wards, renal unit, and oncology department, including access to the CyberKnife, Brachytherapy, Linac and Chemotherapy pharmacy treatment areas.

Dagane said that the students will also access the accident and Emergency department, Pathology services, Radiology and Imaging department, and Surgery Department, including BST access to the seven KUTTRH Surgical Wards and seven surgical operation theatres.

- Operators and owners of any facility storing chemicals to take appropriate measures to prevent flood water getting into 5. ntact with the chemicals
- Producers: Attention to Section 13 of the Sustainable Waste Management Act, 2022 requires producers to bear mandatory 6. Extended Producer Responsibility obligations to reduce pollution and environmental impacts of the products they introduce to the Kenyan market and waste arising therefrom. In this regard the producers should ensure that their post-consumer waste does not clog drainage systems, obstruct flow of rivers or cause pollution to the ecosystems. # **Small scale farmers call on Government to** recognize and protect informal seed sector

armers in the Central Rift are now urging the national government to promote the production of indigenous crops and ensure access to their seeds as a means to mitigate the effects of climate change.

Over 500 farmers, operating under the Makongo Agriculturalists Network (MAN), are also calling for both levels of government to devise policies aimed at safeguarding the sovereignty of Kenya's indigenous seeds.

This is seen as a vital step towards enhancing food security and preserving the rich variety of indigenous seeds.

While appealing to the government to address the shortage of indigenous seeds, organic farm inputs, and ensure access to markets, MAN's spokesperson, Mr. Francis Ngiri, emphasized the importance of implementing systems to identify and document all Kenyan seed varieties. This approach aims to protect sovereignty, preserve historical heritage, and bolster food security.

The event brought together smallholder farmers, botanists, entomologists, agronomists, agricultural economists, meteorologists, and a host of other professionals

Ngiri highlighted that the conservation and utilization of traditional crop varieties offer a wealth of crop ge-

He pointed out that more than 80 percent of smallscale farmers in the country rely on the traditional seed sector, even though the country's seed laws and regulations do not acknowledge the informal seed sector. It's currently illegal to sell uncertified seeds in Kenya, including traditional seeds sold in local markets.

Due to Intellectual Property Rights and the Plant Variety Act, which currently prohibit farmers from selling or exchanging unregistered seeds, the Seed Savers Network is encouraging farmers to participate in community seed banks. This way, they can protect their seeds from issues of bio-piracy and theft.

Ngiri emphasized the need for lawmakers and technocrats at both levels of government to develop legislation and policies that allow farmers to produce safer and healthier foods using readily available indigenous seeds, which they can freely share among themselves.

He also revealed that the Network is promoting the use of traditional farming methods to smallholder farmers, which are pesticide-free and cost-effective. These methods enable farmers to increase their household incomes while improving their nutritional status.

Ngiri explained, "Indigenous seeds go hand in hand with traditional farming. Farming should be an enjoyable and profitable venture for many, not something that many small-scale farmers cannot afford.

# Germany donates Sh25m eye unit to Taita-Taveta

Germany has officially handed over an eye unit to the Taveta County government at Moi County Referral Hospital, marking a significant milestone in their collaborative effort to enhance eye healthcare services in the region. The construction of this state-

of-the-art eye center, valued at Sh 25 million, was made possible through funding from the German non-profit NGO, Deutsches Blindenhilfswerk (DBHW), in conjunction with the Federal Ministry for Economic Cooperation in Germany, facilitated by Salus Oculi Kenya. During the handover ceremony, Simone Henzler, representing DBHW, expressed her satisfaction with the successful completion of the project's first phase. She emphasized that this achievement was a testament to the fruitful partnership between the county and their development partners. Furthermore, she underscored that the newly established eye unit would be instrumental in providing essential eye care services to patients with visual impairments, not only within the region but also to those from neighboring areas.

"We are delighted to have collaborated on and completed this initial phase of the project, which will be instrumental in offering much-needed eye care services to those who require them," she said."

Though the referral hospital has been running a small eye-unit that was faced with challenges of confined space, the fully-fledged eye unit will now have its own stand-alone building, compound and adequate space. Poised to be one of the biggest in Coast region, the unit boasts of a theater, sluice rooms, male and female wards, sterilization and scrub rooms. Governor Andrew Mwadime hailed the project as one of the most critical in terms of enhancing eye-health care for thousands of residents suffering from eye ailments. He stated that the county will continue to engage donors and partners in a bid to woo them to establish more facilities that will serve the residents.

# **Construction of Sh3b Lord Egerton Agro-Industrial Park commences**

The construction of the Lord Egerton Agro-industrial Park, a multibillion-dollar project aimed at transforming the Central Rift region into a major commercial hub, has finally commenced.

Mr. Stephen Muiruri, the County Executive Committee Member (CECM) for Trade, Culture, and Tourism in Nakuru, revealed that the industrial park would host a variety of industries, including ICT hubs, energy sector companies, engineering and construction firms, and chemical industries.

He, further, explained that the County government, in collaboration with Egerton University and the Ministry of Agriculture and Fisheries, was developing this facility on 200 acres at the University's Ngongongeri farm in Njoro. The goal of the industrial park is to attract private

investors to establish food processing plants, adding value to agricultural produce.

Mr Muiruri noted that support from National government had unlocked the delays in the implementation of the over Sh 3 billion project, that is expected to create more than 4,000 employment opportunities upon completion.

Speaking when the County Government handed over the site to a contractor, Mr Muiruri disclosed that the devolved unit's County Aggregation Industrial Park (CAIP) and Export Processing Zone (EPZ) have each been allocated 100 acres at the University's Ngongongeri farm.

He said the County Government had approved a policy document to establish and implement County Aggregation Industrial Parks (CAIPS) and Special Economic Zones (SEZs).

The CAIP project is a partnership between the State Department for Industry and the Council of Governors (COG) and it will see Nakuru County allocate 250 million shillings towards the initiative this financial year which will match a similar amount from the national government," Mr Muiruri indicated.

The CECM who was accompanied by Trade Chief Officer Mr Samuel Ndegwa stated that the devolved unit bets that CAIPS and SEZs will help grow industrialization and incomes to provide quality life to all residents by 2030 in a clean and secure environment.

Mr Muiruri noted that the county administration was also collaborating with the Ministry of Investments, Trade and Industry (MITI) to start CAIPS in line with the bottom-up economic transformation agenda.
