Sh18.6b project for drought hit pastoralists economy

The State Department of Livestock in partnership with the PTA Reinsurance Company (ZEP - REPTA) with the support of the World Bank Group (WBG) will soon launch a Sh18.62 billion Drive Project to boost the pastoralists economy which has been hit by a prolonged drought.

The project is designed for de-risking, inclusion and value enhancement of pastoral communities in the next two weeks and seeks to harbor pastoral systems at the primary level through an integrated package of financial services such as drought index insurance, savings, digital accounts, and financial education through private sector investments in order to provide reliable markets to pastoralists.

The project also intends to mobilize the private sector and create necessary scale to transfer the risk of drought management.

Speaking ahead of the launch at a Nairobi hotel, State Department of Livestock Development Prin-

State to complete transfer of county assets by June

The National Government has committed to complete the county assets valuation exercise and transfer all the assets to the devolved units by the end of June this year.

State Department for Devolution Principal Secretary, Ms Teresa Mbaika said, the transfer of assets to county governments is a constitutional requirement intended to equip county governments with resources necessary to enable them perform their functions.

Speaking in Nairobi during the launch of the National Steering Committee on County Assets Valuation and Transfer, Mbaika explained that the assets contemplated for transfer include those inherited from the defunct local authorities and assets of the national government on devolved functions.

"The Constitution and the Transition to Devolved Governments Act intended that the

State to complete transfer of assets to counties by June 2023

identified assets would be transferred during the “transition period” interpreted to be three years after the 2013 general elections. The process is yet to be concluded almost 10 years after the prescribed time,” she explained.

“Failure to transfer the assets compromises the ability and capacity of the recipient county governments to utilize the assets as a means and instrument of service delivery.

“This delay prompted the Intergovernmental Budget Economic Council (IBEC) to intervene and issue directives to the Ministry of Lands and Physical Planning to carry out valuation of the assets both for purposes of establishing their book value and transfer to respective county governments,” said Mbaika.

To fast-track the process, the PS said her department published gazette notice number 3839 on 24th March, 2023 which has some significant difference from the previous legal

framework.

The PS said this committee is expected to submit its final valuation reports to the National Technical Committee which in turn shall submit to the Intergovernmental Relations Technical Committee (IGRTC) and finally to the Steering Committee.

“The Steering Committee shall then transmit to IBEC for approval and

adoption. The transfer instruments shall thereafter be forwarded to the relevant Government Agency to effect the transfer,” said Mbaika.

The PS expressed hope that with these interventions and the support from partners, her department is certain of beating the June 30th deadline to complete inspection and valuation of the assets.

Principal Secretary (PS) Harry Kimtai said the project is expected to have a positive impact on enhancing climate resilience of pastoral communities and address climate change.

He added that the project will strengthen commercialization of livestock production and ensure the inclusion of marginalized and vulnerable groups, including women and youth.

The PS said that in the country, it is estimated that over 150,000 pastoralists from the Arid and Semi-Arid lands (ASALs) are expected to create markets around the livestock value chain, enhance regional cooperation, peacebuilding, and mitigate climate change and in so doing, close the gender gap to accessing financial services.

“The Drive Project is a critical step towards sustainable development of pastoral communities in Kenya that seeks to provide necessary support and resources which in turn increase resilience and en-

hance economic participation,” Kimtai said.

Further, Kimtai noted that livestock is a key pillar in the economy saying that Kenya is the third largest country in livestock rearing with 10 to 13 per cent Gross Domestic Product (GDP) taking 50 per cent of the agricultural exotic labour force.

Kimtai stated that as part of the Horn of Africa initia-

tive, the Drive Project seeks to build resilience of pastoral communities in Kenya, Ethiopia, Somalia, and Djibouti with over 250,000 households of about 1.6 million pastoralists expected to benefit from it across the four countries over a five-year period. The project will be launched in the next two weeks and will be implemented in 21 ASAL counties.

Technology institute in plan to mitigate climate change

For the past two years, the Rift Valley Institute of Science and Technology (RVIST) has been running an ambitious program focusing on mitigating the effects of climate change.

Teaching staff and students have been visiting the countryside of Nakuru, Baringo and Narok Counties and training farmers on sustained innovation in drought-resistant seed varieties, environment friendly practices and better post-harvest management to reduce losses.

The team has also been engaging the communities in activities such as tree planting, soil conservation, climate smart farming methods and clean-up of water bodies.

This noble cause has caught the attention of the Governing Council of sixth edition of the World Federation of Colleges and Polytechnics (WFCP) 2023 TVET Excellence for All Awards that has nominated RVIST for the award of Sustainable Development Goal- Championing mitigation on climate change.

According to the institution's principal Dr Sammy Chemoiwo, climate change has become a threat to food security the world over. Its effects include unpredictable rains, leading to decreased yields and increased production costs. Dr Chemoiwo, a career educationist in technical education, has also been nominated for the Leadership Award.

Winners for the awards will be an-

nounced during the WFCP World Congress to be held in Montreal, Canada from April 25-27.

The congress, touted as the largest professional and technical education event in the world, will be attended by more than 700 delegates from 50 countries and six continents.

Researchers and students at RVIST

are also exploring the use of technologies and innovations like solar irrigation, digital agriculture, climate-smart agriculture and climate-smart breeding, as ways to tackle the negative effects of climate change.

Other technologies the institute is rooting for include bio-fortification and use of climate-smart seed varieties.

Gov't launches Kenya Coast Guard Strategic Plan

The Principal Secretary for Interior and National Administration Dr Raymond Omollo has lauded the huge strides made by Kenya in the maritime security and safety sector since the establishment of Kenya Coast Guard Service (KCGS) five years ago.

Dr. Omollo said the security sector was cognizant of the modalities and technologies employed by criminals in trafficking narcotics, humans and weapons, piracy and terrorism among

others, adding maritime crimes remain a big threat and are getting advanced and expressed the government commitment to curb the challenges.

Omollo made the remarks in a speech read on his behalf by the Ministry's Principal Administrative Secretary Ms Anne Ngetich during the launch of the first Strategic Plan for the Kenya Coast Guard Service (KCGS) 2023/24 - 2027/28 that focuses on the delivery of secure and safe territorial waters in the country.

The PS noted that the presence of KCGS has suppressed illegal, unreported and unregulated fishing in the coastal and inland waters, through intelligence-led patrols and sustainable utilization of the resources.

"Despite the many positive steps we are taking to the growth of KCGS, we are now witnessing an increase in geopolitical strategic competition, economic volatility, impact of climate change, shifting workforce expectations and evolving technologies," - Dr.Omollo.

Kenya, Finland sign agreement deal to fight gender based violence

Kenya's efforts to strengthen the prevention and response to Gender Based Violence (GBV) in the country has been given new impetus following the signing of a Memorandum of Understanding with the government of Finland.

The MOU, dubbed the Kenya Finland Bilateral Program, aims at eradicating all forms of Gender-based Violence (GBV) including Female Genital Mutilation (FGM) and child marriages in Samburu County by 2024.

The Cabinet Secretary for Public Service, Gender and Affirmative Action, Ms Aisha Jumwa and the Fin-

land Ambassador to Kenya, Pirkka Tapiola led the delegation which signed the agreement in Maralal, Samburu County.

The Programme seeks to strengthen prevention and response to GBV in the country in a three-year project implemented in Bungoma, Kilifi, and Samburu counties.

CS Jumwa said that

“I am happy to hear from the cultural leaders who are taking stock of the post-Kisima Declaration,” CS

in Samburu County, the program has developed a calendar of GBV risks, vulnerabilities and prevention opportunities in order to strengthen coordination through more proactive, focused and collective planning.

“This calendar highlights key events that happen month by month that are likely to contribute to an increase or decrease in GBV including holidays, weather patterns, political events, school terms and vacations, cultural events and national or international days.” said CS Jumwa.

The CS also spoke strongly against child marriage and female genital mutilation cases which are also

pre-dominant in Samburu County and commended the Samburu elders for signing the Kisima Declaration to end FGM and child marriage in 2021.

“I am happy to hear from the elders and cultural lead-

ers who are taking stock of the post-Kisima Declaration and developing a roadmap to focus on the locations with the greatest risk and vulnerability. These efforts should go deep into the forest to meet with morans and

even have exchange visits between counties to inspire other elders to lead efforts to end FGM,” said CS Jumwa.

At the same time, the CS tasked local leaders to form women groups for reformed circumcisers so that they can get funding to start businesses through the Ministry of Public Service, Gender and Affirmative Action.

The CS reiterated the government's commitment in strengthening partnerships to completely eradicate GBV and other harmful cultural practices in Kenya.

The Finland Ambassador to Kenya Pirkka Tapiola commended the synergy between the national government and the county government of Samburu in their efforts to fight and eradicate GBV.

Samburu County Governor Lati Lelelit called upon Samburu residents to stop FGM adding that all negative cultural practices are fuelled by high levels of illiteracy.

The main section is approximately 49km and will have a desirable width of 40m and 25m in sections traversing Aberdares Forest and starts at Ithithe, through Nyayo Tea Zone, Aberdare National Park, Kahuruko and ends at Ndunyu Njeru. Other road sections include in the project are the Njengu -Treetops Gate - Ambone, the Ithithe - Kiamutiga - Mukarara, the Ark Gate Access, the Munyaka - Koinange - Heni - Mwendandu and the Njoma - Weru road sections, all totaling approximately 44km in length. The proposed project traverses through Nyeri and Nyandarua Counties.

Process to establish National Lottery kicks off with public talks

The Government is reforming governance of the betting and gaming sector by establishing a national lottery to promote responsible betting and gaming.

To achieve this, a presidential taskforce was formed to engage in wider

consultation with all key stakeholders in the county on the establishment of a national lottery through public participation.

Speaking to the media during a public participation forum at Machakos Social Hall, the vice chair of the taskforce Mr. Gideon Thurania said their mandate is to establish a

national lottery and to intervene in bringing about regulation in terms of policy formulation and setting up a gambling control bill. “The spirit of this task force is to grow and develop a national gambling industry that is responsible, inclusive and properly regulated,” he said.

Thurania, who is also the

chairman of the public participation forum, said that in the past there have been over-indulgence, under-regulation and infringement as residents get into trouble because of poor regulation in the industry.

He pointed out that Kenya does not have any gambling policy since the laws that exist were formulated in 1966 and since then, there have been so many changes and development such as on-line gambling and gaming

across borders.

The vice chair added that there has been infiltration of players who are not addressed by the 1966 act that controls gaming lottery and betting and that’s why President Dr. William Ruto formed a taskforce to bring in proper coordination and regulation.

“The National Lottery Fund will sit and identify projects to support and engage in public good such as sports, children’s home and culture,” he added.

WHO to support farmers to abandon tobacco, embrace alternative livelihood sources

BY SALOME ALWANDA (KNA)

The World Health Organization (WHO), in collaboration with the United Nations (UN), Food and Agriculture Organization (FAO), World Food Programme (WFP), the National Government and the County Government of

Busia have embarked on a programme to help farmers move from tobacco farming to alternative livelihoods.

The project dubbed tobacco free farms is targeting 150 farmers in Teso North Sub-County especially Angurai South, Angurai North, and Malaba North Wards

through the production of high yielding Nyota variety bean seeds.

Speaking during the inspection of the beans seed consignment at Busia Office, the CECM for Livestock Fisheries and Agriculture Symplicious Mukok said there was need for farmers



to diversify their farming activities.

"We have three tonnes of Nyota bean seed," he said, adding that the seed will later be shared with the neighboring sub counties so that it can later spread to the whole county.

He urged farmers to move from tobacco dependence adding that it had its negative consequences.

The County Agricultural Extension Officer Kennedy Otieno said WHO has mobilized resources to support

tobacco farmers get alternative livelihoods.

"WHO is funding, FAO is offering agronomic support and WFP is offering market linkages," he said.

Otieno explained that the high iron beans take 60 to 70 days to mature adding that it has no gases.

"FAO procured the Nyota bean seeds from KALRO Kitale before it was delivered to Angurai," he said, adding that the intended beneficiaries have been advised to prepare their farms.

The County Government of Nakuru has embarked on an ambitious plan to re-invigorate the cooperative societies sector in the area to help farmers market their produce in order to avoid exploitation by brokers who buy their products for a song.

To achieve this, the devolved unit's administration has highlighted its resolve to assist the farmers form and register societies as one way of putting more money in their pockets.

Noting that farmers should be protected from any form of exploitation, County Executive Committee Member (CECM) in charge of Agriculture Mr

Leonard Bor described the cooperative societies as the panacea of attracting good funding from government and financial institutions.

"Governor Susan Kihika's administration and the national government are keen to help farmers get organized in cooperatives. A significant number of farmers have not realized maximum market potential because they are not members of cooperatives," Mr Bor stated.

He stressed that farmers should come together and establish societies where they will deliver their harvests for sale.

"Unless the farmers get more organized, they will be exploited forever. By becoming 'middlemen' themselves, cooperatives

shield the farmer from the lop-sided relationship with the middlemen. Through aggregation, they enhance their bargaining power and prices owing to economies of scale. It also reduces the cost associated with individual trading," he cautioned.

He was speaking at his office when the County Agricultural Technical Committee received a presentation on the inclusive model for agricultural transformation to boost food production and promote food security from the Presidential Economic Transformation Secretariat.


The model, according to the CECM, is in line with Kenya Kwanza's manifesto to boost food production, promote food security and re-engineer the entire food production, storage and distribution chain to ensure that all Kenyans have access to affordable food all year round, come rain or

drought.

"The model proposes to restructure the agricultural sector through the formation of Ward Cooperatives, where farmers are encouraged to form and join ward cooperatives in which the government will invest. This will create multiple value chains that increase agriculture production and boost economic value. They will also utilize food production resources and reorganize production to reduce the cost of marketing while maximizing profitability to the farmers," Mr Bor explained.

The CECM challenged farmers to move from subsistence farming and penetrate the high-value export market, besides joining cooperatives to help access services and market their produce.

According to official records the county has currently more than 1,000 cooperatives.

IPv4 TO IPv6 MIGRATION STRATEGY

The Communications Authority of Kenya (CA) is the regulatory authority for the ICT industry in Kenya with responsibilities in telecommunications, cybersecurity, e-commerce, broadcasting, and postal/courier services. CA is also responsible for managing the country's numbering and frequency spectrum resources, administering the Universal Service Fund (USF) as well as protecting the interests of users of ICT services.

The Authority wishes to inform the public and all ICT stakeholders that it has developed an Internet Protocol version 6 (IPv6) Migration Strategy as part of measures to protect consumers of ICT services from the potential negative impact of the delayed or non-migration from IPv4 to IPv6 networks.

Benefits of Migrating from IPv4 to IPv6

- There are many benefits that will arise from the intended migration to IPv6. These include:
- The IPv6 will create a sufficient IP address pool for use by persons, as well as machines, facilitating the Internet of Things (IoT) networks.
 - Efficient routing due to the reduced size of routing tables, elimination of the need for address translators in the network, and elimination of the need to perform error checking at various stages of data routes.
 - Transparency in the network due to the fact that each node in the network has a distinct address, which also makes troubleshooting easier
 - Enhanced security as the IPv6 supports end-to-end IP security protocol mode
 - Efficient use of network bandwidth in the sending of data to multiple destinations.

Should Kenya delay in the full adoption of IPv6, then serious technological challenges may befall the country's ICT sector, including a lack of access to the Internet for new devices that will not have IPv4 addresses due to exhaustion.

There is also a potential lag in technological advancements due to the inability of the country to leverage new frontiers like the Internet of Things (IoT) devices which would be IPv6 enabled and which would require access to the Internet.

1.0 Background to the Consultancy

Kenya's mega fauna are in precipitous decline with an average loss of 68% in the last 40 years alone. While most of this decline has occurred outside of gazetted protected areas, designated conservation areas have also suffered losses. These losses are driven by a combination of factors including, climate and land use change, habitat loss and fragmentation, poaching and illegal wildlife trade, and human wildlife conflict.

Wildlife insecurity in Kenya is characterized by international trade in trophies and meat, commercial poaching for bush meat, illegal wildlife trade, and illegal bioprospecting and bio piracy. While the illegal killing of elephants and rhinos for export trade in ivory and rhino horn has been widely recognized as a key threat, the rise of commercial poaching for bush meat is emerging as a serious threat to species survival, as well as affecting tourism in key protected areas. High levels of poaching coupled with IWT in the past have been a threat to species conservation in Kenya. Enhancing the legal frameworks and enhancing supporting to anti-poaching activities will increase the possibility of species survival in Kenya.

The Ministry of Tourism, Wildlife and Heritage through the State Department for Wildlife, is leading the implementation of Global Environment Facility- (GEF-UNDP) funded project, 'Combating Poaching and Illegal Wildlife Trafficking in Kenya through an Integrated Approach-Kenya Illegal Wildlife Trade (IWT-Kenya)'. The project seeks to address legal, policy, and institutional gaps that respond to threats of illegal wildlife trade.

Kenya has taken significant steps toward codifying conservation and wildlife protection into a wildlife policy and legal framework since the promulgation of the new constitution in 2010. The Wildlife Conservation and Management Act (WCMA) of 2013 provides high minimum penalties for the killing of threatened or endangered species.

Nonetheless, the Act still lacks the subsidiary regulations necessary to make it effective in practice. This was highlighted during the design phase of the IWT-Kenya project, and gaps in legislation and regulations was identified as one of the three main barriers that currently prevent an effective response to poaching and illegal trafficking of wildlife in Kenya.

Kenya Wildlife Service is the national agency mandated to coordinate wildlife security matters in Kenya. The success of this depends on close collaboration with the communities living in important wildlife areas and other law enforcement agencies. On the other hand, wildlife crime is also regional and international due to the lucrative trade in illicit wildlife and wildlife products. There is therefore, need to enhance inter-agency coordination and collaboration. At the regional and international level, there is need to up-scale bilateral and multilateral engagements.

Hence, lack of a National Strategy to Combat Poaching and Illegal Wildlife Trade to guide coordinated actions to eliminate wildlife crime was identified as one of the serious gaps that needs to be addressed by the Project. This is one of the activities under Component on Strengthening national and local capacity for effective IWT control in Kenya. The expected results upon implementation are as follows: The outcome is to increase national and local capacity to fight wildlife crime through development of Kenya's National Strategy to Combat Poaching and Illegal Wildlife Trade.

2.0 Scope of the Consultancy

As per the provisions of the Wildlife Policy (2020); the government shall undertake the following:

Strengthen skill training, technological capabilities and innovation to secure all wildlife species and their natural habitats in accordance with the law;

Enhance inter-agency collaboration in combatting wildlife crime;
Mainstream wildlife security into the national security system;
Enhance the capacity of local communities to combat wildlife crime and biopiracy; and
Strengthen collaboration with regional and international law enforcement agencies to combat transnational wildlife crimes

The consultant will be expected to define strategies and approaches: that will reduce poaching, over utilization, and the illegal wildlife trade and their related impacts. Prioritize, develop and implement species- specific conservation and management plans that address emerging issues and challenges.

Conduct a comprehensive and continuous assessment, and communicate the results, of the status and threats for wildlife species
Enhance the coordination and capacity of security and law enforcement agencies to reduce, and improve responses to, incidents of poaching, illegal wildlife trade and reduce wildlife related crimes.

Modernize and expand wildlife security units to increase coordination and effectiveness The consultancy will involve review of comparable institutions, international best practice; an inception report to be followed by a meeting with Senior Management Team (SMT) as well as the Project Steering Committee and targeted stakeholder consultations.

The project will facilitate the development of such a Strategy in full accordance with the African Strategy on Combating Illegal Exploitation and Illegal Trade in Wild Fauna and Flora in Africa (2016-2025), the East African Community (EAC) Regional Strategy to Combat poaching and Illegal Trade in Wildlife and Wildlife Products (2017 – 2022), the Wildlife Conservation and Management Act (2013), the National Wildlife Policy (2020), and the National Wildlife Strategy 2030.

3.0 Institutional Arrangements and Monitoring and Evaluation Framework

A Steering Committee to oversee the Strategy preparation process will be established whose stewardship will be the State Department for Wildlife. The process will be participatory with involvement of all stakeholders. The Strategy is intended to cover a five-year period and be accompanied by a detailed Operational Plan for its implementation, to be agreed with the key law enforcement agencies. The implementation of the Strategy will be monitored by the ICCWC Indicator Framework assessments that will be conducted in Year 1 and then repeated in the final year of the project, with a subset of indicators selected as national indicators in Year 1 and measured biennially in Kenya by the MT&W, with support from UNODC and World Customs Organization (WCO).

4.0 Objectives of the Consultancy

The Ministry of Tourism, Wildlife and Heritage seeks services of a qualified consultant to submit technical and financial proposals for development of a National Strategy to Combat Poaching and Illegal Wildlife Trade in Kenya in line with the National Planning Guidelines, policies and legislative frameworks.

State ropes in corporate groups, CBOs to restore community land and forests

The Government has mapped out community land and forests for community-based organizations and corporate groups to adopt, as funds are extended to them to undertake restoration initiatives.

Through the Ministry of Environment, Climate Change and Forestry, the Government will avail the ecosystems for both state and non-state actors to adopt for a period of three years, allowing time to grow and nurture trees.

Speaking in Nakuru when she joined the World Resources Institute (WRI) in launching the TERRA Fund that will be available for restoration groups to take advantage of, Head of National Tree Growing Restoration Campaign Ms Linda Kosgei, noted that with as little as Sh30, 000, a group would adopt up to 10 acres' ecosystem and cater for the purchase of seedlings, watering of the trees and weeding each year, until the trees are mature enough to sustain themselves.

"The president has committed to planting 15 million trees to raise the tree cover from 10 to 30 per cent in 10 years according to the United

Nations Decade of Ecosystem Restoration plan. By bringing partners such as the WRI on board, the country will be able to reach its target of restoring its ecosystems," she said.

WRI- Africa Ms. Rebecca Shirley, regretted that already 65 per cent of arable land in Africa was too damaged to sustain any meaningful agricultural activities, rallying groups to take up the funds to stop further degradation.

"The funds to a tune of USD 12 Million will go towards restoring about 25,000 hectares of land in the Greater Rift Valley in Kenya, as well as Lake Kivu and Rusizi river basin in Rwanda, in a bid to seize about 3.77 tons of carbon dioxide that was causing

climate change," said Shirley.

She noted that the global non-profit organization would support restoration champions through direct financing, securing policies and capacity building as well as monitoring and evaluating the impact, with a focus on the landscape level, where 70 per cent of the targeted land is managed by communities.

In attendance was Elgeyo Marakwet Governor Wesley Rotich who rallied community forest association, schools and community-based organizations to plug into the programme that ensured that people earned a meaningful livelihood while maintaining the environment.

One Tree Planted founder Teresia Muthoni, whose organization has partnered with WRI to vet applicants for the funding called on groups to seek support in writing proposals and furnishing their ideas for better funding, arguing that the funds were meant to benefit all.

Nakuru Deputy Governor, David Kones, while calling on the residents to plant trees in all available spaces, noted that the funds would go a long way in mitigating climate change that had seen water levels in Lakes Nakuru and Naivasha rise.

International Maasai Festival to be held August

The Ministry of Tourism, Wildlife and Heritage in partnership with the Ministry of Foreign and Diaspora Affairs are organizing the first ever International Maasai festival to be held in the Maasai Mara in August this year.

The festival which aims at boosting Kenya's economy through tourism, celebrating culture and promoting cultural diplomacy, will coincide with the annual wildebeest migration.

Speaking in Nairobi during the launch of the initiative to lobby funds for the festival, Tourism, Wildlife and Heritage Cabinet Secretary Ms. Peninah Malonza noted that it is beyond any doubt that culture unites people and it is through culture that people create meaning to life's experiences. "Kenya has a rich cultural diversity of close to 50 distinct and colorful cultures. The Maasai culture, however, is the most unique culture which sells our nation internationally and plays a huge role in the tourism sector," Malonza said. The CS noted that very few African cultures can claim the fame and universal appeal that the Maasai culture

has earned both locally and internationally and it is no coincidence that UNESCO has classified three Maasai rites and ceremonies as World Cultural Heritage.

She added that the upcoming festival will provide a platform for Public-Private Partnerships to promote cultural entrepreneurship. During the festivals, the locals will have a chance to sell their products contributing positively to the economies of Narok, Kajiado, Baringo, Laikipia and Samburu Counties.

The week-long festivities will also provide an opportunity for conservationists around the world to meet and discuss the conservation of the Maasai Mara game reserve. The Maa Education Trust Chairperson Mr. Andrew Sunkuli, who is the brains behind the event, urged well-wishers to support the event which will be held annually.

Gov't launches trade testing series for candidates in TVETs

The Labour, Skills Development and Social Protection Cabinet Secretary Ms Florence Bore has launched a countrywide National Industrial Training Authority (NITA) assessment for 21,670 candidates in various Technical and Vocational Education and Training Institutions across the country.

Trade testing is a skills testing process to determine the level of competence of a person in his or her occupation or trade area for the purpose of certification and subsequent entry into employment.

Speaking at Cheptarit Vocational Training Centre in Nandi County, Ms Bore said the April test series will take place in 438 testing centres across 47 counties with candidates being tested in 43 trade testable skill areas for Grade 111, 11 and 1.

The CS said the Government trade test is a critical vehicle that goes a long way in reducing poverty by providing individuals with the skills and knowledge needed to secure better paying jobs.

"Investing in the development of the workforce will foster innovation and creativity, which are key drivers of economic growth and competitiveness," she said.

Bore noted that the ultimate goal of skills development is to improve the employability of individuals, increase productivity, reduce unemployment, poverty and strengthen innovation.

Bore who was accompanied by NITA Director General Dr. Steve Ogenga noted that the critical challenge facing training providers today is to prepare 'market ready' graduates to meet industry needs.

"To achieve this, the government aims to improve on skills development efforts and sector linkages for increased employability. This will be achieved by ensuring skills policy coherence across the economic, employment and social development arenas, as well as building a government wide approach that also engaged key stakeholders underlined by the principal of strengthening skills system effectiveness," she said. Bore said the national government remains cognizant of the need to foster a globally competitive, responsive and adaptive workforce through a skills development programs that adequately responds to the current and future skills demand of the industry.

County offers Sh3m fingerlings to Kisumu cage fish farmers to improve production

Fish farmers in Kisumu have received improved fingerling breeds and fish feeds valued at Sh3 million from the County Government to boost their fisheries production.

Governor Anyang' Nyong'o said the government had donated fingerlings and fish feeds costing Sh2 million and Sh1 million respectively to support the cage fish industry after majority of fish farmers along the shores of Lake Victoria incurred losses last year due to the effects of global warming at the water body.

Speaking during distribution of fingerlings at Ogal Beach, Kisumu West, Prof. Nyong'o stressed that his administration has prioritized interventions towards the promotion of cage fish farm-

ing and land-based aquaculture in the area.

"The county government is today giving out fingerlings and fish feeds to some 94 cage fish farmers who were worst hit by the calamity to help them re-stock and assist them to recover," Prof. Nyong'o said.

The fisher folks in all the eight landing beaches in Kisumu County reportedly recorded losses estimated at over Sh884 million with Ogal Beach having the highest number of affected farmers.

The Governor assured that the support will be scaled out to the other remaining

beaches that were equally affected.

"My government wishes to assure the fisher folks at Ogal and the entire county that we will stand with you at all times. We are working on policies that will improve fish farming, especially aquaculture and Blue Economy in general," he pledged.

Apart from the fingerlings' distribution, the County, in partnership with the National Government, has also promoted the construction and rehabilitation of fish ponds and enhanced capacity building in modern aquaculture as a measure to revitalize the sub-sector.

The County boss further stated that the formation of Kisumu Beach Management Unit (BMU) SACCO will be a game-changer for the sector.
