

The Ministry of Environment, Climate Change and Forestry has clarified that the lifting of a logging moratorium announced recently by the Government only applies to commercial plantations and not indigenous forests as misconstrued by a section Kenyans.

Cabinet Secretary Soipan Tuya said, the lifting of the ban imposed by the Government in 2018 following a spike in illegal logging was meant to allow for the harvesting of mature plantations, including those owned by the Government.

We have had a ban on logging existing in the country since 2018. At that time, it was a response to rampant illegal activities and high deg-

Kenya National Library Services unveils online library platform

¬he Kenya National Library Services (KNLS) has launched a Virtual Library to enable readers access books online, the first of its kind in Africa.

The virtual library, according to the KNLS CEO Dr. Charles Nzivo, contains children story books, cartoons, photography, wildlife, tourism, culture, science, information technology and CBC education

materials which are available online.

Dr. Nzivo who was speaking during the launch of the online library services at the Maktaba Kuu head-quarters in Nairobi noted that the services en-

tail a tier-two data centre available to leasing cloud storage services to both public and private entities and a digitization hub.

Speaking during the launch, Youth Affairs, Sports and the Arts Cabinet Secretary Ababu Namwamba said, Kenya's first virtual library contains over 200,000 digitised books, periodicals, research papers and government publications.

Namwamba added that

the virtual library which is accessible from any internet enabled device globally will also host e-books downloadable for offline reading. During the ceremony, CS

"When you hear about the lifting of the ban on logging, it only applies to the commercial plantations which have not been touched since 2018 due to the moratorium," CS Tuya reiterated.

The CS was speaking at North Horr town, Marsabit County where she commissioned Tiniqo and Horri Gudha wetlands, restored by the National Environment Management Authority (NEMA) as part of the 15 billion national tree growing and ecosystem restoration programme.

CS Tuya revealed that Kenya had a total of 150,000 hectares of commercial forests across the country, adding that a maximum of 5,000 hectares will be harvested annually to allow for replanting and regeneration of logged acreage.

"The 150,000 hectares are in parts of our gazet-ted forests, only there will we allow for harvesting of

commercial, exotic trees but not in indigenous forests," the CS said.

She said the lifting of the ban would allow private forest owners who had been restricted by the 2018 moratorium to harvest their mature trees.

"The logging ban also came with restrictions upon private forests where farmers who have forests within their farms could not harvest them. With the lifting of the ban, they will be allowed to log in a regulated manner," the CS said.

Namwamba also launched a tier-two data centre which state/public agencies and private institutions can lease cloud storage services and a digitization hub where Kenyans can seek to upload their books, records, newspapers or photographs.

"The virtual library has an assortment of resources accessible for free, especially children's content; and general information e-books, and journals that attract a nominal daily membership fee of twenty shillings payable via wireless payment platforms", the CS revealed.

He added that one can also pay weekly fee at Sh100, monthly at Sh500, bi-annual at Sh1,500 and an annual membership fee is set at Sh 2,500.

In a speech read on his behalf by CS Namwamba during the launch, President William Ruto who was supposed to preside over the ceremony, declared 12 July as the Annual National Reading Day.

In a dispatch to the media, KNLS said the virtual library solution and its components, the data centre and the digitization hub which was set up at a cost of Sh 250 million, seeks to encourage a reading culture and provide an avenue through which one can grow and hone their skills in a particular field, any-

time and anywhere.

KNLS says content available on Vtabu includes e-books for any subject studied at pre-school, primary, junior and high school, tertiary to the university level while fiction and non-fiction works have also been included as well as e-books and e-journals on any subject.

Authority issues warning to institutions holding unclaimed assets

The Unclaimed Financial Assets Authority (UFAA) has warned public and private in-stitutions holding unclaimed assets that they risk hefty penalties if they fail to release the assets on time.

Revealing that an estimated Sh242 billion was yet to be released to the Authority, the Agency said it will begin seizure of noncompliant companies to fast track surrender.

UFAA chairperson Kigo Njenga, who was speaking during a three-day public sensitisation forum, in collaboration with Huduma Kenya and National Government Administration Officers (NGAO) in Thika, Kiambu County, warned that upon the lapse of a moratorium of up to October 31, 2023, the Agency will obtain court orders to recover in full, interest and penalties accrued on unremitted assets.

billion in cash and Sh30 billion worth of

initiative because some of us would never have remembered the money." shares. "If the Sh242 billion is ploughed back into the economy, it might make a huge impact on the lives of its owners in this ailing economy," he said.

Under the law, unclaimed assets are supposed to be declared and surrendered to the Agency and institutions and organisations that default risk a fine of between Sh7, 000 to Sh50, 000 for each day a report on idle as-

sets is withheld or the duty is not per-formed.

The Authority's CEO John Mwangi said more sensitisation forums will be conducted to educate Kenyans on how to get their unclaimed assets that lay unused with the agency.

He said they have been to Nyeri, Nakuru and now Thika and will move across the country to ensure Kenyans owed by these institutions get their money back.

On his part, Benjamin Kai Chilumo, the Huduma Center CEO said the institution will partner with UFAA to continue devolving government services to Kenyans.

Joseph Gitai, a beneficiary, said he is lucky to get Sh200, 000 remitted from previous companies that he used to work in years ago.

He said he will put up some structures or buy a treasure in his house in Gatanga as a remembrance of the money that he never would have gotten.

"This is a good initiative because some of us would never have remembered that they had unclaimed money. My Sh200, 000 will boost my life. I will buy something to remember the money that I almost lost,"

Water canals in Mwea to be ready in two months-PS

The State Department of Irrigation Principal Secretary (PS) Elphantus Kimotho has assured Mwea rice farmers that the construction of all the water canals would be completed within two months. Construction of the 2.4-km canals which stalled at 1.5 km have hindered distribution of wa-ter into the rice fields.

Speaking during a familiarization tour at Kirinyaga County from the Thiba Dam to Mwea Irrigation Scheme, Kimotho said that with comple-

tion of canals, over 5,600 farmers would benefit from uninterrupted water supply. He commended the project's execution and the scheme mechanization through the use of rice combine harvesters, which minimized cost of production and post-harvest losses.

Ministry to implement water and sanitation works in Tharaka-Nithi

The Ministry of Water, Irrigation and Sanitation has mapped out two major water perojects in Tharaka Nithi County through the Tana Water Works Development Agency (TWWDA) for the implementation of water projects and sewerage treatment plants in the Chuka and Chogoria regions which will tap water for the arid lower region which overs Tharaka South and North through funding from the African Develpment Bank(AfDB) and the National Treasury.

According to Water, Irrigation and Sanitation Cabinet Seretary Ms Alice Wahome, studies conducted by experts in Kenya indicate that about 28 million Kenyans lack access to reliable clean safe water for house-

hold use which the government wants to address urgently.

To address this disparity, Ms Wahome revealed that the government wants to increase access to clean water for domestic use through the establishment of water treatment facilities, increasing the water distribution mains and the household connections within the country.

"The achievement of this goal will enable our cities and towns address the water and waste water needs that come with the rapid increase in population that our country is experiencing and a heavy focus has also been put on addressing all the issues related to climate change, illegal human activities such as farming along the river banks, illegal water obstruction up stream, and encroachment of riparian land which affect clean and reliable water access downstream", said the CS who was speaking at the Chogoria Water Supply Project which was commissioned by President William Ruto.

She noted that Tharaka Nithi County, is adversely affected by extreme weather events, mostly drought, moisture stress, and high temperatures and it experiences two main ecological zones in the highlands (upper zone), comprising Maara and Chuka, which receive adequate rainfall for agriculture; and the Semi-Arid Zone (lower zone) covering Tharaka North and Tharaka South and Igamba Ng'ombe sub-counties that receives less than 700 mm of rainfall per annum.and due to these factors, the larger region experiences stress in water access for household consumption.

In order to bridge that gap, the CS revealed, the Ministry of Water and Irrigation, through Tana Water Works Development Agency (TW-WDA) has mapped out two major water projects, one on the side of Chogoria, and another one on the side of Chuka to address the water supply disparities in the vast county.

The two programs also include sewerage treatment plants for the two regions which will be the first ones in the region. Prior to these investments, the region did not experience any formal waste water management and this is a huge milestone in promoting the realization of the goals set out in the county growth masterplan and these programs jointly will assist in boosting the water connectivity and clean water access in the urban areas and to the downstream households", CS Wahome declared.

To successfully implement these projects in Tharaka Nithi, the Government has already secured funding from Africa Development Bank (AfDB), whose line of funding is dedicated to critical African Government's infrastructure projects through the National Treasury.

The Chogoria Water Supply Project, Ms Wahome said has been successfully implemented through Tana Water Works Development Agency (TWWDA) which provided oversight as the agency charged with water and sanitation infrastructure development in the geographic area covering Nyeri, Kirinyaga, Embu, Tharaka Nithi, and Meru Counties.

While commissioning the Project, President Ruto expressed joy in the impact the project shall create in promoting clean water access in the County. adding that it has already benefited 1,032 households and poised to benefit a projected 50,000 citizens within the region.



Kenya's digital superhighway to boost e-trade and tech start-ups

The Government is rooting for the Digital Superhighway as a crucial enabler of economic growth, spurring digital start-ups, boosting e-commerce, and technology-enabled products and services.

Speaking during the Policy Symposium on Ken-ya's Digital Superhighway and Creative Economy at Strathmore Business School, ICT and The Digital Economy Principal Secretary Eng. John Tanui noted that the availability of high-speed broadband in the country is expected to attract foreign direct investment, besides stimulating innovation and entrepreneurship.

Significantly, Eng. Tanui noted that the digital superhighway will enhance quality and access to educa-

KWS boss decries fence vandalism in conservation areas

BY ARNOLD LINGA MASILA

s the National Government through the Kenya Wildlife Services (KWS) moves to end the perennial human-wildlife conflicts in Taita Taveta and other counties bordering national parks, a new challenge is emerging.

KWS Director General. Dr. Erastus Kanga indicated that vandalism of fences is a blow to conservation efforts.

"As we are here today launching this compensation program for victims of human-wildlife conflicts, I decry the threat of fence vandalism that is hampering our efforts to bring an end to this menace," said

The DG revealed shocking statistics on fence vandalism in both Tsavo East and Tsavo West national parks, which continue to threaten efforts to end incidents of loss of lives, property destruction, and physical injuries.

"Today, out of the 500-kilometer fence we have installed along the peripheries of the Tsavo ecosystems, 120 kilometers have been vandalized, sus-

taining the human-wildlife conflicts," Kanga said.

He was speaking at

The compensation amounts are huge and we must find a way to reduce"Malonza

Voi during the launch of the national human-wildlife compensation payments amounting to a total of Sh 908, 000,000 to go to victims of human-wildlife conflicts for the years 2014 to 2019.

"When you look at the magnitude of this compensation amounts, you can see it's a burden to the ail-

ing economy. We have to be proactive in finding solutions to end the conflicts and the far-reaching consequences and fencing off the parks is one of them," said Kanga.

Presenting a cheque of Sh51,551, 489 to go to compensation of victims from Taita Taveta, Peninah Malonza, the Cabinet Secretary for Tourism, Wildlife, and Heritage said there was an immediate need to reduce instances of human-

wildlife conflicts to ease the financial burden of the state and end the anguish of those who lose their loved ones and property.

"The compensation amounts are astronomical and we must find a way to reduce instances of human-wildlife conflicts to ease the financial burden to the government and the psychological trauma and physical injuries to humans and property destruction," Malonza said.

The CS reiterated the call to end fence vandalism as the National Government, in collaboration with partners, continues to roll out more mitigation programs to bring an end to the problem that has persisted for decades now.

Nationally, according to Malonza, the victim' compensation claims amount stands at more than Sh5 billion as at mid-2023 with the numbers expected to rise at the onset of the dry season.

After seven years of active implementation, the NSCVE is proposed for review to address the dynamic ways in which the threat of terrorism and violent extremism is mutating and manifesting in our communities.

This review seeks to collectively negotiate and adopt a strategy that is people driven, adaptive, responsive, sustainable, homegrown and alive to local needs. The review process shall be an inclusive popular effort guided by the high threshold of the Constitution of Kenya including the values and principles of human dignity, equity, social justice, inclusiveness, human rights and non-discrimination.

To enable public participation in the review process, the Centre has established an interactive page on its website to facilitate dialogue and interactions among different stakeholders. AU States urged to adopt policies to eliminate non-tariff barriers to boost intra-African food trade

African Union Member States have been called upon to adopt policies that encourage intra-African trade in food production by removing non-tariff barriers that currently make imports from outside the continent costly compared to locally produced food.

Speaking at the 14th African Union High Level Private Sector Forum in Nairobi, Albert M. Muchanga, the AU Commissioner for Economic Development, Trade, Tourism, Industry and Minerals, called for increased investment in productivity if the African continent is to realise the full potential of its huge population and vast natural

Amb. Muchanga observed that despite Africa having an almost equivalent population to China, Africa's share of the global GDP is just three per cent compared to 18 per cent for China.

"Africa's share of global trade is just 2.7 per cent as opposed to 20 per cent for China. The difference lies in productivity, productivity and more productivity," Amb. Muchanga said.

In his remarks, EAC Secretary General Dr. Peter Mathuki urged African countries to promote local content within their economies to boost intra-African trade and the continent's share of global trade, adding that there is a lot of potential for growth.

"The United States total GDP is US\$23 trillion while the Democratic Republic of Congo's wealth is US\$26 trillion if it was well used. Africa has the potential to grow its economy to US\$100 trillion if it is fully exploited," Dr. Mathuki said.

Dr. Mathuki urged African countries to establish their own annual economic forum where they can set the economic agenda for the continent, noting that whatever is developing the

rest of the world comes from Africa even as the continent remains poor.

The Secretary General said that the private sector can play a vital role in promoting intra-African trade in four key areas, namely: services trade, digital trade, infrastructure development, and climate action and green transition.

Dr. Mathuki said that the services sector, which represents over 60 per cent of world GDP and more than 50 per cent of employment worldwide, holds great potential for Africa's growth, adding that in the EAC, services are the leading contributors to GDP.

"The region has witnessed significant growth in services exports since the establishment of the EAC Common Market in 2010, and policy reforms have been implemented to boost regional cross-border investments in the financial sector. Such efforts have reduced barriers for service

providers, enabling them to export their services more efficiently," Dr. Mathuki said.

"To unlock the full benefits of the dynamic and fast-growing services sector within the continent, there is a need for regulatory reforms to eliminate barriers faced by service providers and enhance the productive and export capacity of African services firms," he added.

Dr. Mathuki urged the continent to expedite the adoption of an African passport to ease intracontinental trade and the free movement of persons across the continent.

"With an African passport, we will avoid the current situation where one has to get almost 60 visas when travelling across the continent," he said, adding that there is also an urgent need for a common currency to be used throughout Africa to ease intra-continental trade.

Plans to dredge Lake Kanyaboli now complete

A stakeholders meeting called to discuss post-recovery plans following a recent calamity when Lake Kanyaboli broke a dyke that separates it from the vast Yala Swamp heard that, already, one of the stakeholders has identified a company that is willing to undertake the work.

Addressing the media after the stakeholders meeting, Siaya County Government Chief Officer for Water and Environment, Walter Okello said the company, through a stakeholder known as Ignite Africa, will help clean up the lake as part of the efforts to restore the ecosystem.

"Part of the clean-up will involve de-silting and as stakeholders, we were discuss-ing the potential effects of the works," said the chief officer. Okello said through de-silting and reconstruction of the collapsed infrastructure, the Lake will regain its optimum water levels and of the right quality.

He assured the community around Lake Kanyaboli and the entire Siaya County of the county government's commitment to ensuring that the ecosystem was restored.

The Director of Environment, Gabriel Oduong' lamented that the recent breaking of the dykes affected community livelihoods in Siaya and Busia counties, with the latter bearing the brunt of the impact.

"The impact was felt more in Busia County where roads and classrooms were swept away by the gushing water from the collapsed dyke," said Oduong'.

The director said that as part of the post-re-covery plans the County Government of Siaya has embarked on the reconstruction of the collapsed dyke.

Sh908 million released for humanwildlife conflict compensation claims

The Government has released Sh908 million as compensation to thousands of farmers for claims on deaths, injuries and losses caused by human-wildlife conflict across 46 counties.

Tourism and Wildlife Cabinet Secretary Ms Peninah Malonza said, the money would partly compensate all categories that qualify for compensation as per the Wildlife Management and Conservation Act 2013.

The categories include deaths, injuries, crop destruction, and livestock predation amongst others. This compensation covers claims from 2014 to 2019.

Speaking at Moi Stadium in Voi during the launch of the national human-wildlife conflict compensation

program, the CS stated the total claims received funds released would cover a significant percentage of

from farmers in conflictprone regions.

She also disclosed that the government had always prioritized compensating deaths owing to the magnitude of gravity of losing kin or a loved one.

"Compensation for losing a loved one has been prioritized over the years. We intend to pay a substantial part of other categories because they have been delayed for a long time," she

The release of the monies comes as a relief for thousands of artisanal farmers across the country who have been waiting for payments for crop destruction since

According to KWS data, the government has pending claims worth Sh5.6 billion from farmers for deaths, crop and property damage across the 47 counties.

Admitting funding challenges, Malonza said the government was committed to clear all pending claims. Already, claims worth Sh2.6 billion that extended to 2020 have already been processed. Another batch of claims worth Sh2.5 billion is currently being processed.

The launch of the compensation program was hailed by leaders as the most deliberate move by the state to show commitment to tackling protracted delays in disbursing billions owed to farmers who have borne the brunt of human-wildlife conflict for ages.

Taita-Taveta Governor Andrew Mwadime said though the money was not sufficient to cover the hundreds of millions owed to farmers in the region, its release indicated goodwill by the national government to address the residents'

Taita-Taveta County will receive Sh51.5 million to compensate 350 farmers. This is the second-highest amount allocated to the region after Kajiado Countv.

"Our farmers have suffered long waits. We appreciate this good gesture but still ask the government to clear the pending balances," he said.







Egerton University now introduces solar dryers to boost agribusiness

gerton University is → promoting a new tech- □ nology of preserving
 □ vegetable products pioneered by the university, in partnership with Mukebo Self-Help Group.

According to its innovators, the technology, dubbed solar drier, will go a long way in addressing food shortages, preventing a glut in the market, fighting food insecurity and encouraging farmers to venture into agribusiness.

The solar drier is a simple greenhouse-like structure that uses solar energy to dry farm produce which is later packed and stored for future use or sale.

According to Senior Technologist at the Department of Crops, Horticulture and Soil Sciences Dr Tom Owino, almost 90 per cent of farmers in the country depend on rain to grow their crops which negatively affects sup-

Owino said farm products flood markets during the

rainy season leading to low prices. The opposite, he said, happens during dry spells.

'This is brought about by the majority of farmers, depending heavily

on rain to grow their crops. Our new technology tries to combat this menace as well as turn small-scale farming into agribusiness," he said.

Owino said that farmers can use solar dryers to preserve vegetables and sell them when prices are high.

Speaking at the Agricultural Society of Kenya (ASK) trade fair in Nakuru where he showcased the solar vegetable drier, the innovator disclosed that the instituturn their farmi ıg into busi-

Solar dryers are made of ultraviolet- reated poly sheets, the same ones used in making greenhouses, while raised shelves inside the units are made of wood.

"Farmers who own the drier can offer drying services to colleagues at a fee, while the youth can embrace this business idea and create jobs," he said.

Owino said the technology can be used to curb shortage and prevent a glut, adding that the technology can help reduce dependence on crops such as maize.

He explained that solardrying saves labour since the vegetables can be left in the dryer overnight, yet the quality of the product is better in terms of nutrients, hygiene and colour.

"Furthermore, solar-drying improves family nutrition because the vegetables contain higher quantities of vitamins, minerals and fibre than the ones dried under the

Taita-Taveta farmers receive water tanks

Over 400 small scale farmers in Taita-Taveta have received plastic tanks for water storage as part of enhanced efforts to fight perennial water shortage at household levels in the region.

The programme is undertaken through a partnership between the Taita-Taveta County Government and Food and Agricultural Organization (FAO). Governor Andrew Mwadime noted that, with proper waterharvesting facilities, the region can enhance nutritional capacities at household levels through kitchen gardening.

Speaking in Mwatate during the distribution of 256 tanks to vulnerable farmers, the governor stated that low-income households that have been dogged by a lack of water for ages would be prioritized in the program that is geared towards making the county a water-secure region.

He hailed the partnership with development partners, stating that it would extend to other sectors in empowering the local residents. Such other sectors include investing in value addition in agriculture, livestock, fisheries, and mining.

"We are committed to improving access to safe and clean water for the farmers and other low-income families. The tanks will harvest water during the rainy seasons and save many families from the long torturous treks to water sources," he explained. Mr. Abedih Mbatha,

County Program Specialist, said the entire program would entail distributing 800 water tanks to vulnerable families in the arid region. Each tank has a capacity of 1,500 liters

He added that when all the targeted households received their tanks, the region would have an additional capacity to store 1.2 million liters of water. The stored water can then be used for various purposes including domestic consumption and kitchen gardening. Already, 147 tanks had been distributed earlier to selected farmers in Mwatate, Wun-

danyi, and Voi. "Water scarcity can be ad-dressed by enhancing the means and ability to harvest rain water. This program aims at increasing the availability of water at domestic levels for farmers and other people," he

Mr. Eric Kyongo, the CECM Agriculture, said that the tanks would address some of the challenges posed by such factors that have disrupted water availability.

Speaking during an interactive session at the Uwezo Fund, Cooperatives and MSMEs Cabinet Secretary Simon Chelugui stated that, the purpose of the workshop was to align the development partners on their priority programs and strategic focus in the Ministry towards implementation of the Bottom-Up Transformation Agenda (BETA).

The CS explained that cooperatives and MSMEs are a critical component of the

Kenyan economy because they offer an extensive range of services across all sectors of the economy while MSMEs are key players in the production of goods and creation of employment that impact directly the economy.

Both, he added, constitute 98 per cent of all business in Kenya, create 30 per cent of the jobs annually as well as contribute 3 per cent of the GDP growth.

At the same time, Principal Secretary State Department for MSMEs Ms. Susan Mang'eni said the mandate of the department is to develop financing policy, support technology upgrade and modernization, promote and develop MSMEs to enhance their competitiveness and establish integrated intrastructural facilities.

Mang'eni said the government is seeking the help of development partners in interventions such as the

provision of the requisite infrastructure, training and capacity-building of MSMEs, support market access by MSMEs, enhancing financial access by MSMEs and reviewing the policy setting and regulatory framework.

"The Micro Enterprises had engaged 1-9 people and an annual turnover not exceeding Sh 500, 000, small enterprises has engaged 10-19 employees and an annual turnover between Sh 500,000 and Sh 5 million while medium enterprises have engaged 50-250 employees and an annual turnover between Sh 5 million and Sh 100 million," Mang'eni

She added that 70 per cent of MSMEs fail within the first three years of operation because of the high cost of doing business, inaccessible and unaffordable credit, limited market access, and taxation gaps.
