According to the Principal Secretary for Immigration and Citizen Services, Amb. Julius Bitok, the UPI, which will be uploaded in the e-Citizen portal, will give all the new born babies a unique personal number

PS Bitok said the special number will also be used as an identification card, PIN number, National Health Insurance Fund number, and Kenya Revenue identify the individuals in life and in death.

He said the introduction of the unique identifier will bring to an end the national census exercise as the new technology will be able to provide accurate data on the country's population.

"The Government has put the citizenry at the core, by putting the digital transformation agenda first, and this will change many things in our country," he said, adding that with the technological revolution, Kenya cannot be

Consequently, Machogu urged the institutions of higher learning to seek new models of funding to stay afloat as traditional revenue streams are running dry day by day

Mr Machogu further indicated that the institutions' managers should consider tackling the current financial challenges through strategies such as enhanced use of technology to cut costs, exploring new markets, improving efficiency in their operations,

cent, noting that with digitization, the number of both is expected to increase by at least 90 per cent.

He expressed confidence that the UPI model that was borrowed from Estonia will eliminate vetting and discrimination of registration at the border counties, as well as allow every Kenyan to get services from the e-Citizen Portal.

"UPI will confirm during registration whether a child is a Kenyan when the information details of the parents are populated at the e-Citizen portal. The UPI number can be decoded to show if the child is a boy or girl when they are born," the PS said.

He also called upon the registration officers

to ensure they capture all the birth and deaths in their areas of jurisdiction saying the government has already made arrangements with hospitals on how to record the same.

He singled out accuracy, efficiency and tightening of loose ends in revenue collection that comes with manual system as some of the benefits that will be derived from the UPI system.

The PS said, "The digital transformation will also capture monies and revenues paid to the government.

The government's plan is to have all the 5,000 government services uploaded on the e-Citizen platform by 30th June this year.

sources.

He further urged the institutions to re-think their strategies on higher education and shift to technical, vocational education and training that equips graduates with practical competencies for selfemployment and incomegeneration.

Machogu also said universities must enhance revenue collection by developing and implementing a policy on raising resources from other avenues including competitive research, entrepreneurship grants, alumni associations, continuous education, community service and business investments.

Mr Machogu said universities should continue investing in meaningful collaborative research and innovations to attract funding and guarantee quality of education.

For a long time, the universities relied on state funding and revenue generated from the fees paid

by parallel degree students. But all that was dealt a fatal blow when the government cut its funding and undertook reforms in the national examinations in 2016 by disabling "Module II" as all eligible Form Four leavers secured a place in the regular stream.

All 35 public universities are currently experiencing financial difficulties as they are not only unable to pay salaries but have also not been remitting statutory deductions. The challenges point out that the universities are not playing their traditional role of teaching, research and training.

The CS's remarks were contained in a speech read on his behalf by Principal Secretary for State Department of Higher Education and Research Dr Beatrice Inyangala during Egerton University's 46 graduation ceremony.

Police to get tips on handling Gender Based Violence cases

¬he Centre for Rights, Education and Awareness (CREAW) in collaboration with the National Police Service will offer training to police officers in Nakuru that will enhance the way they handle victims of Sexual and Gender-Based Violence (SGBV).

The training, according to the Program Officer at CREAW, William Mbanyamlenge, will also focus on how to improve on public relations between the police officers and members of the public to ease the burden of victims seeking justice.

"We have had instances where the victims are intimidated or frustrated by police officers when they go to report abuse. Male victims of GBV are sometimes mocked or made a butt of jokes at police stations," indicated Mr Mbanyamlenge.

According to the Program Officer, the training will ensure police officers are fully trained on what it entails to get statements and how to collect samples from GBV victims and survivors. This,

he added, will ensure that cases touching on GBV are tight when taken to court to ensure justice for the vic-

Mr Mbanyamlenge spoke in Nakuru during a consultative meeting on SGBV and violence against women that was graced by various stakeholders including representatives from National Gender and Equality Commission (NGEC), National Police Service, Ministry of Education, the county government and the State

Department for Gender, among others.

He said victims of domestic violence are abused at home, a place that should ideally be the most secure environment; and that they end up physically

and psychologically abused and separated or divorced, among other ills.

'Women and children who want to speak about their experiences find it difficult because of shame or fear. When they report, some police officers take the offences lightly, compounding the problem," he said, adding that the training, which will later be rolled out for local leaders including chiefs and their assistants, was intended to sensitize the officers.

In some police stations, he added Gender Desks are not manned by officers trained to handle SGBV cases.

"Transfer of officers is a hindrance because we at times train officers who are then transferred and replacing them takes long," he said. He expressed concern that investigative agencies face challenges as they prosecute such cases because GBV victims may not be willing to open up about what happened, there is poor collection of evidence, and perpetrators work hard to stop the court process.

Fast track cases of mothers with children in remand, PS urge courts

Government The wants cases involving mothers with children in remand custody fast tracked if the alleged offences fall under petty crimes category to protect the interest of innocent children.

Principal Secretary (PS) for Correctional Services Ms Mary Muthoni Muriuki said it is sad that such innocent children find themselves locked up in prison facilities alongside their mothers for prolonged periods yet they are not at fault.

She expressed fears that the children find themselves mixed with adults of all manner of characters and get exposed to all kinds of mannerisms simply because their mothers were on the wrong side of the law.

"If the offences involving the mothers with children in prison fall on petty crime cases, they should be fast tracked to enable them get out of prison so that such children can grow just like any normal child out there," the PS said.

The Eldoret Women Prison currently has 20 children brought in with their mothers.

She said apart from the fact that the children who come to prison with their mothers were not budgeted for, they need to be taken care of in terms of food and clothing.

She said, "As a department for correctional services, we are working on this to ensure the children are taken care of in separate areas also, since they are prone to behaviour change that they may get exposed to while in prison.'

She made the remarks while on a tour of Eldoret GK prison and Kimumu Probation Hostel, Eldoret, where juveniles in conflict with the law are hosted as they undergo rehabilitation and transformation before being reintegrated into their families.

CS lauds TVETs managers for reforms that have stirred up education sector

I ducation Cabinet Secretary (CS), Ezekiel Machogu has lauded reforms initiated in the TVET sector over the last 15 years saying they have revolutionized technical education in terms of physical infrastructure and provision of modern training equip-

ment

Machogu was speaking at the Kenya School of Tecnical Vocation Education Traing during a workshop with the Kenya Association of Technical Training Institutions (KATTI) Principals and Technical and Vocational Education and Training (TVET) County Directors on prudent management of institutions.

The CS asked the principals and county directors to develop mechanisms that appeal to the public to embrace TVET as a pathway for trainees to achieve their career aspirations from artisanship to PhD levels.

He said the Competency Based Education and Training (CBET) Curriculum re-

view is meant to provide specific skills and competencies that match industry requirements hence the need to find approaches to fine tune the existing CBET curriculum to meet the industry needs and international standards.

The CS said one of the policies that require urgent attention is on industrial linkages, calling upon technocrats to fine-tune the draft Policy Framework on Industrial Linkages for the necessary legislation.

County automates laboratory inventory for data security, better healthcare

The County Government of Nakuru will automate its laboratory information and inventory management systems to help address challenges of data insecurity and documents damage.

Governor Susan Kihika said they were exploring a modern system whose key features will include workflow and data tracking, flexible architecture, data exchange interfaces, data mining, data analysis and electronic laboratory notebook (ELN).

Kihika observed that effective laboratory information and inventory management systems facilitate easy record keeping, tracking and reporting, which will help in eliminating the risks of human error and improving the overall turnaround time.

"We envisage a platform that will be a solution that works fast and facilitates seamless communication between scientists, businesses, laboratories, and the public," she said.

The automated system, according to the Governor will not only reduce the need for manual data input, but also alleviate bottlenecks and streamline workflows within the health

department. While affirming her commitment to leave a legacy in the health sector, Kihika said she has prioritized improvement of health facilities to ensure access to affordable and quality medical services for the people of Nakuru.

She assured the residents that her team will, through public-private partnerships, upgrade diagnostic equipment in all the public

health facilities across the County. Kihika noted that the upgrading of old and building of new sub-county hospitals will save residents the trouble of travelling to the county referral hospital in Nakuru for specialized services such as surgical procedures. The Governor announced that her administration is working on several strategic partnerships to provide residents with

convenient and subsidized access to medical consultations through telemedicine.

"Telemedicine, remote diagnosis and treatment of patients by means of telecommunications technology has gradually become acceptable. With the new normal and preventive measures in place, telemedicine might be the antidote to patient care," added Kihika.



Scientists to improve coconut sub sector

cientists have intensified research on innovative technological interventions to derive more benefits from the coconut sub-sector with an estimated potential of Sh25 bil-

The interventions in manufacturing which target to benefit small and medium enterprises are being implemented under a research initiative spearheaded by Jomo Kenyatta University of Agriculture and Technology (JKUAT), in a multi-disciplinary and multi-institutional partnership that seeks to enhance Kenya's competitiveness in the manufacture of value-added nut products, particularly the coconut. Addressing postgraduate students after they presented a research project, and members of the project at JKUAT, Prof. Bernard Ikua, the Deputy Vice-Chancellor in charge of Administration and Finance at the institution challenged the students "to work hard in order to realize outputs that will impact the coconut

value chain in Kenya and globally."

Boost to Lamu's fishing sector as groups receive Sh 22 million grants

BY AMENYA OCHIENG (KNA)

enya Marine Fisheries and Socio-Economic Development (KEMSFED) has extended grants totaling Sh22 million to smallholder fishing and common interest groups to expand the county's growing blue economy sector.

The grants, which have been released to 28 common interest groups in Lamu, are part of the KEMSFED national project aimed at disbursing Sh315 million to 142 communities within the five coastal counties.

Beneficiaries are common interest groups spread across 98 focus wards in 19 sub- counties within the Coast hosting the highest number of households that are largely dependent on fisheries to ensure that they maximize sustainable economic benefits from marine resources available.

Speaking during the launch of the KEMS-

The grants that have been disbursed aim at making lives of fishermen better,"Governor FED grant initiative at the Lamu County Mokowe headquarters, Lamu Governor Issa Abdalla Timamy noted that the grants would further enable the County speed up plans to modernize Lamu's cottage fishing

"The grants that have been disbursed by the World Bank through the KEMSFED project aim at improving the livelihoods of fishermen who are still largely dependent on old ways of fishing despite the enormous potential to grow the fishing sector," he said.

He revealed that Lamu

would receive a total of Sh500 million once the Sh10 billion KEMSFED five-year project is fully rolled out.

KEMSFED grants are implemented under the Enhanced Livelihoods for Coastal Communities Initiative for which Lamu will receive Sh49 million within the first phase of the roll out.

"There has been a lot of push especially by my administration to have the funds rolled out promptly, since occupying the position of Chairman of the Blue Economy within the Council of Governors," he added.

He further added that plans are currently underway to set up a fish market,

an ice plant and a fish preparation area within Mokowe Township in a move that he stated would create job opportunities.

County Executive Committee Member (CECM) in charge Fisheries and Blue Economy Faiz Fankupi who also spoke at the launch gave an assurance to the interest groups of the county's support to aid in modernizing the fishing sector.

He said the grants are meant to fund productive livelihoods to support the fishermen's access to complimentary livelihoods as one way of reducing dependence on fishing in light of declining catch due to overfishing and effects of climate change.

Fankupi further stated that the County Government was in the process of securing title deeds to all the fish landing sites within Lamu County in order to prevent land grabbing.

Government approves five- year National Blue Economy Strategy

BY **ERASTUS GICHOHI** AND **MABEL KEYA SHIKUKU** (KNA)

The Ministry of Mining, Blue Economy and Maritime Affairs in partnership with the Inter-Governmental Authority on Development (IGAD) has endorsed a five-year National Blue Economy Strategy to help the country achieve full potential of her blue resources.

Cabinet Secretary Salim Mvurya said the formulation of the Strategy is timely and will go a long way to facilitate exploitation of maritime resources which have a huge potential in helping to grow the economy and in employment creation.

"We are currently exploiting only eight per cent of the potential of the blue economy, that is oceans, lakes and rivers which have a huge potential to transform the economy of the country", Mvurya said.

Speaking during a validation exercise in Naivasha, the CS said Kenya has adopted and domesticated the Blue Economy Strategy which was developed by IGAD member states in 2018 and is set to be launched at a later date.

He noted that his Ministry will formulate policies, relevant bills and regulations which will be transformed into necessary legislation to help operationalize the strategy.

"My ministry has mapped out over 400 Beach Management Units across the country which will be converted to cooperatives by June this year to enable them access financial credit and turn them into commercial enterprises," the CS observed.

Mvurya reiterated that the government will establish fish landing sites at designated areas and equip them with key infrastructure including storage cold rooms, value addition units and market linkages for fishery resources.

"We will soon launch the construction of a Sh1 billion project in Kisumu that will be producing over seven million fingerlings to serve the country's water bodies and over 2,000 fish ponds across the country," Mvurya said.

He added that his ministry has engaged the Defense Ministry to enhance surveillance across maritime resources in the country to address rising cases of illegal activities on the high seas.

According to Council of Governors (COG) chair on Blue Economy Issa Timamy, the strategy will ensure blue economy resources are fully tapped to create job opportunities and improve livelihoods.

Timamy, who is also the Lamu governor said they have partnered with the National Government to establish three landing sites in Lamu so as to facilitate fisheries activities in the Indian Ocean.

IGAD Country Representative Dr. Fatuma Adan said the regional body will support governments to harness the potential of their blue resources.



embers of the Sauti lacksquare Savings and Credit Cooperative Society (SACCO) will now enjoy loans of up to four times their total deposits after automating its operations to improve service delivery.

Sacco Chairman Mr. Elly Ndwigah, speaking in Nakuru announced the automation of its processes and the introduction of mobile banking to improve service delivery to give members get an option of depositing collateral and self-guarantee for loans applied for.

"The new Management Information System (MIS) has an established members' portal where members can access and query their accounts while providing an interactive platform for communication," he noted.

The remarks were contained in a speech read on his behalf by Board Member Johnstone Mutungi, during a members' education day.

Ndwigah noted that there was a need to step up membership recruitment drives as the Sacco planned to rollout to Front Office Services (FOSA) among other prod-

"We are changing our Angaza loan to a mobile loan product that will guarantee Sh20,000 credits for three months. On top of that, we are introducing Sharia compliant products, mortgages, asset financing as well as education and holiday saving packages," he added.

He attributed the total asset growth from Sh258.8 million in 2018 to the current Sh993 million, to the recovery and sale of Donholm Land Project, which had been bogged down a long court battle.

Mutungi urged members to rigorously market the Sacco products and recruit new members in a bid to hasten the FOSA roll out.

The Sacco has recorded a Sh9.8 million growth in its share capital with the members expecting a 15 percent payout on their shares, for the just concluded year.

Meanwhile Meru branch Sauti Sacco members have been urged to be more proactive in recruiting new members to strengthen the financial status of the Sacco.

Speaking during this year's members' education day in Meru town, Sacco credit committee chairman Murithi Wamae said the number of members was on a downward trend, hence the need for a more aggressive recruitment approach.

Wamae said the national management committee was working on the logistics on how to recruit members from outside the mother Ministry of Information, Communication and the Digital Economy, saying the diminishing membership was as a result of members retiring without being replaced with new officers.

"Since the government has not been recruiting new employees regularly as was the case a few years ago, the Sacco membership has also been affected by natural attrition," Wamae said.

He however assured members that the Sacco had stabilized financially and was able to offer timely services to all members, all geared towards enhancing members' confidence and trust in the national management committee.

Wamae further said besides the numerous successes that the Sacco had achieved in recent times, there were challenges as well, saying some of the institutions within the mother ministry had deliberately failed to remit members' contributions to the Sacco account thereby affecting the financial stability of the Sacco.



The case for Made in Kenya phone

Kenya Summit". With a cheaper Made in Kenya smartphone, citizens will be able to access government services and opportunities at their own convenience.

The gadgets will cost an average of Sh5,000 to enable widespread access. The cheapest smartphone in the market currently costs about Sh8,000.

"Based on the feasibility studies that have been undertaken, we should be able to have locally produced phones selling at \$40 per unit." Mr Owalo added.

In seeking to produce its own smartphone, Kenya is following in the footsteps of other countries in Africa namely Egypt, Democratic Republic of Congo and South Africa.

Egypt launched its locally made smartphone dubbed Nile X in 2019. It's specifications include a 13 mega pixel dual camera, 4G technology, 4GB RAM, 64 GB storage, 5.7 HD display, Android 7.0 Nougat operating system, fast-charging and fingerprint sensor.

Sico, an Egyptian company backed by the government, invested in the venture over \$23 million (Sh2.8 billion), creating some 2.000 jobs.

Egypt also manufactures Samsung Galaxy phones in conjunction with the South Korean multinational Samsung. The first Egypt-made Samsung phone was released in October last year. Industry data shows that it costs from Sh3,767 to Sh6,279 to build a low-cost smartphone.

So, how would a Kenyan smartphone look like? In January, Mr Owalo said the smartphone will run on an Android system.

The phone will allow users to install other secondary applications and access web apps for a great digital experience, besides having basic call, text, timing and calendar features.

Kenyans will certainly want a smartphone that is 4G enabled, at least 10-mega pixel dual camera, bigger capacity RAM, 64GB storage, longer battery life and fast-charging.

Mr Owalo, who said that American tech giant Google is helping in the manufacturing of the gadget, believes the country is equal

to the task and would not only give citizens the best but also what they want to drive the digital agenda. "ICT is an enabler and a creator of opportunities. The phone will help the government achieve the plans in its bottom-up blueprint," he said.

President William Ruto believes that having a low-cost smartphone will enable millions of Kenyans access digital platforms for business and government services.

"I want to assure the country that we will have the cheapest smartphone in Africa, manufactured in Kenya, within the next eight to 12 months," President Ruto said in November last year at a meeting with investors in the micro and small enterprises sector.

According to the Communications Authority of Kenya's latest report, the country has 48.3 million internet subscribers and 60.7 million mobile phone devices connected to mobile networks, out of which 32.9 million are feature phones and 27.9 million smartphones.

Slow uptake of 4G and 5G-enabled smartphones has been blamed on costly gadgets, therefore, a homemade affordable phone would be a game-changer.

As the government strives to give the country its first smartphone, Mr Owalo said it is also working to ensure there is reliable internet infrastructure all over Kenya

"All Kenyans should have access to the internet. We will roll out 100,000km of fibre optic cable to places that are not connected. The government will do 52 per cent of the cable while private sector 48 percent," said the minister.

Besides the cable, the government is in the process of setting up 25,000 free WiFi hotspots targeting people at the bottom of the pyramid. "By June, at least each county will have two WiFi hotspots," he said.

Eng. John Tanui, the PS State Department of ICT and Digital Economy, said private-public partnerships would help make Kenya an ICT hub in the region.

"The government has made strides in ensuring that ICT is incorporated in all aspects of public service. As partners, let us ensure that Kenyans can access opportunities from anywhere they are," he said at the meeting.

This year's Connected Kenya Summit will be held between April 2 and 4 in Diani, Kwale County. Its theme is "Digital economy: Endless opportunities shaping our future".

Mr Stanley Kamanguya, the CEO ICT Authority, said previous summits have introduced creative and innovative solutions to the country's pressing problems.

"Huduma centres and e-Citizen are products of Connected Summit. Now we have the masterplan that we must implement to push the agenda forward."

Five million farmers registered in digital system

THE GOVERNMENT HAS registered five million farmers digitally as the country embraces technology to distribute subsidies to boost food production.

Mr Raymond Omollo, the Principal Secretary Interior, termed the

registration that has been going on in the past weeks successful.

"This paves way for the distribution of subsidised fertiliser to farmers ahead of the long-rains season that starts in March," said Mr Omollo in the registration exercise jointly done by the ministries of agriculture and Interior.

Up to 300,000 metric tonnes of planting fertiliser, which is about six million bags, are expected to be distributed to registered farmers in March by the government ahead of the planting season.

A majority of the farmers who have enrolled into the system dubbed Kenya Integrated Agriculture Management Information System are maize growers, according to the Ministry of Agriculture.

Kenya intends to use the system to establish a national farmers'



database that it would use to design intervention measures to boost food production as climate change effects bite. ■

State eyes Sh4 trillion tax collection in long-term strategy

Treasury CS says government will expand the tax base in the informal sector and map out rental properties

he government has lined up a number of tax reforms to increase revenue collection to Sh3 trillion in the financial year 2023/24 and over Sh4 million in the long-term.

National Treasury Cabinet Secretary Njuguna Ndung'u said the government will undertake administrative and policy tax reforms that include the full roll out of electronic Tax Invoice Management System (eTIMS) to reduce Value Added Tax (VAT) collection gap from 38.9 per cent to 19.8 per cent and corporate income tax (CIT) gap from 32.2 per cent to 30 per cent.

Further, Mr Ndung'u said there would be integration of Kenya Revenue Authority tax system with the telecommunication companies, expansion of the tax base in the informal sector, mapping of rental properties and roll out of measures at the Customs and Border Control Unit leveraging on technology to reduce tax leakages.

But more importantly, build confidence and compliance in the tax system," said Mr Ndung'u in the 2023 Budget Policy Statement.

The document outlines priorities and policy goals that guide the national government and the county governments in preparing their budgets.

To actualise bottom-up economic transformation agenda for inclusive growth, the government has laid out various programmes in the different sectors.

In the housing sector, it says it will restructure long-term housing finance schemes, including coming up with National Housing Fund and Cooperative Social Housing Scheme, to grow the number of mortgages from 30,000 to a million by enabling low-cost mortgages of Sh10,000. This will help in the delivery of 250,000 housing units a year.

In health, the Kenya Kwanza administration promises to reform the National Health Insurance Fund (NHIF), turning it from an occupational scheme for salaried people in the public and private sectors to a social insurance scheme. Therefore, the government will change the contribution structure from an individual contributory scheme to a household contribution model.

For the information and communications sector, the government will support extension of national optic fibre infrastructure to ensure universal broadband availability over the next five years. The laying out of an additional 100,000km of the national fibre-optic network will help to deliver the target.

And in education, the government will pay for in-service teacher training to help bridge the current teacher shortage gap of 116,000; establish a special service tariff for all learning institutions for basic utilities such as water, electricity and internet connection and establish a National Skill and Funding Council that will amalgamate HELB, TVET and University Funding Board and increase funding to bridge the current 45 perc ent gap.



What about agriculture?

Farmers are increasingly using organic and conservation farming methods and registering increased yields that fetch higher prices.

What does the Kenyan constitution say about climate change?

The constitution recognises the right to a clean environment and it's sustenance for the benefit of posterity.

Are there specific laws to help manage climate change?

Yes, there is the Climate Change Act 2016, which requires the Cabinet Secretary, Ministry of Environment, to formulate a National Climate Change Action Plan (NCCAP), which should be reviewed every five years. The current plan ran from 2018-2022.

What is the purpose of the Action Plan?

It provides a legal framework for Kenya to deliver on its climate change goals under various priority areas, -including disaster risk management, blue economy, food security, forestry, housing, manufacturing, energy, transport and health.

Are there any other laws that protect the environment?

There is the Environment and Management Coordination Act 1999, Energy Act 2019 and The United Nations Framework Convention on Climate Change and the Paris Agreement, which Kenya ratified.

Which bodies are involved in enforcing laws related to climate change?

We have the National Environment Management Authority (Nema), the Environment and Land Court, the National Environment Tribunal, National Climate Change Council, Climate Change Directorate and departments in county governments that all help in enforcement of climate and environment-related laws.

Is it all doom and gloom with climate change?

No, climate change comes with various opportunities that you can exploit in different sectors.

Where can I get information on climate change in my locality?

You can visit the Ministry of Environment or Nema officers at the county headquarters. They will guide you on what to do to help fight climate change in your community.

Talk about irrigation agriculture in relation to climate change

Climate change has significantly made rain-fed agriculture unsustainable. Therefore, use of irrigation helps to overcome climate risks like drought, enabling production of food all year round.

But irrigation is too expensive ...

You don't have to install drip lines, whose set up cost can be expensive. You can make your own drip system at home using recycled plastic bottles. Make holes on the bottles, fill with water and install at the base of the crops.

...and in transport?

Electric vehicles and use of bicycles are gaining currency in Kenya and across the world.

250,000 fingerlings gift to farmers as governor pledges modern fish market

rinyaga County Government has distributed 254,000 fingerlings to farmers to boost fish production in the wake of increased interest in fish consumption in Mt. Kenya region.

The fingerlings which were given out to 254 farmers, each of them receiving 1,000, are part of the county's elaborate plan to empower farmers undertake aquaculture as a mainstream activity as opposed to having it as an alternative source of livelihood.

To create a market for the expected bumper harvest of fish in the near future, the County Government will be putting up an exclusive fish market at Kiaga in Ndia Constituency, where farmers will be aggregating their produce for sale.

For the past three years, fish farming in the County has been growing gradually under the Wezesha Kirinyaga Economic Empowerment Program initiated by Governor Anne Waig-

uru.

She noted that aquaculture would bridge the huge deficit of fish supply both within and outside Kirinyaga since half of the fish produced in Kenya comes from aquaculture while the other half is from ocean and lake fishing.

Waiguru said one of the processing factories that will be set up in the upcoming Sagana Industrial Park will deal in fish processing, hence the importance of having locally available raw material. Fish farmers will thus gain further from value addition of their produce.

She said her vision is to see Kirinyaga get a fair share of fishing potential given that it is endowed with favorable aquaculture conditions which include fresh water and ready market.

The county head said she

wants to increase annual fish production from the current 29.4 tons valued at Sh12.8 million to 62 tons, which will fetch the farmers around Sh30 million per year.

Under the fisheries program, the County Government has been supporting farmers by providing them with free fishpond liners, fingerlings and six-month fish feed.

The farmers on the other hand construct the fishponds and thereafter nurture the fish to maturity. They then use the proceeds from the first harvest to restock their ponds with more fingerlings in order to sustain the project.

While distributing the fingerlings to the farmers, the County Executive Committee member for Agriculture, Livestock and Fisheries, Dr. John Gachara, said the first phase of the aquaculture program in Kirinyaga was launched in 2019 where farmers who were supported then were able to produce fish independently.

Defence CS Duale appointed regional standby force chair

Defence Cabinet Secretary, Aden Duale has been appointed Chairperson of the Council of Ministers of the East Africa Standby Force (EASF) in a meeting held in Addis Ababa, Ethiopia.

Duale took over the chairmanship of the Council from the Ethiopian Minister of Defence, Dr. Abraham Belay whose term ended while Brigadier Paul Njema of Kenya Defence Forces was appointed Director of the EASF Secretariat.

The meeting further unanimously agreed to have Kenya chair the Assembly of Heads of State and Government and the Committee of the Chiefs of Defence Forces (Staff).

The Ministers meeting was preceded by that of the Committee of Chiefs of Defence Forces from the member states under the chairmanship of Chief of General staff of the Ethiopia National Defence Forces, Field Marshall Birhanu Jula Gelalcha.

The defence chiefs noted that the security dynamics of the region had changed over time and that there was need to enhance the capacity of EASF beyond a Standby Force.

The Council proposed that

EASF evaluates itself to see how it could be structured to meet the demands of the current security challenges. To this effect, the participants proposed the establishment of the Panel of Elders (PoE)

awaiting its regularization. The EASF Secretariat pointed out that the African Union (AU) had expressed interest of establishing a Medical Training Centre in one of the EASF Member States comprising Burundi, Comoros, Djibouti, Ethiopia, Kenya, Rwanda, Seychelles, Somalia, Sudan, and Uganda.

EASF was established as a regional mechanism to provide capability for rapid deployment of forces to carry out preventive deployment, rapid intervention, peace support/stability operations and peace enforcement.

The Force is a regional organization mandated to foster peace and security in the Eastern Africa region and is one of the five regional multidimensional Forces of the African Standby Force (ASF) comprising the Military, Police and Civilian components...

IRA Strategic Plan to enhance consumer protection and access to insurance

The Insurance Regulatory Authority (IRA) has embarked on an institutional reorganization that aims to ensure effective insurance industry regulation to meet the ever-dynamic customer demands and surmount emerging challenges.

Newly appointed Chair of the Authority, Mwambu Mabonga said the ongoing reorganization aims to position IRA on the driving seat of a fast growing insurance industry in Kenya, executing its mandate in line with the existing government policy guidelines.

Mr Mabonga, who took over from immediate former Chair, Mohammed Sheikh Amin, lauded his predecessor and the IRA board for spearheading a progressive change process, which he pledged to continue driving to its successful conclusion.

"I am joining this Author-

ity when progressive thought leaders have initiated what will immensely change the insurance landscape in this country. I want to assure the entire board and management that I will work towards achieving the set goals for the benefit of the insurance industry," said Mr Mabonga, when he officially took over the chairmanship from Mr Amin.

He said the Authority was developing its 5th Strategic Plan, to run from 2023 to 2027, with the aim of placing greater focus on consumer protection and enhancing access to insurance services.

"An effective and unhindered industry growth and insurance penetration can never be achieved when issues of insurance access, costs and customer trust remain a

challenge, and that is what this Strategic Plan seeks to address." he said.

The Strategic Plan, he noted, will propose intervention strategies to address existing challenges as IRA strives to put in place measures aimed at promoting insurance and protecting the insured.

Mr Mabonga said he was fully aware of the challenges currently facing the insurance industry, and pledged to consult widely with all stakeholders with a view to settling on lasting solutions for the growth of the industry and public interest.

He praised the Management team for steering the Authority to its current position, noting that the milestones and achievements realized since its establishment 15 years ago could not have come in the absence of a committed, professionally driven team of public servants found within the management.

County integrates TB services in workplace to reduce transmission

The County Government of Nakuru has rolled out an initiative to integrate tuberculosis (TB) services into workplace health programs to help reduce transmission of the disease. The County Executive Member (CECM) for Health, Ms Jacqueline Osoro, said the initiative seeks to systematically engage workplaces in TB prevention and management.

Osoro explained that subcounty health management teams and TB and leprosy coordinators will work closely with Tuberculosis Accelerated Response and Care (TB ARC11) project to integrate TB prevention and management in workplaces and learning institutions across the County.

The CECM emphasized the importance of regular TB screening at the workplace, including among health workers, saying this will help in TB transmission control and management.

She urged the health workers to be on the frontline and lead by example, by taking regular TB screening, to help build confidence among the community members on the importance of TB screening and transmission control

The County Chief Officer for Medical Services, Dr. John Murima, urged the healthcare workers to make use of the empowered community health volunteers to help cut the transmission of TB within the community.

The Tuberculosis (TB) Accelerated Response and Care project which capitalizes on Kenyan expertise and know-how to significantly reduce the burden of TB in Kenya, was designed by the United States Government in close collaboration with Government of Kenya health managers.
