## County staff to own affordable houses in tenant purchase plan

Mombasa Governor says staff who have reached mandatory retirement age to also benefit in order to accord them an opportunity of having decent homes, to pay through their pensions

The County Government of Mombasa is negotiating with GulfCap Real Estate – the developer of Buxton Point Affordable Housing Project to enable county staff to own houses in the Phase Two through a tenant purchase agreement.

The project, consisting of 2,000 housing and commercial units is being done through a partnership between GulfCap Real Estate and the County Government of Mombasa.

GulfCap Real Estate is also de-

veloping the Sh13 billion Starehe Point, affordable housing project in Nairobi through a partnership with the National Govern-

ment. At least 6,000 units

made up of one, two and three-bedroom houses are under construction.

Governor Abdulswamad Nassir said, staff who have reached the mandatory retirement age will also

benefit in order to accord them an opportunity of having decent homes to pay through their pensions.

The county staff will be deducted monthly

from their salaries and an amount to be determined will go towards the purchase of the houses so that by the time they reach re-

## Laikipia residents earn millions from conservation of bandit infested forest

Residents of Laikipia North are raking in millions of shillings from conservation of the Mukogodo Forest.

Mukogodo Forest is one of the few community-managed forests in Kenya and it has seen the Il Ngwesi community get Sh36 million through carbon credits.

The funds support the community in education, health care, water and additional land acqui-

sition in other parts of the country like Maasai Mara in Narok County.

On the flip side, the forest has been a notorious hideout for bandits, a move that led the government to declare it a disturbed and dangerous zone.

The forest is targeted in the ongoing security multi-agency operation to restore security. However, that has not stopped residents from reaping benefits

from it.

Laikipia Conservancies Association chairperson Kip Ole Polos, during the annual general meeting in Lokusero said that, through carbon credits money, the community's lives had changed.

"We have got money from carbon credit that has made a big impact on this Il Ngwesi community. Today, we are here to inform

tirement age, they will own the houses.

The Governor spoke during a tree planting event at Buxton that also marked the beginning of handing over 584 completed Phase One units.

In conjunction with the developer, the County Government of Mombasa is coming up with a programme that will require the support of the National Government for non-salaried residents to also realize their dream of an affordable and quality house, the Governor said.

The East African Legislative Assembly Member of Parliament (MP), and Chairman of GulfCAP Real Estate, Suleiman Shahbal, urged buyers of the apartments at Buxton to create green spaces for their children to play safely by planting trees.

Shahbal said although the project was marred by

opposition at the beginning, court cases and summons to the Senate that threatened to derail it, he is now proud that Phase One is nearing completion and more than 3,000 jobs were created while 30 companies supplied building materials.

“This is the first affordable housing project that we started after other developers had started and we have finished before all of them. Mombasa should be proud,” Shahbal said.

Admittedly, Shahbal said mortgage payment may be out of reach for many who would like to own the houses, but together with the Governor are seeking an intervention from the President to enable many people buy the houses.

Former Mombasa Mayor, Ahmed Mohadhar, said with the support of the President, many low-income dwellers will have an opportunity to own houses.

the community on how their money was spent. We have seven forest neighbourhoods and each has benefitted,” the chairperson said.

He said the funds had educated over a thousand students from secondary to tertiary levels.

“We have educated 1,038 students, each getting a bursary of eight thousand five hundred per term. Education is our top priority as a community,” Ole Polos said.

He said about six million was channelled into rehabilitation of dams, water tanks aimed to cushion residents from dry weather conditions.

Among the beneficiaries of the water projects and bursaries from the carbon credits money include Ngare Ndare community, Ethi village, Lokusero, Sang’a, Leparua, Chumvi and Ngaresero neighbourhoods.

Laikipia County Commissioner Joseph Kanyiri said forest conservation

Michael Ole Pasare said they are committed to conserving the Mukogodo Forest through rehabilitation of trees that had been cut down in the past and at the same time prevent people from logging.

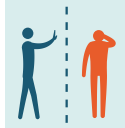

## Japan donates six patrol vessels to enhance surveillance in high seas

The Government of Japan has donated six patrol vessels worth Sh306 million to the State Department of Blue Economy and Fisheries to enhance surveillance and combat illegal, unreported and unregulated fishing in Kenya's territorial waters.

Mining, Blue Economy and Maritime Cabinet Sec-

retary Salim Mvurya said during the launch of the vessels by Deputy President Rigathi Gachagua in Mombasa that the blue economy is the next frontier of economic development hence the need to enhance security in the blue spaces.

“We have looked at the entire sector and one of the key priorities is to ensure

that artisanal fishermen are now able to do fishing as a business. “All Beach Management Units (BMUs) will be put in cooperative societies in readiness to venture into industrial fishing,” said Mvurya, adding that landing sites will be constructed.

Japanese Ambassador to Kenya Okaniwa Ken said the six vessels are in addi-

tion to 19 vessels that had previously been presented to the Kenya Coast Guard Service (KCGS). The patrol

vessels, Okaniwa said, will ensure there was a rule of law, safety and security in the seas.

“I hope that illegal fishing will be diminished and people from these areas can benefit from fishing resources in the sea,” said the ambassador, adding that Japan cherishes its cooperation with Kenya.

The Japanese Ambassador also noted the need to capacity-build the fisherfolk to tap into the blue economy sector. Blue Economy and Fisheries PS Betsy Njagi said the Kenya Blue Economic Zone is very rich in fisheries resources.

## 27 counties in World Bank sponsored climate change mitigation drive

At least 27 counties have been enlisted under a World Bank funded programme to develop infrastructure needed to mitigate effects of climate change country wide.

The World Bank (WB), under the Financing Locally Lead Climate Change Action Programme (FLOCA) in partnership with the Commission of Administrative Justice (Office of Ombudsman) are working with selected counties to set up infrastructure to address complaints arising from climate change.

The Vice Chair of the Commission of Administrative Justice (CAJ) Mr. Washington Opiyo Sati said the counties have been acquainted with the programme policy paper on how to set up the complaint handling infrastructures in their respective counties. "This policy aims at helping counties to set up the complaints handling infrastructure because they receive climate issues from Wananchi every day," said Sati while addressing the media.

Some of the counties that had representatives in the three-day training in Wote

include Nairobi, Kajiado, Machakos, Taita Taveta, Ki-tui and Makeni.

The vice chair urged county governments to come up with new innovations aimed at minimizing the impact brought about by climate change effects.

"The Commission in partnership with WB under FLOCA programme aim to respond to challenges brought about by climate change," he noted.

He observed that they will also engage with members of the public on the need to know how to access information that will help them hold the county and national governments accountable.

"The CJ Act of 2021 requires that the county and national governments must be held accountable. We shall engage with the public at Unoa grounds to enlighten them that it is their right to get information from government," Sati said. On her part, CAJ Chief Executive Officer (CEO) Mercy Wambua said through FLOCA, they want to empower locals on how to handle effects of climate change that impact negatively and infringes on their rights.

## Gvt. rolls out curriculum to curb extremism

The Ministry of Labour and Social Protection has launched a training curriculum and manual on preventing and countering violent extremism for children officers.

Cabinet Secretary (CS) Ms Florence Bore said the curriculum will go a long way in building the capacity of children officers to identify, prevent, respond and counter violent extremism among children.

Speaking in Nairobi during the launch, Bore said the project encompasses preventing violent extremism through rehabilitation, vocational training and social integration for children in conflict with the law.

"I would like to commend the United Nations Office on Drugs and Crime (UNODC) for their support for the statutory children institutions by providing

equipment for vocational training, scholarships, the automation of services in the institutions, counselling and reintegration, family empowerment and positive parenting programs, provision of micro business start-up kits among others," Bore said.

The CS noted that a sizeable number of children are involved in conflict with the law, explaining that the Kenya National Bureau of Statistics (KNBS) in 2021 documented about 4,500 children in conflict with the law with offences such as immorality, drug trafficking, robbery with violence, house break-ins among others.

Bore said this is a threat to the success of the country since the success of a country is dependent on its young generation, insisting that it is the duty of everyone to reduce the chances of these children transitioning into adult criminals.

The Commissioner General spoke in Homa Bay town during a meeting with the university officials while accompanied by Homa Bay County Commissioner Moses Lilan, the Deputy Governor Joseph Magwanga and Peter Ocholla, Tom Mboya University Vice Chancellor and other officials from the

State Department of Correctional Services. “We are here to start the implementation of the presidential directive which is to ensure that we hand over this land to Tom Mboya University for its expansion,” Warioba said. The Deputy Governor on the other hand appreciated the President for initiating the process, saying that he had promised

to send a team to look into the issue of the university’s expansion during his last visit to Homa Bay.

“We had extensive engagements on issues pertaining to the prison’s land for the purpose of expanding Tom Mboya University when his Excellency the President visited us and he did promise to send a team for that reason,” he stated.

The Ministry of Environment, Climate Change and Forestry with support from the Global Environment Facility (GEF) through the United Nations Development Programme (UNDP) is implementing the Integrated Sound Management of Mercury in Kenya’s Artisanal and Small-Scale Gold Mining as part of the Global Opportunity for Long Term Development (GOLD) in the Artisanal and Small-Scale Gold Mining (ASGM).

The Project covering six (6) priority areas namely Kakamega (Ikolomani and Roasterman), Vihiga, Migori (Masara, Osiri and Kehancha) and Narok (Lolgorian), is pursuing strategies to reduce and finally eliminate the use of mercury in the processing of gold by supporting the introduction of mercury free technologies in the ASGM sector. It further supports the formalization of the sector for ease to access credit/ formal financing and grants, and technical support.

Mining is a high-risk activity; incidences of fatalities and injuries are common particularly during raining seasons when shaft walls collapse or rain water drains into the shaft. There is therefore need for guidelines on mine health, safety and environment to protect the miners, as other workers and hence mitigate fatalities in an event of an accident(s).

Similarly, the ASGM sector continues to mine without permits/license, since they have not been designated areas to mine in compliance with the Mining Act 2016. It is thus prudent that they be allocated areas to mine and issued with the relevant permits if they are to maximize on their potential in mining activities and also generate revenue for the government.

In light of the above, the State Department for Mining in partnership with planetGOLD Kenya program have developed two (2) draft guidelines in respect to the above areas of concern and hereby extends an invitation for Public Participation to share their views on the draft guidelines. The fora are to ensure comprehensive engagement by providing a platform to share views on the drafted documents in accordance with Article 10 of the Constitution of Kenya.

# State launches sensitization drive on complaints against advocates

ACC has offered free legal camps in Tana River, Lamu, Mombasa, Kwale, Kilifi, Kakamega, Uasin Gishu and Kisumu Counties.

The Commission which is domiciled at the Office of the Attorney General and Department of Justice (OAG&DOJ), has also planned a similar exercise in other parts of the country beginning with Meru County in July.

Addressing participants during an outreach programme held in Kisumu County, ACC Secretary George Nyakundi stressed that Kenyans should embrace the Alternative Dispute Resolution (ADR) approach in resolving disagreements to ensure the client and advocate relationship is maintained.

In the event that the parties fail to reach an accord,

the matter should be escalated by lodging a complaint with the ACC which is mandated to receive complaints, investigate, prosecute and reconcile disputes, Nyakundi said.

The Commission has facilitated the refunding of over Sh23 million to Kenyans whose money had been illegally withheld by their advocates.

# Complaints commission recovers Sh6m from lawyers

BY MOSES WEKESA (KNA)

The Advocates Complaints Commission has recovered over Sh6 million withheld by advocates without justification which was meant for their clients from July 2022 to March this year.

The money was recovered following complaints filed by Kenyans against advocates

for a failed advocate-client relationship.

During the 2021/2022 Financial year, the Commission recovered over Sh23 million from advocates which was returned to Kenyans who suffered the losses.

The Secretary to the Commission George Nyakundi says, the commission also subjected about 352 complaints against advocates

to the Alternative Dispute Resolution (ADR) mechanisms during the last financial year. During the same period, the commission received 1003 complaints from Kenyans against advocates, which translated to about 84 complaints per month. From July last year to March 31st this year, the commission has received over 600 complaints.

# Gov't to distribute Sh18.3m worth of insecticide nets in fight against malaria

BY JOSEPH NG'ANG'A (KNA)

The Ministry of Health will distribute 18.3 million Long Lasting Insecticidal Nets (LLINs) in 28 targeted counties by next year.

State Department for Public Health and Professional Standards Principal Secretary (PS) Dr Josephine Mburu (pictured) said the move is aimed at ensuring households in malaria-risk areas have one net for every two household members, ultimately contributing towards reducing the burden of malaria in the country.

Speaking in Nairobi during the beginning of events leading up to this year's World Malaria Day commemoration, Mburu said the Ministry of Health plans to use innovative tools such as the use of drones in larval source management in lake endemic zones.

“The Ministry will also continue to provide

prompt malaria diagnosis and treatment through microscopy and the use of quality-assured malaria rapid diagnostic test kits and medicines throughout all public and faith-based health facilities,” said

the PS.

She added that to further bring services closer to the people and ensure no one is left behind, the ministry will enhance primary health care through which malaria services will be available up to the community level.

“This year's World Malaria Day theme, ‘Time to Deliver Zero Malaria: Invest, Innovate, Implement’ underscores the urgent need for action and further investment to achieve zero malaria illness and deaths,” the PS said.

Mburu said Kenya has made progress against malaria through the implementation of several interventions targeted at various parts of the country.

“In the last decade, we have reduced the prevalence of malaria by more than 50 per cent, and the number of new malaria cases has also significantly decreased. Several counties have consistently recorded very low

incidences of malaria and this provides an opportunity to implement malaria elimination in these counties,” she said.

The PS said that the Kenya Malaria Elimination Implementation Plan (2021-2023) outlines the implementation pathway of malaria elimination activities in the country.

“In the last year, our efforts together with Ghana and Malawi have resulted in the approval of the malaria vaccine for scale-up which

was launched in Kenya last month,” the PS said.

She continued, “Indeed, the tremendous progress we have made has not gone unnoticed. I am proud to reiterate, as some of you may already recall, that our President Dr. William Ruto, received an award at the African Union (AU) summit on behalf of the Republic of Kenya in recognition of Kenya's efforts in the fight against malaria, particularly in the effective use of the malaria scorecard for action

and accountability”.

Mburu said despite the tremendous investment in malaria, the uptake of malaria interventions at the community and household levels remains below target.

“I commend the private sector's role in contributing to the fight against malaria through multi-sectoral advocacy and resource mobilization. The recent efforts by the End Malaria Council of Kenya are an excellent show of commitment by the private sector.

### 1.1 BACKGROUND INFORMATION

The Government of Kenya launched the Industrial Transformation Programme in July 2015 that provided a framework for the country's industrialization process. A key component of this programme is the setting up of industrial zones and parks. KenGen plans to develop an industrial park (to be called KenGen Green Energy Park) at the Olkaria geothermal hub in Naivasha.

KenGen intends to leverage on its Geothermal resources available at Olkaria to establish the Energy Park. The area marked for industrial development is about 342 Hectares (845 acres). The masterplan will accommodate both industrial and non-industrial activities such as Offices, Data Centres, Research & Development Centre, Hospitality, Visitor Experience Centre, Administrative & Commercial uses. Industrial use land has been master-planned targeting Medium/ Heavy Industries, Steam Intensive Industries and Light Industries.

A feasibility study has been carried out and has identified two business models for the proposed development. The Master developer model which assumes KenGen will be solely developing the Energy Park and Sub-developer model where it is assumed that KenGen will be leasing some parcels of land to sub developers, who will develop some specific components of the Green Energy Park and sub-lease the serviced Industrial Land.

The opportunity available is for land lease to the sub-developers interested in setting up operations in the master-planned parcel to utilize geothermal steam and/or brine (hot water), raw water and electricity. The Kenya Electricity Generating Company PLC now invites expressions of interest from interested Sub developers and individual manufacturing/processing firms to lease land and set up at the proposed KenGen Green Energy Park in Olkaria, Naivasha.

### 1.2 THE KENGEN GREEN ENERGY PARK

KenGen has completed plans to set up an Energy Park at its geothermal power generation hub at Olkaria, Naivasha, Kenya. KenGen intends to leverage on its Geothermal resources available at Olkaria to establish the Energy Park. The park will provide industrial, commercial and recreational facilities and would be developed in four phases during the span of 2025 to 2045. # State to give Machakos' Wamunyu Handcraft Centre major facelift

The Government will soon renovate and give the iconic Wamunyu Handcraft Centre in Machakos County a facelift to match its status as an international producer of curios.

The Principal Secretary at the State Department of Culture and Heritage Ummi Bashir says, despite Wamunyu being renowned worldwide for producing masterpiece artefacts, the centre remains in a state of neglect and announced her Departments' plans to allocate funds in the next financial year to give both the workshops and the exhibition room a facelift.

"I'm disheartened by the state of this centre, it's in dire need of renovation and the environment in which the artists' work is not conducive," the PS noted.

Bashir also pledged that the government will explore ways to link the art-

ists with markets for their products both locally and internationally to avoid exploitation by middlemen who buy the artefacts for a song.

"I have noted with a lot of concern that the artists make very little money from the carvings despite working very hard while the brokers make a killing which is very unfair," she said.

The PS further disclosed that the State Department will establish curio malls at a central place where the artists can market their commodities.

"We shall also organize cultural festivals to

showcase the artefacts besides marketing them digitally where each item will be allocated a USSD code," she added.

Bashir also noted that the State Department will collaborate with the Kenya Wildlife Service (KWS) to have the curios sold to tourists at the KWS gates in Donyo Sabuk and Athi River.

On raw materials, the PS said she will reach out to her counterpart in the State Department of Forests to provide seedlings to avert deforestation.

"It is important that the trees that are cut for the carvings are replaced to combat climate change," the PS added.

She also urged the artists to form a co-operative society to reap huge benefits.

Bashir spoke when she toured the facility in the company of the Director for Culture and Heritage Dr. Kiprop Lagat.

70-year-old Lazarus Kithuka, an artist, hailed the government's plan to revamp the centre.

Kithuka who has over 40 years' experience noted that the art of carving that was once a source of livelihood to many residents in Wamunyu is slowly dying mainly due to lack of markets for the products.

"Although the enterprise

was struggling, it took a nose-dive during the Covid-19 pandemic and it has never recovered," he said.

On average Kithuka said he makes Sh500 a day, down from Sh3,000 when business was good.

"Sometimes I make as little as Sh100 for one item which takes me about two hours to make, business is very slow," he added.

## Nyamira, drone firm sign health services pact

Nyamira County is partnering with Zipline Company, a US-based logistics drone manufacturing company to avail instant Sexual Reproductive Health Services (SRHSC) to adolescents and young adults in the area through an automated drone which also entails delivering medical commodities to the residents.

The County AIDS/HIV and STI Coordinator (CASCO) Irene Omwenga said their partnership with Zipline will be very instrumental in reaching out to the young adults and adolescents who fear to access sexual and reproductive health services from health facilities because of stigma.

"Our county's records indicate that 50 per cent of new HIV/AIDS infections are among youths between the age of 15-24 years, a worrying trend in our county in which we highly welcome partners to help us reduce and eventually end the new HIV/AIDS infections," Ms Omwenga revealed.

# KEFRI challenged to lead greening initiative for 210 TVET institutions

BY JUDY TOO AND KIPTANUI CHERONO (KNA)

The Kenya Forestry Research Institute, KEFRI, has been tasked to supply seeds to 210 technical and vocational training (TVET) institutions to raise at least 20,000 tree seedlings for the 2023/2024 tree planting season.

According to the Principal Secretary for the State Department for Forestry Ephantus Kimotho, the seeds will be supplied through the 22 KEFRI stations across the country by the end of May this year.

Kimotho further said 145 kilograms of seeds with 290,000 tubes to raise 2.9 million tree seedlings was distributed to 28 TVETs during the launch of the Green Initiative Challenge (GIC) for TVETs at the Eldoret National Polytechnic.

Kimotho said they aim to donate one million seeds to every TVET to produce at least 100 million tree seed-

lings, adding that if each of the 500,000 students in TVET institutions planted at least 30 tree seedlings annually, the country would be able to have 150 million trees planted.

During the launch, Principal Secretary of State Department for Technical and Vocational Training Dr. Esther Muoria said during the ongoing campaign to plant trees countrywide, the Ministry of Education in Collaboration with the Ministry of Environment, Climate Change, and Forestry aims to plant five million trees this season as its contribution towards President William Ruto's greening initiative that aims to achieve 15 billion trees within the next 10 years.

The PS underscored the significance of conservation of the environmental resources to mitigate effects of climate change, adding that the ministry intends to escalate its share of tree planting to one bil-

lion in five years, towards the achievement of the 15 billion tree cover targets.

“As the Ministry of Education contributes to the realization of required forest cover, we would like to plant up to five million trees this tree planting season and be able to scale it to one billion in the next five years,” she said.

“The success of the green initiative effort depends on the participation and collaboration of TVET principals and other stakeholders; therefore, I encourage all of you to join hands in the ongoing tree planting campaign,” the PS said.

She signed a memorandum of understanding with the forestry department for the supply of seeds.

The PS lauded the Eldoret National Polytechnic for its initiative to install a biogas plant, encouraging more institutions to follow suit as one way of embracing clean energy.

# Universal internet access initiative gets Sh5bn funding push

Communication Authority of Kenya offers the money from the Universal Service Fund in what kicks off the 100,000km fibre installation journey

Some 19 counties, especially those in far-flung areas, will benefit from Sh5 billion last-mile fibre optic cable connection as the government moves to boost internet access in regions with low connectivity.

The cables will be laid out using money from the Universal Service Fund (USF), which is administered by the Communications Authority of Kenya (CA).

The fund was created in 2009 to support widespread access to ICT services, which include rollout of infrastructure and communications services in unserved and underserved areas.

The money comes from levies on licensees, appropriations from government as well as grants and donations.

CA and the ICT Authority (ICTA), which last week signed a Technical Cooperation Agreement, will implement the project, alongside other government actors.

The internet connectivity initiative targets schools, government institutions and offices, health facilities, rural businesses, homes and public spaces.

This is in line with the Government Digital Transformation Agenda on deploying 100,000km of fibre network to all the 1,450 wards across the country.

### Number of internet subscriptions on the rise

According to the Communication Authority of Kenya's latest report, the country has 48.3 million internet subscribers and 60.7 million mobile phone devices connected to mobile networks, out of which 32.9 million are feature phones and 27.9 million smartphones. Kenya seeks to become the digital hub in Africa in the next coming years. The plan involves expansion of the fibre optic network by 100,000km, digitising of all government services and setting up of free WiFi hotspots across the country. The aim is to make Kenya a paperless economy by cascading digital technology use in all sectors. At least 4,200 government services can now be accessed online.

## Millions to benefit as State moves to expand internet connectivity in 19 counties

In laying out the 100,000km cables, which is part of the National Optic Fibre Backbone Infrastructure (NOFBI) that seeks to provide affordable and quality broadband infrastructure, promote and facilitate open access to underserved areas through enhanced broadband connectivity, the government will construct 52,000km mainly connecting its key institutions while 48,000km will be done by the private sector for homes and businesses.

The counties to benefit are Turkana, West Pokot, Baringo, Elgeyo Marakwet, Samburu, Marsabit, Mandera, Tana River, Lamu, Kilifi, Kwale, Kitui, Laikipia, Isiolo, Garissa,

Wajir, Kitui, Makuani, Kajiado and Narok. According to the 2019 population census, the counties have a total population of about 16 million people. "What we are doing today is phenomenal and will greatly transform the country in the coming years," said CA director-general Ezra Chiloba.

ICTA chief executive officer Stanley Kamungu said the partnership would help in the attainment of the digital transformation agenda.

"It is an interesting time to begin the 100,000km journey," he observed, adding that the project would be implemented in three years.

The agreement effects a memorandum of understanding the two institutions signed in

December 2022.

Mr Eliud Owalo, the Cabinet Secretary Ministry of Information, Communications and the Digital Economy, recently said the government is working to ensure there is reliable internet infrastructure across the country.

"All Kenyans would have access to the internet. We will roll out 100,000km of fibre optic cable to places that are not connected. The government will do 52 per cent of the cable while private sector 48 percent," said the minister at the Connected Summit.

So far, according to Mr Owalo, the government has installed 25,000km of fibre and by June, an additional 5,000km network would have been laid out.

## Kenya on track to achieve zero infections as world celebrates Malaria Day

As the world celebrates Malaria Day today, Kenya is among countries that would be recognised for cutting prevalence of the disease by 50 per cent in the last five years thanks to the government's interventions, including through the introduction of a vaccine.

Dr Josephine Mburu, the PS in the State Department for Public Health and Professional Standards in the Ministry of Health, said prevalence declined to 93 per 1,000 people by the end of 2022.

The number of new cases and deaths has, similarly, fallen significantly in the years, she added.

In the past years, an estimated 3.5 million new cases and 10,700 deaths were recorded each year, especially in areas where the disease is endemic.

Dr Mburu committed that the ministry will intensify intervention measures, especially in the lake region, where the disease affects most people.

"We're pleased to report that several counties have recorded a decline in malaria cases, which is a positive step towards achieving our goal of eradicating malaria," she said during the launch of the Kenya Malaria Behaviour Survey 2022, among other key documents.

Dr Andrew Mulwa, the Head of Preventive and Promotive Health Services at the Ministry

of Health, said the government plans to distribute 18.3 million treated nets in 28 targeted counties in 2023 and 2024 to ensure households in malaria-risk areas have one net for every two members.

He said the plan aims at reducing the burden of malaria and ultimately contributing to the global goal of eliminating the disease by 2030.

Kenya, alongside Ghana and Malawi, last month approved the scale-up of malaria

"In five years, our target is to have installed over 100,000km of fibre cable in conjunction with the private sector." Besides the cable, the government is in the process of setting up 25,000 free WiFi hotspots targeting people at the bottom of the pyramid. "By June, at least each county will have two WiFi hotspots," he said.

The laying out of the cable is part of the wider plan to place ICT at the centre of the country's economic transformation.

According to Mr Owalo, by June over 5,000 government services will already be on the e-citizen platform.

"We are currently at 4,200 and we are sure that we would surpass the government by June," he said.

The government is also digitising its records and automating all systems to maximise the benefits of interoperability under the digital government services, products and data management.

The wider plan, contained in the Kenya Digital Masterplan 2022-2032, envisages the training of 20 million citizens including special interest groups on digital skills, training of 10,000 officers in public service in high-end specialised ICT areas, training of 300,000 civil servants on digital skills and data protection and training of 350,000 teachers on digital skills to aid in the technology-led economic transformation. ■

The use of the RTS,S vaccine has the potential to prevent millions of cases of malaria, particularly among young children in sub-Saharan Africa, where the burden of the disease is highest.

The expansion of the vaccine's use in Kenya is a significant step in the fight against malaria and underscores the country's commitment to achieving the World Health Organization's goal of reducing malaria cases and deaths by at least 90 per cent by 2030.

The World Malaria Day 2023 is marked under the theme, "Time to deliver zero malaria: invest, innovate, implement."

Malaria remains a major public health concern in Kenya, but the End Malaria Council is making significant strides towards its elimination in particular through indoor spraying, said the chairman Chris Gitonga.

"The End Malaria Council has mobilised an additional \$1 million towards the fight," said Dr Mburu, adding that funding challenges remain especially with stagnation or declining of external funding. ■

# Hope as government unveils Cyberknife - an innovative cancer treatment technology



President launches centre at KUTRRH where the technology will be used to treat cancer patients, reducing waiting time

President William Ruto on Monday launched a cancer treatment centre at the Kenyatta University Teaching, Referral and Research Hospital (KUTRRH), where a new cutting-edge technology will be used to treat patients.

The technology, known as Cyberknife, promises to revolutionise treatment of brain, head and neck, liver, lung, pancreas and prostate cancers, among others.

President Ruto said the Cyberknife Centre at KUTRRH introduces a revolution in cancer management and treatment, not only in Kenya but also across the region.

"This technology is able to administer with precision radiation treatment as it targets tumours," he said, adding that since it is non-invasive, patients recover faster after treatment.

He said the fact that Kenya is the second country to deploy Cyberknife technology in Africa after Egypt propels the country

to an advanced regional and international medical hub.

"Kenians now do not need to travel to other countries for cancer treatment since the services are in our public hospitals like KUTRRH," he said, adding that up to Sh10 billion has been saved by some 6,000 cancer patients who have sought health services in public hospitals.

INFOBOX

**What is Cyberknife?**

Cyber means relating to computers or internet and knife is a tool for cutting or chopping. But in this case, this is an equipment used to offer painless, non-intrusive treatment that delivers precise robotic radiation therapy to cancerous and non-cancerous tumors, making recovery faster.

**What kind of cancers does it treat?**

The technology is used to treatment brain tumours as well as breast, liver, prostate, spine, lung, pancreatic and cancers. This technology has been used for over two decades helping millions of patients.

**Is the technology used to only treat cancer?**

Cyberknife is used in the treatment of both cancerous and non-cancerous tumours and several other conditions on the body including on the prostate, lung, brain, spine, head and neck, liver, pancreas and kidney, where radiation therapy is needed.

The President noted that the technology would be affordable to Kenyans since one would be able to use their National Health Insurance Fund (NHIF) cards to pay for services without the need of topping up.

President Ruto said the government is working to bring down the cost of treatment through the NHIF, whose regulations are being revised so that it can support universal health coverage programme.

He announced that at least three linear accelerator (Linac) machines used in radio therapy will be delivered in hospitals in Garissa, Nakuru and KUTRRH in about four months.

Health CS Susan Nakhumicha said the government will employ at least 100 community health promoters whose job will be to work with families to help curb and prevent diseases, especially non-communicable ones.

Prof Olive Mugenda, the chairperson of the board of directors of KUTRRH, said the Cyberknife technology increases options for management and treatment of cancer.

"This is an alternative to chemotherapy for management of various cancers. We have recruited specialists that include oncologists and radiation therapists and brought in an Indian expert to ensure we have requisite staff," she said. ■



**What is personal data?**

This is any information on an identified or identifiable natural person (data subject). This can be a person's phone number, address or more sensitive data or information on health.

**You talk of sensitive data...**

We call it sensitive because it can expose an individual to high risk if unauthorised persons or entities access it, therefore, it requires protection. These include data on race, health status, ethnicity, conscience, belief, genetics, property, marital status and family details like names of children, parents, spouse(s), sex or sexual orientation.

**Who is a data subject?**

This is an identified or identifiable natural person, who is the subject of personal data. Therefore, entities that are legal persons created through a statutory process or a directive are not data subjects.

**In what form can one collect data from a subject?**

Any form. The law covers personal data that is processed using automated and non-automated means. This means that manual or non-digitised processes such as writing data in a notebook are captured under the law. Data can also be a description of how you look or sound, for example biometrics, photos, audio or video recordings.

**Now, what rights do I have as a data subject?**

Under the law, you have the following rights:

1. To be informed of how your personal data will be used.
2. To access your personal data.
3. To object to the processing of all or part of your personal data.
4. To correct false or misleading data.
5. To delete false or misleading data about you.
6. To request for any of your information erased.
7. Not to be subject to a decision based solely on automated processing, including profiling.

**Tell me about the Office of the Data Protection Commissioner (ODPC)**

The ODPC was established under the Data Protection Act, 2019, and its primary function is to protect your personal data.

**How does the ODPC protect my personal data?**

The office registers and regulates the industry players, namely data processors and controllers, to ensure they process personal data in accordance with the law. The ODPC also provides you with rights and remedies to protect your personal data from unlawful processing.

**As a data subject, do I need to register with the ODPC?**

No, only those who collect and use your data, that is data controllers and data processors, need to register.

**Is there a way I can help to protect my data?**

Ensure you are notified by the entity collecting your data about the following:

1. That personal data is being collected.
2. Your rights in relation to the data being collected.
3. The purpose of collection.
4. The safeguards that the entity will adopt to protect your data.
5. Whether they will share the data with other persons or entities.
6. The details of the entity collecting your information.

## Newly commissioned avocado processing factory to benefit thousands of farmers

The British High Commissioner to Kenya Jane Marriott, and the Kisii County Governor Simba Arati have commissioned an avocado oil extraction project at the Kisii Agricultural Training Center (ATC) which has a capacity of processing up to 70 tonnes of avocados daily.

The processing plant which was commissioned last week will utilize locally sourced products from Kisii and the neighbouring counties to produce avocado oil mainly for the export market.

The investment project is a partnership between the British Government and the AvoFresh Processors Limited, which was implemented by the UK's Sustainable Urban Economic Development Programme (SUED) in collaboration with Kisii County and the Kisii Municipality.

"The commissioning of this facility is a demonstration that by working in partnership, it is possible to come up with real opportunities and empower our people to cope with daily challenges," Ms Marriott said.

The UK ambassador further said the extraction facility will in the first year create 95 direct jobs, 100 induced jobs and will work with 1000 farmers which will eventually increase to 3,000 in the subsequent years.

The facility will also provide an opportunity for farmers to

access markets for their produce and reduce wastage that results in post-harvest loss.

Marriot noted the factory will go a long way in capacity building the community and sensitizing them on tackling the biggest global challenge which is climate change.

She lauded the County Governor for cracking the whip on corruption saying this move will minimize exploitation of farmers by middle men.

Arati thanked the UK Government for supporting the county to accomplish what he

termed a noteworthy venture for Kisii residents, which would enable farmers to access a ready market for their avocados.

"I have instructed the department of agriculture to give the investor full support to ensure sustainability of this project and we shall continue mobilizing our farmers through their respective cooperative societies to ensure

continuous and sustainable supply of raw materials," he said.

The governor said that his office will continue reaching out to the British High Commissioner and other development partners for support to enable them to reap maximum benefits from the project.

"While respecting the principles of a free market economy, I ask the management of AvoFresh to try as much as possible to ensure that our farmers who have suffered in the hands of middlemen for many years get value for their hard earned labour," Arati stated.

Avofresh project manager David Gitonga said that over the last few months, they managed to work with the County government to actualize the processing facility by ensuring that farmers within the County are aware of the processing facility and further thanked the UK government for both financial and technical support.

The Avocado Oil Extraction Facility will process avocado oil, initially crude avocado oil, but will in time progress to include extra virgin avocado oil and virgin avocado oil, promoting the utilization of oil, including rich avocado oil.

Gitonga said UK had played a key role in realizing this investment by providing expert advice and Sh79 million in seed fund support.

#### Embu allocates Sh50M to support creative arts sector

"As a county, we have decided to go the opportunity way to ensure that our youth

are able to monetize their talents and earn a living from them," the county boss said.

She challenged artists across the county to come up together and form a Sacco to enable them grow economically as they will also benefit from national and county government economic empowerment programs.

"If you form a Sacco for the creatives, I promise you the County Government will put in some money to support your work," she said.

She also announced plans to hold an annual talent search programme dubbed "Zindua Talanta" focusing on performing and creative arts to generate content for a community TV station that will broadcast local content.

President Ruto's daughter Charlene, urged the youth to be aggressive in exploiting their inherent skills and talents to transform their lives.

"My father did not come to tell me to start engaging in youth affairs, I personally went and told him I am passionate about the young people and I want to support them and he gave me his blessings," she said.

#### Specialist on women rights roots for more funds to women kitties

An advisor to the Presidency on Women Rights Ms Harriette Chiggai is rooting for an increase in the amount of funds allocated to kitties established for womenfolk in order to help them mitigate against the myriad challenges they face on daily basis. While calling for the increase in funding for women, Ms Chiggai also defended a recent government decision to increase allocations to their kitties due to the acute challenges they face.

The Advisor who was speaking during The African Women Entrepreneurship Cooperative AWEC General Assembly in Nairobi told the delegates that women are more trustworthy and quick in loan repayments hence the need to boost their kitties.

Ms Chiggai's remarks comes hot on the heels of a recent decision by President William Ruto to triple the allocation given to the Women Enterprise Fund from a paltry Sh4 billion to Sh13.5 billion during the relaunch of the Women Enterprise Fund and the launch of the second product of the Hustler Fund early last month.

Ms Chiggai noted that the elimination of financial intermediaries in the Women

Enterprise Fund was a big win for women where many were subjected to corruption deals before accessing the loans.

To make disbursements from the Women Enterprise Fund more transparent, the Government re-modeled the Fund from manual to digital in line with the promise on digital inclusion.

This re-modelling, Ms Chiggai says, will ensure that no one is left behind in the disbursement and the launching of four more loan products in the market including Personal Loan, Micro Loan, SME Loans and start Up Loans. Ms Chiggai noted that women empowerment has contributed immensely to the economic growth with statistics indicating that if one goes to the farm, they'd notice that over 75 per cent of the farmers are women.

"Go to any market, majority of the traders in markets are women yet they are marginalized when it comes to access to finance to grow their businesses," says Ms Chiggai.

The advisor further noted that her office will continue championing for financial institutions to make their systems friendly to women and their businesses.

## Boost to Kisumu fishermen as European Union, Sweden fund fish scaling market

The County Government of Kisumu, in conjunction with the National Government, European Union and the Government of Sweden, has launched a fish scaling and processing market at the Jubilee Market in Kisumu as part of its fulfilment of its manifesto to transform the lives of the fishing community.

The project was launched as part of the Agricultural Sector Development Support Programme towards strengthening the development of

value chain in Kenya, with 50 groups directly expected to benefit from the market's value chain.

The facility is expected to directly impact the entire Kisumu economy by availing to them nutritious fish.

The establishment of the facility marks the completion of the fish value chain in Kisumu with only the fish frying section now missing.

However, the marketing community cited the need to beef up security in the area especially by introducing flood lights.

The chairman of the bus park, Shem Ochuodho, noted that the presence of street urchins poses a security threat to the business community, but unveiled plans to empower the local street children by training them to make them self-reliant.

He further cited the need to refurbish the garbage collection system and installation of permanent coverage for the drainages in the market to spruce up sanitation in the market and improve drainage, especially through proper garbage collection, to

ensure garbage is not piled in the area as well as reinforce toilet facilities.

The Kisumu Agriculture CEC Ken Onyango lauded ASDP for the project which he noted will ensure hygienic fish handling.

Onyango termed the project a milestone for the local community, especially after being launched in a market which has a very nostalgic history to the local community due to the central role it played as a food gateway to the region and the entire African continent.
