

versity and Technical Education respectively.

In a speech read on his behalf by the State Department for Basic Education Principal Secretary Dr. Belio Kipsang, the Cabinet Secretary said the Committee will provide overall oversight of the implementation, policy guidelines and directions in the implementation of the recommendations alongside resource mobilization to support implementation of the recommendations.

He said the Committee will also approve all policies and legislations before submission to the Cabinet, review progress reports of the technical committees and provide feedback on the implementation process.

According to Mr. Machogu, the Legal Committee will handle all legal and policy documents governing education in the country as per the PWPER report.

"It will comprise legal

officers from Office of the Deputy President, Office of the Prime Cabinet Secretary, Office of the Attorney General, Ministry of Education, Teachers Service Commission and Semi-Autonomous Government Agencies", he added.

The Cabinet Secretary said the Sessional Committee that comprises all chief economists and technical officers will deliver the sessional paper whereas the Departmental Technical committee will comprise technical officers from respective state departments, and each will be chaired by the respective principal secretary.

"There is an urgent need to improve linkages between institutions working in education by demarcating the roles each plays and should play with uttermost clarity. We need to cut waste and improve efficiency and effectiveness of our educational institutions," the Cabinet Secretary stated.

packed again, then brought here to be sold...," Kuria said.

He was leading a fundraiser at Kapsabet Showground to complete construction of the Anglican Church of Kenya Plaza.

Kuria said industrial parks launched across the country are meant to enable common people in business to buy and process farm produce using minimum capital possible within their reach.

The Trade CS said the government has identified industrial parks as key centres where local people's produce is processed in real time hence minimising wastages normally experienced during harvest seasons.

He said he will be visiting the county again in a few weeks' time to launch the proposed industrial park, believed to be the first of its kind in the county.

The Head of Public Service Felix Koskei, who was present, pleaded with the church at the communities' level to support the govern-

### Government establishes a National Health **Procurement Board to lower health costs**

**¬**he Government has constituted a National Health Procurement Board to handle bulk purchasing of health products and technologies.

The Principal Secretary in the State Department for Public Health and Professional Standards Ms. Mary Muthoni said the move is aimed at lowering the cost of healthcare products through economies of scale.

Ms Muthoni said the Board will lead to the establishment of a fully integrated and interoperable health information ecosystem to drive patient-centric services, prevent fraud, and improve responsiveness, efficiency, transparency and sharing of health data among health providers.

The PS was speaking in Naivasha during training of trainers (ToTs) for Community Health Promoters (CHPs) drawn from all the 47 counties in a bid to upscale primary health care networks in the counties.

Ms Muthoni at the same

time said the Government will engage 100,000 CHPs to manage the Smart Primary Care Network (PCN) which will be launched by President William Ruto during this year's Mashujaa Day on October 20 in Kericho County whose theme is "Universal Health Care".

She said the CHPs will work and train people in villages and households on preventive healthcare.

This is in giving priority to primary healthcare (PH) which will in turn help reduce the disease burden in the country by giving more attention to preventive rather than curative healthcare.

In total, 315 primary healthcare networks will be operationalized through the establishment of the governance, coordination, and financial structures for

These PCNs will foster integration of care across levels of the health system and improve efficiency of the health system by providing care at the optimal level and ensuring that no one is left

Additionally, they are expected to create an efficient emergency referral system while improving sharing of resources across levels of care as well as improving data flow for better decision making.

"For a long time, the

country had concentrated on curative rather than preventive healthcare which has seen the disease burden increase in the country and hence, cost of healthcare as treatment is costlier than putting in place preventive measures," Muthoni ex-

She noted that Kenya is restructuring the health service delivery system by shifting the emphasis from curative to "preventive and promotive" health care in order to lower the nation's disease burden and improve the overall livelihoods of Kenyans by providing an efficient integrated and high-quality affordable healthcare.

Ms. Muthoni noted that the government's Bottom-Up Economic Transformation Agenda (BETA) had identified various gaps in the healthcare system which include inadequate human resources (HC) for health, lack of proper health financing to ensure universal healthcare, and ineffective supply chain for commodity security.

# Pharmacy and Poisons Board to develop guidelines on drug safety

he Pharmacy and Poi-**I** sons Board is in the process of drafting new guidelines on good pharmaceutical practices in Kenya in order to address the issue of drug safety and appropriate use of medication.

The Board's Chairperson of the Training and Assessment Technical Committee Prof. Francis Ndemo says the guidelines seek to improve the quality of pharmacy practice and training.

He said medication is now the third leading cause of death in the country hence the need to address drug safety and inappropriate use of medication.

"Drug-related morbidity is on the rise, and these guidelines will help us ensure that we give the best pharmaceutical care in the country," Prof. Ndemo said.

Speaking in Machakos during a stakeholders' forum, the chairperson, who is also the Dean. School of Pharmacy at the United States International University (USIU), said besides the safety issue in the guidelines, the Board would also address manufacturing of poor quality drugs, supply chain management and primary healthcare as envisioned in the Universal Health Care (UHC).

"Pharmacists and pharmaceutical technologists need to be more engaged in the provision of primary healthcare.

We intend to come up with the best guidelines for pharmaceutical care and we have benchmarked in other countries for the best practices," Prof. Ndemo

## Education ministry to separate grading and placement in KCSE exams, says PS

**¬**he Ministry of Educa− tion will review the grading system for all KCSE candidates sitting for their exams this year in order to enable more learners to meet the cluster requirements for various courses which they wish to pursue at both university and college levels.

Basic Education Principal Secretary Dr. Belio Kipsang has said, once adopted by the Cabinet, the new grading system will focus on the learner's competencies, skills and knowledge.

"The other things you need to look at are the best areas that the kid has acquired knowledge and competences by picking on the best subjects and learning areas which they have scored well so that you use that to grade them.

which is numeracy and literacy and then you pick the best five from all the subjects that the kid has done," he said. The Principal Secretary made the remarks in Kilifi County on the sidelines of a consultative forum that was organized by the National Assembly Departmental Committee on Education. "That is why we are having cluster subjects and

"So you pick the first two we used to say you must be graded on Mathematics. Kiswahili, English, Biology and sometimes Chemistry.

"So you find this kid graded on so many learning areas which are aligned to placement but we want to separate placement from grading so that you test the kid on two critical areas, on numeracy and literacy and that is why we are saying we are going to grade this kid

on mathematics and a language as compulsory. And a language is either Kiswahili or English, not both and we would have taken care of numeracy and literacy," he added. Dr. Kipsang said the move is informed by the recommendations proposed in the Presidential Working Party on Education Reforms report which suggested that grading of the learner be done by separating placement and testing.

"The recommendations of the Presidential Working Party is that we would want to separate placement and testing to appreciate what our children have learnt", he said.

Dr. Kipsang said the new grading will benefit at least five cohorts under the former 8:4:4 system of educa-

# Rift Valley Polytechnic partners with Israel and UK for student internships

**¬**he Rift Valley National Polytechnic (RVNP) has worked out partnerships with several firms in the United Kingdom and Israel aimed at equipping its students with hands-on skills in an industry setting during their time of study.

The institute's Principal Mr Sammy Chemoiwo indicated that the venture was geared towards bridging the skills gap among the students by ensuring they spend at least 30 per cent of their training working with relevant industries in the two countries.

Disclosing that five of RVNP's students would be proceeding to the United Kingdom for a three-month industrial attachment program in various indus-

#### Introduction

The Government of Kenya has identified the Cotton Textile and Apparels (CTA) value chain as one of the priority sectors to drive government development agenda, create jobs and increase export earnings. For this to be achieved, there is need to ensure availability of adequate raw materials to support the entire value chain. Kenya accounts for just 0.4% of approximately USD 84 billion US textiles market despite its 10% cost advantage over lower-cost countries.

With the establishment of Export Processing Zones (EPZ) policies and participation in the AGOA trade agreement since year 2000, Kenya has been a key beneficiary and textile and apparel exports have grown to more than USD 500 million per year, and now accounts for 30% of industrial export growth.

Currently firms located within our EPZ and other Kenyan companies source all their fabrics requirements from East Asian countries; since the country lacks textile mills with capacity to meet both quality and quantity requirements for globally competitive export markets. The total consumption of fabric in the country is estimated to be 100 million meters of fabrics per year.

In the recent past, there has been efforts by both government and private sector to promote cotton growing with a view to addressing the shortage of cotton lint. However, there is need to promote the manufacture of synthetic fabrics which form a huge part of raw materials for both domestic and export markets.

The government is therefore soliciting for expression of interest (EoI) from interested and qualified manufacturers for synthetic fabric. This EoI is Open to both Local, Regional and International Bidders.

#### Purpose

A: As a newly appointed Vice-Chancellor and aware of the challenges facing universities in Kenya, my primary challenge is to ensure that university education remains relevant to the ever-changing national and global trends in industry and development. We need to adapt to these changes to benefit from technological and social advancements. **T**he Government has launched the National Guidelines on Workplace Mental Wellness to address mental health in the workplace across the country

The launch of the new guidelines was presided over by Dr. Patrick Amoth, the Acting Director General of Health at the Mathari Teaching and Referral Hospital who read a speech on behalf of the Cabinet Secretary for Health, Ms Susan Nakhumi-

Nakhumicha said the newly developed guidelines focus on promotion, prevention, care, and support, emphasizing the responsibility of all within an organization from individuals to leader-

The CS said individuals are encouraged to prioritize mental wellness while managers should create supportive environments and organizational leaders must implement wellness pro-

The rules are applicable to all workplaces in Kenya,



including private, public, formal, and informal sectors, she said. "The launch of the National Guidelines on Workplace Mental Wellness marks a significant moment in Kenya's commitment to addressing mental health in

the workplace," Na-

Let us commit to advocate for and invest in mental health in all workplaces -Nakhumicha

khumicha declared. She said there is no health without mental health, saying the call to action is very clear.

"Let us commit to advocate for and invest in mental health in all workplaces and turn them into places of healing and support for the prosperity of our people and our great nation," she said.

Nakhumicha said that recognizing the severity of mental health as a public health and developmental challenge, the Kenyan government has implemented recent reforms to strengthen

the nation's mental health system.

These reforms, she said, are aligned with the Universal Health Coverage Policy (UHC 2020-2030).

The reforms include the Kenya Mental Health Policy 2015-2030 which adheres to national and international standards.

Kenya leads the region with its Mental Health Action Plan (2021-2025) which provides a framework for implementing the Mental Health Policy and Taskforce on Mental Health Report in line with the Economic Transformative Goals and Sustainable Development Goals, the CS said.

"Mental health significantly impacts workforce productivity. The average adult spends about 1,795 hours annually working, totaling over 84,365 hours in a lifetime and studies reveal that approximately 15 per cent of the working population grapples with at least one mental health condition, translating to around 3.7 million Kenyans facing such challenges," Nakhumicha said.

East African Community, Arid and Semi Arid Lands and Regional Development Cabinet Secretary Ms Rebecca Miano who was speaking during a conference hosted by USAID Kuza and partners, themed "Why Northern Kenya, Why Now?" to discuss the status and opportunities for investment in the Northern region said the region is endowed with unparalleled natural resources but is caught in a cycle of under-development.

"Northern Kenya is endowed with big rivers but has constant water shortage and no water for irrigation. It is home to some of the country's most substantial river systems, including the Tana, Ewaso Ng'iro, and Turkwel rivers. Despite these many rivers, the region faces severe water shortage", said Ms Miano.

To avert this level of marginalization, Ms Miano said, the government is working towards enabling the people in all ASAL areas to have water supply throughout the year.

The CS further said the region has vast resources for green renewable energy but inadequate electricity connection due to insufficient investments in energy infrastructure leaving the residents disconnected from the very renewable energy sources that could drive development and improve their quality of life.



ember states of the Inter-governmental Maritime body have been urged to develop and harmonize their national policies and strategies to a regional and continental level to enable the region achieve the African Dream Agenda 2063.

The member states include Kenya, Tanzania, Uganda, Zambia and the Democratic Republic of Congo. The Inter-governmental Maritime body is now expanding to the rest of the Eastern, Southern and Northern Africa.

The Principal Secretary, State Department for Shipping and Maritime Affairs, Mr. Shadrack Mwadime said, there is a need for the region to align its national and regional goals and ambitions to become maritime labour-producing nations that will grow national maritime and blue economy industries.

"The region should strive

to supply the global market where opportunities abound for well-trained maritime professionals," Mwadime

He said Kenya has already completed public stakeholder participation for both the National Maritime Transport Policy and Maritime Education Training Policy and will soon embark on a legal process to adopt the policies, which are expected to spearhead growth in the maritime sector.

The PS made the remarks in a speech read on his behalf by the Secretary of Administration from the State Department for Shipping and Maritime Affairs, Mr. Isaiah Nakoru, during the opening of the Regional Consultative Forum for Maritime Administrations and Maritime Training Institutions held at a Nairobi hotel.

Mr. Mwadime commended the Intergovernmental Standing Committee on Shipping (ISCOS) for spearheading the ongoing drafting of a Regional Maritime Transport Policy which will provide a coordinated approach for its member states and the

Eastern region at large.

The PS at the same time, called upon stakeholders in the maritime sector to focus on what is happening globally at the International Maritime Organization (IMO) where key decisions are made with minimal African presentation.

"African countries must collaborate and work together to increase their participants at the International Maritime Organization Council," he stressed.

Mwadime noted that the

amendments to the IMO facilitation convention mandates public authorities to establish, maintain and use single window systems for the electronic exchange of information required on arrival, stay and departure of ships in ports from January 2024, terming it an important step towards acceleration of digitization in shipping.

Regarding the amendments, the PS told all maritime administrations and relevant agencies to ensure compliance to the IMO conventions and regulations which he termed play a key role in maritime trade facilitation.

# Kenya's drive to wipe out meningitis gains momentum with WHO support

lans by the Ministry of Health, in collaboration with the World Health Organization, to develop Kenya's National Meningitis Elimination Plan are at an advanced stage.

According to the Ministry of Health, the strategic initiative which is supported by the WHO aligns with the UN health body's global roadmap to eradicate meningitis by 2030 (DM2030).

Meningitis is a rare infection that affects the delicate membranes called "meninges" which cover the brain and spinal cord in the human body.

The primary objective of the initiative, the Ministry says, is to eliminate bacterial meningitis epidemics, reduce preventable cases, lower fatalities and enhance the resilience of healthcare

According to the World Health Organization (WHO) meningitis can be caused by several species of bacteria. viruses, fungi and parasites and can affect people of any age but young people are at

the biggest risk.

"The WHO's framework to curb meningitis in Africa by 2030 centers around five pillars, prevention, diagnosis and treatment, surveillance, support and aftercare, advocacy and engagement," Dr. Anderson Latt, the WHO Regional Meningitis Control Officer who is leading the process said.

To achieve these goals, the Ministry's Meningitis Elimination Plan emphasizes the need to strengthen integrated surveillance systems to better detect and respond

to meningitis outbreaks, enhance laboratory confirmation capacity for rapid and accurate diagnosis and improve capacities in data management to ensure data quality and effective decision-making.

Meningitis, according to Dr. Livinus Martins Chinueze, the Epidemic Preparedness and Response leader at the WHO country office, has persistently posed a severe public health risk, particularly in regions where it is endemic.

Speaking during a five day

workshop to develop the Kenya plan 2023 Dr Latt acknowledged that meningitis has been a persistent global health care challenge over the past two decades and still continues to have the highest prevalence in Africa.

He said in Africa for instance, the disease has remained a persistent healthcare challenge with the highest prevalence observed over the past two

'One in five people surviving an episode of meningitis may have long lasting after effects," Dr Latt said.

The after effects of meningitis, includes hearing loss, seizures, limb weakness, difficulties with vision, speech, language, memory and communication as well as scarring and limb amputations after pepsis.

According to statistics from the MoH, Kenya has experienced its share of meningitis challenges in March-April 2006, notably the Meningococcal Meningitis Outbreak in the then West Pokot District, Rift Valley Province.

# A Garissa primary school turns to irrigation farming for food security

primary school in Garissa County which is one of the most affected areas by extreme weather conditions and food insecurity have turned to irrigation farming to sustain their livelihoods.

Currently, Garissa County has hundreds of farms, fetching tons of foodstuffs ranging from mangoes, rice, bananas, and oranges to animal fodder and lifting the lifestyle of the farmers from irrigation agriculture.

Unlike most schools in the county which rely on donors, well-wishers and government for support, Kunow Primary School in Balambala Sub-County has planted its own food and trees for firewood.

KNA toured the school to have a look at what it has done and to share their story of resilience and the impact on the surrounding communities amid

calls from the national and county government and international bodies to come up with innovative ways to tackle climate change.

The school's head teacher Mohamed Ali took KNA through the farms which have been divided into two; one for food crops and the other for trees in which they have planted around 250,000 trees of Gliricidia plants.

Ali said the school hopes to increase the trees to one million in the coming years in line with the government's initiative to boost tree cover in the country by 2030.

They use the trees for their firewood, where they are cut into small pieces, mixed with other materials such as sawdust then put in a compression machine to make firewood.

"In the other farm, we normally grow food crops to sustain the learners we have here," Ali said.

# Rhino conservation efforts pay off as population hit 960

enya's black rhino population has doubled from 400 in 1989 to the current estimated population of 960.

The Principal Secretary for Wildlife Ms Silvia Museiya said, with strategic rhino conservation interventions, Kenya projects to have 2,000 black rhinos over the next fourteen years from the current 960.

Ms Museiya said, the Government supports initiatives by the Kenya Wildlife Services (KWS) to expand the rhino range through opening up of new rhino sanctuaries and restocking of rhino sanctuaries that are below their carrying capacities.

The Principal Secretary, who was speaking at the KWS headquarters in Nairobi at the launch of Seventh

Edition of the Recovery and Action Plan for Black Rhino 2022-2026, said such efforts will solve the rhino deaths caused by the fight for territories by the animals and suppressed growth rates because of reducing spaces for the rhinos.

Ms Museiya said it was encouraging that private and community landowners have expressed interest to collaborate with the government in rhino conservation in attempts to expand the rhino range.

She said the government was committed to realizing the potential for expanding existing areas, particularly securing the Tsavo West National Park Intensive Protection Zone (IPZs) which has the capacity to host a large number of rhinos for longterm survival.

The PS said there was an urgent need to deal with causes and impacts of climate change which have led to unpredictable seasons, prolonged droughts and resources that constrain rhino habitats.

She commended the rhino conservation areas in the national parks, national reserves, private, and community lands for their efforts to

conserve the rhinos.

She explained that efforts to safeguard the black rhinos' population was bolstered by the Wildlife Conservation and Management Act (WCMA), 2013 which introduced punitive penalties for wildlife crimes particularly for the critically endangered species.

She observed that inten-

sive national security surveillance and support from the international community also significant fight against the illegal wildlife trade and reduced rhino poaching in the country

The black rhino is classified as Critically Endangered by the International Union for Conservation of Nature (IUCN) and listed under the

Convention on International Trade in Endangered Species of Wild Flora and Fauna (CITES).

The classification and listing are based on the great challenges confronting the rhino species.

Kenya has the third largest black and white rhino population in the world, after South Africa and Namibia.

## ALL TEA FACTORIES AND COMMERCIAL GREEN LEAF TRANSPORTERS

#### 1. TRANSPORTATION OF GREEN LEAF BY TEA FACTORIES

All tea factories are hereby notified that the following further conditions, on transportation of green leaf, have been imposed by the Board on their tea manufacturing licenses in line with Section 37 (1) & 40 of the Tea Act, 2020:

- A tea factory shall register all its vehicles for transportation of green leaf with the Board using the prescribed format:
- ii. All green leaf transportation vehicles shall bear green leaf transportation stickers issued by the Tea Board of Kenya;
- A tea factory shall ensure that all its green leaf transportation vehicles are labelled with the factory's name which is clear, legible and visible at all times;
- iv. A tea factory shall ensure green leaf transportation vehicles comply with Kenya Tea Industry Code of Practice KS 2128 on transportation of green leaf;
- v. A tea factory shall ensure that green leaf transportation is done by designated vehicles/tractors with a capacity of not less than 3.0 tonnes;
- vi. A tea factory shall ensure that all its green leaf transportation vehicles /carriers are designed in a manner
- that allows free air circulation to the green leaf being transported;
  vii. A tea factory shall ensure that its green leaf transporters do not collect, transport or deliver green leaf from growers other than those registered with the factory;
- viii. A tea factory shall ensure that all its green leaf transporters maintain records of the green leaf collected in a manner that is verifiable. The records shall show the list of growers assigned to the green leaf transporter, cumulative collection, routes and collection centers;
- ix. A tea factory shall not receive green leaf from a commercial green leaf transporter who is not registered with the Board;
- A tea factory shall sign a commercial green leaf transportation contract with all its commercial green leaf transporters supplying green leaf to the factory and avail valid copies of the agreements to the Board;
- xi. A tea factory shall maintain a copy of the commercial green leaf transportation contract at the factory for inspection by the Board;
- xii. A tea factory shall certify the list of tea growers, collection centres and route(s) assigned to its green leaf
- xiii. A tea factory shall regularly update details of its green leaf transportation vehicles registered with the Board;

All tea factories are therefore required to comply with the aforesaid additional conditions in addition to their existing terms and conditions of their current licenses, by 11th October 2023.

#### 2. REGISTRATION OF COMMERCIAL GREEN LEAF TRANSPORTERS

AG CHIEF EXECUTIVE OFFICER TEA BOARD OF KENYA

Section 37 of the Tea Act requires all persons intending to carry on the business of commercial green leaf transportation to register with the Board.

All persons, firms or bodies providing green leaf transportation services to tea factories are therefore required to comply with Section 37 of the Act by registering with the Tea Board of Kenya by 11th October 2023.

Applications for registration of green leaf transporters shall be made through https://imis.teaboard.or.ke

The Tea Board of Kenya shall take legal action against any Tea Factory and/or Green Leaf Transporter who fails to comply with the above conditions in line with the provisions of the Tea Act, 2020.



# Gov't implements agriculture policy reforms for access to quality inputs

#### BY WANGARI NDIRANGU(KNA)

The Government has put in place some policy reforms in the agriculture sector to ensure producers in crops, livestock and fisheries subsectors progressively access quality agricultural inputs.

Agriculture and Livestock Development Cabinet Secretary Mithika Linturi said, the reforms target institutional reforms and implementation of targeted programmes to initiate and consolidate proven approaches based on best practices in agriculture.

In a speech read on his behalf by the State Department for Crops Principal Secretary Kellow Harsama during the Fourth International Phytosanitary Conference, Linturi noted that threats to plants for instance pest and diseases, crossboundary transfer of pests through international travel and trade, disruptive human activities and climate change are increasingly contributing negatively to efforts toward attaining food security.

"What this means is that even as the African continent grows food, it needs to know how to mitigate the challenges of pests and diseases which have been

Kenya has been recording high cases of notifications due to exceeding residual levels known to cause up to 40 per cent reduction in yields," he added.

Linturi said the government has a constitutional and civic duty to achieve the right to food for all citizens as required under Article 43 of the Constitution, and strives to ensure that food is available, affordable and safe for consumption.

The CS further said increasing agricultural productivity, providing safe, nutritious food for the

population and increasing international markets for Kenyan produce is among the factors that inspired Kenya's new government to launch its Bottom-Up Economic Transformation Plan (BETA)

Speaking on the sidelines, Harsama said the government will ensure fresh produce exports to Europe and other export destinations have met the standards to avoid rejection and high cost of doing business.

He noted that due to strictness by export destinations, local fresh produce has either been banned or retested in the laboratories thus leading to high cost of doing business.

"In the last decade, Kenya has recorded high cases of notifications due to exceeding maximum residual levels caused by pesticides applied and the country has had problems on issues of regulation guiding what they call application of residues, chemicals on some of the fresh produce like fruits and vegetables," Harsama said.

### Stakeholders advocate stringent regulations for cyber security

The Government and stakeholders in the cyber security space are pushing for the implementation of stringent rules and regulations in an effort to enhance online security and trust as the government implements the digital agenda.

The National Computer and Cybercrime Coordination Committee (NC4) Taskforce Chairman Mark Mutunga says, they are taking a holistic approach in the formulation of regulations to govern the digital space with the need to engage the public and take into consideration their views and suggestions.

Speaking in Nairobi during a public participation forum with members of the public, Mutunga said there are many areas that need to be regulated, stating that there have been issues of personal data given to security

personnel when accessing buildings where one is required to record their names, phone numbers and ID number or leave their ID cards.

"Anybody can take a photo of that ID together with other information you have given. This means that they have access to so much personal data which we do not even know how it is stored and managed," said Mutunga.

He said they are working with their legal teams on how to come up with regulations that will streamline handling of public data.

Co-chair of the Taskforce Evans Ombati the issues raised by members of the public are very crucial and called for research, consultation and comparative analysis in order to come up with the right regulations which capture all the relevant issues and serve everyone's needs.

# Authority taps into the Internet of Things (IoT) to implement smart water metering infrastructure network

BY YOBESH ONWONG'A (MYGOV)

The Water Resources Authority (WRA) has tapped into the Internet of Things (IoT) to develop and implement the use of a smart water metering infrastructure network to monitor water abstraction across the country.

Similarly, Mohamed Shurie, WRA Chief Executive said that the authority has embarked on a programme to automate and upgrade its monitoring stations to transmit real time data to a central server.

"One of the efforts WRA is implementing to mitigate climate change effects, is ensuring that all abstractions from a water body are recorded and permitted. This has eliminated the use of ordinary meters that were prone to tampering and malfunctioning," said Shurie.

The CEO said that the system provides WRA with near real time water resources abstraction data which will enable the Authority ensure that water resources are utilized efficiently and that it exercises its core regulatory mandate of regulating the use of water resources in Kenya.

"This is coupled with installation of a Water Resources Information Management System (WRIMS) that enables Data management, processing and information packaging for whoever needs it," he noted.

Speaking to MyGov, Shurie disclosed that one of the key mandates of WRA is the regulation of water use to ensure fair and equitable allocation and apportionment of the available water resources.applied and the country has had problems on issues of regulation guiding what they call application of residues, chemicals on some of the fresh produce like fruits and vegetables," Harsama said.

"To effectively carry out this mandate, WRA determines the availability in respect to surface and ground water quantity and quality so as to attain efficient and economic use, social equity and environmental sustainability," said the CEO.

In addition to water allocation and apportionment, Shurie pointed out that WRA also monitors and assesses water resources, gathers and publishes information on water resources, receives and determines application for water permits and collects water use charges.

To achieve this, John Kinyanjui, WRA Manager incharge of Water assessment and Monitoring said that an extensive and reliable water resource monitoring network is required in order to generate data that will inform decisions on water resource apportionment and management.

"Enhancement of the accuracy of water abstraction data to enable proper regulation of the use of water resources.

The Authority currently runs a monitoring network comprising 223 surface water, 260 for rainfall, 142 ground water and 658 water quality stations," he pointed out.

Kinyanjui noted that improved compliance with water abstraction and use permit conditions will impact posi-

tively on the WRA's regulatory framework and assure viability of future water resources development projects.

"The Authority is strengthening the hydro meteorological monitoring system by automating the stations to collect and transmit real/near real time data," he said.

## Kenya has the potential to benefit as an international commercial arbitration centre

today's globalized world, multinational en-stantly seeking new markets and avenues for growth. Transition economies, such as Kenya, have emerged as attractive destinations due to their high economic growth

Nairobi, in particular, has become a gateway for MNEs looking to enter the East African market. However, despite the increasing interest in arbitration for resolving commercial disputes worldwide, Nairobi's status as a potential hub for international commercial arbitration (ICA) is yet to be fully established.

This article aims to shed light on the subject by discussing the existing provisions in Kenyan law to support ICA and the

relevant experiences within the country's legal system.

Kenya's business environment has consistently ranked poorly in terms of its favorability to businesses. Its current position of 56th out of 190 countries in the ease of doing business index indicates that the country is not attracting foreign investors to its full potential. One of the key reasons for this is the cumbersome process of resolving commercial disputes through the overwhelmed courts.

However, Kenya has taken steps to improve its legal system and commercial environment. The establishment of the Nairobi Center for International Arbitration is a notable effort towards this goal. Nevertheless, the effectiveness of these institutions has yet to be assessed through a comprehensive comparative study.

This lack of reliable information about the Kenyan legal and commercial progress may have contributed to the country's poor ranking. Thus, it is crucial to examine Nairobi as a reliable center for ICA in order to enhance Kenya's legal and economic status.

Kenya has faced numerous challenges in establishing itself as a favorable seat for ICA. Limited institutional and legal frameworks have hindered effective and efficient performance of commercial arbitration. This limitation has resulted in a lack of forums for local arbitrators to showcase their capabilities. Additionally, international businesses tend to avoid non-national arbitration venues and arbitrators in Africa due to perceived incompetence in international commercial arbitration. Reported interference by national

courts, issues of cost management, inadequate capacity of existing arbitral institutions, and corruption perception have further contributed to the challenges.

However, there have been significant positive developments in recent years. The Court of Appeal of Kenya has consistently made progressive decisions in favor of international arbitration, positioning Kenya as a favorable seat for ICA and upholding international obligations and the finality of international arbitration awards. Efforts such as the establishment of the Nairobi Center for International Arbitration and the Centre for Alternative Dispute Resolution (CADR) reflect Kenya's commitment to becoming an ICA hub. Nevertheless, collaboration with other ICA institutions and the establishment of relevant training institutions could further enhance the arbitration capacity in the region.

Institutions play a vital role in determining the relationship between businesses and the legal environment they operate in. Institutional voids, especially in countries with weak legal institutions, pose significant challenges for international businesses. This is why multinational enterprises tend to prefer established jurisdictions like Paris, Vienna, Singapore, or London as arbitration seats rather than Nairobi. Kenya needs to create a conducive institutional environment that promotes arbitration and ensures effective and fast dispute resolution. This involves addressing concerns about a jurisdiction's reputation, the time taken to conclude cases, and the autonomy of parties in arbitration agreements. By embracing private and public collaborative efforts. Kenva can institutionalize the market for arbitration and establish itself as a proarbitration country.

The Kenyan legal system recognizes the significance of arbitration as an alternative legal system. Article 159 of the Kenyan constitution promotes the use of arbitration and encourages alternative methods of dispute resolution. It emphasizes the principles of justice serving all, regardless of their status, and the need to avoid delays in the justice process. Additionally, ratified conventions and treaties, such as the New York Convention, form part of Kenya's legal system and guide and enforce international arbitration in the country.

To achieve its potential as an international commercial arbitration hub, Nairobi needs to address the challenges it currently faces. Strengthening the legal and institutional framework for arbitration, enhancing advocacy skills through continued legal education, and promoting a culture of arbitration are essential steps in this journey

Speaking after touring several projects under the Kenya Development Response to Displacement Impacts Projects (KRDIP) in Dadaab constituency, the PS said that the objective of the project is to improve access to basic social services, expand economic opportunities and enhance environmental management in the refugee hosting communi-

Dokota said that the KDRDIP contributes to the country's key development priorities of reducing poverty and inequality. He also noted that it is part of the government initiative to social service delivery for vulnerable groups and marginalized communities as envisaged in the Constitu-

"Resources are always scarce here so the project came to neutralize that because we have an influx of refugees here so we have an issue to do with suppressed resources. This will help in bringing equality when they have income generating activities to grow the economy," Dokota said.

"Because of the continuous effects of droughts, we have engaged the communities in nontraditional livelihood such

so that they can improve on their economic condition and act as a stimulus in this particular area," he added.

Over the years, the conflicts, terrorist's attacks and natural calamities such as recurring drought and floods have caused thousands of Somalians to move into Kenya to seek asvlum.

At the same time, as a result of the conflicts and civil war in Sudan, thousands of people have also moved to Kakuma refugee camp in Turkana County.

To control the situation, the government with the funding from the World Bank in 2017, came up with the Kenya Development Response to Displacement Impacts Project (KDRDIP) aimed at helping the host communities compensate for what they had to share with the refugees.

- 1. Ensure that their farms (including out-growers) are certified to the National Horticulture Standard (KS 1758:2016: part 2) or Global GAP food safety standard.
- 2. Submit valid food safety certificates stipulated above (1) during export license application or renewal.

Subsequently, exporters of beans and peas in pod are required to demonstrate compliance, failure to which their dealership for beans and peas in pods will be revoked.

# Stakeholders request harbor for Lake Turkana

**↑** takeholders from Lake Turkana have appealed to the Government to construct harbors in the vast lake to spur cross-county trade between the two counties of Turkana and Marsabit which share the Lake.

The stakeholders said lack of docking facilities have also hampered maritime transport while proliferation of sea weeds is largely stifling growth and expansion of the fishing industry and other economic activities around the world's largest desert lake in the North of Kenya.

These are among some of the concerns raised by users Lake Turkana, during a stakeholder's engagement and public participation forum organized by the State Department for Shipping and Maritime Affairs in Lodwar Town to validate the draft National Maritime Transport Policy (NMTP) and Maritime Education and Training policy (MET).

Making his contributions to the Task Force, Dr. Tioko Logiron, the Director of the Income Generating Unit at the University of Turkana

cautioned drafters of the while the Maritime Educa-Maritime Transport Policy to resist temptations of 'universalizing' maritime transport, saying different water masses present unique challenges which should be addressed differently.

"The Transport Policy has been universalized yet the case of maritime transport in lake Turkana are not the same as in other water bodies, say in the Indian Ocean or Lake Victoria," posited the University don.

The State Department has so far finalized a two month long stakeholder's engagement and public participation process which targeted all the six counties of the Coast region and several counties that are home to inland water ways including Turkana, Hobabay, Kisumu and Nakuru to ensure participation of the people in development of the two

He thanked stakeholders and the public for participating in validation of the saying this will ensure inclusivity and instill a sense of ownership to the document.

"The constitution of Kenya binds all state organs, state officers and all persons who implement public decisions to ensure the participation of the people," he said adding that the draft will now be presented for approval by relevant organizations of Government for finalization of the process, "after incorporating the additional inputs from the public."

The Government is working on modalities of ensuring the smooth milling and marketing of coffee to guarantee farmers security during the on going reform process.

the petition items indicated that some of the coffee mills have been closed.

Four mills in Kiambu County and one in Nyeri County have been closed, which has led to farmers to have in their stores a lot of coffee which is not pro-

Consequently, families relying on coffee are suffering with children not going to school because of lack of school fees.

There have been indications that several employees have been laid off where coffee mills have been closed.

Very little coffee has been traded at the Nairobi Coffee Exchange because value chain actors have been disengaged, and therefore coffee farmers are unable to efficiently trade," the PS explained.

Trade Principal Secretary Alfred K'Ombudo said export performance for the country has stagnated for a long time and if it is going to be reversed agriculture exports, with coffee being a major player, must increase.

'We are looking at improving our coffee export performance by moving from the current 40,000 metric tons back to 150,000 metric tons," the PS explained.

He added that they do not want to just improve the quantity, but the quality is also important, and are putting money in the hands of farmers to help in achieving the required international quality.

Agriculture and Food Authority (AFA) Board chairman Cornelly Serem said they will have deliberations with key stakeholders in the sector, and if it takes amending the law so that there is a smooth operation and sale of coffee then they will have to amend it.

### State unveils new rules to curb domestic violence, protect survivors

The fight against domestic violence in the country has received a new impetus following the launch of a set of rules intended to prevent domestic abuse and protect survivors of the vice.

The Protection Against Domestic Violence (PADV) rules provide for individuals who suspect or fall victim to aggressive behaviour within the home, a legal redress to report their circumstances to the relevant authorities and receive

Speaking during the launch, the Ministry of Public Service, Gender and Affirmative Action Cabinet Secretary, Aisha Jumwa, noted that all forms of physical, emotional and psychological abuse witnessed in homes pose dire human rights situations that require concerted efforts, including a comprehensive legal framework to solve.

The CS affirmed, while lauding the rules as momentous, the government's commitment to protecting the rights and wellbeing of all Kenyans through a cross-sectoral approach that addresses cultural and other forms of social biases that encourage sexual and genderbased violence.

'These rules emphasize prevention, intervention, and holistic support, reflecting a multi-sectoral approach that involves collaboration between government agencies, civil society organizations, and the community at large," the CS said.

According to data from the Kenya Demographic and Health Survey (KDHS), more women than men are susceptible to sexual and physical assault.

However, the rules seek to safeguard the rights of all people living in Kenya irrespective of their age, gender, ethnicity or socioeconomic status.

The PADV rules allow victims or their representatives to apply for protection orders against a suspected perpetrator, provided that the complainant can prove the suspected aggression, threat or a committed case of vio-

# **Busia county and Finnish NGO collaborate to turn solid waste into organic fertilizer**

**T**he County Government of Busia, in collaboration with a nongovernmental organization from Finland, has set up a biodegradable plant that synthesizes solid waste into vital organic fertilizer to encourage farmers to embrace climate-smart agriculture, use organic fertilizers, and do robust research to build resilient food systems and boost food security in the border county.

The NGO, the Finish-Ink organization in partnership with the county government has set up the plant not only to ensure food security and sustainability but also a clean the environment.

The project coordinator under the Fecal Sludge Treatment Programme Mr. Moses Mawese said the biodegradable system is emerging as a game changer for the agricultural and hygiene sectors. "This eco-friendly alternative is not only re-



ducing the landfill burden but also revolutionizing farming practices, offering a glimpse of hope for a greener future," Mr. Mawese noted.

Finish-Ink seeks to address the waste recovery gap and poor disposal of untreated numan and other wastes that have been a threat to human life and the ecosystem for decades.

This project applies the sanitation circular economy approach as a guide to its

implementation. It envisions healthier and socioeconomically empowered communities and as a result, people are using safely managed sanitation facilities, practicing hygienic behavior, and using safely treated human and other organic waste manure for farming.

"The end product in the sanitation value chain is compost which is generated at the Busia Fecal Sludge Treatment Plant (FSTP),

he added. The organization is championing the use of organic modified fertilizer which has many benefits to the crop and farm as compared to synthetic fertilizer over a long period of time.

"Organic manure improves crop yield through its nutrients, it also improves soil fertility and structure both physically and chemically, it further improves the capacity of soil to retain moisture," Mawese said.

The process entails receiving waste products from the market before sorting and segregation to remove nondegradable materials.

Shredding is done then incorporated in a ratio of four to one then it is taken through decomposition which takes two to three months to become well decomposed and later taken for a laboratory test.

"We use the windrow format technique of decomposition in our project which is anaerobic as it relies on oxygen," he said.

#### KenGen unveils Sh22m school feeding program in seven counties

■ The Kenya Electricity Generating Company PLC (KenGen) has launched a Sh22- million food I initiave to support school feeding programs in seven counties.

The school feeding programme, according to a news release, re-affirms the corporation's commitment to education and community well-being.

"In an effort to alleviate food shortages and support local communities, KenGen is doubling its earlier food distribution efforts which initially amounted to Sh 10 million, benefiting marginalized groups, including people with disabilities, youth, children, and women who have been severely impacted by food scarcity", said the KenGen Chief Executive Officer Eng. The food distribution drive which began in November 2022 focuses on schools near KenGen's power stations, aiding the government's school feeding program to mitigate the

The Managing Director and CEO said the food donations, including maize, beans, and cooking oil, were carefully selected to support schools in marginalized communities facing economic hardships.

Eng. Njenga says the campaign targets seven counties with active KenGen installations namely Machakos, Embu, Turkana, Nakuru, West Pokot, Kajiado, and Kitui, impacting approximately 136 schools, ensuring students have access to food as schools re-open amidst challenging economic times.

Speaking during a flag-off ceremony in Kajiado County, Eng. Njenga emphasized KenGen's dedication to uplifting local communities and fostering a strong partnership in electricity generation, recognizing education as a vital equalizer.
