### **New pension** scheme to benefit retired **public servants**

The Government, through the National Treasury, has implemented a new pension scheme to benefit all public servants and teachers on their retirement.

The Public Service Superannuation Scheme (PSSS) is part of the reforms enshrined in the Public Service Pensions' sector enacted by the Government in 2012 through a gazette notice and effected on January 1, 2021.

The Scheme covers civil servants, teachers employed by the Teachers Service Commission (TSC) and the disciplined servicesincluding the National Police Service, Prisons Service and the National Youth Service.

Michael Obonyo, an Assistant Director of Information who heads the communications unit at the Treasury said, the Scheme is meant to ensure sustainability of the wage bill for pensions in the public sector.

The previous scheme Defined Benefit Scheme, entirely depended on exchequer funding.

"The introduction of the new scheme has now stopped the bleeding of the exchequer and an assurance of a sustainable wage bill for pension in the public service,' he said.

PSSS on the other hand is a contributory approach where the government and the employees contribute to the scheme monthly to fund the retirement benefits of the employee.

The scheme is for the benefit of public servants who are below the age of 45 years as at 1st January 2021 and are on permanent and pensionable terms of service.

It is mandatory that members part with 7.5

formation, Communication and the Digital Economy Cabinet Secretary Eliud Owalo said his Ministry is implementing the Kenya National Digital Master Plan 2022-2032, as the prime enabler of the country's digital priorities.

Owalo further said the plan entails five key pillars of driving the digital transformation agenda which include: digital infrastructure, digital services and data management, digital skills, digital entrepreneurship and effective alignment to policy, legal and regulatory frameworks.

Speaking during the official opening of the Third Nation Digital Summit on enhancing Africa's digital transformation, Owalo said the government is leveraging ICT to deliver more efficient information and public services by digitizing government records and digitalizing 5,000 government services.

He said through the ecitizen platform, some 839 services have already been

on boarded to the portal with an average of 300 services being on boarded weekly to reach the target by June 2023.

"Our proposition of 5,000 services by June is realistic and attainable. We are targeting the private sector so

that we get an impact on our economy through the shortest time possible," he

"As part of our digitalization agenda towards a paperless government, the Cabinet Office and meetings have already been digitized,

for efficiency and effectiveness," said Ówalo.

"We are correspondingly ensuring that KRA is able to chip in and ensure we have adequate resources for our tax revenue to be able to expound and bring more people on the tax base and enhance our recurrent and development expenditure,' added Owalo.

He said plans are underway to establish and operationalize the national digital identity which will enable use of digital technologies to identify Kenyans through a national integrated identity management system that will facilitate a central master database for all citizens.

The CS noted that the database will serve as a primary source of identity for citizens, adding that it will enable them access government services from the comfort of their homes.

Owalo said they are expanding the national digital superhighway fiber optic cable by 100,000 kilometers over the next five years in partnership with the private

per cent of their monthly basic salary and the government contributes 15 percent of the monthly basic salary in respect to each employee.

Civil servants are guaranteed of getting their benefits as early as 30 days into their retirement.

The Assistant Director said unlike in the old scheme where one had to reach the age of retirement (60 years) to get their pension, in the new contributory scheme they are assured of a lump sum even if they took an early retirement.

"The Government had good intentions in coming up with the new scheme so as to enable the civil servants retire well and with huge perks as well as with a medical cover," Mr. Obonyo stated.

Obonyo was speaking in Homa Bay town during the PSSS sensitization meeting where he stated that Treasury wanted to make members understand the transitional arrangements from the old to the new scheme so as to plan ahead.

Mr. Obonyo added that there was a need to explain to public servants the rationale behind the establishment of the new pension scheme.

PSSS trustee, John Matiangi, said members of the scheme can also increase their contributions adding, "They are allowed to increase their contributions to whichever level they want because that is their money which they are saving for retirement."

The trustee said members of the scheme will eniov tax benefits as contributions are deducted from the salary before tax is calculated.

He said the scheme is manned by trustees who are drawn from trade un-

# Develop demand-driven programmes to bridge skills gap, PS urges TVETs

Technical and Vocational Education and Training (TVET) Principal Secretary Dr Esther Muoria has called on Technical and Vocational Education Training (TVET) institutions to design demand-driven programmes which will bridge identified skill gaps in the labour market.

Speaking at Karumo Technical Training Institute during the inaugural graduation ceremony, Dr Muoria said TVET has become critical in achieving rapid economic, social, and technological growth universally.

"The reason behind this is that human resources require greater skills to participate in the knowledge economy. Hence, we being responsible for TVET institutions are expected to offer demand-driven programmes to supply prop-

I urge all technical institutions to benchmark with the besti in the world"Dr Muoria ter for available courses and acquire skills at TVET institutions, in order to achieve their dream careers in life.

"We are all too aware that TVET graduates enter into a globally competitive labour market and for this reason, I urge all technical institutions to benchmark, collaborate and partner with other top institutions in the world. Such collaborations will result in internationally

recognized programmes, relevant to both local and the international labour markets," Dr Muoria said.

She said there are plans to start rolling out the Competence Based Education and Training (CBET), where training will be industrybased on a 50-50 basis, since the industry players have become an integral part of the whole.

She consequently appealed to the Kenya Association of Technical Training Institutions (KATTI) family to re-organize TVET training to Competency Based Skilling (CBS) and identify international institutions to collaborate in offering the

Through such collaborations, she added, TVET trainees will upon graduation obtain dual certifications and would have a competitive advantage to seek employment globally.

The Karumo Technical Training Institute Principal, Ms Florah Kanyua, said the institution is in the process of being ISO certified, which will help them improve the processes and enhance customer satisfaction, hence sustainable development.

"We are proud that today we are channeling out 889 trainees," said Ms Kanyua.

### 18 countries in Nairobi to enhance malaria control programs in Africa

 $R^{\text{epresentatives from 18}}_{\text{countries around the}}$ world have gathered in Nairobi for a peer review meeting to accelerate Malaria control and elimination in Africa.

The meeting, organized by the Roll Back Malaria Partnership and other partners to End Malaria, is informed by rising concerns over the near-stagnation in malaria control programs revealed in the World Malaria Report of

Dr. Josephine Mburu, the Principal Secretary for Public Health and Professional Standards at the Ministry of Health opened the meeting by emphasizing the importance of collaboration in the fight against malaria.

The meeting proposals will ensure commodity security, enhance prevention, and strengthen health systems towards malaria elimination.

The outcome of the meeting will help accelerate malaria control and elimination in the region, particularly in Africa, which contributes 96 per cent of cases and deaths

Dr Mburu noted that despite significant progress made in the fight against malaria, there are still gaps in program coverage, mosquito resistance to insecticides, and drug resistance.

Dr Mburu challenged representatives to work on proposals that will safeguard the fragile and guarantee sustainability.

She also expressed her gratitude to development partners for their continued support and recognized the efforts of the RBM partnership to end malaria in highlighting critical gaps that require urgent attention.





**¬**he Meru University of Science and Technology (MUST) has launched an e-waste management project to boost environmental conservation by getting rid of the enormous electronic waste in the country.

Speaking during the launch, MUST Vice Chancellor Prof Romanus Odhiambo said the project aims at raising public awareness and engaging stakeholders on e-waste and recycling, training as many people as possible and expanding the faculty's processing capacity including research as well as jobs creation.

He said the institution has already trained 175 technicians who will be graduating in June and who will thereafter extend the expertise to the villages and eventually the entire country.

Odhiambo said the graduates will double up as agents for the University's collection centre as it continues to scale up the project.

"According to the global e-waste monitor report of 2020, 53.6 million metric tonnes of e-waste are produced each year and if left unchecked this could double to 120 million tonnes by 2050. Globally, only 17.4 percent of e-waste is managed appropriately," said Odhiambo.

He added that e-waste is expected to increase from

five per cent to eight per cent due to increased use of ICT equipment globally.

"We are the first University in the country to come up with a model where resources are used and recovered rather than disposed off at the end of life," Odhiambo said. He said the university will strive to practise a circular economy whose intention is to produce no waste and instead, products, parts, and materials used, cared for, repaired, reused, and recycled as much as possible in an environmentally friendly manner.

"This is intended to be the preferred alternative to the dominant economic development that contributes to a lot of disposed off e-waste,' said Odhiambo.

The project has been funded by the Germany Development Corporation, working closely with the European Union and other private partners in e-waste management.

"In the meantime, we are looking forward to working together with partners to establish a mini-recycling centre that will act as a teaching factory cum income generation centre that will help in the circular economy for youth job creation," said Odhiambo.

### Water regulator bars farmers from obstructing drying rivers

BY ANN SALATON (KNA)

The Water Resources Authority (WRA) has barred farmers from obstructing rivers following an acute water shortage in Narok county.

The National WRA Board Chairman Isaac Kool said the water levels are in the red stage, meaning very little water is flowing in the rivers and once obstructed, it will not benefit the people living downstream. Kool said the situation is the same in the entire country as 90 per cent of the rivers have been adversely affected by the prevailing dry spell being experienced in the country.

He said the authority has developed a model to analyze the levels of water in the rivers, so as to advise people on when to obstruct the water and when to avoid obstruction.

At 'green stage', the river is full to capacity and obstruction is allowed as much as an individual would like.

The second stage is the 'yellow stage' where the levels of water have gone down forcing the authority to regulate the obstruction of water. The third stage is the 'Red stage' where the rivers are dry and WRA does not allow obstruction

of water.Kool said most of the rivers in the country are in the red stage hence the little water in the rivers should be allowed to flow naturally without any form of obstruction.

"We call on farmers who do irrigation along the rivers to stop until the rains come so that everybody can benefit from the little water available," he said.

Kool spoke after a meet-

ing with the Narok County Commissioner Isaac Masinde and Narok Water and Sewerage Company (NARWASCO) officials led by their Chairman Moses Samante.

Commissioner Masinde said a multi-agency team of WRA, NARWASCO, National Environment and Management Authority (NEMA) and the interior department will move around to ensure

no farmer is irrigating their farms using water drawn from rivers in Narok.

Masinde asked people to avoid wastage by using the little water they get properly during this season.

Samante on his part said his company will be forced to ration the water in town so that all residents living in different estates of the town can benefit from the little water.

The Government spent Sh62.2 billion to cater for medical bills and cover for lost productivity through absenteeism, presenteeism and premature deaths in addressing mental health conditions in the public service in 2021, according to Kenya Mental Investment Case 2021, Ministry of Health report.

To address these issues which bog down productivity in the Public Service, the State has made provisions to allocate more funding to mental health services in the 2023/2024 budget and train health workers at all levels to manage and treat mental health challenges that have been on the rise

Speaking in Nairobi during the Public Service Mental Health Champions Initiative launch, Aisha Jumwa, the Cabinet Secretary for Public Service, Gender and Affirmative Action said the country has a huge mental health burden adding that 410 Mental Health Champions have been trained to provide support in counselling services to public servants across the

According to the Kenya Mental Health Policy (2015-2030), mental disorder estimates that 20-25 per cent of outpatients seeking primary healthcare present symptoms of mental illness, while government statistics indicate that at least one in every four Kenyans suffer from a mental illness at one point in their lives.

Mental disorders frequently lead individuals and families into poverty,"Jumwa

Jumwa pointed out that the biggest challenge to mental health is low awareness of mental disorders particularly, the symptoms of these conditions among the persons suffering from the condition and the community at large.

The CS underscored the Government's commitment to investing in the mental health and well-being of public servants for sustainable development in the public service.

She noted that mental health is a key determinant of overall health and socioeconomic development of the country.

The mental health cham-

pions will be tasked to demystify instances where mental illness continues to be marred by customs and misconceptions including being a curse, witchcraft and spiritual problem, instead of a disease that can be treated and managed if and when diagnosed and managed professionally.

Jumwa disclosed that mental disorders have an impact on individuals, families, communities and na-

The CS noted that persons with mental disorders often have their human rights violated, as a result of stigmatization and discrimination.

She said one of the biggest challenges is low awareness of mental disorders, particularly, the symptoms of this condition among the affected persons.

During a roundtable discussion from mental experts and mental health champions, it emerged that homelessness and inappropriate incarceration are far more common among people with mental disorders than the general population, and having mental disorders exacerbates their marginalization and vulnerability.



The County Government of Mombasa has signed a Memorandum of Understanding with the National Bank of Kenya (NBK) to implement a project aimed at addressing access to essential health care, water, sanitation and hygiene by Mombasa residents.

The NBK Director Corporate Banking, Ken Ouko, lauded Mombasa Governor Abdulswamad Sharriff Nassir for making the initiative, stating that it is the first county the Bank is getting into an agreement with the County to finance the projects.

Ouko said the MOU will implement the County Health Management System (HMS) which will be used to monitor and keep records of patients, their diagnosis, medication and duration of their treatment, noting that

the data once uploaded, can be retrieved by other hospitals in the County.

"After this MOU is actualized, a patient does not need to be going to different health facilities with their files, replicating the same information from previous health care centers anymore," Ouko said.

"The health system will enable us manage medicine stocks across the County, making it easy for the people of Mombasa to access better medical attention and ensure that the information in the system is real time and contemporary," Ouko added.

The Second Phase of the agreement revolves around water, sanitation and hygiene projects (WASH), which will involve smart metering installed by Intelligent Systems that will enable the County monitor how water is consumed.

### **CS: State to deliver all key ICT projects as promised**

Information, Communications and The Digital Economy Cabinet Secretary Eliud Owalo has underlined his Ministry's commitment to deliver all key ICT projects including the Digital Superhighway Program.

### Kenya, Uganda support full implementation of the Angololo water project

Renya and Uganda have expressed their total support for the full implementation of the Angololo Water Resources Project in Busia County which straddles the Kenya Uganda border for the benefit of the people of the two countries.

The Ministers responsible for water affairs from Kenya and Uganda Ms Alice Wahome, and Sam Cheptoris underlined their commitment towards the project while addressing the Development Partners Roundtable meeting on the project in Nairobi.

During the meeting

which the ministers cochaired, the ministers said the Angololo project falls in the Sio-Malaba-Malakisi sub basin that is in the Lake Victoria Basin and falls in the larger Nile River Basin and it is located on the trans-boundary river Malaba that is shared between Kenya and Uganda.

The ministers noted that when fully implemented, the Angololo Water Resources Project will build a 31.3 million cubic metres dam that will supply water to over 270,000 peo-

ple, irrigate 4,000 hectares shared between the two countrie.

They further said the project will generate 1.3 megawatts of electricity, which will be boosted by a floating solar system.

The project has a catchment of 430 square kilometresand in Kenya, it will principally be in Busia County and small parts of Bugoma County while in Uganda it will benefit people from Tororo, Manafwa and Namisindwa District.

"According to the just concluded Full Feasibility Study, conducted by NERLSAP-CU, in economic terms, the Angololo Water Resources Development project is viable, giving an Economic Internal Rate of Return (EIRR) of over 14% at all the discount rates of 5, 10, 11, and 11.5%", the two ministers revealed.

They further said that the EIRR va-lue obtained is higher than the prevailing Economic Opportunity

Cost of Capital (EOCK) for both Uganda (11 per cent) and Kenya (11.5 per cent) and at the prevailing EOCK ra-tes, the economic analysis re-sults show a positive Net Present Value (NPV) of 24.89 Million dollars for Ùganda; and 19.52 Million dollars for Kenya) and both the Benefit Cost Ratio (BCR) and Net benefit to investment ratio (N/K) ratio are greater than 1, which demonstrates that the project is economically viable.

"Out of a total of 209.4 million cubic metres of available on River Malaba per year, the Angololo project components will use water for irrigation whose component will use 39.2 million cubic metres per year (MCM/YR) while water supply will use 1.7 MCM/ YR, livestock 0.2MCM/YR and for continuous normal flow of water in the river 95MCM/YR will be left for what is termed as Minimum E-Flow", the ministers announced.

They added that the annual available water projection factors in both climate change and population growth until the year 2050.

The project was identified by the Nile Equatorial Lakes Subsidiary Action Program – NELSAP-CU and the two Countries in 2010 and NEL-SAP conducted pre-feasibility with support from the Royal Government of Sweden and the Royal Government of Norway.

Following this identification study, the Go-vernments of Kenya and Uganda formally requested NELSAP-CU to integrate it into its pipeline of natural re-sources projects for further appraising and develop-ment.

The project was approved during the 18th Nile Equantorial Lakes Council of Ministers (NELCOM) which is a meeting of Ministers of Water of the 10 Nile Basin Countries held in Entebbe, Uganda on 13th October 2015.

In light of the provisions of section 57 A of the Environment Management and Coordination Act (EMCA) 1999, Regulation 42 and 43 of Environmental (Impact Assessment and Audit) Regulations Legal Notice No. 101 of 2003, the National Environmental Management Authority (NEMA) has received a Draft Strategic Environmental and Social Assessment (SESA) report for the KENGEN Energy (Industrial) Park Master Plan, Olkaria, Naivasha Sub-County, Nakuru County. The SEA findings are expected to integrate the existing sectoral plans and programs to establish sustainable development mechanisms.

Kenya Electricity Generating Company (KENGEN) PLC the Plan Owner, intends to leverage on KenGen geothermal power production at Olkaria to develop an industrial zone i.e an Energy (Industrial) Park in Olkaria Geothermal Hub in Naivasha Sub-County, Nakuru County, Kenya. The proposed site covers 1,824 Ha and is entirely located within KenGen land. The proposed masterplan is scheduled to be implemented in four (4) phases of 5 years each with the initial phase anticipated to kick on in the year 2025. The Energy Park is anticipated to have industries including Fertilizers; Iron & Steel; Plastics & Packaging; Fabricated Metal products; Pulp & Paper; Wood & Wood Products; Textiles and Apparel (Steam Intensive Industry); Food & Beverages

ounty governments have been urged to allocate funds to support menstrual hygiene management programmes in their health sector programmes.

The Lake Region Economic Bloc Menstrual Health Ambassador and current Busia County Governor Dr. Paul Otuoma said at least 65% of women and girls in the country cannot afford sanitary towels.

Otuoma noted that the only way to address menstrual hygiene management was for the counties to come

up with intervention forms through budgetary alloca-

He urged the Lake Region Economic Bloc Counties to come up with specific programmes that will address the menstrual challenges facing women and girls in the region.

Otuoma said already the Lake Region Bloc has partnered with USAID to help implement the menstrual hygiene management programme.

USAID aims to accelerate sanitation and menstrual hygiene anagement by engaging and empowering multiple stakeholders including the private sector, civil society, local governments, and targeted communities to lay the groundwork for a sustainable, transformative, and locally owned sanitation framework.

He noted that the programme will create fraternity and the gender

awareness, especially in communities that still have cultural barriers to issues of menstrual awareness.

He noted that it is important to address the behavioural change of the communities and help them understand that menstruation is a biological phenomenon. Otuoma acknowledged that the programme will help build awareness for various stakeholders, policymakers and service providers to address challenges of menstrual hygiene.

The programme will also incorporate the medical champions to specially point out areas of concern in trying to address menstrual hygiene.

He added that the programme will also bring on board innovative ways and support those that can generate re-usable cost-effective sanitary pads.

"There is a rise of absenteeism cases in schools where 60% of the absentees are girls undergoing menstruation. This affects their learning and productivity," Otuoma noted.

Magdalene Mwajuma, an official with Msichana Empowerment NGO, said it was important to sensitise girls in schools by giving them the right access to information about menstrual hygiene. Mwajuma affirmed that the majority of girls and women cannot access quality and afford sanitary towels because of high levels of poverty especially in rural

### Women educationists campaign to curb teen pregnancies in Kajiado

The Forum for African Women Educationalists (FAWE) Kenya has launched a new project in Kajiado County dubbed 'Imarisha Msichana' aimed at reducing teenage pregnancies.

The program is being im-

plemented in partnership with the Mastercard Foundation in eight primary schools in the County and seeks ways to end teenage pregnancy and encourage re-entry of teenage mothers to schools.

Speaking during the launch, 'Imarisha Msi-

chana' Project County Coordinator Nelly Naserian noted that teenage pregnancy in Kenya has been on the rise, especially during the Covid 19 period.

Naserian added that girls are forced to drop out of school when they get pregnant to give birth, and fail to resume, thereby cutting short their education and dreams.

"There has been a significant increase in teenage pregnancies in Kenya especially during the Covid 19 period. Teenage pregnancy

cuts short a girl's education as she is forced to drop out the

of school depriving them the opportunity to further their education and attain their career goals," she said.

She said many young girls engage in unprotected sex due to peer pressure and ignorance, putting themselves at risk of pregnancy and HIV/AIDS infection.

The Coordinator noted that the 'Imarisha Msichana' Project seeks to establish 'Tuseme' and mothers' clubs in schools where girls will be sensitized on human sexuality and prevention of teenage pregnancies.



### NTSA plans to outsource vehicle inspection services

**¬**he National Transport and Safety Authority (NTSA) is conducting public participation workshops to review and adjust the new rules regarding drunk driving and inspection of motor vehicles to increase the number of road worthy vehicles on the roads and reduce accidents.

In partnership with the Ministry of Roads and Transport, NTSA has prepared a Traffic (Revised) Act that comprises changes that they have gathered through the public participation and wish to be enacted.

The NTSA 2022 draft regulation, which is currently at the public participation stage, seeks to change the law to allow the agency outsource inspection services from other firms across the country, a role which under the current law is reserved for NTSA only.

Un-roadworthy motor vehicles are said to be some of the major causes of road accidents as revealed recently by the Authority



As at December 31, 2022, the number of deaths from road accidents was reported to be the highest in a period of one year compared to the previous years, gathering a total of 4135 on-scene deaths.

The NTSA Chairman Aden Noor Ali (pictured) requested drivers to be keen and vigilant on the road and ensure their vehicles are properly inspected.

There are 17 inspection units in the country as of now with the capacity of inspecting commercial vehicles.

"We are working to have inspection units in every county to make our services easily accessible because our main aim is to decrease the number of accidents by ensuring there are roadworthy vehicles on the road," reiterated Mr Ali.

He further said the transport authority is looking closely at the boda boda riders and working on a law that will put them into clusters (SACCOS) according to their area of service.

The Director General, NTSA, George Njau said the agency is proposing to suspend the driver's license if a driver is found to be drunk driving for 6 months.

Njau said this rule approach has been signed by 190 countries under the UN convention.

"Kenya is a signatory to the UN Convention, we are not coming up with rules that are new for Kenyans, what we are bringing here is best industry practice and what has worked to reduce road accidents to the rest of the world," he said.

The DG noted that they shall work closely with the transport sector as the operators to help meet the minimum standard for safe operation of motor vehicles in a road worthy manner.



### State guarantees compensation to Sh39b Dongo-Kundu affected

The Government has assured all 1,648 residents affected by the construction of the multibillion Dongo Kundu Special Economic Zone (SEZ) that they will be compensated adequately.

Speaking in Mombasa

during a baraza with the residents of Likoni sub county, Trade, Investments and Industry Cabinet Secretary Moses Kuria urged the citizens being displaced by the construction of the Sh39 billion Dongo Kundu Special Economic Zone to be patient over the compensation issue as the Government works

Government through the Kenya Ports Authority (KPA) has set aside Sh1.4 billion for the exercise and we are going to make sure the payments are done accordingly," Ku-

There is a disquiet as some residents allege seclusion in the compensation plan which has aroused tension between residents and the local administration.

The residents also complained that the Sh65,000 per acre as the disturbance allowance being offered was too little, pleading for an in-

The SEZ Authority representative present clarified that there was no compensation for land taking place, and that the money is for disturbance allowance as the Project Affected Persons (PAPS) are being relocated.

Kuria said the government is working with local leaders to ensure that everything is set for the project to kick off smoothly.

The CS added that the Government was fast tracking the rolling out of key initiatives and supportive infrastructure to make it ready for investors.

Kuria said that the Dongo Kundu project has put Kenya in the world map, adding that the government is doing all it can to attract international investors to the project.

"This is a very important project for the government, it is close to the president's heart because it will bring international investors and will solve the unemployment issue in Mombasa and Kwale counties directly and indirectly," he added.

The government is currently doing some undertakings including the implementation of the resettlement action plan for PAPs demarcation and titling of land for lease to inves-

The National Treasury identified gaps in the operationalization of Articles 187 and 189 of the Constitution on transfer of function between the two levels of Government and cooperation between the National and County Governments.

Accordingly, the National Treasury and Planning constituted an Inter-Agency Taskforce to develop a legislation for operationalization of Articles 187 and 189 of the Constitution on transfer of functions and cooperation between national and county Governments, respectively. The Taskforce comprises of members from the National Treasury, Controller of Budget (COB), Intergovernmental Relations Technical Committee (IGRTC), Council of Governors (CoG), Commission on Revenue Allocation (CRA), Office of Attorney General (OAG), State Department of Devolution and Parliamentary Budget Office (PBO).

The interagency has finalized preparing the Draft Public Finance Management (Amendment) Bill, 2023, which seeks to amend the Public Finance Management Act, 2012 and the Intergovernmental Relations Act, 2012; and to fully operationalize Articles 187 and 189 of the Constitution on Transfer of Functions and Cooperation between National and County Governments.

The objects and purpose of the Public Finance Management (Amendment) Bill, 2023 is to provide for: -

- Financial management of cooperation between national and county governmentoramongcountygovernmentsincludingplanning,budgeting,accounting& reporting and oversight;
- Financial Management of Transfer of Function between national and county governments including planning, budgeting, accounting & reporting and oversight;
- clear mechanisms and procedure for establishment of Joint Authorities and Committees and administrative structures for cooperation between national and county governments and among county governments.

#### Key Highlights for the Half-Year Ended 31 December 2022

In the half year trading period ended 31 December 2022, Kenya Power has reported a decrease in the earnings before tax from a profit of KShs.5,659 Million in the similar period previous year to a loss of KShs.1,589 Million. This drop is attributable to increased foreign exchange losses, and the implementation of the 15% reduction of the end user electricity tariff as recommended by the Government in January 2022.

As a result of the tariff reduction, the basic electricity revenue for the six months period decreased by KShs.6,696 Million. On a positive note, the Company recorded a 4.4% growth in electricity sales to 4,764GWh for the period compared to a similar period last year. The growth in sales was driven mainly by growing energy demand occasioned by increased economic activities and an expanded customer base.

Operating costs increased from KShs.19,036 Million to KShs.21,724 Million due to increased foreign exchange losses arising from revaluation of outstanding payments to power generators denominated in foreign currencies as a result of the depreciation of the Kenya Shilling.

Non-fuel power purchase costs increased from KShs.40,487 Million to KShs.43,881 Million owing to additional electricity purchases made during the period to support growth in demand. Similarly, fuel costs increased from KShs.10,871 Million the previous period to KShs.15,081 Million attributable to significant increase in fuel prices during the period under review.

Finance costs increased to KShs.7,392 Million from KShs.6,777 Million resulting from a rise in unrealised foreign exchange loss arising from revaluation of foreign denominated loans as a result of depreciation of the Shilling against major currencies.

#### Improving performance

The Company projects to improve its business performance in the second half of the financial year by retaining the unwavering focus on increasing electricity sales, enhancing system efficiency, and prudently managing its resources. To support these efforts, we are also taking measures to enhance employee productivity and transform customer experience.

We will continue to focus on provision of reliable power supply by strengthening the electricity network, and sustain the connectivity drive through strategic initiatives such as the Last Mile Connectivity Project with a goal of securing future business growth while also achieving universal access in line with the Government's development agenda.

Looking ahead, we are excited to tap into new growth frontiers in the areas of electric mobility and energy storage that will not only drive demand growth but also boost the sustainability agenda. By diversifying our revenue streams and leveraging our strengths, we will propel the Company to the next phase of growth and secure its position as the leading energy utility in the region.

Collaboration is key to our success, and we are actively working with other energy sector players to pursue a cost-reflective power tariff. Our goal is to ensure that sector revenue requirements are adequately provided for while balancing the important need for affordable electricity. This will enhance the sustainability of the sector and provide sufficient resources for a sustainable energy supply-demand balance, and to maintain the network to ensure quality and reliable electricity supply.

To mitigate against the impact of the fluctuation in foreign exchange rates that have continued to adversely affect the financial performance, we are pursuing several initiatives including allowing a section of our customers whose income is in foreign currency (USD and EURO) to settle their electricity bills in these currencies.

We are confident that our continued focus on the key areas as highlighted, will enable us to achieve our objectives and create value for our shareholders.



# KVDA sponsors bee-keeping projects to tackle cattle rustling fuelled clashes

Pastoralists in West Pokot have embraced beekeeping as an alternative source of employment, thanks to the Kerio Valley Development Authority (KVDA) efforts to mitigate the effects of climate change and conflicts fuelled by the cattle rustling menace.

Ms Lucy Maira, a representative of Achawa Women Group in Kodich, Kacheliba in North Pokot said, prolonged drought brought about by the effects of climate change has affected pastoralism and charcoal making which are the major economic activities in the area.

"People in the region have started to diversify their operations to offset the animals' losses due to drought by venturing into bee-keeping which is a lucrative alternative source of income," she said.

She said the group received a boost when KVDA provided them with training on beekeeping and honey harvesting techniques. This involves using bee smokers and bee suits which are gentler on bees while protecting the bee keepers.

"We have been provided with modern beehives to boost honey production as the hives

have higher yields than traditional ones, we harvest two times a year and in a season, a farmer can harvest 60 to100 kilograms, depending on the season," she said.

In an interview with the Kenya News Agency, KVDA Managing Director Sammy Naporos pointed out that due to the prevailing economic conditions, small stock like bee-keeping is the way to go adding that bee-keeping in ASALs is a lifeline like dairy, coffee and tea farming in Central and other parts of Kenya.

He noted bee-keeping in ASALs is the most sustainable source of livelihood because it does very well due to favourable ecological conditions like availability of flowering acacia

trees and water among others.

Naporos further pointed out that big stock like cattle, goats and camels are susceptible to drought, with farmers likely to lose big numbers. But with bees, two weeks of rain is enough for flowers to regenerate and a farmer will be able to harvest honey within a period of 90 days.

Additionally, he said livestock are the main cause of conflict as neighbouring communities fight from time to time to steal cattle from one another, but with apiculture, members of the communities can carry out their activities peacefully since cattle rustlers do not target bee-hives.

'We have a number of programmes. We do capacity building but the challenge we have is that bee-keeping is majorly done the traditional way. So, the quality of the honey is mostly compromised. We train farmers on how to handle honey, to understand when it is ready for harvest, extraction, handling and storage of the same which is also very sensitive in terms of concentration," he said. Naporos said KVDA is engaging artisans to produce hives in large numbers so as to produce more honey by engaging many members of ASAL the communities.

### Gov't sets aside Sh250b to power industrial growth

County Governments have been asked to move with speed and identify land for infrastructural development and strategic partners for their industrial parks as the government seeks to boost trade and industrial growth.

Noting that the government has sourced funding amounting to Sh250 billion for industrialization, Trade and Investment Cabinet Secretary Moses Kuria said, the Government is continuing to source for financial partners to support the programmes.

Kuria further said it is committed to moving the country towards full industrialization so as to create jobs and increase the country's GDP and called on the county governments to pull in the same direction.

"I want to thank Equity Bank for the financial support and I am appealing to other financial institutions to follow suit. County governments and investors should take advantage of the financial support systems to attract small and medium enterprises in those parks," he said.

Kuria was addressing close to 20 governors during a benchmarking tour of Tatu City and Twiga Foods in Kiambu County. The CS said besides Equity Bank and the Government's Sh100 million that President William Ruto announced for supporting special economic zones, Exim Bank has also agreed to pump an additional 3 billion dollars to fund Kenya's industrialization programs.

The European Union (EU) and Trademark East Africa too have agreed to give a grant of 25 million Euros to support aggregation.

Industrialization Principal Secretary Dr. Juma Mukhwana said the Government is in the process of conducting a national feasibility study to identify commodities that add value to specific areas in order to reduce local competition.

"We need to ensure that products being processed in a certain county are not manufactured in a neighboring one. We need to get the right products viable for specific counties so that it adds value and does not outcompete what is being done in other areas," said the PS.

He said the country has huge industrialization potential, and encouraged investors to consider investing in the manufacturing space. By Muoki Charles (KNA)

## State to establish National Open University of Kenya to enhance accessibility-Machogu

Plans by the Government to establish the National Open University of Kenya are at an advanced stage. This is in a bid to make university education more affordable, accessible, and attainable to all students.

Education Cabinet Secretary (CS) Ezekiel Machogu says the move is among the far-reaching reforms the Ministry is undertaking to address the high cost of university education in the country.

"One of the flagship initiatives that the Government is currently undertaking to enhance access to affordable university education is the establishment of the National

"Once established, it will make university education more affordable, accessible, and attainable to all students, no matter their location or income level," he said.

The CS made the remarks while presiding over the 10th Graduation ceremony of Pwani University where a total of 1203 graduands were conferred with various degrees. "Our ultimate goal is to ensure we have an accessible, affordable and functional education system that is globally competitive and responsive to the demands of national and international development," Machogu added.

He said the availability of

skilled and knowledgeable manpower is vital in solving divergent needs and challenges of the modern society, including globalization, technological advancement, climate change, poverty, cyber security and the burden of diseases.

"The role of universities in training, research and innovation cannot be overstated. This is a critical sub-sector that is of direct relevance to our national and regional development agenda," the CS noted.

Machogu called on universities to explore ways of addressing the financial challenges facing them.

"Our universities should

utilize their internal capacities to overcome the challenges they face. The current difficulties call for innovative solutions.

"Our universities should, for example, develop and strengthen unique niches that contribute to both the national and global development agenda in order to attract local and international students for training and research," he observed.

He, at the same time, called on the institutions to boost their online presence and invest in world-class facilities with marketable and relevant programmes that can attract students from all corners of the world.

### State to hire 200,000 seafarers by 2027

■ The Government plans to recruit at least 40,000 seafarers annually which will lead the country to achieve a target of 200,000 seafarers by 2027.

The Principal Secretary for Shipping and Maritime Affairs Mr. Shadrack Mwadime said, the recruitment of seafarers is aligned with the Bottom-Up Economic Transformation Agenda of the Government to create jobs for the unemployed and under- employed youth.

"This programme will secure the full development and alignment of hospitality, engineering and other sectors with seafaring skills to create good jobs," Mwadime said.

The PS, who was speaking in his office at NSSF Building in Nairobi said, the Government's vision of building a 'trusted Kenyan seafarer' is aimed at yielding at least Sh3.983 trillion in remittances in over 35 years.

Mr Mwadime said the Blue Economy Agenda, which is defined to fisheries and maritime sub-sectors, once fully implemented will attract investment, drive manufacturing and

industrialization, generate tax revenues and create good jobs and wealth for the citizenry.

He said, according to recent statistics, the number of seafarers in the country has been increasing yearly, citing the rise in 2016 to 1000, in 2020 to 2,000, while by February 2023 they had reached 6,890.

As per the Kenya Maritime Authority recruitment and placement system, by February 2023 the number of seafarers onboard ships was 488 while those in the process of recruitment was 2000. Those on ongoing contracts were 2000, on leave 980, those on training and ongoing refresher courses were 512 while those in between jobs were 1000. The PS assured trainees undertaking shipping and maritime courses in local universities and colleges that the Government will ensure they get an advanced training, adding that the State Department of Shipping and Maritime Affairs has urged partners to offer scholarships to graduates to pursue advanced courses
