KFCB to crack down on those sharing disturbing content on social media

he Kenya Film Classification Board (KFCB) has vowed to prosecute individuals who share offensive and disturbing audio-visual content on social media.

The Board's Acting Chief CEO Mr Christopher Wambua says, the Board has noted with concern, the rising number of cases of people sharing graphic and disturbing audio-visual content on social media platforms in disregard for the interests and safety of children and other vulnerable members of society.

Wambua who was speaking to the media in Nairobi noted that in the recent past, the vice has not only become rampant but also taken a disconcerting turn with some bloggers and social media users sharing

extremely offensive video content with the potential to cause harm.

The CEO cited the streaming of graphic content of a mother killing a minor recently in Kitengela and warned those sharing such content that law enforcers will arrest and prosecute them.

"The digitisation of the Judiciary Pilot has been very successful and can be appreciated and upscaled within the entire public sector," he said.

Dr. Gachugu also recognized the vital role played by the government and private stakeholders such as Kenya Private Sector Alliance (KEPSA), Mastercard Foundation, and eMobilis in supporting the digitization project.

Speaking during the ceremony, the Senior Public Policy and Advocacy Officer at the Ajira Digital project in KEPSA, Mr. Jared Maranga, noted that digitization has had a very significant impact on the Judiciary.

"With digitization reducing the time to access court documents by up to 80%, there has been a notable reduction in case backlogs by up to 60% in some courts," said Mr. Maranga.

The official further noted that virtual proceedings have become much more accessible due to the digitization of documents, allow-

ing Judges and Magistrates to access case files remotely from their Court Chambers or homes.

Addressing the Stakeholders on behalf of ICT and the Digital Economy Principal Secretary, the Secretary Administration Mr. Mohammed Jabane, reiterated the department's support for the Ajira Digital Program adding that the government is keen on boosting the Program by rolling out national infrastructure throughout the country to enhance hoto by Eric Bosire) digital technology development and create job oppor-

tunities. Mr. Jabanelauded the Program's efforts in addressing the issue of unemployment among Kenyan youth.

"We need to develop useful partnerships and drive the digitisation project to the next phase and ensure that we help more youths get digital skills which will help in tackling this problem of unemployment head on," he said.

Wambua noted that some social media users are increasingly misusing digital apps to host and stream live video sessions of explicit adult shows in blatant breach of the laws of the land.

"Indeed, some apps are being transformed into digital brothels from midnight onwards and equally worrying is the non-consensual dissemination of intimate images or videos of individuals in violation of privacy laws", the CEO said.

These activities, Wambua said, are being perpetrated at a time when children, who are heavy users of the internet and social media, are at home for the April holidays.

"As a society, we need to step back for a moment and reflect whether we are losing the values that define us and report the same to relevant government agencies and platform operators for appropriate action", said the KFCB boss.

Consequently, KFCB in collaboration with relevant public and private sector agencies will continue empowering parents and caregivers with the necessary skills and knowledge to enable them help children navigate the online environment safely.

"Through the Parental Digital Literacy (PaDiL) Programme, the Board has joined hands with Netflix, Tik Tok and Google to empower parents with the knowledge to undertake their parenting responsibilities effectively in an increasingly digital environment", Wambua revealed.

He appealed to parents, caregivers and guardians to pay attention and to keenly monitor the content children under their care access on social media networks, broadcast channels and other platforms and in cases where children have access to the Internet and smart devices, parents must exercise responsibility to ensure minors do not access inappropriate content.

Use part of alcohol revenue to rehabilitate drug addicts, NACADA implores counties

The National Authority for the Campaign against Drugs and Alcoholo Abuse (NACADA has urged county governments to use part of revenues collected from alcohol licensing to strengthen alcohol and drug addiction rehabilitation services in their counties.

NACADA CEO Mr. Victor Okioma says, most counties are not keen on rehabilitating men and women who have been ruined by excess use of alcohol and drugs.

The NACADA boss observed that the county governments revenue collection department had enhanced most efficient ways of increasing alcohol licensing income in total disregard of the type of liquor consumed and its associated negative effects. "We are asking counties to use alcohol licencing fees to rescue the lives of alcohol and drug addicts in their counties," Okioma told a meeting which brought together national

and county government officials at Nandi County administration headquarters.

He proposed a committee tasked to oversee the level of alcohol and drugs addiction at counties level which comprises representatives from both National and County Governments including other relevant non state actors.

According to him, the committee among other things will be instrumental in suggesting ways of helping alcohol and drug addicts so that they can be restored back to their normal lives. The CEO tasked the Nandi

County enforcement offic-

ers, led by the County Commissioner Caroline Mueni who attended the meeting to ensure that no illegal liquor making industries exist in the county.

He revealed that such illegal liquor making points use harmful chemicals mixed with ethanol to ruin the lives of many innocent consumers.

Commissioner Mueni on her part welcomed the idea and said she had engaged county commissioners of Kisumu, Vihiga, UasinGishu and Kakamega Counties to help identify and crackdown on illegal liquor making industries.

Jonah Bwambok, Nandi County Government Director for Liquor Consumption, said out of close to Sh12 million revenue expected to be collected from alcohol bars licensing, a portion will be used to strengthen alcohol and drug addiction services, including operationalization of proposed Kabirirsang Alcohol, Drugs Rehabilitation Centre.

Gov't signs bilateral labour deals to secure jobs for Kenyans abroad

The Ministry of Labour and Social Protection has signed bilateral labour agreements with seven countries to assist qualified unemployed Kenyans secure jobs abroad.

Labour Cabinet Secretary, Ms Florence Bore said, so far, seven agreements have been signed adding that the initiative will benefit thousands of Kenyans in different cadres as the government moves to address rising unemployment in the country.

Among the agreements signed, she said, was between Kenya and Saudi Arabia where about 130, 000 opportunities have been identified for qualified Kenyans to tap into.

Kenya, she added, was looking beyond the gulf countries which have traditionally absorbed Kenyan workers to ensure that as many Kenyans as possible benefit from the programme.

Negotiations, she disclosed, were at an advanced stage with Canada, South Korea and Germany to secure more job opportunities.

"Germany will be here next week. They have assured us that they have about seven million jobs. This is huge and we want our people to benefit," she said.

To make the programme a success, the CS said the ministry was working on packaging job seekers to ready them for the available opportunities abroad.

"What we have as a country is the human resource. People have graduated with various degrees and courses but do not have jobs. We want to sell this out there and be able to secure opportunities for them," she said.

The ministry, she added, was in the process of reviewing existing bilateral labour relations with different countries to safeguard Kenyans working outside the country.

This comes against the backdrop of Kenyans being tortured and mistreated abroad with the CS assuring that the review targets to address teething problems affecting the programme.

Through the initiative, the government aims to ensure that all Kenyans who secure jobs abroad are put in the right cadres, get the right salaries and work in a conducive environment.

Bore added that the government was equally developing a national labour policy and a National Labour Management Bill to regulate and control recruitment agencies.

This, she disclosed, has seen the number of registered recruitment agencies reduced from 900 to 500 adding that the vetting will continue to ensure only agencies that meet the set standards are allowed to operate.

Speaking at Tom Mboya Labour College in Kisumu during the World Day for Safety and Health Celebrations, Ms Bore asked all unemployed Kenyans to register with the National Employment Authority to benefit from the opportunities being sought abroad.

ana Kendi noted that while the loan is geared towards economic empowerment among locals, it would also go a long way in addressing youth unemployment in the area.Kendi said the majority of the young people in the county have sunk into the abyss of alcoholism and substance abuse out of frustration due to dwindling income-generating opportunities amidst a worsening global economic crisis. The official said the re-

volving fund will play a pivotal role in creating income-generating opportunities for thousands of young people and in so doing help address the rampant alcoholism in the county.

"We have seen an increase in alcoholism and substance abuse here in Nyeri and as a county government we have put different initiatives to curb this vice. One of the initiatives is of course to put a centre that is supported by the health services to help those who are already addicted.

However, what is really leading the youths into drug abuse is financial challenges and we found it fit to launch an empowerment program by providing affordable capital to start some small businesses payable within two years," she said.

During his inaugural address to the Nyeri County Assembly in October 5 last year following his re-election into office, Governor MutahiKahiga announced plans to gradually increase allocation to the Enterprise Development Fund from Sh55 million to Sh 500 million to be loaned at an interest of 5 per cent.



Street families in Nakuru to benefit from vocational training

BY ESTHER MWANGI (KNA)

The Nakuru County Government is rolling out a programme which will empower street families to engage in lawful means of earning livelihoods.

The County Social Services Director Mr. MuriithiKiogora said through public-private partnerships, the county is planning to have the families trained in artisan courses including masonry, welding, solar installing, motorcycle and phone repairs, hair and beauty therapy among other courses.

The Director noted that Governor Susan Kihika's administration was envisioning a vocational training delivery model that will provide alternative livelihoods to both male and female individuals residing on streets to encourage entrepreneurship to break poverty and reduce their involvement in criminal activities.

"Our aim is to equip this segment of the society with gainful artisan courses as a way of keeping them engaged so that they keep off

from criminal activities and drug and substance abuse. Some of the women on the streets are victims of teenage pregnancies who were never given a chance to attend school," Kiogora explained.

Speaking at the CPC centre in Bondeni area of Nakuru during a meeting for partner institutions involved in rescuing and rehabilitating street families, the Director said the County Government's main aim was to link back the street children with their families instead of putting them in children's homes, adding that they were currently sensitizing parents on the need to embrace the family morals of being responsible.

Kiogora, who was accompanied by County Director for Youth Affairs, Josphat-Kimemia, indicated that

rescue, reintegration and re-socialization of the street families into community care would solve the problem which occurs among those placed in the homes.

While reiterating the county government's support and goodwill in ensuring the wellbeing of children and families connected to street life, Kiogora disclosed plans to relocate all the street dwellers in a procedural, humane manner, and within the confines of the law. He added that after the relocation, there will be a rehabilitation exercise that will include enrolling street children into schools, equipping older ones with informal and formal skills, and offering entrepreneurship training to the street dwellers above 18 years before reintegrating them to the society.

Energy PS riled by widespread power transformer vandalism

The Government has underlined its commitment to address the issue of power security in the country once the Ethiopia-Kenya transmission line which is set to be launched soon is operationalized.

Energy Principal Secre-

tary (PS) Mr. Alex Wachira says the line will supply additional Megawatts (MW) of power to the national grid and help stabilize the

country's energy needs. The PS said prolonged drought has significantly reduced the country's energy supply from hydro where he said despite the recent rains. the waters in Masinga Dam for instance had increased by only two meters.

Wachira was speaking when he appeared before members of the Parliamentary Standing Committee on Energy in Naivasha.

Wachira noted there was a need to fast-track the implementation of power projects as doing so would ensure access to cheap

power for consumers.

To this end, he said, the Ministry is looking at the tariffs charged in order to bring the cost of electricity down and also return Kenya Power Company limited (KP) to profitability.

The PS, however decried the continued vandalism of transformers in the country, noting that the power utility company loses an average of 20 transformers in a week, negatively affecting the company's operations.

enya has in the last few weeks signed bilateral agreements with the United Kingdom and the United States in what promises to boost trade and present economic opportunities to citizens of both countries

To begin with, the US and Kenya last week held bilateral talks that sought to increase trade and investment cooperation through "a strategic partnership that prioritises economic and commercial programmes".

"These efforts are expected to create at least a million new jobs per year in Kenya and reduce food insecurity over the next five years," the two countries said in a joint statement from the US Department of State after the meeting in Washington DC.

Further, the US agreed to enhance Kenya's capabilities to counter violent extremist organisations; promote regional security; advance maritime surveillance and bolster the country's military academic institutions. The Kenvan Military Airfield in Manda Bay

in Lamu will also be supported by the US to counter Al-Shabaab and strengthen the African Union Transition Mission in Somalia.

Besides counter-terrorism assistance, the two nations will cooperate to fight cyber threats and make the internet secure.

Under health, Kenya and US agreed to deepen cooperation in HIV/Aids, TB, malaria, immunisation, family planning and reproductive, maternal, newborn, child, and adolescent programmes.

Dr Alfred Mutua, the Cabinet Secretary, Foreign Affairs, who led the Kenyan side in the talks alongside his Trade counterpart Moses Kuria, said the US, whose team was led by Secretary of State Antony Blinken, is also setting up a framework so that Kenyans can apply for jobs in the country and speedily get visas.

These talks are expected to pave the way for the US and Kenya to sign a full free trade agreement (FTA). Kenya is, therefore, inching closer to be the first sub-Saharan African nation to sign a pact with US that will lower tariffs between the two nations.

Kenya is optimistic that it will finish talks on the deal with the US by the end of this year and sign the agreement by April 2024, said Mr Kuria.

According to experts, if Kenya fails to secure the FTA under terms that include 70 per cent of exported products attracting no duties in the US, this would place the country in a precarious position compared to other EAC countries should America fail to renew the African Growth and Opportunity Act in 2025.

Kenya has been a major beneficiary of AGOA, exporting goods worth \$890 million (Sh121 billion) in 2022, an increase from

The EPA guarantees companies in Kenya, including British businesses, duty-free access to the UK market following the country's exit from the European Union (EU).

Kenya calls for help to finance climate action plans

THE GOVERNMENT HAS called on development partners to help the country finance its climate action plans as the country grapples with adverse effects of climate change. Festus Ng'eno, the Principal Secretary in the State Department of Environment and Climate Change, said the country needs about Sh10 trillion to implement its climate action plans despite being a low emitter of greenhouse gasses. "Our updated Nationally Determined Contribution (NDC) 2020 requires Sh8.4 trillion and the current National Climate Change

The World Health Organization (WHO) will establish a regional emergency hub for Eastern and Southern Africa in Nairobi following the signing of an MoU between the health body and the government. Health CS Susan Wafula (right) and WHO country representative, Dr Abdourahmane Diallo, who signed the agreement, said the establishment of the hub will help Africa tackle increased health emergencies ranging from disease outbreaks to natural disasters that threaten to reverse gains made.

The agreement sets the framework for cooperation and understanding between the government and WHO. Ms Wafula thanked the WHO for

enjoying duty-free and quota-free access to the UK market.

The agreement, whose Council meetings will be held every two years, will also see UK exports to Kenya exempted from the raised East African Community (EAC) tax charges that took effect on July 1 last year, posing a big dilemma for Nairobi, which is bound by the regional bloc's decisions.

The UK-Kenya trade is currently worth Sh167 billion annually, but is expected to rise as the former makes direct investments worth Sh1.3 trillion this year alone.

"The UK and Kenya will go far when we walk together," said Jane Marriott, the former UK High Commissioner to Kenya.

Under the agreement, the UK will eliminate tariffs on 97 per cent of goods imported from Kenya for 25 years, while Kenya will gradually reduce tariffs on imports from the UK.

The agreement will save Kenyan exporters over Sh1.5 billion annually in duties on products like green beans and cut flowers.

The agreement also includes provisions on trade, investment, intellectual property, sustainable development, labour rights and environmental protection and is expected to create new business opportunities and support economic growth in both Kenya and the UK.

Kenyans, thanks to the agreement, will be able to secure jobs in the UK. So far, about 2,500 UK businesses export goods to Kenya, employing some 250,000 Kenvans.

UK Prime Minister Rishi Sunak and President William Ruto during the Conference of Parties (COP27) Climate Change meeting in Egypt last November agreed to fast-track Sh500 billion of investments, including construction of the Nairobi Railway City and dams

Mr Kuria presented to UK investors investment opportunities worth Sh2.3 trillion (\$18 billion), noting that, "EPA provides a good framework for strengthening the strategic cooperation between Kenya and the UK in the areas of trade, investment, research, innovation and development at both government and private sector level".

Treasury seeks to change debt limit law for better budget management

The institution is working to amend the Public **Finance Management Act** to introduce a debt anchor pegged at 55pc of the GDP

he National Treasury is seeking to change the country's debt law to remove the current ceiling of Sh10 trillion and replace it with a new measure based on the gross domestic product (GDP) for efficient budget management.

The institution said it is seeking to amend the Public Finance Management Act (2012) by introducing a debt anchor that is pegged at 55 percent of the GDP.

Ms Monica Asuna, the Director of Planning at Treasury, said that the new debt anchor will enable the country to manage its budget deficit better through borrowing.

"By putting a debt anchor, we will manage our debt in a sustainable manner that conforms with guidelines set by the International Monetary Fund on debt limit and reduce the risk of default," she said.

For the last two weeks, Treasury has been taking the proposed amendment through public participation across the country before it is forwarded to parliament for debate and passage into law.

Kenya's debt stock stood at Sh9.2 trillion as at the end of January and with the projected net borrowing of Sh425.1 billion for this fiscal year and a fiscal deficit of Sh720.1 billion in the next financial year, the public debt is expected to surpass the Sh10 trillion limit.

This means that Kenya may not be able to borrow more if it does make amendments to the debt law to enable it meet its debt obligations and finance the fast, ever-growing budget deficit.

The sharp growth in Kenya's public debt is attributed to increased external and internal borrowing and the appreciation of the US dollar against the local unit.

Last week. Treasury kicked off a plan to raise funds in the international market

through a sovereign bond in the financial year 2023/2024 in what is expected to raise the public debt stock.

The institution said in a public notice that it is seeking international lead managers that would guide the process from July 1, 2023 to June 31, 2024.

"The reputable financial institution should be duly licensed to operate in North America and or Europe, Middle East, Asia to provide lead manager services to successfully accompany Kenya's return to the international capital markets," said Treasury.

Among other things, the firm will advise Treasury on the optimal strategy for liability management of Kenya's outstanding Eurobonds, including but not limited to the one that matures in June 2024.





The Eurobond debt

The Eurobond debt stands at Sh914.2 billion and the country would repay it until 2048, according to the National Treasury. Of the Eurobonds, the largest debt is \$2 billion (Sh271 billion), taken in 2014 and matures in June next year. The bond's issuance marked Kenya's entrance into the commercial debt arena to fund its budget deficit. In 2027, Kenya would be obligated to repay a \$900 million Eurobond issued in 2019 while in 2028, the country's \$1 billion dollars Eurobond issued in 2018 will be due. Similarly, in 2032, the country's \$1.2 billion Eurobond matures while in 2034 and 2048, \$1 billion bond each would be up for repayment. Interest rates for all the bonds vary from 6.8 per cent to 8.3 per cent.

I have heard about data protection and data privacy, what's the difference?

The terms are often used interchangeably, but data privacy defines who has access to data, while data protection provides tools and policies to restrict access to the data.

Is giving false information as a data subject illegal?

Providing inaccurate information where you are required under the law to provide accurate information is an offence.

Talk about the major violators of data privacy such as supermarkets, digital lenders and politicians...

The ODPC is currently working on sector-specific directives, which will offer guidance to such entities on how to comply with the data protection laws as they collect data from their clientele. The office is also working on an avgrees campaigns to have data an awareness campaigns to have data controllers and processors appreciate their compliance requirements under the law

Does one retain the right to data privacy after death?

The scope of the Data Protection Act, 2019, does not include dead people.

Is an entity required by law to seek my consent before sharing my data?

An organisation collecting your per-sonal data is not necessarily required to seek your consent before sharing it. However, it is required to notify you whether the information col-lected will be shared, and with which foreseeable entities.

Can a government agency, say the **Kenya Revenue** Authority, acquire and use my data from another agency?

As long as there is a lawful purpose. The Data Protection Act does not information where there is a lawful purpose. But a person can seek recourse where the processing of personal data is carried out in non-compliance of the law.

As a data subject, do I need to register with the ODPC?

No, only those who collect and use your data, that is data controllers and data processors, need to register.

What should guide the information asked from me?

A data collector should ask for infor the purpose of processing. This will vary based on the processing activity being undertaken.

What steps should I take if my data is misused?

The first step is to seek redress from the data collector and if the issue is not resolved, you have a right to file a complaint with the Office of the Data Protection Commissioner via the website, www.odpc.go.ke or physically visit their offices.

Stakeholders call for creation of national BRIEFS horticulture taskforce to tackle disasters

Takeholders have called for the creation of a national horticulture taskforce to help prepare for future pandemics and emergencies as the effects of Covid-19 continue to be felt years after the outbreak.

The experts, drawn from government agencies, ministries and departments, in collaboration with the private sector made the proposal while deliberating ways to strengthen the horticultural value chain to tailor it to more resilient agri-food systems.

The experts spoke in Nairobi during a national workshop on the collaboration between the state and business actors in the agriculture value-chain

Horticulture was one of the most affected sectors during the Covid-19 pandemic with producers, processors, and exporters of French beans and avocado still reeling under the effects of the pandemic.

Besides a rise in interceptions of their products in Europe due to exceeding Maximum Residual Levels (MRLs), farmers experienced delayed harvesting of their produce, low demand, delayed planting, and reduction of cultivated areas leading to losses, decreased income,

and lavoffs.

This was due to interruptions, especially of transport and other logistics, because of restrictions imposed by the government to control the spread of the SARS-CoV-2 virus.

The effects were experienced in both avocado and French beans value-chains,

consequently affecting the economy and food security according to

research by the Institute of Development Studies (IDS) in collaboration with Centre for African Bio-Entrepreneurship (CABE).

The study was about looking at the governance, the interaction between state and non-state actors in responding to the impact of the Covid-19 pandemic in the horticultural sector to make it resilient, especially drawing lessons on what we can learn from the impact of Covid-19 to be better prepared for future shocks and stresses," said DrHanningtonOdame, the CABE Executive Director. Given the unpredictability

of pandemics, inflation and or depreciation of the local currency, the experts argued that it is time to come up with a policy brief to inform a policy or policy review to address unforeseen challenges in the horticulture sub-sector which contributes to 33 per cent of the Agricultural Gross Domestic Product (GDP).

"The policy brief will indicate areas that stakeholders think need addressing and review of either existing policies or coming up with new policies that address particularly issues of resilience because our systems are disrupted every now and then," said David Ombalo, Principal Agricultural Officer and a policy analyst at the Ministry of Agriculture, Livestock and Fisheries.

According to the stakeholders, besides the national horticulture taskforce, there is a need to improve communication in the sub-sector by embracing digital technology to enhance virtual certification and decentralized field inspections through selfregulation.

They indicated that there is a need to change the governance of horticulture value-chains post-Covid-19 to diversify and maximise emerging horticultural markets in Asia, the African Continental Free Trade Area (AfCFTA) and the East Africa Community.

Institute to build a Sh40m waste water treatment plant

The Kenya Marine and Fisheries Research Institute (KMFRI) is constructing a Sh40 million waste water treatment project to conserve the marine ecosystem in Mikindani, Mombasa county. The European Union(EU)funded project, through the United Nations Environment

Programme(UNEP) will improve the quality of the Tudor Creek which has degraded mangroves due to human activities.

KMFRI will use constructed wetland technology that mimics the natural processes of wetlands by using wetland plants, soil and microbes to clean and purify wastewater through manipulation of physical, chemical and biological processes

"KMFRI through its researchers has come up with a system to treat wastewater through the constructed wetland. The wastewater is passed through rocks, stones and plants. We use natural organisms to purify the water, and when the water enters the sea, it becomes clean water," said KMFRI Director General Prof. James Njiru, adding that the water can be used for farming.

Prof. Njiru noted that con-

67 girls in Narok undergo alternative rite of passage

About 67 girls from Sinkiter village in Narok North Sub-County have graduated after successfully completing an alternative rite of passage sponsored by the Coalition of Violence Against Women (COVAW) Community Based Organisation.

During the graduation ceremony, the girls, who had opted not to undergone Female Genital Mutilation (FGM) which is prevalent among the Maasai community, were celebrated and awarded gifts as a way of encouraging more girls to shun the retrogressive cultural practice

Mr. Daniel Ntokoiwan, a village elder, said the community had agreed to put aside any cultural practice which was inimical to the well-being of the girl child by engaging in productive activities which will be beneficial to the community. "I personally donated land where COVAW was training the girls. They have undergone several trainings on Gender Based Violence (GBV) and we are sure they will be a light to the community," he said. Mr. Ntokoiwan observed that cases of teenage pregnancy

and early marriages had decreased since the training began a year ago, lauding the parents and guardians for allowing their girls to attend the

training. The village elder called on parents to spend enough time with their children during this holiday season and monitor their movements so that they can be able to guide them ap-

propriately. "It is our responsibility as parents to ensure that our children; both girls and boys are walking in the right way. If we do not guide our children, they may end up joining bad company," said the elder.

He also challenged residents to report cases of FGM and early marriages to the authorities early enough so as to arrest and prosecute the perpetrators.

Mary Masako, a NyumbaKumi representative, challenged the community to 'say no' to FGM since it is retrogressive and illegal.

"I have not heard anywhere in the bible where FGM was done. We have been practicing FGM for very many years but we have not seen any benefits. This is the time we stop with this retrogressive culture and focus on building the society," Ms Masako said.

efence Cabinet Secretary Aden Duale has re-affirmed the Kenyan government's commitment to support peace initiatives in the region.

The Extra Ordinary Summit is important as it presents an opportunity for us to develop a common position on the drawdown. The approach to be adopted by this Summit should create a proportionate force balance, and maintain the gains already achieved by ATMIS forces," the CS said.
