## Gov't to digitize services for easy public access, introduce digital identity

The Government will place all its services on a common digital platform for easier public access in readiness for the rolling out of a digital identity.

The digital identity, according to the Cabinet Secretary for Information, Communication and the Digital economy Eliud Owalo will pool together an individual's numerous IDs to enable them access all government services online.

Speaking during the launch of the Jitume Centre in Trans Nzoia County, Owalo revealed that over 5,000 services have been onboarded on the e-citizen platform by

his ministry.

He added that the government will introduce electronic IDs which will enable the public to access all services available via online platforms irrespective of their physical location.

The CS also noted that the government is keen on ensuring Kenyans get the required skills on digital technology for optimum uptake of opportunities presented by the digital technology.

"To equip our youth with digital skills, the Government has come up with the Jitume laboratories whose primary objective is to train a public workforce that

# Gov't to lease idle land to increase food production



State Department for Crops Development PS Kello Harsama says government has large parcels of land under parastatals and other organisations lying idle and they can be cultivated to produce food for the country

The Government will soon fully implement the Land Commercialisation Initiative (LCI) to put huge tracts of idle land into agricultural use as it seeks to increase food production and bridge the food deficit in the country.

State Department for Crops Development Principal Secretary (PS) Kello Harsama said the government has large parcels of land under parastatals and other government organisations lying idle and they can be cultivated to produce food for the country.

Speaking during the inaugural investors' conference on the Land Commercialisation Initiative (LCI), the PS said the motivation for the government to cultivate the idle land was the severe effects of the recent drought which almost brought about a food crisis in the country.

"Recently, we experienced the biggest food deficit the country has ever seen with a shortfall of over 10 million bags of maize," the PS said, adding that in the past, in such instances, the government imported food from the region but this time round even the neigh-

bouring countries did not have food to export.

According to Harsama, those who were given the certificates to import duty free maize could not get it from the region with some being forced to import from as far as Brazil and Vietnam with the closest being South Africa where Kenya faced competition from other countries like South Sudan, Burundi, Rwanda and Angola.

The PS said that in order to remedy the food shortage in the country, the government has pri-

# Government to lease idle land to boost food production

oritised the utilisation of idle land by leasing it to local and international investors to produce food for the country and export.

“The President has declared that for us to maximally utilise our land resources, we are going to establish over 100 mega dams across the country to facilitate irrigation agriculture,” said Harsama.

The PS said approximately 2.5 million acres of arable land held by public institutions remain unused and to meet the country’s food

demand, the strategy is to bring 500,000 acres of new land into production. “The country has a deficit of 7.8 million bags of maize against a projected demand of 67 million bags of maize as of 2022,” Harsama said.

He explained that for the initial phase of the project, some of the parcels of land that the government has prioritised include GalanaKulalu, Bura irrigation scheme, Egerton University, Kimabere farm, Kirimum field unit, Masinga farm, Tana Delta irrigation project and the Tana irrigation scheme.

spawns efficient and effective service delivery in different areas of work”, Owalo noted.

The training, the CS revealed must concurrently run digital skills capacity-building programmes.

CS Owalo further said that the digital angle of the Jitume Programme has been designed to equip all TVETS countrywide with 23,000 virtual desktops.

He added that through this programme, one million learners will be equipped with market-ready business and ICT related skills for free.

The CS also said that as part of digital skill enhancement, the Government is also at an advanced stage of operationalizing the Kenya Advanced Institute of Technology (KAIST), a specialist SMART University which will provide master’s and doctorate level training in the three faculties of Mechanical, Electrical, and ICT Engineering.

“We expect KAIST to produce graduates in science, technology and innovation given that these disciplines are a must in a knowledge-based economy,” Owalo said.

The CS said that the government has put in place a 12-month in-

ternship package dubbed ‘Digital Talent Programme’ which has the key components of skill development, on the job coaching, mentorship, training, certification and ICT innovations.

“Our goal is to develop ICT high-end skills in recent university graduates”, said Owalo.

He further noted that the Digital Talent Programme is provid-

ing a platform for structured training, coaching and mentoring besides promoting ICT innovation and development of solutions among the trainees.

Under this Programme, Owalo said, 356 students graduated in November 2022 and another 400 interns, recruited in December 2022 are currently undergoing training.

# State launches program to conserve key water tower

The Government has initiated an aggressive afforestation program for Misango Hills in Kakamega County in a move to conserve the water tower that is a source of over 52 streams.

Principal Secretary for the State Department of Economic Planning James Muhati led key stakeholders in initiating a tree planting campaign on the degraded Misango ecosystem.

Muhati observed that the water tower was a key catchment area for rain-water in three counties of Kakamega, Vihiga, and Siaya and serves a population of over 23,000 people.

“Misango hills is part of Eregi hills, which is originally the Congo rainforest and is the main rainfall pattern determiner for Siaya, Vihiga, and Kakamega South zones,” said Muhati.

The PS said the forest is also home to several herbal plants, with medicinal value, hence the need to protect the ecosystem.

In 2013, more than 560 families living around the 103.7-hectare Hill agreed to move out to enable the government to set up a forest cover. Muhati said Misango Hills has a unique history and will be the most preferred tourist destination for the Western region after rehabilitation.

“Honey from this unique Misango Hills ecosystem is known for many ailments treatments” he added.

The Kakamega County government has already mapped out five historical sites, among them Misango Hills property to promote eco-tourism culture in the larger Western Kenya region. Others include Nabongo Heritage Shrine in Matungu, MaweTatu Heritage Site in Likuyani Sub County.

Nakuru County Government is fast tracking operation-alization of Lord Egerton Agro-industrial Park to help promote investments and accelerate economic growth in the county and across the country.

Trade, Culture, and Tourism County Executive Committee Member (CECM) Stephen Kuria said the County Aggregation Industrial Park (CAIP) and Export Processing Zone (EPZ) have been allocated 100 acres each at Ngongongeri farm in Njoro.

Kuria added that the County Government had already approved a policy document to establish and implement the County Aggregation Industrial Parks (CAIPS) and Special Economic Zones (SEZs) that will host a variety of industries, including agro-processors, ICT hubs, energy-sector companies, engineering and construction firms and chemical industries.

Speaking after inspect-



ing the proposed Lord Egerton Agro-industrial Park site, Kuria stated that Governor Susan Kihika’s administration was collaborating with the Ministry of Investments, Trade and Industry (MITI) to start CAIPS in line with the bottom-up economic transformation agenda.

Kuria, who was accompanied by his Agriculture, Livestock, Fisheries and Cooperatives counterpart

Mr Leonard Bor and CECM in charge of Lands, Housing and Physical Planning Mr John Kihagi, revealed that the devolved unit was envisioning CAIPS and SEZs that would host light industries such as warehousing and logistics and supporting industries, medium and heavy industries such as manufacturers of fertilizers, iron and steel, plastics and packaging, and fabricated metal products.

# Naivasha hospital installs incinerator to improve medical waste disposal

The installation of a modern incinerator at the Naivasha Level IV hospital will enhance efficiency in the handling and management of hazardous and general healthcare waste at the facility.

According to a World Health Organization [WHO] Report of 2018, 15 percent of healthcare waste collected

worldwide is considered hazardous material which is either infectious, toxic, or radio-active waste.

WHO indicates that an estimated 16 billion injections are administered worldwide but not all the needles and syringes used are properly disposed of after use.

The data also shows that low-income countries such as Kenya generate an average of 0.2 kg of hazardous

waste per hospital per day but lack adequate capacity and requisite equipment to handle it.

Nations Development Programme [UNDP] to equip the Naivasha Level IV Hospital with an Sh30 million incinerator and waste-handling truck to boost medical waste management.

An incinerator is defined as an enclosed structure used for burning and reducing the volume of waste under controlled temperatures of over 800 degrees Celsius.

It has an in-built filtration system to treat outgoing gasses from burned materials to ensure the air released surpasses strict environmental guidelines.

# Kericho residents to enjoy reliable water supply as dams expanded

The Government will redesign and expand Itare, Posta, Soin-Koru dams, Londiani dams and Itare-Litein water supply to accommodate and serve thousands of Kericho residents with enough water supply.

The Principal Secretary, State Department for Water, Sanitation and Irrigation Dr. Kiprono Rono said Itare dam in Nakuru will be remodelled to supply about 20 per cent of its water to Kipkelion East in Kericho.

The PS, who held a water consultative meeting with leaders from Kericho including Kericho Governor Dr Erick Mutai, Kericho County Women Representative Ms Beatrice Kemei, Ainamoi MP Benjamin Langat, Soin Sigowet MP Justice Kemei said Itare-Litein Water supply project will also be upgraded to supply more water to parts of Kaplong, Kapakatet and Litein in Bureti Sub-County.

The PS, who was also accompanied by Lake Victoria South Water Works Chair-

person Mr. Odoyo Owidi and the Kericho County Commissioner Mr Michael Lesimam, urged the leadership of Kericho and the residents to encourage the youth to establish tree nurseries, especially of indigenous trees where the government will purchase the seedlings, adding that the projection for Kericho County is to plant more than 10 million tree seedlings every year in order to help combat climate change.

Rono observed that the country is increasingly be-

coming water scarce and efforts to restore wetlands, water springs and conserve the existing water bodies and rivers should be enhanced through active reforestation programs where individuals, communities and institutions can jointly participate.

Speaking to the press outside the governor's office, Rono reiterated that they have revived an orthodox reaction to the illegal water peddlers and those who steal water in the county leaving residents with un-

answered outcry.

"We will ensure that every household in the country gets access to a reliable and adequate supply of clean water to enhance better living and help in boosting animal and crop production," Rono said.

Meanwhile, the PS launched a Water Police Unit to curb water wastage and illegal water connections which deprive many residents from getting enough water in their households.

The PS also said that other small dams and non-dam water points will be constructed across the country in order to encourage more water supply to communities in the country which will assist to realize President William Ruto's Bottom-Up Economic Transformation Agenda (BETA).

Kericho Governor Dr Erick Mutai reaffirmed commitment to the national government projects saying they have signed a Memorandum of Understandings (MoU) with the Ministry of Water, Sanitation and Irrigation.

# Climate Smart Agriculture key to food security

The Government has prioritized sustainable farming practices in its policies and budget to ensure food and nutrition security and build resilience against climate change shocks.

Mr Harsama noted that agriculture is hugely vulnerable to climate change, particularly in Kenya, where farmers bear the brunt of irregular, insufficient and unpredictable rainfall patterns.

In a speech read on his

behalf in Nakuru by Assistant National Coordinator attached to Crop Protection and Food Safety Directorate, Ms Rose Kamau, during the unveiling of Panoramix-GR bio fertilizer manufactured by Koppert Kenya, the Principal Secretary noted that bio-fertilizers improve availability of plant nutrients to the roots through association and are also free-living bio-organisms that fix nutrients in the soil.

Climate change, added the Principal Secretary, is not only threatening food security but is also contributing to the loss of biodiversity, insecurity and nutrition.

Mr Harsama added "The situation on climate change is worsening daily as natural hazards from extreme weather events such as drought and flooding are increasing. This has created greater loss and damage,"

He indicated that Climate Smart Agriculture (CSA) was the solution to erratic weather patterns adding that it involves actions that sustainably increase pro-

determination.

“To strengthen the sector, we must embrace innovation and aim to increase bed nights and tourism numbers for domestic and international visitors,” Ms Malonza said.

She noted that revitalizing tourism requires a multifaceted approach that looks into renewing commitment to sustainability, innovation and the well-being

of the visitors. “First and foremost, we must invest in refurbishing our establishments to maintain and refresh our unmatched national brand,” Malonza said.

Secondly, she said there is a need to upgrade facilities, expand connectivity, provide affordable transport and accommodation, and also introduce new and exciting products that enhance the overall visitor ex-

perience and position Kenya as a premier destination.

Diversifying tourism offerings and investing in capacity building and skills development are hoped to help the sector adapt swiftly to disruptions and attract a broader range of visitors.

KEBS is mandated to offer quality inspection of imports based on Kenya Standards or approved specifications among other services. KEBS inspects imported goods either in the country of exportation, through the Pre-Export Verification of Conformity (PVoC) to Standards program, and at destination or Ports of Entry. The PVoC services are offered by KEBS contracted inspection companies.

KEBS wishes to inform all stakeholders and the public that **Quality Inspection Services Inc. Japan (QISJ)** was contracted with effect from **19<sup>th</sup> August 2022**, to offer PVoC services for used motor vehicles, mobile equipment and used motor vehicle spare parts in six (6) countries namely; **Japan, United Kingdom, United Arab Emirates, Singapore, Thailand and South Africa.** QISJ undertakes amongst other duties, verification of year of first registration and confirmation of vehicle ownership.

We have noted with concern increasing number of vehicles from these six (6) countries being imported into the country for **destination inspection**, having not gone through pre-inspection by QISJ and without genuine logbooks from the last country of registration. Some of these vehicles turn out to be stolen vehicles and / or more than eight (8) years old contrary to requirements of **KS 1515:2000, Code of Practice for Inspection of Road Vehicles.**

Therefore, KEBS wishes to notify the public and importers that all used motor vehicles coming into the country **without Certificates of Roadworthiness (CoRs)** issued by QISJ **MUST** be accompanied with the following documents to be eligible for KEBS destination inspection:

- Interpol clearance.
- Logbook and/or the certificate of deregistration from the last country of registration.
- Export documents from the country of origin.

Governor Gideon Mung'aro said salt firms in the county had in the past exploited county resources without adequately giving back to the commu-

nity hence the need for the county government to have shareholding rights in the companies for the benefit of the locals.

Speaking at the Kasarani Grounds in Marereni area of Adu Ward during celebrations to mark 50 years of ActionAid International's existence in Kenya, Mr Mung'aro said he would not watch as foreigners reap from county resources

without benefiting the locals.

Salt firms whose land leases have expired and want the same renewed will be the first to be affected by Mung'aro's new demand after the governor said he had refused to renew the tenancy agreements till the firms accept to partner with his administration.

"Some salt manufacturing companies have ap-

proached me to facilitate the renewal of the lease agreements but I have refused because I said anybody wishing to carry out salt business in this county will have to work with the county government as partners so that the people of Kilifi can also profit from their ventures," he said.

"Henceforth, anybody doing salt business in the county and wants their leases to be renewed must agree to have one company with the county government," he added.

## Productivity mainstreaming commences in Government

The Government will soon roll out productivity mainstreaming awareness and sensitization for all (MDAs) in the current financial year as part of efforts to ensure that service delivery improves and citizens get value for their taxes.

According to the Principal Secretary for Cabinet Affairs, Mr. Julius Korir, he pointed out that the planned roll out aligned to the National Productivity Policy (Sessional Paper No 3 of 2013) will see agencies adopt mechanisms leading to the adoption of innovation and continuous improvement techniques within the workplace.

Korir said that the mechanisms include investing in technological improvements, automation and improvement in human resource management practices are expected to see MDAs transform themselves to be more effective and efficient.

The productivity mainstreaming in MDAs is spearheaded by a Multi-Agency team of key Public Service stakeholders comprising the State Department for Cabinet Affairs; State Department for Labour and Skill Development; State Department of Performance Management Delivery; and the Salaries and Remuneration Commission.

The National Productivity and Competitiveness Centre (NPCC) a department under the State Department for Labour and Skill Development, Ministry of Labour and Social Development has been designated as the Specialized Agency responsible for the incorporation of productivity mainstreaming in the MDAs 2023/2024 FY Performance Contracts.

Speaking during the clos-

ing of a training session for productivity mainstreaming for the three agencies, Korir emphasized the importance of productivity mainstreaming in the public sector as an enabler for enhancing efficiency, effectiveness, and performance across government organizations.

The PS further observed that in the face of recurrent budget austerity measures and rising citizen expectations on service delivery, there was a need for the public sector workforce to deliver more with less funding through the integration of productivity principles, practices, and measures into the core mandates and processes of public sector agencies.

Korir underscored that services rendered by the public sector were largely financed through taxes hence attracting interests by all stakeholders.

"Productivity and Competitiveness have been identified as core underlying factors that drive economic growth and development of any country. Many other factors also contribute to this but ultimately it is the people, knowledge and skills, technology and attitude that make the difference," he said.

The PS noted that the Productivity Management (Measurement and Improvement) in the Public Sector is one of the Five Pillars of Public Sector Reforms.

"The 20th Cycle of Per-

formance Contracting (2023/2024 FY) has factored productivity mainstreaming as one of the deliverables for all Ministries, Departments and Agencies (MDAs)," he disclosed.

The PS pointed out that all MDAs are therefore required to create an enabling environment that fosters productivity awareness, development of MDAs Metrics, Calculation of Productivity Indices, and Implementation of Productivity Improvement programs using targeted tools.

"The ultimate goal is to cultivate a culture of productivity among employees, reduction of operational costs, reduction of waste thereby enhancing Public Sector Productivity," said Korir.

The PS said that the planned roll out of the programme is aligned to the National Productivity Policy (Sessional Paper No 3 of 2013) which aims at promoting competitiveness, employment creation, rapid economic growth and the transformation envisaged in the Kenya Vision 2030.

Report 2021/2022 was lauded as a catalyst for providing critical information and feedback necessary to enhance the quality of judicial services.



Mudavadi called for reflection on the progress made, key achievements, and challenges hindering the realization of goals in the Judiciary.

He urged stakeholders to develop strategies to mitigate these challenges and expedite the delivery of effective and quality justice to all Kenyans. He also emphasized the need to combat corruption and uphold integrity, underlining that a united front is essential for achieving the national development agenda and socio-economic transformation.

Furthermore, the Prime Cabinet Secretary highlighted the importance of leadership in enhancing accountability and cultivating a performance-oriented culture in Public Service.

He announced plans to introduce Whole-of-Government and Open-Government approaches in governance and encouraged the Judiciary to embrace these initiatives.

The CS offered the support of his office and partnership to strengthen performance management as a key public sector accountability framework.

# Youth urged to study Maritime, Blue Economy courses

The State Department for Shipping and Maritime Affairs is calling on Kenyan youth to take up courses in the Maritime Education and Training field in order to supply the much needed labour force in the global maritime industry.

The Principal Secretary Mr. Shadrack Mwadime says the current demand for seafarers in the global job market has outpaced supply and Kenya should seize the moment to study maritime courses and supply the required human resources capacity to fill the existing gaps.

“There is a growing demand for certified sea workforce with reports indicating that by 2026, there will be need for an additional 89,510 officers to operate the world merchant fleet alone,” Mwadime noted.

The PS was addressing stakeholders during validation workshop of the Maritime Education and Training Policy and the National Maritime Transport policy at the Taita Taveta County Hall in Mwatate.

Kenya, added the PS, has made considerable progress in establishing necessary frameworks for the provision and delivery of Maritime Education and training, including the establishment of programs and courses for seafarers which are guided by the International convention on Standards of Training, Certification and Watch-keeping for seafarers

“In order to meet the international training standards and enable Kenyan seafarers seek employment opportunities in the international shipping industry, Kenya ratified the International Convention on Standards of Training, Certification and Watch-keeping for seafarers 1978 as amended (STCW Convention) in 2010”, said the

PS.

The STCW convention, Mwadime said, provides for uniform standards of training seafarers worldwide besides prescribing the required knowledge, understanding and proficiency at each level of responsibilities.

Kenya, the PS said has put in place various institutions, both private and public, which provide courses in maritime education and training.

The PS however decried the low aware-

ness levels for MET among citizens, inadequate opportunities for shipboard training and inadequate training facilities and infrastructure as some of the challenges hindering the country's ability to effectively utilize the opportunities available in both the national and international maritime industry.

The validation event was the culmination of a three weeks exercise that took the Department to all the six counties of the coast region-Mombasa, Lamu, Kilifi, Tana River, Kwale and finally Taita Taveta.

He said the development of the two policies is intertwined as Maritime Education and Training (MET) plays an important role in the development of competent and skilled labour for the Maritime Transport and related industry.

One of the objectives of the MET policy is to enable the development of qualified and competent human resource for the maritime industry to ensure employability both nationally and internationally.

“Our universities offering degree level certification and Technical and Vocational Institutions offering courses in Maritime related field are approved by the Kenya Maritime Authority for purposes of provision and delivery of coordinated and harmonized qualifications”, the PS said.

ductivity, enhance adaptation, reduce greenhouse emissions to a possible zero and enhance achievement of national food security and development goals. He stated that various studies had shown that non-chemical-based fertilizer improves yields by up to 25 per cent and offers up to 50 per cent reduction in chemical fertilizer application while conditioning the soil, improving soil structure and texture.

It is also non-toxic in addition to being eco-friendly, non-hazardous and controls pathogenic organisms.

Mr Harsama said the deteriorating state of soil in all the 47 counties was due to continuous and wrong use of artificial fertilizers adding that there was a need to educate farmers on application of fertilizer types that match a given soil pH to fix missing nutrients in the soil and neutralize acidity.

The Principal Secretary indicated that the problem of deteriorating soil fertility was getting worse because most farmers do not know the status of their soil since

they didn't test due to costs.

“Collecting and conducting soil tests each year serves as a report card for the soil. The test reports help in determining soil organic matter, pH, electrical conductivity and levels of important macro- (phosphorus, potassium, calcium, magnesium) and micro-nutrients (boron, zinc, among others). These reports also help to estimate lime or Sulphur application rates to increase or reduce soil pH, respectively,” he advised.

Mr Harsama underscored the importance of educating farmers to have the know-how on their soil pH which enables them to be properly advised on what fertilizers to apply and the elements that are missing in order to fix them.

“You cannot manage what you do not understand or rather, what you do not know and therefore, for us to be able to manage the soils, we have to encourage our farmers to do soil testing. With soil testing and the right fertilizer, farmers can witness an increase in yields by between 50 and 150 per cent.” he stated.

# NACONEK unveils integrated environmental conservation through clean energy technologies

The National Council for Nomadic Education in Kenya (NACONEK) has inaugurated an integrated three-tier initiative which promotes use of clean energy technologies for cooking while at the same time bolstering environmental greening through tree-plantation. The initiative also comprises of a nutritious meal provi-

sion to enhance a balanced diet among children benefiting from the government School Feeding Programme. NACONEK Deputy Director in-charge of Quality Assurance and Standards Ms Keziah Wandera says the persistent use of wood fuel for cooking by schools has resulted in massive environmental degradation. Speaking in Mombasa County on the sidelines of

the just concluded 46th Kenya Secondary School Heads Association Conference, Ms. Wandera said use of wood fuel causes a lot of carbon emissions into the environment. "As we all know most schools are relying on firewood to cook. We are selling the idea that schools need to shift from predominant use of fuel to considering clean cooking technologies which

will lower the amount of carbon emissions into the environment", said the Deputy Director. She said the organization has invented a bracket as an alternative to firewood in a bid to minimize cutting down of trees for purposes of cooking. Ms. Wandera described a bracket as a piece of wood that is manufactured from saw-dust, soil or charcoal

dust. She said one bracket can last for three hours thereby saving on the amount of firewood and in the process promoting environmental conservation. "A green environment is more endearing and inviting to the children, it's safer and so schools need to consider planting trees because the trees will provide the raw materials for production of brackets", added Ms. Wandera. At the same time Ms Wandera lauded the introduction of the feeding programme

in the Arid and Semi-Arid Lands (ASAL) counties. She said provision of meals at schools has encouraged children in ASAL counties to access education. "Food attracts children to school and enables them to not only concentrate on learning but also get the energy to undertake physical tasks as well as promoting consistent school attendance", Ms. Wandera added. She said NACONEK is partnering with the World Food Programme to develop menus that ensure children are served with balanced diet meals.

# Ruto's big fight on climate financing

The Head of State has become the poster-President on climate change issues as he seeks to upset the global status quo that has seen Africa suffer

President William Ruto's international stature is growing, thanks to his individual accomplishments, regional dynamics and global perceptions.

His several State visits to countries in Africa, Europe, Asia and the Americas has seen him meet Kings, presidents and prime ministers, besides speaking in international forums especially on climate change financing - one of his pet subjects.

At the recent Global Pact Finance Summit in France, President Ruto was forthright when he spoke about the need for a new multilateral climate finance architecture to fund African countries against the vagaries of climate change.

President Ruto backed the creation of a Green Bank funded by "green taxes" levied globally, as part of a New Global Financial Pact to tackle climate and debt crisis, away from the "hostage" of Bretton Wood institutions.

"We need to move beyond the old donor-recipient paradigm and build new partnerships based on shared responsibility and shared benefits" in climate-smart agriculture, renewable energy and sustainable infrastructure that will help us build a climate-resilient future," he said.

The ripple-effect of such talk sweeps across diplomatic relationships, promoting trade partnerships and showcase leadership on the global arena.

# President backs the creation of a Green Bank funded by “green taxes”

Indeed, Kenya will be hosting the Africa Climate Summit in Nairobi this September, and President Ruto appears to be setting the tempo of the meeting.

“We call for a global financial system that supports climate-positive and green industrial growth powered by renewable resources,” he said as world leaders, including French President Emmanuel Macron listened.

In less than a year since the August 2022 elections, President Ruto is now being mentioned in the same breath as South African President Cyril Ramaphosa, the former chairman of the African Union (AU), Rwandan President Paul Kagame whose reputation rests on his post-genocide economic transformation and President Alassane Ouattara, who is at the forefront of the economic recovery in Côte d’Ivoire.

There is also Nana Akufo-Addo, whose international laurels rest on his democratic governance and economic development, besides peace initiatives within the Economic

Community of West African States (ECOWAS).

State House press secretary Emmanuel Talam explained that the president’s international profile was key in promoting Kenya’s foreign policy at the multilateral system and “the quest for realisation of Sustainable Development Goals and global leadership in emerging issues, including climate change”.

President Ruto is currently the chairman of the Committee of African Heads of State and Government on Climate Change (CAHOSCC). This makes him the poster-President on climate change issues.

Beyond that, the impact of his growing international reputation will be felt in enhanced stately persona, international credibility, regional recognition and domestic standing.

Prof Peter Kagwanja, the CEO of Africa Policy Institute, notes that President Ruto is Kenya’s topmost diplomat whose “hustler ideology” is now part of the five pillars of Kenya’s foreign policy namely: peace, economic, diaspora, environmental and cultural diplomacy.

The *New York Times* drew parallels between President Ruto and US President Joe Biden’s

“Bottom-Up Economic” model during Mr Ruto’s debut address to the United Nations General Assembly days after attending the funeral of Queen Elizabeth II in London in November last year.

The paper observed that the President “nodded to President Joe Biden’s ‘Build Back Better’ domestic plan, proposing a global effort towards ‘building back better from the bottom upward’”.

Other global media outlets have also taken notice, with *CNN*, *Reuters* and *The Economist* collectively labelling President Ruto “influential and effective” largely due to Kenya’s economic regional might and his outspokenness on global issues touching on African interests.

During the 3<sup>rd</sup> Pan-African Parliamentarians Summit on Climate Policy and Equity in South Africa in May, President Ruto said, “Africa demands and deserves two permanent seats in the Security Council” to have a voice at the table of global issues.

Slamming mistreatment of African Heads of State during international summits, which are nothing more than “photo-ops and 90-second

presentations”, President Ruto suggested using the African Union as “one tray” for African matters akin to the European Parliament.

*The Guardian* calls him “a rising star in African politics” and whose “views on a range of global issues are increasing being heard”, while the *BBC* reckons he’s bright enough “to use his growing international stature to his advantage in years to come”.

Indeed, the global space gives President Ruto a platform to articulate Kenya’s foreign policy and vision in economics, investment and regional cooperation, which not only attracts foreign investors, but also boosts tourism.

Diplomatically, the international stature increases opportunities for bilateral meetings, multilateral summits and diplomatic negotiations through which he can address Kenya’s shared challenges, build alliances with strategic partners, besides pursuing support for the country’s national interests.

The global standing also opens doors for technology transfer, trade agreements and collaborations in areas like research, healthcare, education and infrastructure development.

His three-day official visit to South Korea where he met President Yoon Suk-yeol in November 2022, earned Kenya a Sh120 billion funding for a smart city at Konza Technopolis, besides bankrolling the Nairobi Intelligent Transport System and Bus Rapid Transit and other projects in agriculture, ICT, health, energy, infrastructure, education and affordable housing.

President Ruto’s forays at COP27 meeting in Egypt saw UK Prime Minister Rishi Sunak pledge to fast-track new green investments in Kenya, including the Malindi Solar Expansion, Menengai Geothermal, Grand High Falls Dam and Nairobi Railway City.

The economic impact thus includes increased foreign direct investments (FDI), stimulating exports hence increasing job creation and overall economic growth, while interactions with the World Bank and the International Monetary Fund (IMF) can be instrumental in securing financial support and favourable lending conditions necessary for mobilising resources to alleviate poverty via social development programs.

Ambassador Ngovi Kitau, Kenya’s first envoy to South Korea, reckons that Kenya has “pivot status”, which according to the Hague Centre for Strategic Studies, is a country that “possesses military, economic or ideational strategic assets that are coveted by great powers”.

East and Western powers have been scrambling for a piece of Kenya’s pie for its strategic geographic location, economic potential, regional influence and contribution to world affairs, which confer it “pivot status” over its vote in the ongoing Russia-Ukraine crisis for which the United National General Assembly has met five times.

Of the 90 countries that contribute military and civilian police to UN operations, Kenya is ranked sixth, besides being a key player to peacekeeping missions in Sudan, South Sudan, Ethiopia and the Democratic Republic of Congo (DRC), which accounts for Kenya’s “soft power” as a middle-income economy. ■

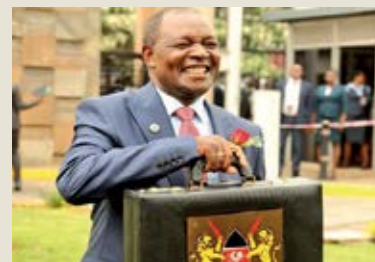
Wi-Fi hotspots. “The objective of this initiative is to help create employment opportunities for the unemployed youth by enabling them to earn from online jobs,” said Mr Owalo, who was accompanied by Elgeyo Marakwet Governor Wesley Rotich and area County Commissioner Gideon Nyandiricha. He added that the government is committed to the expansion of internet accessibility in line with the

ongoing digitisation services. “With digitisation of government services, Kenyans will be able to easily access them reducing time wastage.” Trans Nzoia county secretary Truphosa Amere said the devolved unit supports the initiative, which she described as timely.

“Establishment of internet points within markets and villages would enable the youth access online job and financial opportunities,” she said. ■

### State targets 3.6pc fiscal deficit by 2026

THE GOVERNMENT IS targeting to reduce the fiscal deficit from the current 5.8 per cent of the gross domestic product (GDP) to 3.6 per cent by the financial year 2025/26.

According to the National Treasury, this would be achieved through increased tax collection and a decrease in borrowing.

Treasury projects the fiscal deficit will decline to 3.9 per cent in the financial year 2024/25 before hitting the 3.6 per cent target in 2025/2026.

“The fiscal consolidation path over the medium-term is expected to reduce growth of public debt and boost debt

sustainability position,” said Treasury in a report. The fiscal consolidation is currently ongoing as the government institutes various tax reforms to shore up revenue starting from this financial year. Treasury CS Njuguna Ndung’u while presenting the budget in Parliament two weeks ago said the government intends to collect Sh2.9 trillion, up from about Sh1.9 trillion. The rise in tax collection would, therefore, leave the country with a Sh720 billion deficit, which is equivalent to 4.4 per cent of the GDP. Kenya’s public debt currently stands at Sh9.3 trillion with 52 per cent coming from external sources. While the public debt remains sustainable, Kenya is at a high risk of debt distress, according to the National Treasury. ■

# Why Central Bank raised indicative rate

Central Bank governor, Dr Kamau Thugge.

Governor Thugge says increasing the rate by 1 per cent is aimed at managing inflation that is expected to increase as prices of commodities surge

The Central Bank raised its benchmark rate to 10.5 per cent in a bid to contain inflation that is expected to continue to rise in the coming months due to increased global risks, Dr Kamau Thugge, the new governor, said.

The bank last week raised the rate from 9.5 per cent to 10.5 per cent, pushing it into the double-digit territory for the first time since January 2018.

"Inflation is like a tax since it reduces people's income. Therefore, it is important that we address inflation to reduce the cost of living. Everybody is affected by inflation including those who don't have income," he said, justifying the increase.

According to Dr Thugge, the Monetary Policy Committee (MPC), which he chairs, noted that there is sustained inflationary pressures that have elevated global risks and their potential impact on the domestic economy. The MPC, thus, concluded that there was scope for further tightening of the monetary policy, said Thugge.

Kenya's inflation is partly driven by a rise in prices of imported goods like oil and sugar.

"The contribution of inflation from non-food and non-fuel items has continued to rise.



This indicates persistent underlying inflation pressures in the economy," he said, adding that the tightening of the rate targets the impact of non-food and non-fuel items.

Dr Thugge noted that the main drivers of food inflation include products like sugar, with the price of the commodity doubling. "We are expecting inflation to continue to rise, therefore, our goal is to make sure people make decisions based on the right information," he said.

The MPC, he observed, will monitor the impact of the policy measure as well as the developments in the global and domestic economy and stands ready to take further necessary action. Kenya's overall inflation stood at 7.9 per cent in June from 8 per cent in May, defying rise in cost of fuel, food and

other items. Food inflation during the period increased to 10.3 per cent from 10.2 per cent in May due to a sharp rise in sugar prices.

"Overall inflation is expected to remain elevated in the near term mainly due to recent increase in electricity prices, the removal of fuel prices and associated second round effects," said Dr Thugge.

He noted that the global economic outlook remains uncertain, reflecting continued geopolitical tensions due to the Ukraine war and pace of monetary policy tightening in developed countries. In tightening the monetary policy, Kenya is following in the footsteps of advanced economies as countries try to contain runaway inflation. ■

Fighting inflation

Central Bank governor expects prices of most food items to decrease in the coming months.

These include maize, wheat, beans and Irish potatoes, what would likely reduce inflation.

However, he notes that the price of sugar may continue to rise in the coming months.

According to the Central Bank, Kenya's exports grew 5.5 per cent in the year to May compared to a similar period in 2022, boosting earnings. Income from tea and manufactured goods rose 10.2 per cent and 25.4 per cent respectively during the period.

The rise in earnings from tea reflect an increase in demand from traditional markets.

On the other hand, imports during the period declined 2.3 per cent from a growth of 20.4 per cent in 2022.

### Should motorbike and tractor owners also get the new plates?

Yes. The new plates are for all registered motor vehicles, including motorcycles and tractors.

### What are the costs?

The cost for motorcycle plates is Sh1,550 while for other vehicles, the charge is Sh3,050. The figures are for both front and back plates.

### Isn't the Sh3,050 application fee too high for the mwananchi?

This is actually quite affordable compared to the benefits the plate comes with.

### Are there other charges, say monthly or annually?

This is a one-off thing unless one loses the plate, then they will have to apply and pay for a duplicate.

### And is the new plate mandatory?

It is not mandatory, but it is advisable to have it. This is because of the many security features it has. Again, it is beautiful, who doesn't require a fancy plate for a vehicle they value?

### Is there a deadline for registering?

The NTSA is yet to announce a deadline but it is advisable to get it earlier to avoid the last-minute rush when the deadline is announced.

### What happens if I fail to register for the new generation plate?

Nothing will happen, but you are likely to miss out on a lot, especially on the security features that the new plate comes with.

### What if I have lost my logbook, can I register for the plate since NTSA has details that show the car is mine?

If you have lost the logbook, you are advised to apply for the duplicate then use it to apply for the digital plate. That is the only proof of ownership of the vehicle.

### How long does it take for the number plate to come out?

After submitting the application, it will take seven working days. One will get a text from NTSA updating on the status.

### Is it true that allocation is based on the make or type of the vehicle?

That is false. The plates are allocated on firstcome, first-served basis.

### So, there is no need to physically visit NTSA offices in the process?

Exactly. It's a simple process that you can comfortably do from anywhere as long as you have a TIMS account and internet connection.

### What if my application is rejected?

In case of rejection, you will always get the reason(s) and advised to re-submit.

## Youth urged to leverage Fibre Optic infrastructure to create digital content

Broadcasting and Telecommunications Principal Secretary, Prof. Edward Kisiang'ani (pictured) has challenged Kenyan youth to take advantage of the digital creative space in order to improve their livelihoods and grow the economy.

Prof. Kisiang'ani asked the youth to take advantage of the government's fibre optic infrastructure and be producers of innovate digital content which reflects the African and Kenyan identity.

The PS who was speaking in Nairobi when he officially launched the Creative Economy Conference that was co-hosted by Konza-Technopolis Development Authority (KoTDA) noted that the creative economy is very critical in growing the country's economy.

"The government has recognized that unless we take our position in this space, we shall be left behind, many people will be making money, while we shall not benefit from these de-

to using up to Sh15 billion to develop the digital super-highway, and by extension enhance the development of the digital economy," said Prof Kisiang'ani.

He noted that many people have migrated to the expansive digital world adding that those left behind will be rendered irrelevant. "It is a digital space which is huge, which sometimes has no rules. We started off with Microsoft, now we are using Artificial Intelligence. How much can we apply that? So, this is the dilemma we have, those who will control that space and probably play the music for those who want to dance, will control the world," said Kisiang'ani.

The PS pointed out that the government has embarked on the process of training citizens to improve on their digital literacy skills that can make them relevant in the ever-changing world.

"The development of the 100,000 km of fibre optic infrastructure is going to be used by learning institutions and health facilities. It will

also be used by people in the agriculture industry, but it will also be used by those in the creative sector," added Kisiang'ani.

He further noted that the world is at cross roads on how to use the ever-evolving technological advancements, calling on all stakeholders to regulate themselves so as to get maximum benefits out of these developments.

KoTDA Ag. CEO John Paul Okwiri noted that the proposed Konza Digital Media City and Konza National Data Center, that are to be implemented by the Ministry of Information, Communications and The Digital Economy as a priority for Phase 3 of the greater Konza Technopolis are exciting initiatives that aim at bolstering the creative sector's growth and thereby positioning Kenya as a regional hub for creative innovation.

Okwiri acknowledged that the society has embraced the new normal owing to access to smart phones and other technological innovations dominating the professional world.

## Busia hospital unveils new surgical wards at a cost of Sh100m

The Busia County administration has commissioned surgical wards at the county's referral hospital built at a cost of Sh100 million.

Speaking during the official launch of the facility, Governor Paul Otuoma said, the 100-bed capacity storey building will be a boon to accident victims, patients with chronic wounds, assault cases and those suffering from intestinal obstructions among others.

"This surgical ward will help us move from the 200-bed capacity to 300-bed capacity," he said, adding that it has helped solve 30 per cent of the problems facing the facility.

He, however, took issue with the elevation of the health facilities without considering their capability to provide the required services, adding that it is an issue that should be reviewed.

"I get baffled by those who allow this kind of classification to continue. In my view, classification means you have fulfilled the requirements for you to be admitted at the level that you want. When you tell people that the facility is Level Five yet it is Level Four, we are literally lying making people

seek services that are not there," he said.

Consequently, the Governor directed the County Human Resource Management Advisory Committee to be activated to ensure it provides solutions to the problems facing the health sector.

DrOtuoma further disclosed that plans are underway to expand Busia County Referral Hospital to ensure a one-stop provider of services to the locals, adding that Busia Vocational Training Centre will be relocated to create space for the purpose.

The Governor urged the local residents to register with the National Hospital Insurance Fund, adding that the insurance capitation at the facility was still low making it difficult for it to offer the required services.

At the same time, he assured Community Health Promoters that their outstanding dues will soon be paid.

Busia Acting County Commissioner Kipchumba Ruto said completion of the surgical ward was a milestone for the County Government on matters of health.

## Tana River mango growers to benefit from state's plan to expand fruit plant

The Government has assured mango farmers in Tana River County of its commitment to give a new lease of life to the Coast Development Authority (CDA)- run Integrated Fruit Processing plant in Holo.

The plant crushes 1,200 tons of mangoes every year yet mango production is much higher, hence the need to expand it.

The mango pulp from the plant, christened Tana Gold, is patented and CDA sells it to locals and major juice-producing companies. It also provides market outlets for local farmers through direct purchasing of raw mangoes from local farmers, reducing post-harvest loss.

Tana River is one of the major mango-producing counties. But besides mangoes, the plant can crush other fruits including pineapples, watermelons, and

tomatoes for both local and international markets.

The plant has a honey-processing component that can refine and package semi-refined honey. It also undertakes water bottling for local consumption during fruit-low season. The Cabinet Secretary, the Ministry of EAC, ASALs, and Regional Development Ms Rebecca Miano

said the project is progressive and will benefit small-holder farmers in the Coast region.

She assured CDA that they have embarked on a resource mobilization mission together with PS for ASALs and Regional Development Dr. Idriss Dokota for the expansion of the plant.

"The fruit processing project expansion will be of

benefit to the county and the areas that it serves. The Board has discussed the project, and we are looking at expanding it. I have been informed that right now it is not crushing all available fruits, just because of a lack of resources to expand it," she said.

CS Miano noted that CDA is implementing a number of projects, including a building blocks project to participate in the national housing project.

"We have a whole menu of projects here and more importantly, we are discussing resource mobilization because having projects alone is not enough.

"We need resources, we need human projects' execution managers, so we are putting our house in order so that we can deliver some of those priority projects," the CS said during the inauguration of the newly appointed CDA board members in Mombasa.

## Chebyuk project to offer reliable water to thousands

The Chebyuk-Kibabiimega water project in Bungoma county funded by the National Government through the Ministry of Water, Irrigation and Sanitation is expected to provide reliable water supply to Mt Elgon, Sirisia, Kanduyi, and Kabuchai Constituencies.

Speaking during a site visit by the Service Delivery Unit team led by Bungoma County Commissioner Thomas Sankei, Eng. Samuel Onzere explained that the project when complete will also serve Kibabii University and several schools across the county. Eng. Onzere confirmed that the project has a harvesting capacity of 4000 cubic metres of water every day adding the facility will be ready for use before the end of this year since the treatment plant has been completed.

"We have water coming to the inlet chamber from the intake in Mt Elgon Forest and it will undergo a treatment process so that it is ready for use once it leaves the plant," Onzere added.

Onzere said the project is set to benefit over 86,000 households besides Kibabii Univer-

sity and surrounding schools.

The team also visited the Kopsiro Community Water Supply Project located in the Mt Elgon sub-county under implementation by Lake Victoria North Water Development Agency, in partnership with the County government of Bungoma.

Kopsiro Water Project has the capacity to serve 3,000 people without strain.

"This project was started in 2019 but stalled due to contractual issues. However, it is set to be revived within the next two weeks," he said adding that it has the potential to benefit 3,000 people and 50 institutions when completed, and up to 8,000 when rationing is done."

The County Commissioner urged residents of Mt Elgon to be patient and give the engineers time to complete the project.

The inspection team later proceeded to Misikhu-Naitiri/Nzoia Bridge Brigadier road, under the Kenya Rural Roads Authority (KERRA) and instructed contractor to fast-track its tarmacking.
