

The Government will employ 1300 TVET trainers to address the shortage being experienced in Technical Vocational Education and Training (TVET) institutions as it challenges the institutions to offer demand-driven programmes.

Education Cabinet Secretary (CS) Ezekiel Machogu in his speech read by TVET



Youth Affairs, Sports and the Arts Cabinet Secretary (CS) Mr. Ababu Namwamba has said Kenya is ready to host the World Safari Rally Championships (WRC) competition for the third time in a row.

Speaking at the Service Park in Naivasha, while on an inspection tour of the venue which will be the nerve Centre of the rally, Mr. Namwamba said this year's event was historical as it also marks 70 years since the WRC was first launched in the country.

The CS also directed TVET institutions to design demand-driven programmes that shall bridge identified skill gaps in the ever-changing labor mar-

To prepare TVET graduates for a globally competitive labour market, TVET institutions were urged to benchmark, collaborate and partner with other top institutions in the world to result in internationally recognized programmes relevant to both local and international labour mar-

The CS said plans have been put in place to start rolling out the Competence Based Education and Training, where TVETs will train

with the industry on a 50-50 basis.

The CS appealed to the Kenya Association of Technical Training Institutions to re-organize TVET training to Competence-Based Skilling and to identify international institutions to collaborate in offering the courses.

Through such collaborations, the CS said TVET trainees will, upon graduation, obtain dual certifications and will have a competitive advantage to seek employment globally.

The Kenya Coast National Polytechnic, the largest TVET institution in the entire Coastal region was extolled for consistently nurturing a skilled labour force that matches the market requirements since inception.

The premier institution has registered an increase in the number of graduands from 1339 last year to 1811 out of whom 1033 are female. KCNP is helping grow other TVETs in Kwale, Mombasa, Kilifi, and Lamu counties.

The Government, through Kenya Coast National Polytechnic in collaboration with the World Bank is building a Maritime Centre in Kwale under the East Africa Skills for Transformation and Regional Integration Project. The project is designed to address skills shortages and mismatches in East Africa.

Utilize digital skills laboratories to acquire online jobs, CS tells youth

The youth have been urged to utilize Government investments like the Jitume Labs at TVET institutions to acquire skills on the digital economy and enable them access credible digital jobs.

Speaking during the launch of Jitume Centre at the Eldoret National Polytechnic (TENP), Information, Communications and The Digital Economy Cabinet Secretary (CS) Eliud Owalo said the Government through the Jitume program, is looking forward to train youth on ICT skills using existing TVET institutions so as to create a critical mass of skilled labour to support and benefit from the digital economy.

"The Jitume Lab project seeks to address issues of connectivity, device access and digital skills, as well as job opportunities targeting

the youth countrywide," he said.

The CS pointed out that the Jitume centres will have two main programs: the Jitume class training component that aims at providing enhanced training on skills for the digital economy. This program will feature a physical and virtual program delivery component supported by partners.

The other program is Jitume Kazi, which is a work hub that provides a conducive environment for access of digitally-enabled jobs, sourced locally and internationally through identified partners, in a bid to address the high unemployment rate in the country.

"My message to our youth today is this, the digital economy train has left the station, be part of our aspiration. The opportunities in digital world are immense. I encourage you, to take advantage of the initiatives – Jitume – Class, Jitume – Kazi and be a part of the over one million youth, who will benefit in the next three to five years," added Owalo.

He noted that the Jitume project seeks to equip the youth with digital skills to support the Kenya National Digital Master Plan (2022–2032), which envisages training ICT skills of over one million youth to enter the job market annually.

Additionally, the training of the many young people who are unable to access training facilities on ICT and other vocational areas will support the rapid adoption of ICT in business.

The CS affirmed that the Jitume labs have been opened at TVET institutions so that they can benefit from the already existing governance system.

The labs, he added, have been integrated into TVETs, Constituency Innovation Hubs and other existing institutions. He indicated that each Jitume Center will have up to 100 Virtual Desktop Infrastructure (VDI) with broadband connectivity, reliable power, and a security.

Marsabit farmers receive Sh28 million animal feeds from government

The national government has started disbursing livestock feeds in aid of farmers afflicted by drought in all the four constituencies of Marsabit County.

Through the Regional Development, Asals and Special Programs Ministry, the government has purchased 11,200 bags of livestock feeds which is expected to help local pastoralists in mitigating against the current severe drought.

Speaking during the launch of the exercise at the county headquarters on behalf of the CS in charge Rebecca Miano, Marsabit acting County Commissioner David Saruni said 2,800 families are targeted in the exercise across in the county.

The households are expected to receive four bags of 50 kilogram each being the allocation for the month of February.

Mr Saruni said the government with the help of development partners was committed to assist the populations affected by the prolonged drought which has so far led to the death of 45 per cent of livestock in Marsabit County.

The County Commissioner disclosed that Laisamis constituency has already received It's share while that for North Horr was in progress.

Allocations for Moyale and Saku constituencies were also in the process of disbursement.

He added that through the food for fees to schools, the government had so far managed a 89 per cent transition to secondary school of last year KCPE candidates.

"We are working on ways to address challenges that include drought which have kept the remaining number away from class so that they can also transit" he said.

DRAFT PUBLIC FINANCE MANAGEMENT (AMENDMENT) BILL, 2023

Article 201 of the Constitution provides of principles of Public Finance and among them is that, "there shall be openness and accountability, including public participation in financial matters".

The National Treasury identified gaps in the operationalization of Articles 187 and 189 of the Constitution on transfer of function between the two levels of Government and cooperation between the National and County Governments.

Accordingly, the National Treasury and Economic Planning constituted an Inter-Agency Taskforce to develop a legislation for operationalization of Articles 187 and 189 of the Constitution on transfer of functions and cooperation between national and county Governments, respectively. The Taskforce comprises of members from the National Treasury, Controller of Budget (COB), Intergovernmental Relations Technical Committee (IGRTC), Council of Governors (CoG), Commission on Revenue Allocation (CRA), Office of Attorney General (OAG), State Department of Devolution, Kenya Law Reform Commission (KLRC) and Parliamentary Budget Office (PBO).

The interagency has finalized preparing the Draft Public Finance Management (Amendment) Bill, 2023, which seeks to amend the Public Finance Management Act, 2012 and the Intergovernmental Relations Act, 2012; and to fully operationalize Articles 187 and 189 of the Constitution on Transfer of Functions and Cooperation between National and County Governments.

The objects and purpose of the Public Finance Management (Amendment) Bill, 2023 is to provide for: -

- Financial management of cooperation between national and county government or among county governments including planning, budgeting, accounting & reporting and oversight;
- Financial Management of Transfer of Function between national and county governments including planning, budgeting, accounting & reporting and oversight; and
- clear mechanisms and procedure for establishment of Joint Authorities and Committees and administrative structures for cooperation between national and county governments and among county governments.

BY JUDY MUGUONGO (KNA)

ounty governments have been urged to establish HIV/AIDS kitties so as to boost funding and enhance Kenya's commitment to stop new infections by 2030.

According to the National Syndetic Diseases Control Council (NSDCC), there is need for allocation of more local resources for the management of HIV as external funding is on the decline.

NSDCC Programme officer in charge of Investment Dr.Steve Mutuku urged County governments to domesticate a prototype HIV Management and Financing Bill that will encourage focused resource allocation and also help devolved units 2020/2021 Financial Year,

tap grants and donations from individuals and organisations to accelerate the eradication of HIV/AIDS.

Dr. Mutuku noted that the country spends more than Sh25 billion annually on HIV commodities yet there is a resource gap of more than Sh10 billion every year.

He noted that in the



Kenya contributed Sh12.4 billion towards HIV and STIs management and received Sh35.3 billion from the U.S. President's Emergency Plan for AIDS Relief (Pepfar) and Sh11.2 billion from the Global Fund.

The programme officer noted that Kenya is now a middle-income country, hence the need to prepare for donor transitioning.

He noted that counties have a major role to play by establishing the HIV/AIDS Kitty so as to seal the gap.

Dr Mutuku said more resources are needed for the country to ensure effective testing, treatment and suppression of viral load.

He noted that some counties have been allocating funds for the management of HIV in their annual budget, but the money is never spent due to lack of legal instruments.

He said counties should move with speed to enact the HIV Fund Act, which will allow them allocate monies and spend it on STI and HIV management.

"Countrywide, we have Kakamega County which has successfully adopted the HIV Fund Bill and it has been able to attract a grant of Sh200 million from US-AID," he said.

Nakuru County, Austrian firm in partnership to resolve garbage menace

¬he Nakuru County Government has unveiled a plan to turn solid waste at dumpsites across the County into useful by-products such as organic fertilizers.

Nakuru County Executive Committee Member (CECM) in charge of Water, Environment, Energy, Natural Resources and Climate Change Dr Nelson Maara said the County Government is committed to resolving the garbage problem afflicting the residents.

Other materials like glass, paper, plastic and metals will be recycled if a deal is reached between the devolved unit and an Austrian firm, Komptech.

During a meeting with the Komptech firm's Chief Executive Officer Mr Markus Maierhofer at the county headquarters, the CECM

noted that the county stands to increase its revenue base and create more jobs besides improving health and sanitation to millions of the residents once the deal is sealed.

Maara disclosed that the County Government had

commenced talks with the investor, but added that they were yet to settle on the cost of the project, assuring residents that all solid waste would be transformed into useful items including organic fertilizers.

Acknowledging that the

County population was growing at a rate of between 7 to 10 per cent per year, which he said translated into increased solid waste, Maara said the County will continue facilitating the formation of solid waste management associations which comprise private waste service actors to enable them effectively manage waste at the site.

He regretted that rapid urbanization, improved economic situation and industrialization had transformed solid waste management into one of the greatest challenges facing major urban centres in

Maara, however, underscored the need for placing a special emphasis on the potential of conversion of waste into organic fertilizer to bring positive change and wealth into communities.

"We need innova-Rapid urbaniza tion has made solid waste management a major challenge facing towns-CECM

tive technologies and approaches that change the way we think about, use and treat solid, liquid, domestic, industrial and commercial waste. Nakuru needs to explore the 5Rs of rethinking, refusing, reducing, reusing and recycling to transform waste to wealth," he said.

The CECM added that from innovating waste management through the 5Rs, Nakuru could resolve not only the challenge, but also create employment, promote economic growth, improve health and ecosystems which in turn contribute to a happier, greener and healthier county, and can create enormous savings for the devolved unit.

Komptech CEO, Maierhofer indicated that his firm will provide the necessary solid waste recovery equipment and train workers on machinery operations before handing over the processing plant to the county government to manage.

He said the project once fully operational will generate revenue for the county administration and create job opportunities in the circular economy while providing a lasting solution to the Giotto Dumpsite.

Barwessa farmers benefit from multi-million irrigation project

community in Barwessa, Baringo North Sub-County, has beaten all odds to produce beans by irrigation farming in an area currently experiencing a biting drought, helping them to mitigate the effects of the current drought and famine in the region.

In the past few months, the community has slightly changed the face of the area, by practicing irrigation that has led to an increase in food production for improved livelihoods.

Kiptolelyo Self-help Group farmers in Kapluk Sub-location are celebrating a bumper harvest after a successful planting season that started during the dry spell in September 2022 to February 2023 with over 1,000 kilograms of 'Nyota' beans.

Job Kibet, a farmer, who

owns a kiosk said that 'Nyota' beans took a shorter period to reach maturity and once they harvested, the community bought them since they were sold at a cheaper price of Sh130 per kilogram compared to Sh150 the current market price.

"When we started the project, we did not expect to harvest much but with the support of J. Almacis, we have managed to harvest enough for consumption and for sale. So far, we have sold over 500 kilograms of beans and the remaining will be sold out by the end of the week," he said.

The efforts are supported

The efforts are supported by an Italian private company J. Almacis under the Italian Agency for Development and Cooperation, who gave 20 farmers a Sh. 2.5 million loan as capital with an agreement to repay only 25 per cent of it since it was a pilot project.

In addition to capacity building, J. Almacis has also installed a complete irrigation system using solar energy, to enable farmers to pump water to their farms using a nearby stream as their source of water, which has enabled irrigation of 20 acres of land.

Mary Chesang, another

farmer lauded the project, saying they had signed an agreement with the Almacis group, which stated that some of the produce would be taken to the nearby primary school, to assist children by providing meals, adding that availability of water in their homesteads has enabled them save time they used going to the stream to fetch water and that the cases of water borne diseases have reduced due to high levels of hygiene.

Residents have expressed joy saying the beans sold by the group are cheap in addition to the fact that they are easily available in their locality unlike before when they could travel long distances to buy them in town.

"I am very grateful to the J. Almacis group for starting this project since this area is arid and semi-arid and so dry, I cannot imagine that now in February, we are purchasing beans at Sh130 per kilogram unlike in other areas," said Monica Cheboi.



NMK's new War Museum to promote battlefield tourism

The Government, through the National Museums of Kenya (NMK), is constructing a Sh68 million stateof-the-art World War 1 Interpretive Center at Maktau in Taita-Taveta County to promote the history of war and battlefield tourism in Africa.

The construction is being regarded as the first deliberate step towards formal recognition and honoring of thousands of Africans who participated in the First and Second World Wars.

"The Africans were central to the war yet they have never been fully appreciated for the critical role they played. They were the hands and boots that brought victory," says Mr. Willy Mwadilo, a World War 1 historian and a battlefield tourism expert.

Dubbed as WW1 Interpretive Center, the facility will be a memorial for thousands of Africans who lost their lives and be home to priceless war artefacts recovered from battlefields scattered across the county.

The Maktau Center will also serve as the main repository of WW1 accounts in Kenya and a key platform for amplifying the roles Africans played in the battle.

The NMK acting Director General Mr. Stanvas Ongalo states the WW1 Center will be pivotal in entrenching the Africans' involvement in war narratives in addition to documenting other unknown contributions to the history of world wars.

"The wars were historical events with global significance but Africans' roles have not been as prominent

as other actors. This Center will be a commemorative facility where tourists will visit to get the true picture of Africans' involvement in battle," he said. The Center, which is funded by the Tourism Fund Kenya, has a modern exhibition room, a gallery and other administrative offices.

The location of the center at the remote wind-swept, sun-scorched village of Maktau tucked at the edge of Tsavo West National Park is not by chance. Though dusty, dry and prone to frequent human-wildlife conflict, Maktau village might appear no different from many other rural settlements scattered across the country. However, this village holds a special place, not just for WW1 but also in the aviation history of Kenva.

State to fund initiatives to mitigate impact of climate change in Kitui County

itui County is set to benefit from Sh 120 million from the national Government to help implement projects to mitigate the effects of climate change.

A Deputy Director in the Ministry of Environmental, Climate change and Forestry, Mr. Samuel Muchiri said the funds will be drawn from the Ministry's climate change fund kitty.

Muchiri was speaking at the Kitui County headquarters when he led a team of officials from the Climate Change Directorate (CCD) in the Ministry on a visit to Governor Julius Malombe's office in Kitui town.

They were received by the Deputy Governor Augustine Kanani who briefed the team on the Strengthening of Drought Resilience for Small Holder Farmers and Pastoralists (DRESSEA) Pro-

ject which is set to be implemented in the county.

Muchiri said the Sh120 million initiative will also involve establishment of appropriate warning systems to provide residents with precise weather forecast data for appropriate plan-

"Besides implementing water projects, this project will also promote adoption of pottery, beekeeping, poultry keeping and making of energy saving stoves, briquettes and interlocking bricks for the benefit of the affected beneficiaries," he

The Deputy Governor appreciated the national government for selecting Kitui to benefit from the Sh300 million climate adaptation grant.

He said the project will greatly supplement the County Government's efforts to mainstream climate change adaptation and mitigation measures towards alleviation of the severe climate change impacts on communities in Kitui.

Kitui County is among other 23 counties across the country that have negatively been impacted by climate change resulting in failure of rains, and occasioned the failure of

food production by smallscale farmers in the county.

The county has adopted several national policies geared towards adapting to climate change and its associated risks.

These policies provide information to farmers, enabling them to plan, make viable economic decisions, and adapt to anticipated climatic risks.

According to recent reports by the National Drought Management Authority (NDMA), 11 per cent of the Kitui population is experiencing food shortage, consuming one or two meals per day.

NDMA reports indicate that an upwards of 126,188 residents, majority from the marginal mixed areas of the county, are starving and need urgent food aid.

The report further adds that the shortage of pasture for livestock in the county is forcing cattle farmers to sell off their livestock at throw away prices.

The project will supplement the implementation of the climate change adaptation strategies by the ministry will help reduce the number of people and livestock suffering from drought in the county.

Marsabit County Drought Management Authority (NDMA) Coordinator, Henry Mustafa, said the severe drought has left 309, 176 people in the county food insecure and who are in dire need of food aid.

He added that there has been rain failure for five consecutive seasons in the county adding that the situation could be worse after rain projections showed that no meaningful rainfall was expected this season.

Mr Mustafa, however said that plans by the government to continuously avail emergency relief food and water to those reeling under famine were in place.

Also, the coordinator disclosed that 1,600 students in 80 secondary schools were being assisted to pay tuition fees through the food for fees arrange-

Mr Mustafa said children under five and now the rest of the population across the county were severely malnourished owing to lack of adequate and quality food.



Woman's buzzing honey business in Kakamega forest earns her fortune

omen are now taking the lead in projects that have been seen to create a buzz and believed to be associated only with men.

In fact, in some cultures, certain types of work have been seen as a man's affair. But, this is slowly changing as more women venture into the uncharted waters.

One such sector is apiculture, commonly known as bee-keeping.

Agrippina Khakabo from Kakamega County is among the few women who have embarked on apiculture.

She is currently the farmer's representative for Sericulture (production of silk) and Apiculture in Kakamega Forest Honey and Silk Marketplace.

This project was begun in Kakamega Forest by agricultural researchers from the International Centre of Insects Physiology and Ecology (ICIPE), which identified and trained interested farmers in bee keeping and silk rearing.

Agrippina was among

those trained and she reveals that it only took three years for sericulture before it collapsed.

Since then, Kakamega forest farmers only practice bee keeping and honey rearing.

Currently, 300 bee farmers are registered under the Kakamega Forest Honey and Silk project.

"Kakamega Forest has a diverse species of flowers, which are best known for their high herbal medicinal value," he says.

Agrippina also revealed that bees reared in Kakamega Forest produce exceptionally sweet and highly medicinal honey as a result of feeding on Kakamega forest flowers.

Farmers under this project practice both stingless bees and honey bees rearing.

However, Agrippina's interest majorly lies in the

stingless bee rearing.

"Honey produced by stingless bees has a high medicinal value as compared to honey produced by ordinary honey bees" she says.

There are three major groups that are currently practicing stingless bee rearing in Kakamega forest, with one group rearing up to 100 beehives.

Individual farmers have however shown interest too, to join the venture.

"Stingless bee honey is highly medicinal as it can heal various diseases like wounds, ulcers, diabetes, high blood pressure, congested chests, gums swellings, throat sores among many other diseases," Agrippina told Kenya News Agency (KNA).

The Kakamega stingless bee farmers package their honey in 500 milliliter bottles whose retail price is 500 shillings.

However, she brings to our attention that bee rearing is not all rosy. It comes with its challenges, some of which are long-term.

One of the challenges faced is that the recommended bee hives are way too unaffordable for farmers.

"Longstroth beehives are

the best. They are designed in a manner that allows beekeepers to easily inspect and manage their hives without disturbing the bees too much," reveals Agrip-

"However, one longstroth bee hive can cost as much as ksh.5000, which is quite expensive for our local farmers, "he added.

Rains that are as a result of the proximity of Kakamega Forest is also one of the prevailing challenges for bee farmers in Kakamega.

Too much rain lowers honey production as the bees are forced to stay indoors instead of going out to feed.

Agrippina has urged well-wishers and potential sponsors to come forward and provide support to the farmers so as to enhance productivity.

Currently, the honey reared is marketed locally due to the low production

rate, which can barely sustain an internaStingless bee honey is

medicinal and heal various diseases like wounds, diabetes-Khakabo tional market.

She also advises interested individuals to plant flowers and have water sources nearby to prevent bees from travelling long distances in search of food and water.

She advises farmers to be opening their hives frequently as it creates a friendly environment for the bees and their surroundings, preventing them from becoming aggressive and wild.

Beside training and awareness, the government and partners have also provided linkages to encourage more farmers to rear stingless bees and boost rural incomes and forests' conservation.

"Bee keeping is a sustainable and profitable enterprise that offers a myriad benefit to both the bee keeper and the community," she said as she urged more individuals to practice apiculture. Bee keeping is not just a hobby for Agrippina, but a crucial practice that contributes to the wellbeing of the community.

Bee keepers play a significant role in pollinating crops and plants, thereby ensuring food security for humans and maintaining a healthy ecosystem for all living beings.

State unveils roadmap for better access to primary healthcare

The Ministry of Health has launched the Rehabilitative Services and Assistive Technology Strategy 2022-2026, Disability Medical Assessment and Categorization Guidelines 2022, and the AT scale Project.

The Rehabilitative Services and Assistive Technology Strategy 2022-2026, developed in collaboration with Clinton Health Access Initiative and other stakeholders, envisages for increased access to care up to the primary healthcare and community levels by developing infrastructure, building human resource capacity, and providing equipment needed for rehabilitation services.

Speaking during the launch at a Nairobi hotel, Eng Peter Tum, the Principal Secretary for Medical Services, emphasized the need for extensive healthcare services to support the increasing number of Kenyans living with disabilities, which is estimated to be 0.9 million or 2.2% of the population.

"We are excited to see the impact these initiatives will have on the lives of Kenyans living with disabilities, and we remain committed to providing oversight and guidance to ensure their

success," said Tum who was represented by Dr. Zeinab Gura, Acting Director, Health Care Services.

The PS said the Ministry of Health is committed to prioritizing the provision of rehabilitative

services by reviewing the harmonized benefit package to include the rehabilitation package, developing the list of essential assistive technology, and streamlining the training of human resource for rehabilitation

'We are excited to see the positive impact these initiatives will have on the lives tive impact these of Kenyans living with disabilities," said Tum.

The Disability Medical Assessment and Categorization Guidelines were developed to guide the appropriate and timely identification and categorization of disabilities. The guidelines bring services closer to Kenyans through decentralizing the validation of disability assessment to the County Directors of Health.

The ATscale Project, a three-year project geared towards supporting capacity building, strengthening supply chain for assistive technology, sustainable financing, development of policy and guidelines, enhancing infrastructure, data, and systems, enhancing demand generation, and program coordination, will also be implemented.

Chief Executive Officer (CEO) from the council of Governors Mary Mwiti stated that a majority of people with disabilities are the elderly and those with chronic diseases.

The challenges noted by the Council of Governors include insufficient data with no accurate statistical information on the no of PWDs, causing unequal distribution of resources,' said Mwiti.

She added that the Council of Governors plays a major role in ensuring County contribution towards PWDs and urging cohesiveness between the government, private partners and stakeholders.

Mandera County begins second phase of food distribution

Mandera County has begun its second phase of food distribution in the entire county.

The relief intervention is expected to cover 60,000 households across 30 wards and 517 centres, including Vulnerable Households, People with Disabilities (PWDs), and Internally Displaced persons (IDPs).

While launching the food distribution, Mandera County Governor Mohamed Adan Khalif promised that distribution would be effective and it would reach those who needed it most.

The Governor said the County has conducted accurate assessments of the needs and vulnerabilities of different populations and decided to use targeting mechanisms that prioritize the most vulnerable groups, such as children, pregnant and lactating women, elderly people, and people with disabili-

The governor also acknowledged that as a county, they were exhausted and appealed to national government and developmental partners to chip in before situations worsens.

According to the February 2023 short rains assessment report by National Drought Management Authority, the population facing acute food insecurity and requiring humanitarian assistance has increased to approximately 550,000.

NDMA Coordinator Mandera County, Hussein Idhoro, added that the prolonged failure of rains for five consecutive seasons has resulted in inflated prices of foodstuff, rendering the community unable to afford necessities.

In Mandera, the worst hit areas are Mandera West Mandera South and Banissa constituencies.

Ministry of Tourism, Wildlife and Heritage Cabinet Secretary, Penina Malonza, has called for concerted efforts amongst communities neighbouring the country's wildlife heritage for bolder actions and more effective partnerships to protect endangered animals and plants.

Speaking during this year's World Wildlife Day celebrations held at Amboseli National Park, Malonza said the Maa community has co-existed cordially with wildlife for long which should be emulated by other communities neighbouring game reserves.

Malonza further pointed out her Ministry has a paradigm shift in its wildlife programs by incorporating communities neighbouring national parks in conservation programs. She said this incorporation is crucial in enhancing cordial relationships with wildlife, hence lessening human-wildlife conflicts

"The Ministry in its program has incorporated provision of relief food and water for the local communities neighbouring national parks as well as fodder and water for wildlife as drought continues to bite," noted Malonza.

She said this program will continue until the prevailing dry spell and drought come to an end, adding that the role of animal conservation cannot be fully realised without input from other key stakeholders and aided the key players in the sector of Tourism who have so far contributed immensely up to date.

To cushion wildlife and the local community neighbouring Amboseli National Park against the prevailing dry spell, Malonza observed that her Ministry will drill two boreholes; one inside the national park for animals and the other outside for the local community.

On a request from local residents that the Ministry source for a market for their bracelets, the CS said plans are underway for the Ushanga Initiative to showcase and market the bracelets.

However, she warned business operators against exploiting locals by buying local commodities at very low prices and exporting them at very high prices, hence making exorbitant profits.

Government releases Sh2b to cushion famine stricken families

¬he Government has released Sh2 billion to cushion about six million people facing famine country-wide as the effects of the ongoing drought continue to ravage livelihoods in the country.

The Cabinet Secretary for East African and Arid and Semi-Arid Lands (ASALs) Rebecca Miano said the Government has already kicked off the procurement of relief food which will be distributed to vulnerable households in all the affected areas country-

"We are scaling up various drought response interventions in line with President William Ruto 's commitment to rally the Government and partners in mitigating the impact of the deteriorating drought situation," the CS said.

She pointed out that the National Drought Management Authority (NDMA) is providing livestock feed supplements and implementing water related interventions with funding from the National Drought Emergency Fund (NDEF) and the European Union (EU).

"Cumulative effects of previous successive below-average rainfall seasons has led to depletion of pasture and water in most ASAL counties, which has resulted in poor livestock body condition and widespread livestock mortality," CS Miano said.

Miano added that NDMA is set to dispatch 60,480 bags (50kilogrammes) of livestock feed supplements worth Sh145 million to eight ASAL coun-

She added that Kitui, Makueni, Kajiado, Marsabit and Isiolo counties have already benefited from the feeds while the process is currently ongoing in Mandera, Wajir and Nyeri.

The feeds target livestock left behind as the larger herds migrate in search of pasture and water. "These herds provide milk for families, which contribute significantly to the nutrition status of vulnerable groups such as children below five years, pregnant and lactating women," the CS said.

On water crisis being experienced, CS Miano said NDMA has supported water trucking, provision of water tanks, provision of fuel subsidy to strategic boreholes, repair and

Counties encouraged to invest in Konza Technopolis

ICT and The Digital Economy PS John Tanui has rallied Makueni, Machakos and Kajiado county governments to invest in Konza Technopolis since the Kenya Vision 2030 flagship project has immense potential to transform the socio-economic wellbeing of residents.

Speaking during a stakeholder meeting on the Konza Technopolis Buffer Zone Inter-County Physical and Land Use Development Plan, Eng Tanui advised the three host counties to leverage on the ultra-modern ICT infrastructure at the smart city to enhance service delivery.

He particularly invited the counties to take keen interest in the National Data Centre and the Kenya Advanced Institute of Science and Technology (KAIST) which are being set up at the 5,000-acre facility.

"We are looking forward to seeing how the three neighbouring counties can start engaging and what role they have in the institution (KAIST). It is important that the county governments see how they can leverage that

investment," the PS said.

On the buffer zone, Eng Tanui said his State Department, through the Konza Technopolis Development Authority, was determined to ensure the 10-kilometer stretch was properly planned so as to attract appropriate investments.

"Konza has been well planned. It is important that the 10-kilometer buffer zone is equally planned so that we extent the investment and attract investments from across the world.

"The 10-kilometer will add us another 68,000 acres of land so that we have an overall 73,000 acres of land in our urban plan development," Eng Tanui told the stakeholders led by Kajiado Governor Ole Lenku.

He thanked the host counties for their continued backing of national government efforts aimed at ensuring the buffer zone is properly planned.

"Last year we held sessions which resulted into the signing of an MOU which you were part of, and which was signed by various ministries supporting this agenda," the PS said noting that the smart city was registering tremendous progress.

We are impressed that from an initial population of less than 20, Konza has been able to attract over 3000 people working and building Konza Technopolis," Eng Tanui said.

He assured that the National Government was determined to fasttrack the completion of technology city, dubbed Silicon Savanna, to become anchor of Kenya's innovation, technology and knowledge

Konza Technopolis Buffer Zone Inter-County Physical and Land Use Development Plan was prepared in 2013 by the Ministry of Lands, Housing and Urban Development for purposes of promoting guided development as well as safeguard investments in the Kenya Vision 2030 smart

Besides Governor Ole Lenku, the meeting was also attended by Makueni Deputy Governor Lucy Mulili and Dr Augustine Masinde from the Ministry of Lands and Physical Planning among other stakeholder representatives.

New inpatient unit commissioned at Chepkorio Health Centre

During the commissioning, Elgeyo Marakwet County Governor, Wisley Rotich noted that the laboratory is fully equipped which will make diagnostics easier as residents no longer have to travel to Iten and Eldoret for manageable diseases

He noted that they are in the process of upgrading the facility to a sub county hospital to help people save on cost as more services will be available at the hospital.

The Governor reiterated that drugs will always be available at the facility as the county has introduced a revolving pharmacy in

partnership with Ampath, making it possible for the hospital to have drugs even after KEMSA supplies ran

Governor Rotich noted that all health facilities are supplied with drugs from KEMSA after every two months and added in case the supplies run out that is when the revolving pharmacy kicks in making it impossible for facilities to be without drugs.

He asked residents of the region to make use of the facility and reiterated that the maternity wing is one of the best since it has been upgraded.

Rotich gave a stern warning to health workers who do not report to work that they will face disciplinary action after the grievances they had were taken care of and added there is therefore no reason for them not to report to work.

Keiyo South Sub-County Deputy County Commissioner, Diana Wekesa appreciated the devolved unit for their initiative of putting up the wards and laboratory thereby reducing the distance and time travelled by patients to Iten and Uasin Gishu County to seek for medical services.

Ms Wekesa urged residents to come make use of the infrastructure that has been put up in the health facility. She noted that by using the facility, the government will also take note of the gaps and find ways of filling them, making services provided more effec-

State enacts digital jobs plan for youth

Government, through TVETs, seeks to train over a million young people on accessing online employment and opportunities

hat the future of work is online, and most likely on the mobile phone, is no longer deniable.

This is a fact that the government has acknowledged and has stepped up efforts to create online jobs and opportunities, especially for the youth at the grassroots.

In its latest undertaking, the government is setting up labs in Technical and Vocational Education and Training Institutions (TVETs) across the country under a programme dubbed Jitume targeting to create over a million jobs in three to five years.

The State-backed initiative that is designed to equip vocational learners with technology-

related courses for free, seeks to establish over 23,000 virtual centres known as Jitume Labs as part of the Bottom Up Economic Transformation Agenda.

The initial phase of the programme will see two centres set up in each of the 47 counties by June, according to the Information, Communications and Digital Economy Cabinet Secretary Eliud Owalo.

President William Ruto launched the project at Kabete National Polytechnic in December 2022.

And last week, Mr Owalo launched the first regional Jitume laboratories in Uasin Gishu CONTINUED ON PAGE 2



State steps up efforts to create online jobs

and Bungoma counties.

In Bungoma, the minister inaugurated the lab at Matili Training Institute in Kimilili sub county, noting that Jitume programme complements other online youth empowerment initiatives such as Ajira Digital.

"ICT is at the core of the country's economic transformation agenda thus Jitume programme seeks to address issues relating to connectivity of devices and digital skills as well as offer job opportunities to the youth," he said.

The minister noted that the government chose to set up the labs in TVETs because of the infrastructure they have and the hundreds of learners they attend to.

"Our main aim is creating a critical mass of skilled labour to support and benefit youths from the digital economy." he said.

"Many young people are unable to access training facilities and this is the gap the programme is seeking to address," he added.

He observed that each Jitume Lab has 100 virtual desktop infrastructure with broadband connectivity, reliable power and a security coordinator.

At the centres, the youths are receiving

online and physical training offered by the Konza Technopolis, which is running the programme, aimed at providing skills for the digital economy.

"The second component of the project is Jitume Kazi, which is a work hub that offers the youth a conducive environment to access online jobs. This is a collaboration between ministries, including ICT, Education, Labour, Foreign and Diaspora Affairs and various implementing agencies including ICT Authority, TVET Authority and Konza Technopolis," he said.

In Uasin Gishu, Jitume Lab was opened at the Eldoret National Polytechnic.

"My message to our youth is that the digital economy train has left the station, be part of our aspirations. The opportunities in digital world are immense. I encourage you to embrace this initiative to be a part of the over a million youth, who will benefit in the next three to five years," said Mr Owalo.

According to Mr Owalo, over 17 Jitume labs have already been set up and connected across the country.

Skills gained from the training, according to Mr Owalo will support the Kenya National Digital Master Plan (2022-2032), which guides the country's quest to become a digital economy.

Training offered to the youth is critical in driving government's digital agenda, which involves taking over 5,000 services online, setting up of 1,450 digital village hubs, 25,000 WiFi hotspots and 100,000km of fibre optic

Konza Technopolis Development Authority (KoTDA) acting CEO John Paul Okwiri said Jitume programme would help build the knowledge economy, with a focus on establishing Kenya as a technology hub in the region.

And the momentum to create more online jobs in partnership with counties through the Ajira Digital Training, which introduces the youth to digitally-enabled work and provides the tools, training and mentorship needed, has not stopped.

In Kericho, ICT executive Judith Chirchir launched an Ajira Centre at the Kericho Moi Gardens, assuring the youth of free digital training, which will be offered in all the six sub-counties.

INFOBOX

The government has identified ICT as one of the major drivers of the economy.

It's digital agenda include provision of 25,000 free WiFi spots at public places, issuance of digital loans, moving thousand of services online and the establishment of 1,450 digital hubs in villages to boost youth employment.

The government has launched free WiFi hotspots at various markets across Kenya including Wakulima and Muthurwa so that traders can use the internet to trade online at the comfort of their stalls.

The government is also keen on setting up the first Open University that would expand learning opportunities online. The government's seeks to leverage on the power of the digital superhighway to ensure the success of its programmes including job

The number of digital hubs in villages that the government seeks to create to boost youth employment and internet use.

"Our trainers are ready to begin the free digital training sessions in all our ICT centres. We thank the national government for providing the skills as county provides the infrastructure," Ms Chirichir said.

Ajira Digital South Rift region coordinator Nelson Mitei said the projects seek to expose the youth to gig economy, especially through major employers such as Upwork, Fiverr, iBuild, Kuhustle, iWriter, Uber, Safeboda, Lynk and Jumia Range.

"They will be taught crucial digital skills such as online marketing and how they can use social media platforms to help local businesses gain traction of customers and by that, they will earn a good income for themselves," said Mr Mitei.

Ajira Digital Programme was launched in 2016 and aims at linking over a million youth annually to work online.

Governors laud increased funding of refugee towns

GOVERNORS JEREMIAH
LOMORUKAI of Turkana and his
Garissa counterpart Nadhif Jama
have welcomed the government's
move to increase funding to
refugee hosting towns in the
upcoming phase of World Bank
funded Kenya Urban Support
Program (KUSP).

At a joint meeting with the State Department of Housing and Urban Development, World Bank and UNHCR officials, Governor Lomorukai said the rise in funding would accelerate efforts in upgrading Kakuma-Kalobeyei municipality and enhance service delivery to the host and refugee communities. He noted that Lodwar had immensely benefitted from the first phase of KUSP through the receipt of streetlights, cabro pavements, demarcated parking lots and fire station. Mr Lomorukai expressed confidence that the special allocation of funds to the refugee hosting towns would equally elevate Kakuma-Kalobeyei and equip the area with social amenities.

Mr Jama, whose county hosts Dadaab camp, said the counties would be able to manage the approximated Sh6 billion over the next five years.

According to Mr Jama, both Kakuma-Kalobeyei and Daadab have witnessed massive environmental degradation, loss of bio-diversity and depletion of underground water resources due to population increase.



Kengen to set up 30 electric vehicle charging stations

"The venture is part of Kengen's environmental and economic sustainability plan to reduce global greenhouse gas (GHG) emissions by inspiring confidence for wider EV adoption," said Mr Muthike.

In December last year, Kengen unveiled its first four electric vehicles in Nairobi in a move to support its diversification ambitions in the e-mobility sector.

The company bought the four vehicles to get first-hand experience and data on electric vehicles.

Kengen will use the cost and environmental data from the pilot study to transition its fleet of vehicles to electric.

Drought kills 2.6m animals in arid areas

In Marsabit, 50pc of the cattle and sheep have been wiped out by the drought while in Kajiado, 40pc of cattle have died

ome 2.61 million livestock have died in arid and semi-arid areas due to drought as the crisis worsens, the National Drought Management Authority (NDMA) has said. The number is about 5 per cent of all the animals in arid and semi-arid areas, which was 52.8 million.

The animals that comprise cattle, goats, sheep, donkeys and camels have died due to starvation mainly in Marsabit and Kajiado, the worst hit counties.

In Marsabit, 50 per cent of the cattle and

sheep have been wiped out by the drought while in Kajiado, at least 40 per cent of cattle have died.

"The most affected counties with abovenormal livestock mortality rates included Marsabit, Kajiado, Isiolo, Samburu, Turkana, Wajir and Mandera," said the drought agency.

According to the institution, pasture in the arid areas is completely depleted worsened by high temperatures.

"This is attributed to the poor performance of the 2022 short rains coupled with four consecutive failed rainfall seasons," said NDMA. The drought situation has continued to worsen in 22 out of the 23 arid counties.

"Acute malnutrition has also been noted across the counties and the assessment is ongoing to determine the cases of children aged 6-59 months acutely malnourished and cases of pregnant or lactating women acutely malnourished in need of treatment,"

The drought situation has been exacerbated by the failed rains over the past years, and with the weatherman having predicted that most parts of the country would receive below-average rainfall between March and May season, the crisis would get worse.

However, the government has ramped up drought mitigation measures, with the CS, Ministry of East African Community, Arid and Semi-Arid Lands and Regional Development, Ms Rebecca Miano, noting that Sh2 billion has been released for distribution of relief food and animal rations. Last week, the US government donated Sh16 billion to support the country's drought relief efforts.

USAID said the funds will help meet the urgent needs of some 1.3 million people.

The food assistance comes amid the ongoing drought that has left more than five million people in the grip of hunger, with the number expected to rise further in the next three months.

Kenya is among countries in the Horn of Africa - the others being Somalia and Ethiopia - that have been hit harder by the drought, which is the worst in 40 years, according to the United Nations Office for the Coordination of Humanitarian Affairs (UN OCHA). Up to 5 million people are facing starvation in Kenya, according to NDMA. ■



I have heard about data protection and data privacy, what's the difference?

The terms are often used interchangeably, but data privacy defines who has access to data, while data protection provides tools and policies to restrict access to the data.

Is giving false information as a data subject illegal?

Providing inaccurate information where you are required under the law to provide accurate information is an offence.

Talk about the major violators of data privacy such as supermarkets, digital lenders and politicians...

The ODPC is currently working on sector-specific directives, which will offer guidance to such entities on how to comply with the data protection laws as they collect data from their clientele. The office is also working on an awareness campaigns to have data controllers and processors appreciate their compliance requirements under the law.

Does one retain the right to data privacy after death?

The scope of the Data Protection Act, 2019, does not include dead people.

Is an entity required by law to seek my consent before sharing my data?

An organisation collecting your personal data is not necessarily required to seek your consent before sharing it. However, it is required to notify you whether the information collected will be shared, and with which foreseeable entities.

Can a government agency, say the Kenya Revenue Authority, acquire and use my data from another agency?

As long as there is a lawful purpose. The Data Protection Act does not prohibit the sharing of personal information where there is a lawful purpose. But a person can seek recourse where the processing of personal data is carried out in noncompliance of the law.

What should guide the information asked from me?

A data collector should ask for information that is relevant or related to the purpose of processing. This will vary based on the processing activity being undertaken.

Is there a way I can help to protect my data?

Ensure you are notified by the entity collecting your data about the following:

- a. That personal data is being col-
- lected.
 b. Your rights in relation to the data
- being collected.

 The purpose of collection.

 The safeguards that the entity
- will adopt to protect your data.
- e. Whether they will share the data with other persons or entities.
- f. The details of the entity collecting your information.

What steps should I take if my data is misused?

The first step is to seek redress from the data collector and if the issue is not resolved, you have a right to file a complaint with the Office of the Data Protection Commissioner via the website, www.odpc.go.ke or physically visit their offices.





Residents plead for bus terminus at floating bridge

Nakuru County adopts climate-smart technologies to cushion farmers

akuru County Government has rolled out a campaign to empower smallholder livestock farmers with climate-smart innovations and technologies to cushion them against climate change challenges including drought, floods, pests and diseases that have adversely affected the dairy sector.

The initiative being conducted in partnership with Kenya Agricultural and Livestock Research Organization (KALRO) and Self Help Africa (SHA), will support activities aligned to climate-smart innovations to ensure livestock farmers adopt climate-smart agricultural practices and technologies aimed at mitigating against the challenges they are currently facing, to help them reduce production costs and boost their incomes.

County Executive Committee Member (CECM) in charge

of Agriculture Leonard Bor said the project dubbed 'Climate Smart Research and Innovation for Livestock Development' aims at ensuring sustainability in the sub-sector where farmers will work with consultants to realise high quality production and also identify ways to process and market their products.

He explained that the programme will work with farmers from five cooperatives in the County to focus on developing and demonstrating new climate smart production systems that increase productivity and profitability.

Speaking after holding deliberations with officials from SHA and KALRO, the CECM revealed that the five-year project (2023-2028) was aimed at strengthening smallholder livestock keepers' capacity to meaningfully engage in Climate Smart Agriculture (CSA), increase their technical knowhow on CSA approaches,

unlock market driven valuechains and improve their capacity to participate in productive land and water management, as well as increase their access to finance.

Bor stated that the venture had been designed to introduce practices and technologies that will be able to support livestock farmers to conduct their activities in a climate-smart way by focusing on environmental conservation alongside dairy farming.

He singled out inadequate pastures, poor markets and bad infrastructure as issues bedeviling the sub-sector and need to be tackled on priority basis to help farmers utilize viable solutions to address the challenges and increase their productivity, profitability and resilience.

Bor regretted that the changing climate has affected the feed and fodder situation in most parts of the country, where production has declined.

Expedite court martial cases, CS urges Judiciary

Major boost for Turkana fishermen as The Netherlands offer Sh 1.53 billion support

Turkana and Marsabit counties will receive Sh 1.53 billion from the Government of the Netherlands to exploit Lake Turkana marine resources which are shared by the two counties.

During a meeting with stakeholders, including officials from Turkana and Marsabit Counties, Dutch Ambassador to Kenya, Maarten Brouwer, announced that his country would invest the Sh1.53 billion for five years.

The Embassy has committed to supporting a co-finance of quick interventions as well as a long-term programme for sustainable development of the value chain.

Mr Brouwer stressed the need to set up food chains that are less vulnerable to climate shocks as the region deals with effects of climate change.

"The fish sector has great potential to help build resilience in the immediate and

long-term. We must see it as part of the government 's strategy to build resilience in areas that are more vulnerable to climate change than others," he said.

A study commissioned by the Embassy to evaluate the economic potential of the fisheries sector in Lake Turkana revealed the existence of enormous potential to contribute to food security. It recommended the establishment of cold chain logistics to allow for the trading of fresh fish and the inclusion of water resource management for sustainable fishing.

The stakeholders learnt that the private sector in Kenya and the Netherlands was ready to engage in solutions to challenges facing the sector.

Governor Jeremiah Lomorukai, in a speech delivered on his behalf by County Executive for Agriculture, Livestock Development and Fisheries David Erukudi, outlined plans by the County Government, including developing a fish processing plant, cool chain facilities and equipment support for the fisher folk.

"The fish processing plant will help reduce post-harvest losses and add value to fish and fish products, therefore increasing the market value of fish products and opening up new markets." he said.

new markets," he said.

He called for support to carry out a fish stock assessment, establishment of solar-based cold chain facilities at fish landing points, and the development of aquaculture as an alternative source of livelihood.

The Principal Secretary for Blue Economy and Fisheries Betsy Muthoni Njagi expressed National Government's commitment to developing the blue economy.

PS promotes uptake of clean energy to curb global warming

Energy Principal Secretary, Alex Wachira, has called for concerted efforts among stakeholders to improve access and use of clean energy to mitigate the growing threat of global warming.

Wachira said global warming has affected many countries by inflicting deprivation, hunger, suffering and death among other ravages of weather.

Wachira said its impact has seen Kenya face the worst severe drought in decades affecting more than 4.2 million people, mostly in the Arid and Semi-Arid regions.

The PS said Kenya has joined other nations in the journey to achieve net zero by 2050 through increased use of renewable energy and promotion of energy efficiency among users.

To actualize this, the PS said Kenya has made key commitments, including enabling 100 per cent access to electricity by the year 2030 and achieving 100 per cent access to modern cooking energy services by 2028.

Wachira said energy efficiency

and uptake of renewable energy can support broader transitions from polluting fuels to cleaner forms of energy in the energy system mix.

The PS called for the adoption of Integrated National Energy Planning (INEP) to help consolidate efforts by government agencies, private sector and development partners in a coherent manner to provide energy services to all Kenyans.

He said INEP plans to champion the status of clean cooking to be a top priority under the energy access at both national and county levels, complete with facilitative budgets for implementation.

Notably, the PS said INEP plans address electricity generation, transmission and distribution, energy access covering electricity and clean cooking solutions, energy resource assessment and development, bioenergy development...

He said the promotion of renewable energy as well as energy efficiency binds Kenya to the Paris Agreement.
