kupikia," alisema.

## CA yaongeza usalama wa mtandao kutokana na visa vingi vya udukuzi

Shirika la Mawasiliano ya Kenya (CA) limeimarisha usalama dhidi ya mashambulizi ya kimtandao. Hii inafuatia ongezeko la visa vya udukuzi kutoka milioni 7.7 mnamo 2018 hadi milioni 444 mnamo 2023, na hivyo kufanya Kenya miongoni mwa nchi tatu za juu zilizolengwa barani Afrika.

Mkurugenzi wa Ukaguzi wa Ndani wa CA, Bi. Rosalid Muriithi alisema, juhudi zinalenga kujenga uwezo kwa taasisi kudhibiti vitisho vya mtandao, kurekebisha mapungufu yaliyogunduliwa hivi karibuni na kupambana na vitisho vinavyoibuka.

Kikosi cha kitaifa ya kukabiliana na changamoto za udukuzi (KE-CIRT), kilichoko katika makao makuu ya Mamlaka, alisema, kinafanya kazi saa muda wote kuhakikisha Wakenya wako salama. "Vitisho vya mtandao havitabiriki. Huwezi kupanga jinsi itakavyotokea na wakati itatokea. Kikosi chetu katika CA kinafanya kazi saa 24 kufuatilia na kutoa maoni kwa taasisi zinazodukuliwa, ili

ziweze kuimarisha mifumo yao," alisema. Azima kuu, alisema, ni kuhakikisha uchumi wa kidijitali unalindwa kutokana na uvujaji wa data, jaribio la kuvamia, wizi wa kitambulisho na mashambulizi ya programu hasidi. Akizungumza mjini Kisumu wakati wa hafla ya tuzo za toleo la Kisumu la mashindano ya mtandao yaliyoandaliwa na Mamlaka ya Mawasiliano 2023, Muriithi alisema mpango huo unalenga kuimarisha ujuzi kwa wanafunzi wa ICT ili kuongeza uwezo wa nchi

katika kushughulikia viti-sho vinavyojitokeza katika sekta hiyo.

Kupitia ushirikiano na Huawei na Chama cha Kufuatilia Uhalifu wa Kiberia cha Kenya (KCSFA), kambi ya usalama wa mtandao na mfululizo wa kuwamia kwa 2023 umewavutia wanafunzi 6,000. "Tume kuwa tukikendesha hii huko Nairobi, lakini wakati huu tumeongeza kwa kaunti. Washindi hapa Kisumu watakutana na washindi kutoka maeneo mengine," alisema, alisema.

**W**anaonufaika na mpango wa mgao wa fedha za Inua Jamii sasa watakata pesa zao kila mwezi ili kusaidia kutatua malimbikizi ya muda mrefu.

Uamuzi huu unatokea wakati wanaonufaika wakiwemo mayatima na watoto wanaohitaji ulinzi (OVC), wazee (OPC), na watu wenye ulemavu mkali (PSD) wamekuwa wakilazimika kusubiri kwa miezi kabla ya kupokea malipo yao.

Afisa wa Watoto wa Kaunti ya Nyeri, Mwaniki Kung'u, alisema tayari, Idara ya Huduma za Kijamii na Wazee imegawa Sh 2.8 bilioni kama malipo ya uhamisho wa fedha wa Inua Jamii kwa mwezi wa Julai.

Serikali pia ilitoa Sh 4.3 milioni ziada kwa programu ya Uboreshaji wa Lishe kupitia Fedha na Elimu ya Afya (NICHE), ambayo inaunga mkono juhudi za Inua Jamii.

Jumla ya watu 1,042,864 wanatarajiwa kunufaika na ugawaji huu.

tarajia kugawa KSh 2,000 kwa kila kaya kwa jumla ya kaya 4,800 kupitia Mpango wa Uhamisho wa Fedha kwa Watoto Mayatima na Walio Katika Mazingira Hatarishi CT-OVC na kiasi sawa kwa kila mmoja wa wazee 17,000 chini ya mpango wa Uhamisho wa Fedha kwa Watu Wazee (OPCT) kwa mwezi wa Julai.

Afisa huyo alisifu hatua ya Serikali, akiiitaja kama msaada mkubwa kwa mamia ya wanaofaika ambao awali walilazimika kusubiri kwa miezi kadha kabla ya kupata pesa.

# Wakulima wahimizwa kujisajili kwa mpango wa kupokea ruzuku za kilimo

Idara ya Ustawi wa Mazao imewahimiza wakulima nchini kujiandikisha ili kunufaika na mfumo wa mtandaoni wa Kenya Integrated Agriculture Management Information System (KIAMIS), ambao ni jukwaa linalohifadhiwa chini ya Wizara ya Kilimo na Maendeleo ya Mifugo kusaidia ugawaji wa ruzuku kwa

wakulima. Katibu Harsama Kello, alisema wakati wa mkutano jijini Nairobi ambao ulishirikisha wadau katika mfumo wa uzalishaji chini ya Mfuko wa Kitaifa wa Maendeleo ya Mfumo wa Uzalishaji (NAVCDP) kwamba kuwe na data ya wakulima wote kwenye jukwaa la kati kutafanya iwezekane kugawa ruzuku za kilimo kwa ufanisi, wakati huo huo kutambua

uwezo wa kila kaunti na kusambaza rasilimali kwa miradi inayofaa.

"Kuwa na data ya wakulima wote mahali pamoja kutafanya iwe rahisi kupanga uzalishaji wa chakula nchini. Itakuwa rahisi kutambua uwezo wa kila eneo na kuweka rasilimali kwenye miradi inayozalisha," Kello alisema.

osaikia mandhari laini ya uzalishaji wa kilimo, ikiwa ni pamoja na huduma za mafunzo, mipango ya ushirika, masoko, ushirikiano wa wawekezaji, na mengineyo, alisema. Serikali kuu imekuwa thabiti katika kuhakikisha utoshelevu wa chakula, ikilenga vyakula vya msingi, mifugo, maziwa, na bustani. Kulingana na Kello, nchi inalenga kuweka ekari 200,000 chini ya kilimo cha tikitimaji na mipango ya kupata mbegu tayari inaendelea.

Katika hatua nyingine ya kufanikisha ajenda yake ya utoshelevu wa chakula, serikali kuu kupitia Wizara ya Kilimo imeanza mpango wa kugezuwa ekari 500,000 za ardhi ya umma iliyo bila matumizi kuwa maeneo ya uzalishaji wa chakula. Hatua hiyo, kulingana na Kello, itasaidia kupunguza upungufu wa kawaida wa mahindi, chakula cha msingi kwa Wakenya, na kuepuka vikwazo vya uagizaji vina-vyotawala soko la kimataifa la mahindi.

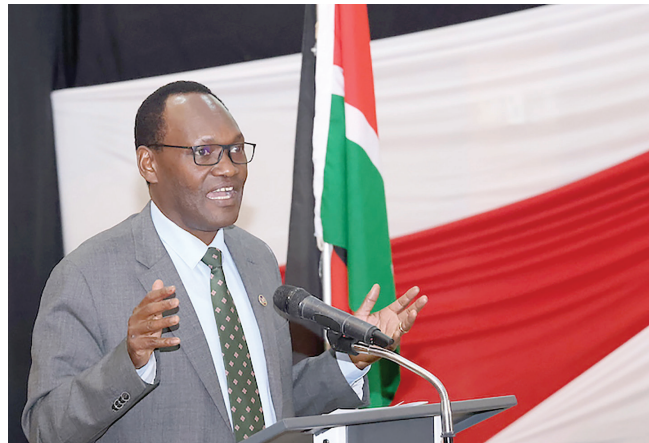

This includes development and implementation of mining policies, programmes and projects, creating a favorable legal and regulatory environment for investments and building capacity among others. The mineral resources sector is one of the priority sectors under the Economic Pillar of the Kenya Vision 2030, the Bottom-up Economic Transformation Agenda "BETA" and is among Kenya's foremost sectors and frontier earmarked for Foreign Direct Investment (FDI).

In order to effectively deliver on providing leadership in the management of the mining sector, the State Department recognizes the need to develop a Five-Year Strategic Plan ,2023-2027 to affirm its Vision and Mission. Further, the National Treasury and Planning, State Department for Planning has issued guidelines on preparation of the 5th Generation of Strategic Plans.

#### Purpose of the Consultancy:

The main aim of the consultancy service is to develop a Strategic Plan for the State Department for Mining covering the entire mining ecosystem. In developing the Strategic Plan, the consultancy shall align the Plan with the Revised Guidelines for Preparation of the Fifth-Generation Strategic Plans for Ministries, Agencies, Counties, Constitutional Commissions and Independent Offices issued by the State Department for Economic Planning in June 2023. The consultancy shall further review elements of the 2018-2022 Ministerial Strategic Plan that appertain to the State Department for Mining and undertake a directional analysis for the State Department. Further, the consultant is expected to take into account process ownership and stakeholder engagement as stipulated in the Statutory Instruments Act, 2025. #### Scope of Work:

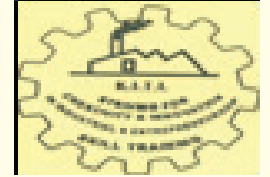

Prof. Li aliwambia wakulima kuwa mtama unakuzwa zaidi kaskazini mwa China, akitaja faida za mazao hayo ikiwa

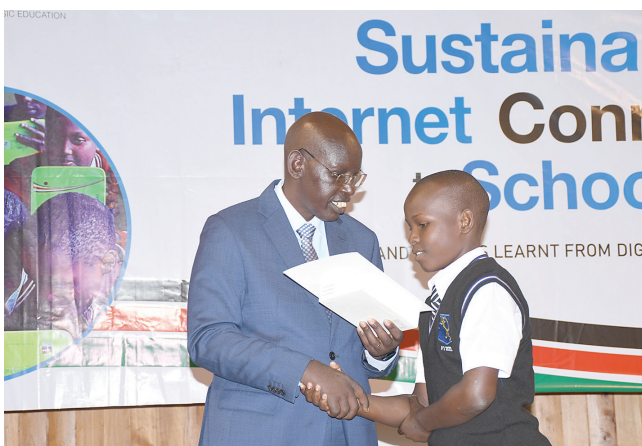

Katibu alitoa maoni hayo wakati wa warsha ya kujifamhamisha na operesheni za Mfumo wa Uthibiti wa Moja kwa Moja (DSS), jukwaa la teknolojia ambalo biashara ya kahawa itafanywa hivi karibuni kama ilivyoinishwa katika utaratibu mpya wa biashara ya kahawa unaosimamiwa na Mamlaka ya Masoko ya Mtaji (CMA).

Aliongeza kuwa serikali itaendeleza upya uanzishwaji

wa Bodi ya Kahawa ya Kenya ili kuangalia na kuratibu sera ya kahawa, hasa kuweka kahawa ya Kenya kimataifa na kufanya kazi na serikali za kaunti kuimarisha huduma za upanuzi.

"Tungependa kuwaa-liku wafanyabiashara na wanunuzi wa kahawa, wa ndani na kimataifa, kuunga mkono wakulima na serikali kwa kutoa bei inayolingana na juhudi za wakulima

Ekari chini ya kilimo cha kahawa, aliongeza katibu iliongezeka hadi ekari 170,000 mnamo 1987/1988 na uzalishaji wa juu kabisa wa tani 129,637 za kahawa safi lakini ulipungua hadi takriban ekari 116,000 na uzalishaji wa jumla wa tani 36,867 mnamo mwaka 2019/2020.

"Hizi takwimu zinaonyesha wazi kazi tunayopaswa kufanya kama sekta," alisema. Afisa Mtendaji Mkuu wa Soko la Kahawa la

Nairobi (NCE), Lisper Ndungu, alitangaza uteuzi wa Benki ya Ushirika ya Kenya kama mtoa huduma wa DSS ili kurahisisha malipo ya mapato kwa wakulima wa kahawa nchini.

Watumiaji wa soko la kahawa -wakala wa kahawa, wafanyabiashara, wamiliki wa maghala, wakulima wa kahawa na watoa huduma wengine, walifunzwa na Sekretarieti ya NCE na idara ya kahawa kuhusu utendaji wa DSS.

Waziri wa Fedha na Mipango wakati huo Ukur Yatani mnamo Aprili 3, 2020 alitangaza Kanuni za Masoko ya Mitaji (Kahawa), Kanuni za 2020, ambazo ziliweka NCE na wanachama wake chini ya usimamizi wa udhibiti wa CMA.

### Kaunti ya Homa Bay, yazindua mpango wa maendeleo wa miaka 5

Kaunti ya Homa Bay, imezindua mfumo wa maendeleo wa miaka mitano unaolenga kuchochea uzalishaji katika sekta mbalimbali za uchumi. Gavana Gladys Wanga alizindua Mpango wa Maendeleo wa Pamoja wa Kaunti (CIDP) wakati wa hafla iliyoafanyika mjini Homa Bay. Mipango hiyo inaeleza miradi za maendeleo iliyojumisha ya serikali ya kaunti kwa kipindi cha 2023-2027.

Bi Wanga alionyesha maeneo kadhaa ya kuzingatia ndani ya CIDP, ikiwa ni pamoja na kufufua mazao yaliyotelekezwa kama mtama, mawe, na muhogo. "Utawala wangu unakusudia kutunga na kufuatilia sheria na sera za kilimo ili kuboresha uzalishaji wa mazao na mifugo," alisema. Katika sekta ya afya, kaunti inaalenga kutokomeza magonjwa na kuambukiza, kushughulikia mzigo wa magonjwa yasiyo ya kuambukiza, kutoa huduma za matibabu muhimu, na kupunguza hatari za afya kwa wakazi.

CIDP pia ina mipango ya makazi na maendeleo ya miji ili kutoa malazi ya gharama nafuu na yanayofaa kwa wakazi. Biashara na utalii vinakusudiwa kukuza kupi-

tia uboreshaji wa vivutio vya watalii na kuunda mazingira mazuri ya biashara na lengo la kuunda utajiri, kupunguza umaskini, na kuunda ajira.

Gavana Wanga alitaja ndoto za kaunti kuhusu ujenzi wa barabara na lengo la kuinua mji wa Homa Bay kuwa jiji ifikapo 2034. Hafla ya uzinduzi ilihudhuriwa na Naibu Gavana Oyugi Magwanga, Seneta Moses Kajwang, na Mwakilishi wa Wanawake Joyce Osogo.

Gavana Wanga alisisitiza kwamba, CIDP ni mwongozo wa kutekeleza miradi za maendeleo kwa miaka mitano ijayo na ilibuniwa kwa mchango wa wakazi wa kaunti kupitia mchakato kamili wa ushiriki wa umma, kuanzisha ngazi ya kijiji.

Mpango wa maendeleo unaalenga kufanya Kaunti ya Homa Bay kuwa tajiri na unazingatia mbinu inayoongozwa na wananchi. Ushirikiano kati ya wakazi na maafisa wa kaunti ni muhimu kwa utoaji wa huduma wenye mafanikio na kufikia malengo yaliyotambuliwa ya maendeleo. Uongozi wa kaunti pia ulisisitiza umuhimu wa kupambana na ufasadi ili kuhakikisha utekelezaji wa ufanisi wa CIDP.

Mradi wa Mawasiliano na Usafirishaji wa Baharini wa Ziwa Victoria nchini Kenya ni mrithi wa Mradi wa Mawasiliano na Usafirishaji wa Baharini wa Ziwa Victoria wa Kimataifa ambao ulianzishwa mnamo 2010 na ulikuwa unategemewa kutekelezwa kwa pamoja kikanda na nchi za Afrika Mashariki zinazoshiriki Ziwa Victoria.
