

# Kenya yapata idhini kuuza maembe yaliyotibiwa kwa joto barani Ulaya


**K**enya imepata idhini ya kuuza matunda ya maembe yaliyotibiwa kwa joto katika Jumuiya ya Ulaya (EU).

Taarifa ya idhini ya kutumia joto la mvuke (VHT) kwa matunda safi ya maembe kutoka Kenya ilitolewa na EU mwezi uliopita, kwa kuongeza idhini ya mwaka 2021 ya kutumia mbinu ya maji moto.

Kupitia taarifa kwa vyombo vya habari, Mkuu wa Huduma za Ugaguzi wa Mmea ya Kenya (KEPHIS), Profesa Theophilus Mutui alisema sasa wauzaji wanaruhusiwa kuuza matunda safi ya maembe yaliyotibiwa kwa joto la mvuke au maji moto.

Mbali na matibabu ya joto, Prof Mutui aliwashauni wauzaji kufuata itifaki ya cheti cha maembe ya Kenya ili kuhakikisha matunda yanakidhi viwango vya mimea na ubora kwa soko la EU.

"KEPHIS imetua idhini kwa kiwanda kimoja cha matibabu ya joto kwa ajili ya kusafisha maembe kwa

soko la EU na Jordan. Taasisi inaendelea kuidhinisha zaidi vituo kusaidia biashara ya usafirishaji wa maembe," Prof Mutui alisema katika taarifa hiyo.

Kwa kuongeza, KEPHIS inasaidia wakulima, wauzaji, na wadau wengine kuzalisha maembe yanayofaa kwa usafirishaji kupitia kuanzisha na kuidhinisha maeneo yasiyo na wadudu (eneo lenye idadi ndogo ya wadudu), na kuwajengea uwezo kuhusu mahitaji ya soko la usafirishaji wa maembe katika maeneo mbalimbali ya uzalishaji wa maembe.

Kenya ilirejea katika soko kubwa la kuuza maembe Ulaya Novemba, 2021 baada ya kukosekana kwa miaka minane kutoptana na uvamizi wa wadudu wa karantini - mabungo ya matunda.

Mamlaka ya Kilimo na Chakula (AFA) - Idara ya Mazao ya Kilimo (HCD) ilisema wakati huo kuwa, kurejea kwa soko la EU klichochewa na kupungua pakubwa kwa uvamizi wa mabungo katika kaunti zi-nazoongoza kwa kilimo cha maembe.

Mnamo Julai mwaka jana, serikali ilizindua kiwanda cha matibabu ya maji moto

kwa mazao ya mboga katika Uwanja wa Ndege wa Kimataifa wa Jomo Kenyatta (JKIA).

Wakati wa hafla hiyo, Waziri wa zamani Peter Munya alisema nchi inahitaji kuendeleza haraka fursa kubwa za sekta ya kilimo ili kuboresha ustawi wa kijamii na kiuchumi wa jamii.

"Kiwanda hiki cha ya maji moto kitafufua na kuongeza biashara ya usafirishaji wa mboga kwa kuboresha upatikanaji wa soko, na hivyo kuiimarisha nafasi ya Kenya kama kiongozi katika kuuza mazao ya mboga safi kwenye soko la kimataifa," Munya alisema.

Maembe ni matunda ya pili yanayozalishwa zaidi Kenya baada ya ndizi na hupandwa katika hektaki 49,098 na kuzalisha tani 69,800 zenye thamani ya Sh 10.5 bilioni mnano 2019. Kaunti ya Makueni inaonzoza kwa uzalishaji, ikiwa na jumla ya miti milioni 4.3 ya maembe yaliyopandwa na zaidi ya wakulima 100,000, na kuzalisha zaidi ya tani 184,000, iki-fuatiwa na kaunti za Kitui na Machakos.

"Kuna maendeleo makubwa ya miundombinu yanayoendelea katika sehemu ya Kaskazini Mashariki mwa nchi na wahalifu wanalenga eneo hili kwa sababu wanajua kuwa pindi tu barabara zitakapowe kwa lami, hawataweza kupanda vilipuzi vya kutengenezwa kienyeji (IEDs), na biashara yao itakwisha," alisema. Bw Murkomen aliezea kuwa, hii ndio sababu kuu wahalifu wamekuwa wakizua na kushambulia wajenzi wa barabara, akiongeza kuwa kuwekwa kwa lami barabarani kutakuwa suluhisho la usalama. Murkomen alisema nchi pia imekuwa ikuza bidhaa nyingi nje kuliko uagizaji, hivyo kuzua msongamano.

The daily release capacity of the reservoir is 2650m<sup>3</sup>/s. the project will be located across Nzeeu River, Part of Kabonge Village, Northeast of Kitui Town, Kitui County.

kupitia simu ya mkononi, kompyuta au kifaa chohote. Taarifa za Usimamizi wa Maombi ya Kupitishwa Kidigitali zinafanya ombi kama hilo kufuatiliwa kwa urahisi kutoka mwanzo hadi mwisho. Njine aliwaonyesha washiriki hatua kwa hatua

jinsi ya kutumia jukwaa la e-PMIS kupitia simu zao za mkononi.

Alisema mikutano ya kuelimisha inafanyika katika maeneo yote yaliyotengwa, ambapo kaunti zimegawanywa katika makundi 15 ili kushughulikia masuala ya vifaa.

"Tunawapa mafunzo wadau katika kaunti zote 47 lakini tumewagawa katika makundi 15," alisema.

Kulingana na Njine, faida nyingine za mfumo mpya ni kwamba, mwananchi yeyote anaweza kuingia kwenye mtandao na kutafuta hali ya maombi ya jamaa bila ya kusafiri hadi Nairobi.

ikiwa yatakulaliwa kikamilifu na wakulima nchini. Akizungumza wakati wa ziara katika kaunti za Baringo, West Pokot, Trans-Nzoia na Uasin Gishu, Dkt Ochieng aliezea kuwa mahindi ya BT yameboreshwa ili kujilinda kutokana na wadudu wa stem borer na teknolojia ya bioteknolojia ya kisasa imetumika kuhamisha jeni kutoka kwa bakteria hadi kwenye mahindi ili kukabiliana na changamoto hiyo.

Bacillus Thuringiensis (BT) ni aina ya bakteria inayozalisha protini ambazo ni sumu kwa wadudu fulani.

## Kiambu yakumbatia matumizi ya apu ya afya

Kaunti ya Kiambu imeanza kutoa mafunzo kwa wahudumu wa afya ya jamii wa kujitolea (CHPs) kuhusu matumizi ya Mfumo wa Taarifa za Afya ya Jamii kwa Kutumia Teknolojia ya Kielectroniki (eCHIS) katika kaunti ndogo 12 za kaunti hiyo. Angalau CHPs 3000 watafundishwa, alisema Mkurugenzi wa Afya wa Kaunti ya Kiambu, Dkt. Hillary Kagwa, akiongeza kuwa mafunzo hayo yanakusidia kuwapa CHPs maarifa na ujuzi wa jinsi ya kui-marisha utoaji wa huduma kwa msaada wa eCHIS.

Mfumo wa Taarifa za Afya ya Jamii kwa Kutumia Teknolojia ya Kielectroniki (eCHIS) ni mradi wa kitaifa uliopita na Wizara ya Afya. Unajumuisha programu ya simu ya rununu ya afya ilioundwa kwenye jukwaa la zana za afya za jamii za daktari.

Mkurugenzi huyo alikuwa akizungumza na maafisa wa afya wa kaunti ndogo, wakurugenzi wa huduma za afya za jamii, na maafisa wa kumbukumbu na taarifa za afya, ambaa watafundishwa CHPs kwenye ngazi ya majimbo. "Madhumuni ya mafunzo haya

ni kuhakikisha CHPs wana-shirikishwa na kuelewa majukumu yao kuhusiana na suala la kuhamisha afya ya jamii katika maeneo yao na pia kuwajengea ujuzi wa kutumia eCHIS," Kagwe alisema.

Kagwa aliongeza kuwa, programu ya mafunzo ya eCHIS inajumuisha mada mbalimbali, ikiwemo kujaza data na usajili wa wagonjwa hadi uwezo wa uchambuzi wa ripoti za juu.

"Kwa kutumia teknolojia kikamilifu, wafanyakazi wa huduma za afya wataweza kupata taarifa za mgonjwa na jamii kwa wakati halisi, kufuatilia mwenendo wa afya, na kugundua mlipuko wa ugonjwa mapema," alisema.

Akizungumza na KNA, mhudumu wa kijamii wa kujitolea Kirigit, Dorothy Kinyua, alisema alikuwa na furaha kuhusu teknolojia ambayo itakuwa na madiliko makubwa katika namna wanavyotoa huduma, alisema wamekabiliana kwa muda mrefu na changamoto kubwa, ikiwa ni pamoja na kutegegeza zana na kumbukumbu zinazotumia karatasi ambazo zinaweza kupotea. Na Grace Naishoo (KNA)
