Serikali yatenga Sh1.1b kwa ununuza wa ardhi ya reli

Serikali imetenga Sh1.1 bilioni kufidia ardhi ili kuandaa njia ya kukamilishwa kwa ukarabati wa Njia ya Reli ya zamani (MGR) Mombasa (MGR) ili kuunganisha na kituo cha SGR eneo la Mirintini.

Katibu wa Idara ya Uchukuzi, Mohamed Daghar, alisema mradi huo wa Sh4.2 bilioni, ulioanza Septemba 2022, ulikatizwa na changamoto za utwaaji ardhi na kusimamishwa baada ya kutekelezwa kwa asilimia 65. Wizara ya Barbara na Uchukuzi imetenga bajeti hiyo kwa Tume ya Kitifa ya Ardhi, na mchakato wa kulipa fidia unatarajiwu kuanzia hivi karibuni.

"Ilitakiwa kudumu kwa muda wa miezi 12 na kuka-milika Agosti, lakini kwa

bahati mbaya, tulikuwa na changamoto ya utwaaji wa ardhi kwa sababu ya haki ya njia ya mradi huu.

Takriban kilomita 1.4 ilibidi kununuliwa, na kwa sababu hiyo, Wizara yangu imetoea pesa zinazohitajika kuititia Kenya Railways kwa NLC," alisema Daghar alipokagua ukarabati wa njia hiyo.

Baada ya kukamilika kwa mradi huo, abiria wanaotumia treni ya abiria ya Mandaraka Express na stesheni saba kando ya Reli ya Standard Gauge (SGR) wanaofika au kuondoka Mombasa wanaweza kutumia njia ya MGR.

"Kama serikali, tutatoza ada nafuu na kukupeleka kila mahali bila kujali muda utakaofika kwa treni iwe ni asubuhi na mapema, alasiri

"Reli ya abiria ni sehemu ya Mfumo wa Mabasi Yaendayo Haraka (MRT) ambao Wizara ya Barabara na Uchukuzi imedhamiria kuuanzisha pamoja na MRT nyingine ikiwa ni pamoja na Mfumo wa Mabasi Yaendayo Haraka (BRT) ili watu wahamishwe kwa usalama na ufanisi na wawewe. kuokoa muda na gharama nyingine zinazohusiana na wasafiri," aliongeza Daghar.

"Katika nusu ya kwanza ya mwaka 2023, uchumi wa Kenya ulionyesha ukuaji wa kuvutia, uki-fikia wastani wa asilimia 5.4, ukiongozwa kwa kiasi kikubwa na kufufuka kwa kilimo na sekta imara ya kutoa huduma," alisitisiza Prof. Ndung'u, akitabiri kupanuka kwa kiwango cha asilimia 5.5 kwa mwaka 2023 na 2024.

Akizungumzia viashiria vya uchumi wa jumla, Waziri aliangazia wasi-wasi kuhusu mfumko wa bei na soko la ubadilishanaji wa kigeni. Kamati ya Sera ya Fedha, ikiitikia shinikizo la mfumko wa bei, iliongeza kwa kiasi kidogo kiwango cha sera, ikisababisha kupungua kwa mfumko wa bei hadi asilimia 6.8 mnano Novemba 2023. Alisema licha ya changamoto kama upungufu wa asilimia 24.7 ya Shilingi ya Kenya dhidi ya Dola ya Amerika, nakisi ya akaunti ya sasa ilipungua

hadi asilimia 4.1 ya Bidhaa ya Taifa (GDP) ifikapo Septemba 2023 na kusisitiza akiba imara ya fedha za kigeni, ambayo ilikuwa dola za Marekani milioni 6,746, sawa na miezi 3.62 ya kufunika uagizaji.

Akijadili hatari zinazowezekana, ikiwa ni pamoa na hali ya hewa isiyotabirika, vizuizi vya bajeti, na kutokuwa na uhakika wa nje, Waziri huyo alisitisiza msimamo wa proaktivi wa serikali katika kushughulikia vikwazo hivi.

"Mabadiliko ya hali ya hewa yanaweka hatari kwa uzalishaji wa kilimo ndani ya nchi, wakati mabadiliko ya kijipolitiki duniani yanaweza kuathiri bei za bidhaa, mauzo, uwakezaji wa moja kwa moja wa kigeni, na malipo ya fedha za kigeni."

Akitoa maelezo juu ya changamoto zilizokutana wakati wa Mwaka wa Fedha 2023/24, utekelezaji wa bajeti, Waziri huyo alikiri vikwazo katika uundaji wa mapato, gharama za huduma

za deni, malipo yali-yobaki, na bili zilizosubiri kutekelezwa.

Licha ya vikwazo hivyo, Prof Ndung'u alisitisiza nidhamu ya kifedha ya serikali, ikishikilia nakisi ya bajeti ya asilimia 0.4 ya Jumla ya Mapato ya Taifa (GDP) na kuthibitisha dhamira ya serikali ya kuimarisha bajeti, ikiwa na lengo la kupunguza hatua kwa hatua nakisi ya bajeti kutoka asilimia 5.5 ya GDP katika Mwaka wa Fedha 2023/24 hadi asilimia 3.9 katika Mwaka wa Fedha 2024/25.

Katibu Mkuu, Dk. Chris Kiptoo, akizungumza wakati wa uzinduzi wa Mwaka wa Fedha 2024/2025 na kusikilizwa kwa mapendekezo ya bajeti ya muda mrefu ya sekta katika Kenya School of Monetary Studies, alisema hatua hizo zilitoa muhtasari wa kina wa mazingira ya sasa ya kifedha, yakielezea changamoto zilizokutana wakati wa utekelezaji wa Bajeti ya Mwaka wa Fedha 2023/24.
