Alifichua kuwa serikali inaandaa mfmumokazi wa kuhakikisha hakuna tatizo katika juhudzi zinazofanywa za kuweka nyaya za intaneti na kuongeza kuwa na kusudi mojatika sekta zote kutaepusha kurudia miradi ya miundombini ya kidijitali.

Kutokana na hali hiyo, alitaka sekta ya kibinafsi kuunda nafasi za ajira kwa vijana kwa kutumia mitandao na mawasiliyan waliyonayo ndani ya dijitali, huku akibainisha kuwa vijana wana uwezo mkubwa na serikali iko tayari kuwezesha mafunzo ili kuhakikisha wana vifaa vya kutosha kupata kazi za kidijitali.

Alisema kuwa kuna fursa nyingi ambazo sekta ya kibinafsi inaweza kutilia katika KONZA Technopolis.

"Ni muhimu kujenga uwekezaji wa sekta ya kibinafsi katika KONZA. Ikiwa tutafanya kazi pamoja, KONZA itakuwa Silicon Savanna yetu," aliongeza.

Aidha, aliwataka wadau hao kufanya kazi kwa pamoja na Serikali kwa nia ya kuhakikisha mafanikio yanapatikana nchini na kuahidi kusaadha sekta ya kibinafsi kwa kila jambo ili kuboresha utendaji

Ikiwa tutashiriki-anana, KONZA itakuwa Silicone Savanna yetu" – Waziri Owalo

wa sekta ya ICT.

Katibu wa ICT na Uchumi Dijitali Mhandisi John Tanui alisisitiza umuhimu wa kuhakikisha uendelevu wa uunganishaji wa Wi-Fi kote nchini, na kuongeza, "tunataka kuwa na mtindo endelevu ambapo sekta ya kibinafsi inatumia miundombini ya serikali kuunganishia nyumba za watu."

Akizungumza katika kongamano hilo, Katibu wa Utangazaji na Mawasiliano Prof Edward Kisang'ani alihimiza mawasiliano ya mara kwa mara na ya kina kati ya sekta ya umma na ya kibinafsi. Katibu Kisang'ani aliongeza kwamba ushirikiano kati ya washikadu tofauti utaunda mazingira ya kufanya kazi yenye uwiano ambayo yataleta matokeo chanya kote nchini.

Mnamo Desemba mwaka jana, kulikuwa na kilio kutila kwa watumiaji bei ya mafuta ya kula ilipanda hadi Sh 480 kwa lita na kuilazimu serikali kuagiza mafuta ya kula kupitia Shirika la Biashara la Taifa la Kenya na hivyo kupunguza bei ya reja reja kwa zaidi ya nusu hadi Sh 220 kwa lita kwa sasa.

Ujumbe wa Indonesia utaongozwa na Waziri Mra-

tibu wa Masuala ya Bahari na Uwekezaji Bw Luhut Binsar Pandjaitan, ambaye atazuru nchi hii kwa mara ya pili katika muda wa miezi sita baada ya kufanya mazungumzo na Rais Ruto Januari.

Ziara ya Waziri Luhut inatarajiwu kuandaa mazingira ya ziara ya kiserikali ya Rais Joko Widodo mwezi Agosti mwaka huu.

Mnamo Mei mwaka huu, Rais Ruto alimtuma Waziri Kuria ambaye aliongoza ujumbe wa ngazi ya juu wa serikali hadi Jakarta kujadili ushirikiano wa Kenya na Indonesia ambapo In-

donesia ilijitolea kuagiza ng'ombe 700,000 kutoka Kenya.

Indonesia ni nchi ya 15 kwa uchumi mkubwa duniani ikiwa na idadi ya watu milioni 300 na Pato la Taifa mara 18 ya ukubwa wa Kenya.

Indonesia, mwanachama wa G20, ndiyo mzalishaji mkubwa zaidi duniani wa Nickel na imekuwa ikiongoza ushirikiano wakukomesha usafirishaji wa malighafi ambayo haijachakatwa na kupata bei nzuri ya alama za kaboni Carbon kusini mwa ulimwengu.

NA FATUMA SAID NA WANGARI MWANGI (KNA)

Serikali ya Kitaifa iko katika hatua za mwisho za kulipa fidia kwa wamiliki wa ardhi na mali walioathirika na ujenzi wa Eneo Maalum la Kiuchumi la Dongo Kundu mkoani Pwani.

Akizungumza wakati wa ziara ya kukagua miradi ya maendeleo ya eneo la Pwani, Mkuu wa Utumishi wa Umma Bw Felix Koskei amewahakikisha Walioathirika na Mradi huo (PAPs) kuwa Serikali na Tume ya Kitaifa ya Ardhi (NLC) imethibitisha kuwepo kwa hadi na hatimiliki kwa wale wanaohusika.

"Utafiti umefanyika na hati miliki zimechapishwa na kila mtu ambaye anastahili na ameihdinishwa kuwa ameathiriwa kikweli na mradi atalipwa kikamilifu," Mkuu wa Utumishi wa Umma aliwahakikisha PAPs.

"Eneo Maalum ya Kiuchumi ya Dongo Kundu limetambuliwa na Serikali na limechorwa ramani am-

bayo itagharamiwa na Japan na tutakuwa na hadi njia saba zitakazojengwa katika eneo hili." Koskei aliongeza.

Akizungumza katika eneo lililotengewa la Taifa Gas, Koskei alisema kuwa mwekezaji huyo tayari amechukua na kukabidhi eneo hilo kwa Kampuni ya Ujenzi ili kuanza kazi za ujenzi.

Alisema kuwa wamekubaliana na kushughulikia hati za fidia na wanaolengwa wamepeewa mahali pa kuishi huku wakisubiri hati miliki ili kuruhusu maendeleo

kuanza.

"Huu ni mpango wa serikali wa kuhakikisha kuwa Eneo Maalum la Kiuchumi linaendelezwu ili kuvutia wawekezaji zaidi, kubuni nafasi za kazi na pia kutengeze bidhaa zetu," Koskei alisema.

Aliongeza kuwa kando na Taifa Gas, makampuni na wawekezaji wengi wameonyesha nia ya kuendeleza miradi zaidi katika eneo hilo.

Hata hivyo, alisema ukoselwa wa miundombinu

ya msingi hasa ya barbara, maji na umeme unaofanya wawekezaji wengi kuchelewa kuingia, huku akihakikisha kuwa Serikali inafanya kila iwezalo kuhamisha walioathirika na mpango huo ili kupisha njia za maendeleo. Wakati huohuo akiwahutubia Wafanyakazi wa Mamlaka ya Bandari ya Kenya, Koskei alionya kuhusu ufisadi akisisitiza kuwa uovu huo ni suala zito sana ambalo linaweweka viongozi na nchi kwenye ramani ya dunia kwa sababu zote mbaya. Kwa hivyo, Koskei aliwataka wafanyakazi wa KPA kuwa sehemu ya timu inayopambana na ufisadi kwa kuripoti watu wafisadi.

Aidha, Mkuu huyo wa Utumishi wa Umma aliwakumbusha wafanyakazi kuwa serikali itamlinda kila mtu anayefanya jambo sahihi. "Hakuna mtu anayepaswa kukushawishi kwamba amepokea simu kutoka juu, mtu akiamatwa kwa kuhusika na ufisadi atachukuliwa na kama mtu binafsi," Koskei aliongeza.

The French Ministry of Europe and Foreign Affairs allocated €516,148 to the project being implemented by a joint team from Moi University, the French Institute for Research for Sustainable Development (IRD), the Institut Pasteur and the Peruvian National Cancer Institute.

The next FSPI call will be published in November 2023. NRF and the Embassy of France, with support from the IRD and CIRAD, plan to submit a proposal in the field of environmental science on "Research and partnership building for greater resilience of agroecosystems in Kenya while protecting, harnessing and promoting biodiversity in a context of climate change".

Ushirikiano wa Kenya na Mpango wa Chakula Duniani mjini Mombasa, Machogu alisema ushirikiano na WFP unazidi nyanja ya elimu. "Kujitolea kwa pamoja kuboresha maisha ya Wakenya na wakimbizi kumetusaidia kufanya kazi katika sekta mbalimbali kama vile afya, kilimo na udhibiti wa majanga," Machogu alisema.

MAMLAKA ya Mali za Kifedha Isiyodaiwa (UFAA) imepanga kuongeza kiasi cha mali ambayo haijadaiwa inayotolewa upya kwa wamiliki wake halali ili kuingiza utajiri katika uchumi na kukuza ukuaji wa uchumi nchini.

Mwenyekiti wa UFAA Bw Kigo Njenga alisema lengo kuu la Mamlaka ni kuongeza uunganishaji wa watu na mali yao iliyopotea na kapatikana ambayo akaunti zao za sasa zinazifika Sh57 bilioni, Sh27 bilioni taslimu na karibu Sh30 bilioni hisa na mali nyinginezo.

"Tunachoshikilia kwa sasa ni Sh27 bilioni taslimu na sawa na pesa taslimu na hizi zimeongezeka kutoa Sh500 milioni ndani ya miaka mitano iliyopita. Ndoto tuliyo nayo ni kukuza hii hadi utafiti wa msingi wa Sh241 bilioni ambao tutajiribu kuunganisha tena na wamiliki halali," alisema Njenga.

Akizungumza wakati wa kongamano la wawakilishi wa kitaifa, Njenga alisema kuwa serikali ya Kenya Kwanza inakumbatta Ajenda ya Mabadiliko ya Kiuchumi ya kuanzia mashinani (BETA) ambayo yanahitaji ufadhili na njia

rahisi ya kuifadhili ni kuharakisha kuunganishwa tena kwa watu na mali zao zilizopotea au kutelekezwa. .

"Ili kufanya hivyo, tunaliomba Bunge na Serikali kuharakisha mchakato wa kurekebisha sheria na kawni ili kutoa njia rahisi kwa wanaodai kupata mali zao kwani itaongeza kiwango cha fedha kinachotolewa kwenye uchumi mkuu kwa maendeleo," alisema Njenga.

Alifafanua kuwa iwapo watapata sheria inayowaruhusu kulipa madai ya kielektroniki yali-yohakikiwa, watu wanao-

daiwa fedha kidogo ambaolio wengi watalipwa na hivyo kuingiza kuzunguka katika uchumi.

"Tumeanzisha kampeni ya kuhamasisha nchi nzima na tunafanya kazi na vyombo vya habari, mashirika ya kidini na huduma nyingine za kijamii kuwaambia Wakanya kwamba tunashikilia pesa zao na kuwashimiza kuzipokea," alisema Njenga.

Njenga alisema kuwa hadi sasa, Mamlaka imeunganisha tena mali zenye thamani ya Sh 2 bilioni kwa wamiliki halali na wanakusudia kuongeza mara kumi.

Kaunti ya Vihiga ina vikundi vitatu vya maji kimoja huko Kaimosi katika Kaunti Ndogo ya Hamisi, cha pili Mbale katika Kaunti Ndogo ya Sabatia na cha tatu Maseno katika Kaunti Ndogo ya Luanda, vyote vikitoa lita 15 milioni za maji safi na yaliyosafishwa kwa siku kuhudumia wakazi.

Akizungumza wakati wa ziara ya kutembelea eneo la Serikali ya Utoaji Huduma (GDS), Mhandisi Samuel Onzere kutoka Shirika la Maendeleo ya Maji ya Ziwa Victoria Kaskazini lililokuwa likitekeleza mradi huo, alithibitisha kuwa mradi huo ulikamilika Aprili 1, 2022 na utakabidhiwa kwa Kampuni ya Maji ya Amatsi ili kuusimamia na kuudumisha.

Mhandisi Onzere alisema hata hivyo wanakabiliwa na changamoto chache, ikiwa ni pamoja na vifaa vya zamani na vilivyo-chakaa vya kusambaza maji, gharama kubwa ya umeme ambayo hutumia

asilimia 60 ya mapato yote yanayokusanywa, gharama kubwa za uendeshaji na kurekebisha ambayo hutumia asilimia 40 ya mapato yote yanayokusanywa na gharama ya juu ya magonjwa yatokanayo na maji kati ya mengine.

Hata hivyo alisema wanahitaji takriban Sh500 milioni ambazo zita-hakikisha changamoto zinazowakabili zinatatu-liwa kabla ya kuanza kwa mradi huo.

Aliongeza kuwa pia wamefunga sola ambazo zitasaidia kupunguza gharama ya kuvuta maji wakati wa mchana, huku umeme ukitumika usiku wakati hakuna juu.

Mkuu wa Kitengo cha Utoaji wa Huduma Serikali, Agnes Odhiambo ali-

wataka washikadu wote kuhakikisha kuwa maji yanafika katika boma zote kwa kuwa maji ni bidhaa muhimu inayopaswa kuwafikia watu wote.

"Hata Mamlaka ya Barabara za Vijijini nchini Kenya inatengeneza na kutunza barabara, haipaswi kuingilia utoaji wa huduma zingine kwa wakazi ikiwa ni pamoja na maji kwa kuhanibui mabomba ya maji barabara," alisema Odhiambo.

Alisikitika kuwa zaidi ya familia 800 zimekatiba huduma ya maji kwa sababu ya barabara inayoendelea ya Mbihi-Magada na kuzitaka pande husika kufanya kazi kwa amani ili kuhakikisha zinarejesha huduma ya maji kwa familia zilizoathirika.

Ili kuunda muundo jumlishi, unaobuni nafasi za kazi ambao unawekeza katika raslimali nyingi za kilimo Kenya, Serikali ya Kitaifa kupitia Wizara ya Uwekezaji, Biasara na Viwanda (MITI) na Serikali za Kaunti kupitia Baraza la Magavana (CoG) zimeanzisha Maeneo ya Kiviwanda ya Kaunti (CAIPs) sambamba na mpango wa kiuchumi wa Bottom-Up. Huu ni mfumo unoangazia mkulima kwanza na maeleo katika nchi za nje ili kuhanikisha wazalishaji wadogo wanachanga katika ukusanyaji, uvumishaji na uuzaji katika nchi za nje mazao kutoka kote nchini.
