

Waziri huyo alikuwa akizungumza katika mji wa North Horr, Kaunti ya Marsabit ambapo alizindua ardhioevu ya Tiniqo na Horri Gudha, iliyorejeshwa na Mamlaka ya Kitaifa ya Kusimamia Mazingira (NEMA) kama sehemu ya mpango wa kitaifa wa upanzi wa miti 15 bilioni na urejeshaji wa mfumo wa ikolojia.

Waziri Tuya alifichua kuwa Kenya ilikuwa na jumla ya hektari 150,000 za misitu ya kibiashara kote

nchini, akiongeza kuwa ni hektari 5,000 zitakazokatwa miti kila mwaka ili kuruhusu upandaji upya na uundaji upya wa ekari zitakazokatwa miti.

"Hektari 150,000 ziko katika sehemu za misitu iliyotangazwa kwenye gazeti la serikali, ni huko tu ndipo tutaruhusu ukataji wa miti ya kibiashara, ya kigeni lakini sio katika misitu ya kiasili," Waziri alisema.

Kenya Livestock Commercialization Project (KeLCoP) is a six-year project that is jointly funded by the Government of Kenya (GOK) and the International Fund for Agricultural Development (IFAD) and beneficiary communities. The Financing Agreement entered into force on 5<sup>th</sup> March 2021. The completion date of the project shall be 31<sup>st</sup> March 2027 and the Financing Closing Date shall be 30<sup>th</sup> September 2027. The Project Goal is to contribute to the Government's agriculture transformation Agenda of increasing rural small-scale farmers' incomes, food and nutrition security whereas the project development objective is to increase incomes of 110,000 poor livestock and pastoralist households, especially youth and women, in an environmentally friendly manner, in selected project areas of the 10 participating counties. The 10 participating counties are namely: Busia, Bungoma, Kakamega, Siaya, Nakuru, Trans Nzoia, Elgeyo Marakwet, Baringo Marsabit and Samburu. Chuo kikuu cha Egerton kimetuma wanafunzi 40 nchini Israel kusomea teknolojia ya hali ya juu ya kilimo na maji na kupata utaalamu wa ku-saidia kukabiliana na uhaba wa chakula humu nchini.

Makamu Mkuu wa chuo hicho Prof Isaac Kibwage alisema, wanafunzi hao watasafiri hadi nchini Israel kwa ajili ya programu ya mafunzo ya kina kwa muda wa miezi 11 katika vyuo vikuu na vyuo vya kisasa huku wakihudumu katika mashamba ya kisasa.

Kwa mujibu wa Makamu Mkuu wa Chuo, wanafunzi hao pia watapatiwa mafunzo ya fani mbalimbali za kilimo, ufugaji, uzal-

ishaji wa mazao na ufugaji wa samaki chini ya mpango wa kilimo uliopewa jina la Kituo cha Kimataifa cha Mafunzo ya Kilimo cha Arava (AICAT).

Mara tu watakapofuzu, alisema wahitimu hao watajarajiwa kutoa mapendekezo ya mradi wa kilimo kutekelezwa Nakuru na kaunti jirani.

"Tuna matumaini kwamba watatumia ujuzi wa kiteknolojia watakopata Israel kuleta mabadiliko katika nchi yetu," Prof. Kibwage alisema.

Wanafunzi hao wa kiume 28 na wa kike 12 watasoma katika bewa la AICAT ili-yopo Mercaz Sapir, mkoa ulio karibu na jamii 15 za kilimo na mashamba makubwa ya maziwa, maghala na vibanda vya ng'ombe.

Mapema mwaka wa 2016, serikali za Kenya na Israel zilitia saina mkataba uliopewa jina la "Azimio la Jerusalem" au "Azimio la Ushirikiano katika Maji na Unyunyuzaji" ambao ungewawezesha wahitimu wanya kutoka vyuo vya elimu ya juu kuhudhuria kozi ya miezi 11 ya mafunzo nchini Israel.

Makubaliano hayo yalionyesha kuwa wanafunzi waliotafuta kwa programu ya hupewa tikiti za ndege kwa njia ya mikopo ambayo baadaye hurejesha wakati au baada ya mafunzo ambayo yanahusisha mafunzo ya kazi. Wanatakiwa kushirikiki katika shughuli za uzalishaji shambani wakati

wa mafunzo. Madhumuni ya mafunzo hayo, ambayo hufanyika katika eneo la jangwa la Arava kusini mwa Israeli, ni kuwafahamisha wanafunzi kwa teknolojia ya kisasa ya kilimo huko Arava.

Akizungumza wakati yeye na Mkurugenzi wa AICAT Bi Hanni Arnon wakitia saina Mkataba wa Makubaliano kwa niaba ya Taasisi hizo mbili, Makamu Mkuu wa Chuo alidokeza kuwa wanafunzi hao wataendelea na mafunzo ya kina ya uzalishaji wa mazao, matumizi ya mbegu na matumizi bora ya maji, rasilmali za maji, kushughulikia maji chafu, kuchakata tena na kutumia tena, unyunyuzaji kwa kutumia teknolojia na matumizi bora ya maji. Kwa mujibu wa Makamu Mkuu wa Chuo, hatua hiyo itaongeza utekelezaji wa ajenda ya serikali hasa katika kuhakikisha kuna chakula cha kutosha nchini.



#### DRAFT PUBLIC FINANCE MANAGEMENT (ULINZI PRIME HEALTH SERVICES FUND) REGULATIONS, 2023

Section 4(a) of the Statutory Instruments Act, 2013 provides that **"the object of this Act is to provide a comprehensive regime for the making, scrutiny, publication and operation of Statutory Instruments by requiring regulation-making authorities to undertake consultation before making Statutory Instruments"**. In addition, Section 5(3) of the Statutory Instruments Act, 2013 states that **"without limiting by implication the form that consultation referred to in sub-section (1) might take, the consultation shall -**

- involve notification, either directly or by advertisement; of bodies that, or of organizations representative of persons who are likely to be affected by the proposed instrument; or
- invite submissions to be made by a specified date or might invite participation in public hearings to be held concerning the proposed instrument.

Ulinzi Prime Health Services (UPHS) was established by the Defence Council in July 2022 with the objective of partially opening up Kenya Defence Forces (KDF) Levels IV, V & VI medical facilities for uptake by prescribed civilians at 'fee-for-service'.

Accordingly, a Multi-Agency Taskforce composed of officers drawn from the Ministry of Defence, Ministry of Health, the Office of the Attorney General & Department of Justice and the National Treasury has now finalized preparing the draft Public Finance Management (Ulinzi Prime Health Services Fund) Regulations, 2023.

Kuzinduliwa kwa mpango wa fidia kulipongezwa na viongozi kama hatua ya makusudi zaidi ya serikali kuonyesha dhamira ya kukabiliana na ucheleweshaji wa muda mrefu kwa wakulima ambao wamebeba mzigo mkubwa wa migogoro ya binadamu na wanyamapori kwa muda mrefu.

Gavana Andrew Mwadime alibainisha kuwa, kukiwa na vifaa sahihi vya kuhifadhi maji, kaunti inaweza kuongeza uwezo wa lishe katika ngazi ya familia kupitia mashamba madogo katika boma. Akizungumza mjini Mwatate wakati wa ugawaji wa matangi 256 kwa wakulima wanaoishi katika mazingira magumu, gavana huyo alieleza kuwa familia za kipato cha chini ambazo zimekuwa zikikabiliwa na ukosefu wa maji kwa muda mrefu zitapewa kipaumbele katika mpango huo unaoenga kuifanya kaunti hiyo kuwa eneo lenye utoshlevu wa maji. Alipongeza ushirikiano huo na washirika wa maendeleo, akisema kuwa utaenea hadi sekta nyingine katika kuwawezesha wakazi wa eneo hilo. Sekta hizo nyingine ni pamoja na kuwekeza katika kuongeza thamani katika kilimo, mifugo, uvuvi na madini.

"Tumejitolea kuboresha upatikanaji wa maji safi na salama kwa wakulima na familia zingine zenye kipato cha chini. Matangi hayo yatavuna maji wakati wa misimu ya mvua na kuokoa familia nyingi kutokana na safari ndefu za mateso kuelekea vyanzo vya maji," akaeleza.

Bw Abedih Mbatha, Mtaalamu wa Mpango wa Kaunti ya FAO, alisema mpango mzima utahusisha kusambaza matangi 800 ya maji kwa familia zilizo hatarini katika eneo hilo kame. Kila tangi lina uwezo wa lita 1,500.

Aliongeza kuwa familia zote zinazolengwa zitakapokea matangi yao, kaunti itakuwa na uwezo wa ziada wa kuhifadhi lita milioni 1.2 za maji. Maji yaliyohifadhiwa yanaweza kutimika kwa shughuli mbalimbali ikiwa ni pamoja na matumizi ya nyumbani na mashamba madogo kwenye boma.

Tayari, matangi 147 yalikuwa yamesambazwa kwa wakulima waliochaguliwa huko Mwatate, Wundanyi, na Voi. "Uhaba wa maji unaweza kutatuliwa kwa kuongeza njia na uwezo wa kuhifadhi maji ya mvua. Mpango huu unalenga kuongeza upatikanaji wa maji nyumbani kwa wakulima na watu wengine," alisema. Na Wagama Mwangi (KNA)

WIZARA ya Ushirika na Biashara Ndogo na za Kati (MSMEs) imewahakikishia washirika wa maendeleo ufadhili wake usio na kikomo kwa wajasiriamali binafsi kwa kuwawezesha maendeleo endelevu ya kiuchumi kupitia mageuzi ya sekta hiyo.

Akizungumza wakati wa kikao na washirika wa maendeleo katika Hazina ya Uwezo, Waziri wa Ushirika na Biashara Ndogo Simon Chelugui alisema kuwa, madhumuni ya warsha hiyo ni kuwaunganisha washirika wa maendeleo katika mipango yao ya vipaumbele na mwelekeo wa kimkakati katika Wizara kuelekea utekelezaji wa Ajenda ya Mabadiliko kuanzia mashinani (BETA).

"Kweli mmekuwa nguzo muhimu katika juhudi zetu za kutekeleza majukumu yetu



kama Wizara kwa kuendelea kuunga mkono programu zetu mbalimbali na tunataka kudumisha hali hiyo ya ushirikiano katika siku zijazo," alisema.

Waziri huyo alieleza kuwa vyama vya ushirika na makampuni makubwa ya kibiashara ni sehemu muhimu ya uchumi wa Kenya kwa sababu yanatoa huduma mbalimbali katika sekta zote za uchumi na makampuni makubwa ya kibiashara ni

wahusika wakuu katika uzalishaji wa bidhaa na uundaji wa ajira unaoathiri moja kwa moja uchumi.

Zote mbili, aliongeza, zinajumuisha asilimia 98 ya biashara zote nchini Kenya, zinaunda asilimia 30 ya ajira kila mwaka na pia kuchangia asilimia 3 ya ukuaji wa Pato la Taifa.

Wakati huo huo, Katibu Idara ya Serikali ya MSMEs B. Susan Mang'eni alisema jukumu la idara hiyo ni kuanza sera ya ufadhili, kusaidia uboreshaji wa teknolojia na uboreshaji wa kisasa, kukuza na kuendeleza MSMEs ili kuimarisha ushindani wao na kuanzisha miundombinu jumuisi.

Mang'eni alisema kuwa serikali inaomba msaada kutoka kwa washirika wa maendeleo katika utoaji wa miundombinu inayohitajika, mafunzo na kujenga uwezo wa wajasiriamali binafsi, kusaidia upatikanaji wa soko

kwa wajasiriamali binafsi, kuboresha upatikanaji wa fedha kwa makampuni hayo na kupitia upya uwekaji wa sera na mfumo wa udhibiti.

"Biashara za kati ziliajiri watu 1-9 na kuwa na mauzo ya kila mwaka yasiyozidi Sh 500, 000, biashara ndogo zilikuwa na wafanyakazi 10-19 na mauzo ya mwaka kati ya Sh 500,000 na Sh 5 milioni wakati makampuni makubwa yalikuwa na wafanyakazi kati ya 50-250 na mapato ya kila mwaka ya kati ya Sh 5 milioni and Sh 100 milioni," alisema Mang'eni. "Huu ni mpango mzuri kwa sababu baadhi yetu tusingeweza kukumbuka kuwa tulikuwa na pesa ambazo hazijadaiwa. Sh200, 000 zangu zitaboresha maisha yangu. Nitanunua kitu cha kukumbuka pesa ambazo nusura nipoteze," alisema.
