Serikali itaweka huduma zake zote kwenye jukwaa la kawaida la kidijitali kwa ufikiaji rahisi wa umma ikijiandaa kuzindua kitambulisho cha kidijitali.

Kitambulisho cha kidi-

jitali, kulingana na Waziri wa Habari, Mawasiliano na Uchumi wa Kidijitali Eliud Owalo kitaunganisha pamoja vitambulisho vingi vya mtu binafsi ili kuwezesha kupata huduma zote za serikali mtandaoni.

Akizungumza wakati wa uzinduzi wa Kituo cha Jitume katika Kaunti ya Trans Nzoia, Owalo alifichua kuwa zaidi ya huduma 5,000 zimewekwa kwenye tovuti ya e-citizen na wizara yake.

Aliongeza kuwa serikali itaanzisha vitambulisho vya kielektroniki ambavyo vitawawezesha wananchi kupata huduma zote zinazopatikana kupitia majukwaa ya mtandaoni bila kujali mahali walipo.

Waziri pia alibainisha kuwa serikali ina nia ya kuhakikisha Wakenya wanapata ujuzi unaohitajika katika teknolojia ya kidijitali ili kutumia vyema fursa zinazotolewa na teknolojia ya kidijitali.

Hivi karibuni Serikali itatekeleza kikamilifu Mpango wa Biashara ya Ardhi (LCI) wa kuweka maeneo makubwa ya ardhi isiyotumika kwa shughuli za kilimo huku ikilenga kuongeza uzalishaji wa chakula na kuziba pengo la uhaba wa chakula nchini.

Katibu wa Idara ya Ukuzaji wa Mazao Kello Harsama alisema serikali ina sehemu kubwa ya ardhi chini ya mashirika ya umma na mashirika mengine ya serikali ambayo haitumiwi na inaweza kulimwa ili kuzalisha chakula kwa nchi.

Akizungumza wakati wa kongamano la kwanza la wawekezaji kuhusu Mpango wa Biashara ya Ardhi (LCI), Katibu alisema motisha ya serikali kulima ardhi hiyo isiyotumiwa ni athari kubwa za ukame ambao majuzi nusra usababishie mzozo wa chakula nchini.

"Hivi majuzi, tulipata uhaba mkubwa wa chakula kuwahi kutokea nchini kutokana na upungufu wa zaidi ya magunia milioni 10 ya mahindi," katibu alisema, akiongeza kuwa siku zilizopita, katika hali kama hizo, serikali iliagiza chakula kutoka kanda lakini wakati huu hata nchi jirani hazi-

kuwa na chakula cha kuuza nje.

Kwa mujibu wa Harsama, waliopewa vyeti vya kuagiza mahindi bila ushuru hawakuweza kuyapata kutoka kanda hii, wengine wakilazimika kuagiza kutoka nchi za Brazil na Vietnam huku ya karibu zaidi ikiwa ni Afrika Kusini ambako Kenya ilikabiliwa na ushindani kutoka nchi nyingine kama Sudan Kusini, Burundi, Rwanda na Angola.

Katibu alisema ili kukabiliana na uhaba wa chakula nchini, Serikali imeweka kipaumbele matumizi ya ardhi isiyotumika kwa kuikodisha kwa wawekezaji wa ndani na nje

ya nchi kuzalisha chakula kwa ajili ya nchi na kuuza nje ya nchi.

"Rais ametangaza kwamba ili tuweze kutumia vyema rasilimali zetu za ardhi, tutajenga zaidi ya mabwawa makubwa 100 nchini kote ili kuwezesha kilimo cha unyunyuzaji," alisema Harsama.

Katibu alisema takriban ekari milioni 2.5 za ardhi ya kilimo inayomilikiwa na taasisi za umma bado haijatumika na ili kuki-dhi mahitaji ya chakula nchini, mkakati ni kuwa na ekari 500,000 za ardhi mpya katika uzalishaji.

"Nchi ina uhaba wa magunia milioni 7.8 ya mahindi dhidi ya makadirio ya mahitaji ya magunia milioni 67 ya mahindi kufikia 2022," Harsama alisema.

Alifafanua kuwa kwa awamu ya awali ya mradi huo, baadhi ya sehemu za ardhi ambazo serikali imezipa kipaumbele ni pamoja na Galana Kulalu, mradi wa unyunyuzaji wa Bura, Chuo Kikuu cha Egerton, shamba la Kimabere, shamba la Kirimum, shamba la Masinga, mradi wa unyunyuzaji wa Tana Delta.

Waziri huyo pia alisema kuwa kama sehemu ya uboreshaji wa ustadi wa kidijitali, Serikali pia imepiga hatua kutekeleza Taasisi ya Juu ya Teknolojia ya Kenya (KAIST), Chuo Kikuu cha SMART ambacho kitatoa mafunzo ya kiwango cha uzamili na uzamifu katika vitivo vitatu vya Ufundi, Uhandisi wa Umeme na ICT.

"Tunatarajia KAIST kutoa wahitimu katika sayansi, teknolojia na uvumbuzi ikizingatiwa kuwa taaluma hizi ni za lazima katika uchumi unaotegemea maarifa," Owalo alisema.

imu kinachoitwa 'Programu ya Talent ya Dijitali' ambayo ina vipengele muhimu vya ukuzaji wa ujuzi, kufundisha kazi, ushauri, mafunzo, vyeti na ubunifu wa ICT.

"Milima ya Misango ni sehemu ya vilima vya Eregi, ambayo asili yake ni msitu wa wa Kongo na ndio kielelezo kikuu cha mvua kwa maeneo ya Siaya, Vihiga, na Kakamega Kusini," alisema Muhati.

ya afya na kuweka njia kwa huduma za afya za kina na endelevu nchini.

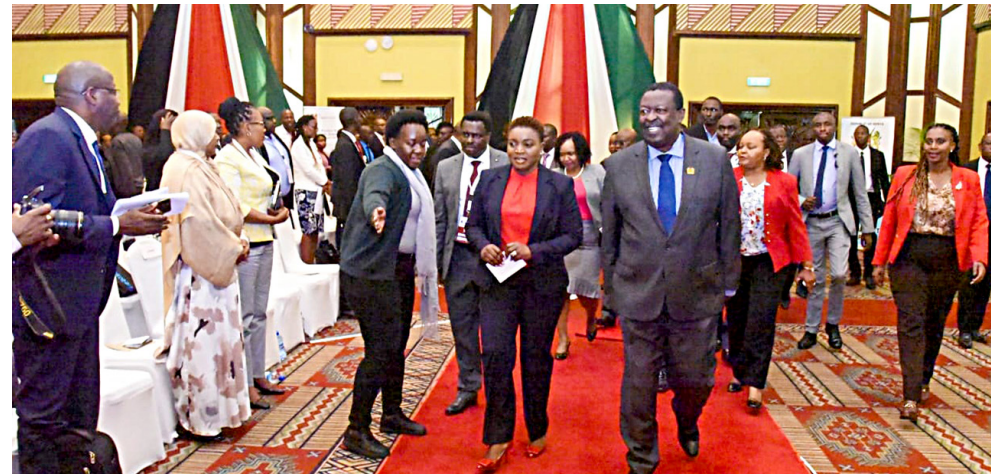

Kenya Bureau of Standards (KEBS) is a statutory body established under the Standards Act, CAP 496, Laws of Kenya. KEBS is mandated to offer quality inspection of imports based on Kenya Standards or approved specifications among other services. KEBS inspects imported goods either in the country of exportation, through the Pre-Export Verification of Conformity (PVoC) to Standards program, and at destination or Ports of Entry. The PVoC services are offered by KEBS contracted inspection companies.

KEBS wishes to inform all stakeholders and the public that **Quality Inspection Services Inc. Japan (QISJ)** was contracted with effect from **19th August 2022**, to offer PVoC services for used motor vehicles, mobile equipment and used motor vehicle spare parts in six (6) countries namely; **Japan, United Kingdom, United Arab Emirates, Singapore, Thailand and South Africa.** QISJ undertakes amongst other duties, verification of year of first registration and confirmation of vehicle ownership.

We have noted with concern increasing number of vehicles from these six (6) countries being imported into the country for **destination inspection**, having not gone through pre-inspection by QISJ and without genuine logbooks from the last country of registration. Some of these vehicles turn out to be stolen vehicles and / or more than eight (8) years old contrary to requirements of **KS 1515:2000, Code of Practice for Inspection of Road Vehicles.**

Therefore, KEBS wishes to notify the public and importers that all used motor vehicles coming into the country **without Certificates of Roadworthiness (CoRs)** issued by QISJ **MUST** be accompanied with the following documents to be eligible for KEBS destination inspection:

- Interpol clearance.
- Logbook and/or the certificate of deregistration from the last country of registration.
- Export documents from the country of origin.

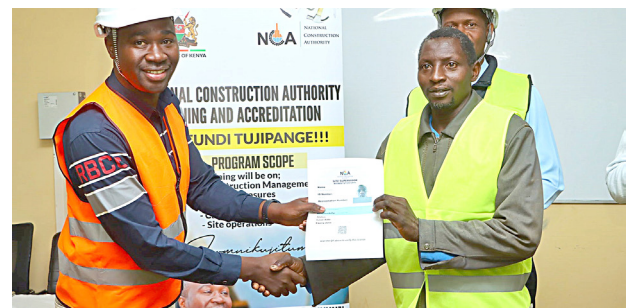

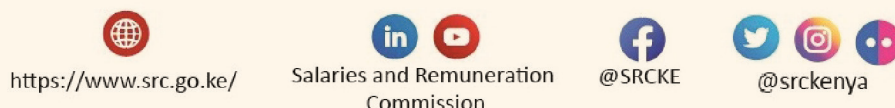

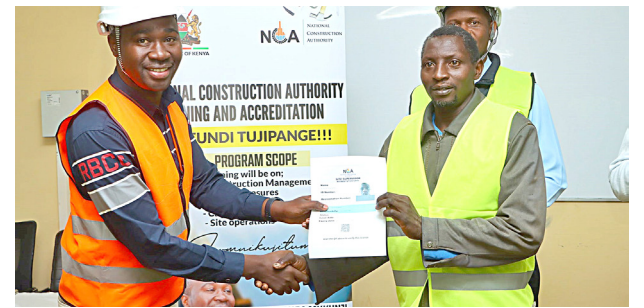

Kwa hivyo, huu ndio mkanganyiko tuliona, wale watakaodhibiti nafasi hiyo na pengine kunufaika wengine wakiwatazama, watatawala dunia," alisema Kisiang'ani.

Katibu alidokeza kuwa serikali imeanza mchakato wa kutoa mafunzo kwa wananchi ili kuboresha ujuzi wao wa kusoma na kuanzisha wa kidijitali ambao unaweza kuwafanya kuwa muhimu katika ulimwengu unaobadilika kila mara. "Uendelezaji wa miun-

dombinu yenye urefu wa kilomita 100,000 utatumwiwa na taasisi za mafunzo na vituo vya afya. Pia itatumwiwa na watu katika sekta ya kilimo, lakini pia itatumwiwa na wale walio katika sekta ya ubunifu," aliongeza Kisiang'ani.

Aidha alibainisha kuwa dunia iko katika njia panda kuhusujinsi ya kutumia maendeleo ya kiteknolojia yanayoendelea kubadilika, na kutoa wito kwa wadau wote kujidhibiti ili kupata manufaa kutokana na maendeleo hayo.

Kaimu Afisa Mkuu Mtendaji wa KoTDA John Paul Okwiri alibainisha kuwa mapendekezo ya Konza Digital Media City na Kituo cha Kitaifa cha Data cha Konza, ambayo yatatekelezwa na Wizara ya Habari, Mawasiliano na Uchumi wa Dijitali kama kipaumbele kwa Awamu ya 3 ya Konza Technopolis ni mipango ya kusisimua ambayo inalenga kuimarisha ukuaji wa sekta ya ubunifu na hivyo kuiweka Kenya kama kitovu cha kinkanda cha ubunifu.

Hospitali ya Busia yafungua wodi za kisasa za upasuaji

Uongozi wa Kaunti ya Busia umefungua wodi za upasuaji katika hospitali ya rufaa ya kaunti hiyo zilizojengwa kwa gharama ya Sh100 milioni. Akizungumza wakati wa ufunguzi rasmi, Gavana Paul Otuoma alisema, jengo hilo la orofa la vitanda 100 litasaidia waathiriwa wa ajali, wagonjwa walio na majeraha sugu, wanaoshambuliwa na wale wanaougua kuziba matumbo miongoni mwa mengine. "Wodi hii ya upasuaji itatusaidia kutoka uwezo wa vitanda 200 hadi vitanda 300," alisema na kuongeza kuwa imesaidia kutatua asilimia 30 ya matatizo yanayokikabili kituo hicho. Hata hivyo, alitilia maanani suala la kuinuliwa kwa vituo vya afya bila kuzingatia uwezo wao wa kutoa huduma zinazohitajika, na kuongeza kuwa ni suala linalopaswa kuchunguzwa upya. "Ninashangaza na wale wanaoruhusu aina hii ya uainishaji kuendelea. Kwa maoni yangu, uainishaji unamaanisha kuwa umetimiza mahitaji ya kukubaliwa katika kiwango unachotaka. Unapowaambia watu kwamba kituo ni Level Five na bado ni Level Four, tunadanganya watu kutafuta huduma am-

bazo hazipo," alisema. Kwa hivyo, Gavana aliangazi Kamati ya Ushauri ya Usimamizi wa Wafanyakazi ya Kaunti ianzishwe ili kuhakikisha inatoa suluhu kwa matatizo yanayokumba sekta ya afya. Dkt Otuoma aliendelea kufichua kuwa mipango inaendelea kwa kupanua hospitali ya rufaa ya kaunti ya Busia ili kuhakikisha kuwa kuna huduma za kila mara kwa wenyeweji, akiongeza kuwa Kituo cha Mafunzo ya Ufundi Busia kitahamishwa ili kutoa nafasi kwa ajili hiyo. Mkuu huyo wa kaunti aliwataka wakazi wa eneo hilo kujiandikisha katika Hazina ya Taifa ya Bima ya Hospitali na kuongeza kuwa uwezo wa bima katika kituo hicho bado ni mdogo na hivyo kuwa vigumu kutoa huduma zinazohitajika. Wakati huo huo, aliwahakikisha Wahudumu wa Afya ya Jamii kwamba ada zao ambazo hazijalipwa zitalipwa hivi karibuni. Kaimu Kamishna wa Kaunti ya Busia Kipchumba Ruto alisema kukamilika kwa wodi ya upasuaji ni hatua muhimu kwa Serikali ya Kaunti katika masuala ya afya. Na Salome Alwanda (KNA)

Mradi wa Chebyuk kutoa maji kwa maelfu Bungoma

Mradi mkubwa wa maji wa Chebyuk-Kibabii katika kaunti ya Bungoma unaofadhiliwa na Serikali ya Kitaifa kupitia Wizara ya Maji, Unyunyuzi na Usafi wa Mazingira unatarajiwa kutoa maji ya kutosha katika Maeneo Bunge ya Mlima Elgon, Sirisia, Kanduyi na Kabuchai. Akizungumza wakati wa ziara ya timu kutoka Kitengo cha Utoaji Huduma ikiongozwa na Kamishna wa Kaunti ya Bungoma Thomas Sankei, Mhandisi Samuel Onzere alieleza kuwa mradi huo ukikamilika pia utahudumia Chuo Kikuu cha Kibabii na shule kadhaa katika kaunti nzima. Mhandisi Onzere alithibitisha kuwa mradi huo una uwezo wa kuvuna lita ujazo 4,000,000 za maji kila siku na kuongeza kituo hicho kitakuwa tayari kutumika kabla ya mwisho wa mwaka huu mtambo wa kutibu maji utakopokamilika kujengwa. "Tuna maji yanayoingilia kutoka Msitu wa Mlima Elgon na itafanyiwa mchakato wa kuyatibu ili yawe tayari kutumika mara tu inapoondoka kwenye kiwanda," Onzere aliongeza. Onzere alisema mradi huo unatazamiwa kunufaisha zaidi ya

boma 86,000 kando na Chuo Kikuu cha Kibabii na shule zinazozunguka. Timu hiyo pia ilitembelea Mradi wa Usambazaji Maji kwa Jamii wa Kopsiro ulioko katika kaunti ndogo ya Mlima Elgon unaotekelezwa na Shirika la Maendeleo ya Maji la Ziwa Victoria Kaskazini, kwa ushirikiano na serikali ya Kaunti ya Bungoma. Mradi wa Maji wa Kopsiro una uwezo wa kuhudumia watu 3,000 bila matatizo. "Mradi huu ulianza 2019 lakini ulikwama kutokana na masuala ya kimatekani. Hata hivyo, unatarajiwa kufufuliwa ndani ya wiki mbili zijazo," alisema na kuongeza kuwa una uwezo wa kunufaisha watu 3,000 na taasisi 50 utakopokamilika, na hadi 8,000 imgao ukifanywa. Kamishna huyo wa Kaunti aliwataka wakazi wa Mlima Elgon kuwa na subira na kuwapa wahandisi muda wa kukamilisha mradi huo. Timu ya ukaguzi baadaye ilielekea barabara ya Misikhu-Naitiri/Nzoia Bridge, chini ya Mamlaka ya Barabara za Mashambani (KERRA) na kumagiza mwanakandarasi kuharakisha uwekaji lami. Serikali imewahakikishia wakulima wa miembe katika Kaunti ya Tana River kuhusu dhamira yake ya kufufua kiwanda cha Matunda kilichoko Hola kinachosimamiwa na Mamlaka ya Maendeleo ya Pwani (CDA).

Kiwanda hicho hutengeneza tani 1,200 za maembe kila mwaka lakini uzalishaji wa maembe ni mkubwa zaidi, hivyo basi kuna haja ya kukiapanua.

Bidhaa ya maembe kutoka kiwanda hicho, iliyoibatizwa jina la Tana Gold, ina hati miliki na CDA inauza kwa wenyeji na makampuni makubwa ya kuzalisha juisi. Pia hutoa soko kwa wakulima wa ndani kupitia ununuzi wa moja kwa moja wa maembe mbichi kutoka kwa wakulima wa ndani na hivyo basi kupunguza hasara baada ya kuvuna.

maembe kwa wingi. Lakini kando na maembe, kiwanda hicho kinaweza kushughulikia matunda mengine ikiwa ni pamoja na mananasi, matikiti maji, na nyanya kwa soko la ndani na nje ya nchi.

Kiwanda hicho kina sehemu ya kusindika asali ambayo inaweza kusafisha na kupakia asali. Pia hutengeneza maji ya chupa kwa

matumizi ya ndani msimu wa matunda kupungua.

Waziri wa EAC, ASALs, na Maendeleo ya Kanda Bi Rebecca Miano alisema mradi huo ni wa kimaendeleo na utawanufaisha wakulima wadogo katika eneo la Pwani.

Alihakikishia CDA kwamba wameanza kukusanya rasilimali pamoja na Katibu wa Idara ya ASALs na Maendeleo

ya Kanda Dk. Idriss Dokota kwa ajili ya upanuzi wa mtambo huo.

"Upanuzi wa mradi wa kusindika matunda utakuwa wa manufaa kwa kaunti na maeneo ambayo inahudumia. Bodi imejadili mradi, na tinalenga kuupanua. Nimefahamishwa kuwa hivi sasa haushughulikii matunda yote yanayopatikana, kwa sababu tu ya ukosefu wa rasilimali za kuupanua," alisema.

Waziri Miano alibainisha kuwa CDA inatekeleza idadi ya miradi, ikiwa ni pamoja na mradi wa vitalu vya ujenzi ili kushiriki katika mradi wa nyumba wa kitaifa.

"Tunahitaji rasilimali, tunahitaji wasimamizi wa utekelezaji wa miradi ya kibinadamu, kwa hivyo tunajitandaa ili tuweze kutoa baadhi ya miradi hiyo ya kipaumbele," Waziri alisema wakati wa uzinduzi wa wanachama wapya wa bodi ya CDA huko Mombasa.
