

Kenya's Public Service Day to shine spotlight on innovations, achievements

Kenya will join the rest of Africa to mark a very important day for public servants in the continent under the auspices of the African Union (AU). As the Ministry of Public Service, Gender and Affirmative Action prepares for the African Public Service Day (APSD), the Principal Secretary for the State Department for Public Service Mr. Amos Gathecha (pictured) explains to MyGov writer **Mutiso Mbithi** what this day entails and the milestones made by the Government to modernize the Public Service to make it customer friendly through digitalization and other innovations.

Q: Please explain what the Africa Public Service Day (APSD) entails.

A: The African Public Service Day (APSD) is a special day for public servants and public service organizations which is celebrated on the 23rd June of every year across the African Continent by African Union (AU) member countries. It is meant to mark and appreciate the work being done by the Public Service and recognize their positive contribution to the socio-economic development of the African Continent. However, here in Kenya, we will mark ours on dates to be announced later this month. To mark the day, celebrations are held through annual national and biennial continental events as a strategy to boost public administration programmes, public sector performance and governance.

Q: What innovations has the **Department for Public Service** put in place to improve service delivery in Kenya?

A: The State Department continuously strives to come up with innovative ways to provide services to the citizens. Some of these are the Huduma Kenya one-stopshop service delivery platforms which comprise Huduma Centres, Huduma Contact Centre; Huduma Mashinani; and Huduma Electronic and Mobile platforms.

Q: What is the government doing to improve public service delivery in Kenya?

A: We have put in place a number of strategies to improve service delivery which include: the re-engineering of service delivery processes, automation and digitalization of government services and providing online services to the citizens. Through Huduma Kenya programme, we have taken services closer to our people and automated 5,000 services. We have given full medical cover for public servants and enhanced their training both locally and internationally in collaboration with development partners.

Q: What attributes does a public servant require to be declared 'Public Servant of the Year?'

A: To qualify for the Public Servant of the Year Award, a public servant should demonstrate outstanding performance of service provision to the citizens, be a person of integrity and accountable for their actions at any level.

Q: How will Kenya benefit from the Africa Continental Free Trade Area (AfCFTA) once it is implemented? What are some of the trade areas?

A: This year, AfCFTA envisages to spur tourism, transport, business services, communication services; financial services, transport services, and tourism and travelrelated services. Through AfCFTA members will progressively eliminate tariffs and non-tariff barriers to trade in goods, liberalize trade in services, cooperate on investment, intellectual property rights and competition policy. Through AfCFTA, we will re-think the

continental financial architecture to integrate youth and women as drivers of cross-border trade while stimulating and reinvigorating access and inclusion is a priority for the future.

Q: How is the government harnessing digital skills especially of the youth for transformation of service delivery to the pub-

A: One of the key objectives of APSD is to recognize the innovations that have been developed by public servants and promote their replication for improved service delivery and majority of the innovations submitted have been developed. Through digitization of government services, we have opened up businesses to hitherto marginalized members of our society through Access to Government Procurement Opportunities (AGPO) which has enhanced economic inclusion in the country.

Q: Please expound on the theme of this year's APSD

A: This year's theme is 'The Future of Public Service as a Catalyst for Revitalizing the Economy and Acceleration of the Implementation of Africa Continental Free Trade Area." It recognizes that the Public Service is operating in an era of increased uncertainty and disruption influenced by technological developments, a robust media, security challenges, geopolitics, emerging pandemics, global disasters and a youth segment under the influence of millennialism, culture, values, bulge, democratization, unemployment and urbanization. The public service workforce is surmounting numerous challenges and leveraging significant opportunities and the theme is premised on the government development agenda with a key focus on innovation to drive economic growth and improve the standard of living for all Kenyans.







Kenya yatwaa uenyekiti wa Benki ya Maendeleo ya Afrika

Kenya imechukua wadhifa wa uenyekiti wa Bodi ya Magavana wa Benki ya Maendeleo ya Afrika (AfDB).

Prof Njuguna Ndung'u, Waziri wa Fedha, alimrithi Gavana wa Misri Hassan Abdalla kama mwenyekiti wa benki ya bara baada ya mkutano wa kila mwaka wa AFDB wiki moja.

Uenyekiti huzunguka kati ya nchi wanachama wa AFDB. Bodi hiyo inajumuisha gavana na gavana mbadala aliyeteuliwa na kila nchi mwanachama ambaye anatumia mamlaka ya kupiga kura sawia na umiliki wa hisa wa nchi yao. Kwa hivyo, Kenya itakuwa mwenyeji wa mikutano ya kila mwaka ya AfDB 2024, jijini Nairobi. Katika hotuba yake ya kukubali, Waziri Ndung'u alisisitiza kujitolea kwa Serikali ya Kenya kuhakikisha mikutano inafanyika.

Waziri alisisitiza jukumu la taasisi za maendeleo kama muhimu katika kuunganisha na kukusanya rasilimali zinazohitajika ili kupunguza athari za mivutano ya kijiografia, janga la Covid-19, utoshelevu wa chakula na mabadiliko ya hali ya hewa. Alisema AfDB ina bidhaa mbalimbali ambazo nchi za Afrika zinaweza kuzitumia ili kufikia utangamano wa kimkakati wa Afrika. "Mipango ya Benki, sera, mikakati na uendeshaji vinatarajiwa kuhamasisha zaidi ufadhili wa

maendeleo ambao ni muhimu kwa ustahimilivu katika kip-indi kijacho," Profesa Ndung'u alisema. Waziri huyo alisema Benki ina uwezo wa uchumi kwa Afrika kutafuta maendeleo na pia kuiweka katika njia ya kufikia malengo ya Ajenda ya 2063. Waziri alipongeza juhudi za AfDB kwa kuwa mstari wa mbele katika maendeleo ya kimataifa na kuwa mshirika mkuu wa maendeleo katika Mataifa yote ya Afrika.

"Mjadala wa sasa ni jinsi gani benki za maendeleo zinapaswa kutoa msaada kwa maendeleo na kutatua dharura kwa njia ya haraka, rahisi na ya kina. Kwa hili nathibitisha kuunga mkono kazi na maono yake tunapofanya kazi pamoja kwa ajili ya kuboresha watu wetu," waziri alisema.

Rais wa Benki hiyo, Akinwumi Adesina, alitoa wito kwa viongozi kuzingatia maeneo yenye faida linganishi, akisema changamoto za Afrika zinahitaji ushirikiano katika utekelezaji wa maendeleo na uhamasishaji wa rasilimali.

Mikutano hiyo ya kila mwaka inayowaleta pamoja mawaziri wa fedha na maendeleo, watunga sera, taasisi za serikali, mashirika ya kimataifa ya maendeleo, mashirika yasiyo ya kiserikali na wadau wengine mwaka huu ilifanyika Sharm El Sheikh Misri.

Wagonjwa hao walitambuliwa na timu ya madaktari waliotoa uchunguzi wa matibabu bila malipo ambao ulifanyika katika hospitali ndogo za kaunti kufikia tarehe 29 Jumatatu wiki hii.

Gavana wa Makueni Mutula Kilonzo Jnr aliipongeza timu hiyo kwa kutoa huduma nadra za matibabu kwa wakazi kutoka Makueni na kaunti jirani.

Mutula aliongeza kuwa uongozi wake umejizatiti kutoa sehemu ya ardhi ili kuanzisha kituo cha upasuaji wa mishipa ya fahamu mjini Wote katika juhudi za kutoa huduma za kimatibabu kando na kutoa mafunzo kwa wanafunzi.

Aliongeza kuwa mipango inaendelea kuboresha kambi ya upasuaji wa mishipa kuwa ikifanyika kila wakati.

Kampuni yatumia Sh 250m kwa miradi katika Laisamis

Maisha yamekuwa magumu kwa maelfu ya wanafunzi katika Eneo bunge la Laisamis ambako maji ni anasa, na elimu ni ndoto isiyoweza kutimia.

Kwa kuchoshwa na kutokuwa na uhakika wa hali ya hewa, tamaduni zilizopitwa na wakati na miundombinu duni, wanafunzi wanajikuta katika hali gumu hasa wakati inakuwa vigumu kupata chakula.

Imekuwa ni kawaida kwa wasichana na wavulana kufuku-zwa shule ili kufanya kazi za nyumbani ikiwa ni pamoja na kuchunga mifugo. Wasichana hao wakati mwingine hulazimika kuanzisha familia katika umri mdogo, baada ya kukeketwa, na hivyo kuacha shule kabisa.Lakini upepo wa mabadiliko hatimaye umeanza kuvuma kuelekea kwa watoto na wakazi kwa ujumla wa Laisamis. Serikali na washirika wake wa maendeleo wanajitahidi kukabiliana na vikwazo hivyo katika harakati za kubadilisha maisha ya wakazi ambao wengi wao ni wafugaji. Mradi wa Umeme wa Upepo wa Ziwa Turkana (LTWP) umewasaidia Wakenya hao. Mradi umesaidia kuboresha shule na umetengeneza mtandao wa barabara za ndani ili kurahisisha harakati na usimamizi wa shughuli za masomo. Kupitia "Winds of Change (WoC) Foundation", kampuni imetumia Sh250 mil-ioni katika kipindi cha mwaka mmoja uliopita katika shughuli zake za Uwajibikaji kwa Jamii ambazo ni pamoja na ujenzi wa mabweni na madarasa, ukarabati na kuchimba visima na kuwasaidia wakazi kukabiliana na tatizo la hali ya ukame na njaa. Katika Shule ya Msingi ya Titus Ngoyoni na Shule ya Msingi ya Loiyangalani katika kaunti ndogo ya Loiyangalani, LTPW imefadhili ujenzi wa bweni la wasichana lenye vitanda 96 katika kila shule ili kuongeza usajili na kuboresha matokeo. Katika Shule ya Msingi ya Layeni katika kaunti hiyo ndogo, madarasa mawili va kisasa venve uwezo wa kuhifadhi wanafunzi 40 kila moja pia yamefadhiliwa na kampuni hiyo hadi kukamilika kwa kuunga mkono utekelezaji wa CBC.
