State signs deal to roll out Universal Health Coverage in all 47 counties

ealth Insurer, the National Health Insurance Fund (NHIF) will soon be transformed into a Social Health Insurance Fund (SIF) as the Government seeks to roll out effective Universal Health Coverage (UHC) in the 47 counties.

According to Health Cabinet Secretary Dr. Susan Nakhumicha, an agreement has already been signed between the national government and the 47 county governments to roll out the UHC in the country with immediate effect through a thorough process of stakeholder engagement.

Dr Nakhumicha says in the new arrangement, the funding for Level One, Two and Three facilities will be financed through a public financed mechanism and individual capitation, while Level Four and Five

Hospitals will be financed through Social Health Insurance while Level Six will be financed through a Critical Illness Fund and Social Health Insurance.

In a joint communique read by Council of Governors (COG) chair Ann Waiguru at the end of a two-day meeting in Naivasha whose aim was to review the intergovernmental relations and engagements between the

Gov't explores strategies to reduce petroleum costs, high cost of items

¬he Government is currently working on various strategies aimed at reducing the cost of petroleum products and ultimately reduce the cost of living for its citizens.

Energy and Petroleum Cabinet Secretary Davis Chirchir told a parliamentary committee that his ministry is considering all possible ways of reducing the cost of the products to attain feasible solutions that will benefit all Kenyans.

Speaking during a consultative forum held by the National Assembly Departmental Committee on Energy, Chirchir said that the ministry was working on the scrutiny of internally generated revenue and other measures to reduce the cost of petroleum products.

"The increase of the cost of petroleum products causes inflation, yet it is very important to work on the drivers of the economy

to stay afloat so as to stop affecting the prices of other commodities too," he said.

The CS also said the ministry was discussing reconciling and budget reporting the process. "The energy committee has gone ahead of all the others to discuss and concluded that we will have to work on the list that will help us make our budget and report," he said.

This, he said, will help to look into the challenges and concerns that have been raised and be able to sort them out as well as have full disclosure of finances allocated to the ministry. He added that this was a good discovery the committee had made to ensure that the ministry is able to resolve budgeting and reconciliation templates.

"Demurrage charges can accumulate from one million dollars to seven million dollars affecting the price of petrol when allocation

is done," Chirchir said. He explained that the long delays to offload the petrol from chartered ships is as a result of the few facilities available, which then leads to the accumulation of the demurrage charges.

The CS said the ministry has been trying the Government to Government (G2G) policy from international oil companies for two months now and it had turned out to

prove that there is less risk involved unlike what was perceived earlier.

The chairman of the Energy Committee of the National Assembly Departmental Committee Eng. Vincent Musyoka said the main agenda of the meeting was budget reporting and engagement between the committee and the ministry.

two levels of government said after the two-day sensitization of governors and the county executive committee members in charge of health, they are now ready to roll out the UHC in earnest.

Dr Nakhumicha noted that her ministry, on behalf of the national government and the counties had signed the Inter-Governmental Participatory Agreement (IPAs) and her ministry has been given a go ahead to enter into service level agreement with county governments to ensure services are provided at county levels since UHC was a key component of the Kenya Kwanza manifesto.

To this end, the CS said the IPAs has solved the impasse between the national and the county governments that had been brought about by the earlier system known as Medical Equipment Management Service which has now been replaced by

National Equipment Support to counties.

MEMS has been unpopular with governors as they perceived it as a national government affair which excluded them from its acquisition and was bedevilled with challenges such as lack of manpower to operate the equipment. The purpose of the two-day meeting was to find ways to strengthen the health

sector-specific intergovernmental collaboration and address emerging issues which include: Community Health Promoters (CHPs), Operationalization of Primary Healthcare Networks (PCNs), Sustainability of UHC, Medical Equipment and related services deployed by the national government in counties and NHIF reforms among others.

CS proposes to have local engineers' involved in Public **Private Partnership Projects**

The Ministry of Roads and Transport has mooted a proposal to review the existing procurement laws to cap a provision of 40 per cent for local professional engineers in all public-private partnership

This is meant to ensure local engineers take part in the growth and development of the country's economy by tapping their knowledge, skills, and new technologies to actualize the government agenda.

Cabinet Secretary Kipchumba Murkomen says the local engineering profession holds the key to unlocking and unleashing the potential of emerging technologies in the industry for the benefit of Kenyans.

Murkomen said his ministry has moved with speed to align its policies and programmes with sector targets including the Sustainable Development Goals, Agenda 2063, Vision 2030, the Fourth Medium

Term Plan (MTP IV), and most crucially

the Bottom-Up Economic Transformation Agenda (BETA).

He said the ministry is actively seeking to scale up the use of public-private partnerships financing for commercially viable projects including new highways, seaports, and airports and others among which the local engineers should be part and parcel of.

The CS disclosed that in the road's sub-sector alone, the government is undertaking projects portfolio valued at Sh700 billion which are geared towards reducing the cost and duration of travel across the country and the region.

Other projects being un-

dertaken by the ministry are the modernization of the National Air Traffic Management System and disaster

recovery centre at a total cost of Sh1.1 billion which will be completed by 2026. Murkomen said the government is also seeking funding for the extension of the Standard Gauge Railway to Malaba, the planned construction of the Mombasa-Malaba Highway, and the ongoing rehabilitation of the Metre Gauge Railway lines across the country.

The CS however said that despite these multi-billion shilling investments, local engineers continue to miss opportunities to engage meaningfully in the projects due to their low professional and financial reach.

The ministry will introduce a change in policy and laws to recommend local engineers to undertake 40 per cent of capital projects under public-private partnerships," Murkomen said.

The CS, who was addressing participants during the 4th Engineering Partnerships Conference in Naivasha, said the program has a current cohort of 220 trainees and is set to train 1,000 others in the next two years.

Data Protection Commissioner leads nationwide campaign to raise awareness on data privacy

¬he countrywide sensitization campaign spearheaded by the office of the Data Protection Commissioner on Data Privacy and Protection Act (DPA) 2019 has entered its second phase to create awareness and ensure effective implementation and enforcement of the law.

The campaign that targets data controllers, processors and the general public has so far covered 17 counties out of 47 and intends to complete the remaining counties before the end of June this year.

Among the counties to be visited during the second phase are Mombasa, Kilifi and Kwale in the coastal region.

The Data Protection Act that was enacted in 2019 seeks to protect the privacy of individual and personal data by regulating the processing of personal information by data controllers and processors.

This is the first ever campaign in Kenya dedicated to the topic of personal privacy and data protection and also aims at raising awareness about the responsibilities of public authorities and private companies in collecting and storing personal

During the campaign forum in Mombasa, stakeholders lauded the commission for spearheading public education on data protection.

The key speakers at the Mombasa event agreed on the necessity to further work on awareness regarding the importance of personal data protection in today's digital era.

commissioner (CC) Abdirizack Jaldesa, the speakers said the on-going campaign by the Data Commission will help citizens to know their rights and reduce cases of data breaches or privacy violations.

"We need strong laws to enhance digital security systems against the grow-ing threat of data violation, " said Jaldesa in a speech read on his behalf by the Assistant County Commissioner Irene Musyoki.

The County Commissioner said there is a need to develop strategies for the safety and security of data collected by the government, corporate organizations and other entities.

He noted that the government is one of the biggest collectors of personal data for the purpose of improving efficiency in the delivery of public services saving the information provided must be safeguarded.

Government implements life-saving projects in Garissa through KDRDIP

CA boss urges broadcasters to adapt to tech disruption for industry growth

The Communications Authority (CA) of Kenya has urged content creators and broadcasters to embrace the emerging technological trends in the sector in order to benefit from the infrastructure laid down through the government's digital transformation agenda.

CA Director General (DG) Ezra Chiloba said, he is aware that many traditional broadcasters are going through difficult times especially in generating revenue from advertising because of the nature of the technological disruption being witnessed in the sector.

"The question is how does the traditional media reposition itself to remain relevant and profitable in the new era," Chiloba said.

Speaking at a Nairobi hotel during the inaugural Kuza Awards Conference, Chiloba said that it is a fact that the present digital revolution cannot be stopped and or people left behind. "It is therefore my hope, that a platform such as what we have today, will form an avenue, to discuss the imperatives for the broadcasting industry to stay on top of this current technological disruption," Chiloba said.

He noted that as an authority, CA is carrying out regulatory reviews to see to it that they are responding to the changes in the sector as he called for comments and ideas from players in the sector as the government seeks to make it better. "The Authority developed the Programming Code for Radio and Television which came into force on July 1, 2016. On achieving the above milestone, CA opted for the 'carrot' as opposed to the 'stick' approach to enhancing compliance in the sub-sector. This is what saw the birth of the now renowned 'KUZA' Awards that premiered in 2017. The awards celebrate excellence in our broadcasting industry and reward responsible broadcasting," Chiloba explained.

According to the implementation committee chairperson of the maternity, Ali Hassan, an average of between 120 and 150 women give birth at the facility annually.

Area leaders called it a game-changer. The project is funded by the government and the World Bank with an aim of improving access to basic social services, expanding economic

opportunities, and enhancing environmental management in the refugee-hosting communities of Garissa, Wajir, and Turkana counties.

The World Bank, led by Matthew Stephens and his deputy Annette Omollo and officials from the KDRDIP led by its manager Wilfred Omari, toured several project sites to assess and review their implementation progress ahead of the project's deadline in December 2023.

They toured the Afwein Primary School where KDRDIP constructed an administration block and renovated five classrooms, Modogashe Girls' Secondary School, who got a multipurpose hall, a library and class renovation and the Modogashe town lighting project.

The teams also visited several livelihood groups who received grants of Sh500,000 to set up businesses.

KDRDIP is a Sh10-billion credit programme from the World Bank to the Government of Kenya, and an additional grant of Sh800 million by the Danish Government (DANIDA).

India High Commissioner to Kenya Namgya Khampa said that Kenya and India have a very old and historical relationship and the diaspora can play a critical role in bringing the two countries closer.

Kenya Building Research Centre roots for affordable building materials

BY PARIN WANJIRU (PCO)

¬he Kenya Building Research Centre is rooting for the use of appropriate building materials and technologies alongside traditional building materials in order to promote sustainable construction practices and support the government's affordable housing agenda.

After conducting a survey in Kilifi County and mapping of traditional building materials using the Global Positioning System (GPS) device the KBRC which is domiciled in the State Department of Public Works has identified materials such as coral sand, coral stones, coconut leaves

(makuti), mangrove poles and timber as some of the locally available traditional building materials largely used by the local people in

the construction of houses which could be domesticated in the construction industry to compliment traditional building materials.

Although these traditional building materials are preferred due to their availability and aesthetic value, KBRC noted that there was a need to adopt appropriate building materials and technologies since the extraction of these traditional materials is unsustainable and may consequently lead to environmental degradation.

The study, which was led the KBRC Director Oliver Okelo, emphasized on the need for wider adoption of sustainable building materials, innovations and technologies such as the expanded polystyrene, light gauge steel framing, interlocking soil blocks and finishers like eco-friendly paints, industrial wood, unplasticized polyvinyl chloride windows and doors since these modern technologies have proved to be more versatile, environmentally friendly and cost-effective.

Okelo noted that expanded polystyrene is a light weight foam insulation material that offers thermal insulation and sound-proofing properties and its ease of installation, moisture resistance and versatility makes it an ideal choice for walls, roofs, and

The survey further revealed that light gauge steel framing, which on the other hand is used to make floors, roofs and frame walls presents a cost-effective and durable construction technology while interlocking soil blocks is a sustainable building technique which offers environmental friendliness, cost-effectiveness and the ability to construct various structures in both private and public sectors.

Gvt develops National Maritime Transport Policy

The Ministry of Mining, Blue Economy and Maritime Affairs has developed a National Maritime Transport Policy to address challenges in the growth of maritime transport services in the country.

The engagements commenced with Mombasa and Lamu Counties two weeks ago and will be followed by Tana River, Malindi, Taita Taveta and finally Kwale County between 19th - 30th this month.

According to the Cabinet Secretary for Mining, Blue Economy and Maritime Affairs, Mr. Salim Mvurya, the development of the document is informed by the realization that a coherent and sound National Maritime Transport Policy is an integral ingredient for sustainable utilization of maritime resources

"The overall Policy goal is to create a coherent governance framework and build the requisite capacities for trade facilitation while guiding the development of a safe, secure and environmentally friendly maritime transport sector for sustainable development", says the

He noted that the policy has come at an opportune time when the country is witnessing heavy infrastructural developments in both rail and ports, such

as Lamu Port-South Sudan Ethiopia Transport (LAPSSET), construction of the second phase of the New Container Terminal 2 (1.2M TEUs), Dongo Kundu Special Economic Zone, Dongo Kundu Distribution-parks, Shimoni Integrated Port Development Project, and Lamu Coal Power Station among others.

Mvurya said that key areas have been identified in the policy among them Maritime Trade Development and Facilitation, Maritime Safety, Maritime Security, Maritime Education and Labour, Maritime Environment and coordination and implementation of International Maritime Organization instruments.

In a speech read on his behalf by the Director of Shipping in the State department Mr. Julius Segera, during the launch of stakeholder's validation workshops at a Mombasa hotel, the Principal Secretary State Department for Shipping and Maritime

The policy, Mwadime said, proposes a number of interventions whose successful implementations will propel the country to higher economic path.

These include developing and promoting incentives for maritime transport industry development, developing a national maritime education and training policy, enhancing maritime search and rescue services, develop and implement the National Security Strategy and Risk Register and develop and enforce maritime Labour Force related framework.

"Development and implementation of the National Maritime Transport Policy will not only enhance the development of the Blue Economy but also improve the country's competitiveness in the international maritime domain" noted the PS.

Mwadime thanked stakeholders for making significant contribution in the formulation and development of the policy, saying while public participation is a guiding principle as enshrined in the constitution, "the wide spectrum of experiences gained through the process will ensure successful implementation of the policy for the country's trajectory growth."

The Kenya National Food Fortification Alliance, Ms Muthoni noted, will go out of its way to focus on enhancing the nutrient content of these everyday staples in order to improve the overall health and wellbeing of the citizenry with a particular bias towards vulnerable groups.

Persons living with albinism get free skin cancer screening

eople with albinism in Nyamira have received free skin cancer screening tests and medical interventions in marking International Albinism Awareness Day.

The lead dermatologist Dr Beatrice Itemesi who is also a consultant at the Nakuru Referral Hospital told KNA that people with albinism are prone to skin cancer because of the effects of constant direct contact with ultra violet rays from the

"Kenya has lost several people with albinism to skin cancer due to inability to seek early medical diagnosis and treatment and some have alluded to these deaths to witchcraft because they never sought any medical intervention," Itemesi said.

"This necessitated the office of National Council for Persons with Disabilities (NCPWD) in conjunction with the Department of

Health Services to initiate a that cases of skin cancer for programme to screen people with albinism across the country so as to know their health status in relation to skin cancer so that they can start treatment and other medical interventions immediately for those who test positive," she added.

Dr. Itemesi said skin is a mirror to the soul and therefore needs optimal care for it to reflect what is inside an individual.

"People are happy with their lives when they are happy with their skin and are able to work and feel normal just like everybody else who has 'normal' skin," she said.

She noted that since initiation of free screening for skin cancer blended with other medical interventions for other skin related conditions, the skin of people with albinism has greatly improved.

The prickly red skin with rashes has disappeared for those who consistently use the sun screen lotion, she said.

The dermatologist observed

people with albinism have reduced over time because they have embraced self-skin care after sensitization sessions which have helped them know and appreciate the value of a well-cared for skin.

"They are happier because their skin is flawless and the red rashes have vanished. The most common type of skin cancer for people with albinism in Kenya is called oculocutaneous (OCA) which affects the skin, hair and eyes and has tendencies of spreading fast to other parts of the body like lungs and liver and heart. It can be quickly detected when you see brownish patches on the skin of a person with albinism or burnt lower lips which look pale and cracked," she said.

Mr Stephen Wafula, a senior accountant at NCPWD, who has albinism, said they have struggled very much to fight stigma and discrimination and put up with name-calling and use of derogatory words from the community.

TVET curriculum reforms focus on skills through dual training system

(KNA)

The Government has intensified the rollout of the Dual Training System in the TVET curriculum to address the unemployment and skills gap among the youth.

The State Department for Technical, Vocational Education and Training (TVET) says through the curriculum reforms, graduates would be largely exposed to practical knowledge required to join the job market than theorybased education.

The module allows learning to take place alternately in two venues - the training centre and the company.

Consequently, the Government has partnered with industries and institutions to roll out the new system where trainees typically spend 70 per cent at a company and only 30 per cent at a vocational centre and subsequently get absorbed into the firms upon graduation.

Education Cabinet Secretary Ezekiel Machogu stated that the adoption of the Dual Training System was in line with the Competency-Based Education and Training (CBET) module for TVETs and is anchored on practical

and industrial exposure.

In a speech read on his behalf by State Department for TVET Principal Secretary Dr Esther Muoria during the launch of Kisumu National Polytechnic Strategic Plan (2023-2027), Machogu noted that the new system provides an effective way to incorporate practical knowledge from industries with theories taught in the classrooms.

"This shift will focus on training learners for specific

industries depending on the labour demand. The firms will tell us the skills that they need, which will inform our decision to admit students for a particular course with an idea of the companies they will work for upon graduating," the Cabinet Secretary stated.

Through the help of our partner industries and institutions, Machogu pointed out, the trainees have the opportunity to be exposed to get hands-on experience and guidance from the already qualified staff thus increasing chances of their employ-

On her part, the Principal Secretary TVET DrMuoria, reiterated the profound benefits of the dual training system citing it as a key driver in revolutionizing the TVET sector and boosting the output of the young workforce.

The new training modality, she noted, enables trainees to acquire work ethics and learn the culture of the company in the process of learning the needed skills.

'Companies tell us the skills they want to be trained at TVET centers. Hence, 70 per cent of the coursework for the trainees is based on these industries, offering them an opportunity to also learn the company's culture. This produces all-rounded graduates who can easily fit in the job market," Muoria explained.

In addition, the PS stated that the government seeks to leverage the global space to establish a dual training system with firms in foreign countries to develop a local workforce whose skills are aligned and meet international standards.

Kenya Urban Forum 2023 to review urban sector laws

■ The First Edition of the Kenya Urban Forum 2023 which has been running in Naivasha for the past one week has resoved to review and harmonize all urban sector regulations and the County Government Act 2012 in order to support Urban Development in the country

The three day inaugural Forum which is the first of it's kind to be held in Kenya attracted Professionals from the National Government, County Government as well and Internationally and was opened by President William Samoei Ruto and closed by the Deputy President Rigathi Gachagua. Among the thirteen resolutions made by the delegates were that the National and County Governments in partnership with urban sector stakeholders shall review and harmonize the urban sector Legislations including the Physical and Land Use Planning Act 2019, Urban Areas and Cities Act 2011 (amended in 2019) to guide urban planning and development in the

The forum also resolved that the two levels of the Government, and other urban sector stakeholders shall review theSessional Paper No. 1 of 2016 on the National Urban Development Policy to align to existing urbanization dynamics and realities.

It was also agreed that, the National Government in collaboration with the Council of Governors shall create a framework to establish, and operationalize the National Urban Development Fund as provided for in the National Urban Development Policy.

The County Governments with the support of National Government and urban sector stakeholders shall establish mechanisms to leverage ownsource revenue potentials as identified in the study by the Commission on Revenue Allocation including adoption of innovative funding mechanisms such as the Land Value Capture.

They also agreed that National and County governments shall strengthen and expand cooperation and multilevel climate action in order to enhance inclusion of local-level contributions in new and updated nationally determined contributions and support the implementation of nationally determined contributions at the local level.

The delegates also agreed that the two levels of the Government shall collaborate in the provision of adequate housing for all including by integrating urban social rental housing into the Affordable Housing Program (AHP).

CS expresses concern over malnutrition in drought stricken semi arid counties

The Government has decried the level of malnutrition affecting children under-five years, expectant and lactating mothers in a number of Arid and Semi-Arid Lands (ASALs) across the country as a result of the prolonged drought which hit some parts of the country.

The Cabinet Secretary for East African Community, Arid and Semi-Arid Lands and Regional Development Ms. Rebecca Miano said, despite the fact that the March, April and May rainfall season experienced early this year delivered positive impacts in most ASAL areas, malnutrition still remains a threat in

the six counties of Marsabit, Mandera, Garissa, Baringo, Turkana and Isiolo.

MsMiano said even though malnutrition has reduced, there is need for intervention in the six counties and other ASAL areas that are affected by livestock diseases, high prices of maize and access to water for livestock.

In a statement on the drought situation in the country, the CS singled out Garissa, Isiolo, Marsabit, Samburu, Tana River, Baringo, Turkana, Kajiado, Kil-III, Meru North, Narok and West Pokot as the counties affected by livestock dis-

Consequently, the CS announced that the government, in collaboration with partners, will continue to support drought intervention measures by providing unconditional cash transfers, screening and treating malnutrition cases, rehabilitating and maintaining water facilities, treating and vaccinating against emerging livestock diseases by county governments in order to cushion lives and livelihoods of affected communities. "The government and partners are undertaking these interventions as a measure to boost resilience against drought and other climate-related shocks," said Miano.

The CS also announced that her ministry, through the National Drought Management Authority (NDMA) is de-silting water pans and restocking livestock in the highly vulnerable households in targeted counties.

"The ministry through NDMA is closely monitoring the drought situation as the government prioritizes long-term climate adaptation and resilience building for the ASALs," she stated.

She further stated that the government, through the Kenya Food Security Steering Group (KFSSG) will next month conduct the long rains food and nutrition security assessment for this year to determine the impact of the long rains on the local livelihoods, whose outcome will determine both the medium-term and long-term drought interventions.

Nakuru County builds Sh90 million shelter for gender based violence victims

■ Nakuru County Government has launched the construction of a Sh90 million Gender-Based Violence (GBV) rescue centre where victims of gender violence could seek help.

The centre in Gilgil constituency, according to the County Chief Officer for Youth Gender and Sports Ms Stella Mwaura, is the first of its kind in the devolved unit

MsMwaura said the centre is a milestone for the county as it will provide shelter to victims of gender violence, some who have been living on the streets, corridors and markets.

"This is not to say that we're encouraging GBV in our society. We will not allow people to walk out of their homes on the slightest excuse to come and stay here. The days when people treated their spouses like personal property and as-saulted them at will are long gone," she said.

According to the Chief Officer, the first phase of the project will involve construction of a hostel, multipurpose rooms and counselling cubicles. Speaking during the official handover of the site to the contractor, MsMwaura disclosed that it will be the second facility of its kind in the country, after the one in Makueni County. Mwaura stated that the centre will be run by professionals who will be conducting thorough vetting before admitting those seeking to be accommodated so as to weed out undeserving cases out for free accommodation.

Also present were Chief Officer in the Office of the Governor Mr Newton Mwaura and his Resource Mobilisation counterpart Mr Alex Maina. She said the centre will help

to track GBV incidents in the 11 sub-counties to ensure a proper database that would inform government interventions. "Our preliminary studies have indicated that most of those who get involved in GBV abuse alcohol and drugs. Others are still trapped in outdated cultural beliefs and they assault their wives as a way of asserting themselves," she said. By Anne Mwale(KNA)
