Katibu wa wizara Dkt Idris Dakota asema GDMIS itafanya idara za serikali kuripoti na kutoa hali ya utekelezaji wa miradi chini ya usimamizi wao kwenye mfumo wa pamoja

Utekelezaji wa Mfumo wa Taarifa za Usimamizi wa Utekelezaji Serikalini (GDMIS) unatazamiwa kuleta mageuzi katika namna serikali inavyopoti kuhusu mafanikio yake. Dkt Idris Dokota, Katibu wa Masuala ya Baraza la Mawaziri, alitoa tangazo hili wakati wa warsha iliyo-husisha Wizara, Idara, na Mashirika 18 (MDAs) mjini Mombasa. Alieleza kuwa GDMIS itawezesha idara zote za serikali kutoa taarifa kuhusu hali

ya utekelezaji wa miradi iliyochini yazo kupitia mfumo wa pamoja.

Dokota alisisitiza kuwa mfumo wa mtandaoni una uwezo wa kufuatilia hali ya utekelezaji wa maamuzi yote ya baraza la mawaziri na magizo ya rais kwa wakati halisi, kutoa uchanganuzi wa uwajibikaji na usahihi wa hatua muhimu za serikali. Zaidi ya hayo, GDMIS itatoa zana kwa wananchi kutathmini utendaji wa serikali katika utoaji wa huduma na kutimiza ahadi za kampeni za

ucaguzi.

"Maendeleo ya GDMIS yanawiana na ajenda ya serikali ya mfumo wa kidijitali ambayo inalenga kuhakikisha kwamba utekelezaji wa programu na miradi unafanywa kwa ushirikiano na kukiwa na nafasi ndogo ya kurudiwa au kuingiliana," alibainisha.

Katibu alisema kuwa GDMIS ikishatekelezwa kikamilifu itatoa wigo mpana ikiwa ni pamoja na sheria na vile vile hali ya mikataba ambayo nchi inashiriki na kuhushishwa ndani ya sheria zake.

Katibu alisema, "Mfumo huu utaweka data kati ya mradi, kuongeza uwazi kwa kutoa hali ya mradi kwa wakati halisi, na kuweka uwajibikaji wa juu kwa kupanga ma-

Waziri la Nishati na Petroli, Davis Chirchir, alisisitiza kwamba ununuzi huu hau-taongeza tu uwezo wa kuhifadhi petroli na bidhaa bali pia kuharakisha matumizi ya Gesi (LPG). Hili litaafikiwa kwa kuanzisha ushughulikiaji na uhifadhi wa wingi wa LPG wa kuagiza bidhaa katika matangi ya kuhifadhiya ya KPRL huko Changamwe, Mombasa.

Mkurugenzi wa Ufuatiliaji na Tathmini Ofisi ya Mkuu wa Utumishi wa Umma Mathayo Rotich alisema mfumo huo utaweza kubaini changamoto zinazoweza kuikwamisha mipango ya serikali.

Rotich alizsema kuwa

kabla ya kuundwa kwa GDMIS, Maamuzi ya Baraza la Mawaziri na Maagizo ya Rais yalikosa mbinu iliyopangwa vyema ya kuratibu utekelezaji, kuripoti na kuimarisha ushirikiano kwa ufanisi.

Hivyo, alisema, maagizo mengi yamesalia kutotekelezwa au yamepingwa mahakamani na wananchi.

KPRL, Chirchir alibainisha, itasalia kuwa chombo cha kisheria kama kampuni tanzu ya KPC na kwa mujibu wa ajenda ya Kenya Kwanza ya kubuni nafasi za ajira, hakutakuwa na kupotea kwa ajira kwa sababu ya ununuzi huo.

Katikati ya msitu mkubwa wa kiasili juu ya milima ya Kasighau wenye mandhari ya kuvutia kuna ajabu ya asili: chemchemi za asili zilizobatzwa jina la Lalambela na wakazi.

Maji baridi kutoka kwenye chemchemi yamekuwa yakinirika chini ya uso wa mwamba wa vilima vya miamba ya kale kwa muda mrefu, yakinyunyuzia mashamba yaliyokauka na kuzima kiu ya maelfu katika vijiji, viliyuo kame.

Chemchemi hizi za kudumu ni uti wa mgongo wa Mradi wa Maji wa Kijamii wa Bungule, ambaa huhudumia maelfu ya nyumba za mashambani katika vijiji vya Bungule na Jora jirani na Mbuga ya Kitaifa ya Tsavo katika Kaunti Ndogo ya Voi. Wakati wa kiangazi, mradi pia hutoa maji kwa nyumba katika baadhi ya maeneo ya kijiji cha Rukanga.

Naye Katibu wa Mradi wa Maji Bungule Bw Daudi Mwashighadi anaeleza kuwa jamii kuititia kamati ya mradi inawajibika kikamilifu katika mradi huo ikiwa ni pamoja na



usambazaji na ukarabati wa sehemu zinazohitaji ukarabati. Licha ya mafanikio ya mradi huo, kuongezeka kwa idadi ya watu na ukataji miti uliokithiri katika mil-

Takwimu kutoka kwa Idara ya Maji zinaonyesha kuwa kaunti hiyo ina miradi 112 ya maji ya jamii. Miradi hii, hasa inayopatikana katika maeneo ya mashambani, inahudumia zaidi ya asilimia 50 ya wakazi wa kaunti hiyo

Serikali na washirika wake wa maendeleo imeneanzisha mradi muhimu wa Sh750 milioni wa Uchumi wa Baharini un-aotarajiwa kuleta manfaa kwa zaidi ya familia 50,000 katika Kaunti ya Kilifi. Mradi wa Regenerative Seascapes Project for Planet Earth, Nature, and People (ReSea) (Re-Sea) ulizinduliwa rasmi na Salim Mvurya, Waziri wa Madini, Uchumi wa Baharini na Masuala ya Bahari. Hafla ya uzinduzi ilifanyika katika Shule ya Msingi ya Dabaso eneo bunge la Kilifi Kaskazini, Kaunti ya Kilifi.

Lengo kuu la mradi wa ReSea ni kuimarisha hali ya hewa na ustahimilivu wa kijamii na kiuchumi kwa watu katika ukanda wa pwani wa Kenya, kuanzia Takaungu katika Eneo Bunge la Kilifi Kusini hadi Marereni katika Eneo Bunge la Magarini, kama alivyoeleza Waziri Mvurya. Mpango huu ni sehemu ya mradi wa miaka mitatu wa Sh3.3 bilioni unaotekeliza na

Missions Inclusive kwa ushirikiano na Muungano wa Kimataifa wa Uhifadhi wa Mazingira, kwa ufadili uliotolewa na Global Affairs Canada.

Wakati wa uzinduzi wa mradi huo, Mvurya ali-sisitiza kuwa wengi watakaonufaika ni pamoja na vikundi vya wanawake na vijana vinavyojihusisha na mipango ya mabadiliko ya tabianchi na uchumi wa baharini. "Mradi utahamasisha wanawake, vikundi vya vijana, na mashirika yanayohusika na mabadiliko ya hali ya hewa na uchumi wa baharini. Tunalenga kuanzia chini hadi juu, kuunda uhusiano na uwezo uliopo ili kulandana na vipaumbabe vya jamii," Mvurya alisema.

Waziri huyo aliamuru Shirika la Huduma za Wanyamapori (KWS) na Walinzi wa Pwani ya Kenya (KCG) kukoma kuwanyanya sasa wavyo wa naotumia zana haramu za uvuvi, badala yake wawa-sidie kufuata sheria kwa kuwapa uwezo wa kupata zana zinazofaa za uvuvi.


# UNESCO yatuza Kipchoge kwa kujitolea michezoni na uadilifu




"Leo Taasisi inatunuku stashahada 664 za Elimu

Wakulima wa Kenya sasa wamejizatiti kukabiliana na uvamizi wa viwavijeshi kuititia mfumo

jumuishi wa kudhibiti wadudu ulioanzishwa na Shirika la Kilimo na Mifugo la Kenya (KALRO) kwa ushirikiano na Mpango wa Ushirikiano wa Kilimo na Chakula wa Korea-Afrika (KAFACI).

Mkurugenzi Mkuu wa KALRO, Dkt Eliud Kireger, alisizita umuhimu wa usimamizi jumuishi wa

wadudu katika kudhibiti viwavi hao, kutoa mbinu endelevu, ya gherama nafuu, na inayotunza mazingira ambayo inajumuisha mikakati mbalimbali ya kuzuia na kupunguza idadi ya wadudu kwa muda mrefu. Mradi wa KAFACI Fall Armyworm Project umekuwa ukifanya kazi kwa karibu na wakulima katika Kaunti ya Machakos ili kuthibitisha thamani ya mbinu hii. kumbatia teknolojia hizi kwa shauku.

Kukumbatiwa huku kumekuwa na athari ya mageuzi katika kudhibiti wadudu, na kusababisha kuongezeka kwa mavuno ya mahindi.

Mpango huo unalenga kuongeza mavuno ya mahindi kwa kudhibiti ipasavyo viwavi jeshi, sio tu nchini Kenya bali pia katika bara zima la Afrika. Kenya inaorodheshwamiongoni mwa mataifa yanayoongoza kwa matumizi ya mahindi

meupe. Ingawauzalishaji wa mahindi nchini Kenya ulikuwa unaendelea kupanuka, uvamizi wa viwavi jeshi mwaka wa 2017 ulileta changamoto kubwa kwa kilimo. Mdudu huyu vamizi alisababisha hasara kubwa katika shughuli za kilimo, ikiwa ni pamoja na

kuongezeka kwa gharama za uzalishaji kutoptana na utumiaji wa kemikali za kuua wadudu, kupungua kwa uzalishaji wa mahindi, kuongezeka kwa uagizaji wa bidhaa kutoka nje, na uhaba

wa chakula uliofuata na bei ya juu. Familia zilizo hatarini zaidi, zisizo na vifaa vya kudhibiti viwavi jeshi, ndizo zilizoathirika zaidi. Utatifi uliofanywa chini ya KAFACI mwaka 2020 ulibaini kuwa wakulima wengi walilazimika kutumia hadi dawa tano kwa msimu ili kudhibiti wadudu hao. Licha ya juhud

hizi, bado walirekodi hasara ya zaidi ya 50% ya mavuno na sifuri bila katumia dawa. Katibu Mtendaji wa KAFACI, Keunpyo Lee, aliangazia uzito wa tatizo la viwavi jeshi katika nchi nyiningi za Afrika. Hili lilipelekewa serikali ya Korea kulichukulla suala hilo, na mradi huo kwa sasa unafanya kazi katika mataifa 16 ya Afrika.

Lee alitoa wito kwa nchi za Afrika kuongeza uwezo wao wa kufutilia na kutathmini viwavi jeshi huku wakiten-geneza teknolojia sahihi za kulinda mahindi na mazao mengine dhidi ya uvamizi wa wadudu hao.

Mradi wa KAFACI Fall Armyworm Project ni mpango wa miaka mitano na uwezekano wa kuongezwa ikiwa viwavi hao wataendelea kuwepo katika eneo hilo. Mradi huo umefadhiliwa na kwa dola za Amerika 1.6 milioni.
